# **2006 Independence Day Honours List**

His Excellency The Governor-General, Sir Clifford Straughn Husbands, GCMG, KA, on Thursday, November 30, conferred National Honours and presented insignia to a number of persons in a ceremony held at Government House on the occasion of the Fortieth Anniversary of the Independence of Barbados.

The Barbados National Honours and Decorations System was instituted by Letters Patent dated July 25, 1980.

The Letters Patent provide inter alia, for the establishment of the Order of Barbados in which there are four (4) classes of awards:-

- (a) Knight or Dame of St. Andrew
- (b) Companion of Honour of Barbados
- (c) The Crown of Merit in two grades The Gold and Silver
- (d) The Barbados Service Award in two grades-The Star and Medal

The Barbados Star of Gallantry, the Barbados Bravery Medal and the Services Medal of Honour were also instituted by Letters Patent dated July 25, 1980.

Over the years, awards have been made to persons in various fields of endeavour. This year, the public and private sectors are represented in the areas of law, public service, cancer research, education, tourism and hospitality, community service and central banking.

In recognition of his involvement in the successful resuscitation of a visitor who encountered difficulty while swimming during the early morning hours of August 30, 2006.

For extraordinary and outstanding achievement and merit in service to Barbados and to humanity at large.

SIR LOUIS RANDALL TULL, K.A., Q.C., M.P., was born on January 27, 1938 at Lears, St. Michael to Carlotta and Godfrey Tull. He received his early education at St. Matthews Boys' School, St. Giles Boys' School, and Harrison College. He graduated from the University of Manitoba with a First-Class Honours Degree in Classics, winning the faculty's gold medal. He read law at St. John's College in the University of Oxford, gaining both his Bachelor's and Master's Degrees.

Sir Louis completed his legal training at the Council of Legal Education in England, and was called to the Bar of England and Wales. He is a member of the Inner Temple Legal Society. He became one of the leading advocates in Barbados. In 1981, he was appointed a Queen's Counsel.

Sir Louis was first appointed to the Barbados Senate in 1971. In 1976 he was elected to the House of Assembly as the member for the St. George South constituency, and became Minister of Education and Community Development, later Education then Education and Culture. As Minister of Education he gained the consensus of all the Teachers' Unions and other stakeholders to the Education Bill, returned all 14 year olds to the classroom, raised the school-leaving age to 16 years, and increased places for children of secondary school age by building new schools, and expanding existing ones.

As Minister of Culture Sir Louis led Barbados' delegation to Carifesta in Cuba in 1979, and presided over Carifesta 1981 in Barbados. He restructured and popularized the Crop Over Festival. He provided greater facilities and resources for the arts and culture. He is credited for using the resources of Government to facilitate the democratization of culture, and raising cultural awareness in Barbados. He served as Chairman of the Inter-American Committee on Science, Education, and Culture.

Sir Louis was a member of the University of the West Indies' Council and Grants Committee and has been for many years a member of the Council, Finance and General Purposes Committee, Grants Committee and Audit Committee of the Cave Hill Campus.

In 1981 he was appointed Attorney-General and Minister of Foreign Affairs, and in 1985 Minister of Commerce, Industry and Consumer Affairs. During this period a spate of intellectual property, commercial and offshore financial services Legislation was passed, and also the Companies Act. He represented Barbados on the United Nations Negotiations on the Law of the Sea. As Minister of Foreign Affairs he played a critical role in the Grenada crisis in 1983.

In 1977 he was awarded the Queen's Silver Jubilee Medal, and 1984 the Gran Cruz, Orden de Boyaca, the Government of Colombia's highest award.

He is an Honorary Fellow of St. John's College, University of Manitoba since 1974.

In 1998 he was appointed Ambassador Extraordinary and Plenipotentiary and has served as Special Envoy for the Government on a number of overseas missions.

In 2003, he was appointed by CARICOM as the Regional Negotiator for the United Nations Negotiations on the Convention Against Corruption. With 33 years' service, he is one of the longest serving parliamentarians in the history of Barbados.

His contribution to community life has been varied and exemplary. Sir Louis is married to Ordene Tull née Haynes and has three (3) children, Michael, Carolyn and Nicole.

The Accolade of **KNIGHT OF ST. ANDREW** is being conferred in recognition of his outstanding contribution to the legal profession, public life and community service.

#### COMPANION OF HONOUR OF BARBADOS

For distinguished national achievement and merit.

THE HONOURABLE MR. JUSTICE FREDERICK LAWRENCE ADAMSTRAW WATERMAN, CHB, was born on August 19, 1938 and received his primary education at Christ Church Boys' School, his secondary education at Foundation Boys' School (1946-1947) and Harrison College (1947-1958); his tertiary and professional education at King's College, London University (1958-1961) and the Council of Legal Education Grays Inn in the United Kingdom (1961-1962).

He is a Barrister-at-Law and Attorney-at-Law and holds a Second Class Honours Degree in Law and a Degree of the Utter Bar also with Second Class Honours.

In November 1962, he was called to the Bar of England and Wales and in February 1963 he was called to the Barbados Bar.

Justice Waterman has served as Magistrate (1963-1966), Deputy Registrar of the Supreme Court (1966-1967) and as Crown Counsel (1967-1970) in the Judicial and Legal Service of Barbados.

He has worked in the Legal Service of the Bahamas on contract as Crown Counsel (1970-1973), Assistant Legal Draftsman (1974) and was later that year promoted to Principal Legal Draftsman (Head of the Legislative Drafting Department) (1974-1980).

In September 1980, Justice Waterman joined the Legal Service of Bermuda. He served as Parliamentary Counsel, Law Reform (1980-1985) and as Parliamentary Counsel in the Attorney-General's Chambers (1985-1989). He acted as Attorney-General on one occasion.

In August 1989, Justice Waterman returned to Barbados, rejoined the Public Service and was appointed Chief Parliamentary Counsel. He was appointed one of Her Majesty's Counsel in January 1991.

In June 1991, he was appointed a Judge of the High Court and in August 2000, after acting on several occasions as a Judge of the Court of Appeal, he was substantively promoted to the Court of Appeal where he is presently serving. Justice Waterman has also acted as Chief Justice.

Justice Waterman is a member of the Judicial and Legal Service Commission and has been since March 2004 the Chairman of the Community Legal Services Commission.

He and his wife Diana are the parents of two sons, Craig and Patrick.

#### HONORARY COMPANION OF HONOUR OF BARBADOS

For distinguished national achievement and merit.

MR. GEOFFREY LAKIN BELL, CHB, was born on November 8, 1939 and was educated in Grimsby, U.K. and at the London School of Economics and Political Science. He received an honors degree in Economics and then joined Her Majesty's Treasury after graduation in 1961. Between 1963 and 1964, Geoffrey Bell was a visiting scholar with the Federal Reserve System of the United States, mainly based in St. Louis, where he studied monetary economics. Also, he wrote about the Euro-Dollar Market, publishing one of the earliest articles on this subject. Over the next few years, Geoffrey Bell wrote extensively on this subject culminating in the publication of "The Euro-Dollar Market and the International Financial System" in 1973. This book was regarded for a long time as one of the most important contributions to this new subject.

After returning from the Federal Reserve, Geoffrey Bell divided his time between Her Majesty's Treasury and the London School of Economics, where he lectured in monetary economics in 1964 and 1965. During this time, he wrote a number of articles on monetary policy as well as on the emerging euro-dollar market. In early 1966, Geoffrey Bell was invited to become Economic Advisor to the British Embassy in Washington, becoming the youngest economist ever to assume this post and the position of first Secretary. Geoffrey Bell spent three years in Washington

establishing a wide variety of relationships in economics and finance on both sides of the Atlantic. At this juncture, Geoffrey Bell decided to become a merchant banker joining the eminent London Bank, J. Henry Schroder Wagg as Assistant to the then Chairman, Gordon Richardson.

Mr. Bell formed his own company in 1982 with the original base of clients including many central banks and governments as well as large international corporations. His relationship with the Ministry of Finance of Barbados started in 1984 and has continued uninterrupted since that time, being involved in all of the external financing issues of the Government. Similarly, Geoffrey Bell has been fortunate enough to have been the external advisor to the Government of Jamaica since 1997. During the period 1987 to 1993 he was the Chairman of one of London's oldest merchant banks, Guiness Mahon Holdings and negotiated its sale to the Bank of Yokohawa in 1984.

Apart from his work at Geoffrey Bell & Company, Geoffrey Bell is an active golf player. He is married to Joan and they are the parents of Allison.

#### **GOLD CROWN OF MERIT**

For highly meritorious service or achievement in science, the arts, literature, sports, civic duties or any other endeavour worthy of national recognition.

MR. SHOUKET ASSAD ABED, GCM, J.P., Mr. Shouket Assad Abed, J.P. was one of the pioneers of the retail trade in Barbados and established and painstakingly built his successful business. He was among a small group of community-spirited persons who in 1958 got together to launch the Jaycees, which is still recognised as one of the most efficiently run and nationally beneficial charities ever to exist in Barbados.

It was this organisation that also gave Barbados the Jaycees Carnival, the precursor to the current Crop Over Festival, which flourished until 1964 and provided a launch pad for many of the successful entertainers, musicians, designers and other creative persons of that generation, including the world-renowned Merrymen.

The Jaycees was but one of several similar organisations, including the Lions Club, to which the nominee devoted and continues to devote his time and energy while asking or demanding nothing in return. His reward is in knowing that his contribution makes a difference in the lives of countless less fortunate persons across the length and breath of Barbados.

He remains a major contributor to disaster relief cases, hurricane and flood victims and countless charitable causes. He also provides significant discounts to underprivileged families for the purchase of school uniforms for their children.

Most significant, but least known of his greatest contribution to the Barbadian society, is the fact that over the past ten years Mr. Abed has made monetary donations at the start of the school year, to schools across Barbados to be used to satisfy pressing needs of students, parents, teachers and the institutions themselves.

MR. JOHN ANDREW FREDERICK COLE, GCM, BCH, on leaving Harrison College in 1953 joined the family business, Cole's Printery Ltd. where (since his early teens) he had done an apprenticeship in the basics of typesetting, composing and proof reading. Between 1956 and 1959 Mr. Cole worked with publishing companies in the United Kingdom, and on returning to Barbados he helped with the introduction of new printing processes which were sweeping the industry world-wide.

Mr. Cole was appointed to the Board of the Barbados Development Bank in 1988, and later to the Boards of Hotels & Resorts Limited and Enterprise Growth Fund. He was appointed an Independent Senator in 1991 and became Deputy Chairman of the Barbados Tourism Authority that year. In 2005 he was appointed a director of Consumers' Guarantee Insurance. He is currently President of the Barbados National Trust and is Chairman of Bush Hill Tourism Trust Inc., the institution which is responsible for the restoration of the house where George and Lawrence Washington lived when they visited Barbados in 1751.

Mr. Cole is involved with the work of the Dyslexia movement and is a Trustee of the Gift of Dyslexia Foundation Trust. He is also a Trustee of The Codrington School.

In cricket he represented Carlton Club in all three Divisions of the Barbados Cricket Association (BCA), eventually taking part in the Over Forties competitions over a period of 17 seasons. He also represented Barbados internationally in Masters Swimming as a member of the Casuarina Masters, and has represented Barbados in motor sport - both rallying and track.

On January 1, 2001 he received the Barbados Centennial Honour for his contribution to the printing industry. A patron of the arts, his particular focus is on fine art and classical music.

After a career spanning over 50 years in the family business Cole's Printery Limited, and over two decades as a director of Casuarina Beach Club Ltd., John Cole now devotes most of his time serving the broader community.

He is married to the former Suzanne Johnson and has two children and two grandchildren.

The award of **GOLD CROWN OF MERIT** is being made in recognition of his contribution to the printing industry, tourism and civic duty.

**DR. KEN RUPERT HAREWOOD, GCM,** GlaxoSmithKline's Distinguished Professor, Director of the North Carolina Central University Julius L. Chambers Biomedical/Biotechnology Research Institute, and Adjunct Professor, Department of Molecular Genetics and Microbiology, Duke University, is widely recognized for his contribution in the areas of cancer biology and cancer drug discovery.

Dr. Harewood received his secondary education at the Lodge School where in addition to academics, he excelled at football, becoming team captain and a member of the Barbados National Football Team. He attended New York University where he earned a Bachelor's degree in Biology. He received his graduate education at the City College of the City University of New York earning Masters and Doctoral degrees in Biochemistry. After completing his post-doctoral training at the New York Blood Center, Dr. Harewood joined the Central Research Division of Pfizer Inc. as a member of the Cancer Research Department.

Dr. Harewood's extensive corporate research experiences resulted in creative contributions to national and international efforts that culminated in the discovery of the first human leukemia virus as well as the virus that causes AIDS. He conducted pioneering work on cloning the gene for chymosin leading to FDA approval of the first recombinant DNA process for a food ingredient. He also developed innovative cell-based strategies to facilitate the discovery of novel drugs to treat cancer.

Dr. Harewood's high level of recognition is evidenced by the numerous honours and awards he has received. Some of which include: the Harlem YMCA Black Achievers in Industry Award; the National Consortium for Black Professional Development Health Sciences Award; the 1998 Barbados Charity Fund Pride and Industry Award; the 2006 North Carolina Central University Chancellor's Merit Award; and the 2006 Oliver Max Gardner Award - the most distinctive honor given to a faculty member by the University of North Carolina Board of Governors.

Dr. Harewood's stature within the scientific community has earned him memberships on scientific boards and committees such as: the Board of Directors of the North Carolina Biotechnology Center; the Board of Governors of the Research Triangle Institute; the Board of Directors of the University of North Texas Health Science Center Institute for Cancer Research; and the External Advisory Committee of Hunter College's Gene Center. He is a member of the American Association for the Advancement of Science; the American Society for the Biochemistry and Molecular Biology; the American Society for Cell Biology; and the American Association of University Technology Managers. Dr. Harewood has published

numerous articles in scientific journals, and over the past six yews he has authored proposals that have secured more than \$40 million in research funding to support North Carolina Central University's expanding programs in the biomedical sciences and biotechnology.

Dr. Harewood is the son of the late Glenville and Annie Harewood of College Land St. John. He and his wife Eudine live in Durham, North Carolina. The couple has two children, Dionne and Kevin and five grandchildren.

**DR. MARION VERNESE WILLIAMS, GCM,** was born Marion Mottley to two teachers Rudolph and Cledlene Mottley. She received her early education at St George's Primary School and St Michael's School, joining Queen's College at 12, and she graduated from the University of the West Indies in 1968 with a degree in Economics. On returning home she joined the East Caribbean Currency Authority, the precursor to the Central Bank of Barbados, where she was responsible for monitoring the economies of Barbados and the Eastern Caribbean, and where she reached the position of Research Director. In 1973, she joined the Central Bank, and it was here that her career took off.

Dr. Williams earned her Masters in Economics with distinction in Monetary Economics, (having been the first postgraduate in Economics from Cave Hill), she has qualified as an Associate of the Institute of Bankers and as a Certified Management Accountant and later earned a PhD in Economics from the University of Surrey. In those early years Dr. Williams was the Bank's key person on capital market matters, having been part of discussions leading to the establishment of the Barbados Stock Exchange. She authored the booklet for the Bank on trading on the Stock Exchange, was often the Central Bank's representative on the Board of the Stock Exchange in its early years, and was a member of the Regional Stock Exchange Committee which developed rules for cross listing and cross trading in the Caribbean. She was also instrumental in coordinating strategic planning in the Central Bank, and for 15 years was the coordinator and author of every strategic plan of the Bank. She played an integral part in the IMF Stabilization Programme of 1992 and helped to publicly familiarize Barbadians with the issues in outreach programmes organized by the Bank and the Barbados Economic Society.

One of Dr. Williams' specialties was prudential regulation and the challenges of liberalization and this became the subject of her PhD thesis in 1995 and later her first book "Liberalizing a Regulated Banking System" published in 1996. Dr. Williams was an active promoter of the International Financial Services sector.

In her private capacity, Dr. Williams is vice president and a fund raiser for the Caribbean Special Olympics, a former member and now an honorary member, of the Soroptimist Club of Jamestown and through her husband's affiliation, is from time to time active in the Rotary Club of Barbados. She is also an active promoter of literature and the arts, particularly through her association with the Frank Collymore Hall, its Literary Endowment and as host of many of the visual and literary arts functions sponsored by the Bank.

Dr. Williams is married to Clyde Williams. They are the parents of two children, Dawn and Paul.

#### SILVER CROWN OF MERIT

For meritorious service or achievement in science, the arts, literature, sports, civic duties and any other endeavours worthy of national recognition.

MRS. BERNICE CLEOPATRA CRITCHLOW-EARLE, SCM, was born on December 10, 1949 in Guyana formerly (British Guiana) and later emigrated to the United Kingdom in 1955 where she received her primary and secondary school education at St Katherine Church of England Girls' School and her tertiary and professional education at Waltham Forest Technical College, Ealing Technical College and Queens University.

Mrs. Critchlow-Earle gained her teacher's certificate from the University of London. This prepared her both to work and to teach in the tourism and hospitality industry. Her varied employment experience in the United Kingdom spanned both working in the hotel and catering field as well as lecturing at Colleges in those areas.

Mrs. Critchlow-Earle holds a Master of Science Degree in Hospitality and Tourism Management from the International Management Centres Association and Revans University, Colorado. She is currently pursuing her Doctorate with the same institution.

In 1977 she returned to the Caribbean region and took up an appointment as Lecturer at the Bermuda College.

Mrs. Critchlow-Earle joined the faculty of the Barbados Community College in April 1981 as an Instructor in the Division of Hospitality Studies and in 1982 was appointed Head of that Division, a position she still holds. During her tenure at the Barbados Community College she has been involved in many major developmental changes in the Division of Hospitality Studies, namely; the upgrading of the Division into the Hospitality Institute, Articulation programme for the students with the

University of the West Indies and other Universities and Colleges and the development of the All Saints' Unit in St Peter.

Mrs. Critchlow-Earle has worked tirelessly and effectively in the field of Hospitality and Tourism Education and Training. This work has not been limited to Barbados but has been extended to the Caribbean region. In 1999 she received the Tony Mack Award from the Caribbean Hotel Association for her contribution to Regional Tourism Development. In 2003, the Government of Antigua and Barbuda presented her with a plaque in recognition of her contribution to the establishment of the Antigua and Barbuda Hospitality Training Institute. Her significant contribution to the development of Hospitality and Tourism Education and Training in Barbados overall was publicly recognized also in 2003 when she was the recipient of the Inaugural Minister of Tourism Lifetime Achievement Award for Outstanding Achievement, Loyalty and Dedication to the development of Tourism in Barbados.

Mrs. Critchlow-Earle has served as a member of the Tourism Advisory Council of Barbados. She was the Chairperson for the Council of Heads of Caribbean Hospitality Schools (1994-1996) and Consultant to the Caribbean Human Resource Development Programme for Economic Competitiveness (CPEC) and the Caribbean Tourism Credentialling Programme (CTCP) (2000).

Mrs. Critchlow-Earle is the mother of one daughter, Erika.

The award of **SILVER CROWN OF MERIT** is being awarded in recognition of her contribution to education and the development of the hospitality sector.

MS. SANDRA KATHLEEN OSBORNE, SCM, after graduating with BSc and LLB degrees from the University of the West Indies, began her professional career as an Attorney-at-law in 1978 when she was called to the Bar of Barbados and Trinidad and Tobago. For the next ten years she served as a Crown Counsel in the Attorney General's Chambers and later practised at the private Bar before venturing into the world of Corporate Counsel in 1989. In 2001 she earned the designation - Fellow of the Institute of Chartered Secretaries and Administrators in Canada.

She currently holds the position of Executive Vice President, General Counsel and Corporate Secretary, Sagicor Financial Corporation and also serves on the boards of some subsidiaries within the Sagicor Group.

She was appointed a Director of Barbados Shipping & Trading Co. Ltd., in 1991. From 1991 to 1996 she was a Director and later Chairman of St Gabriel's Management Inc. and between 1994 and 1996 was Secretary of the Barbados Amateur Swimming Association.

From 1996 to 2001 she was a volunteer Technical Partner and Mentor of the Youth Entrepreneurship Scheme. Since 2002 she has been a Vice President of the Barbados Tennis Association.

From 1999 to 2001 she was a member of the committee which made recommendations to introduce mutual funds and securities legislation in Barbados. In 2004 the Securities Commission named her a member of the committee charged with reviewing legislation relating to take-over bids, securities, mutual funds and unclaimed intangible property.

Ms. Osborne also serves on Committees to review the by-laws and rules of the Barbados Stock Exchange and the Barbados Central Securities Depository.

MR. HEWITT DRURARD McDONALD SYMMONDS, SCM, J.P., was born on January 31, 1941 and received his primary and secondary education at Miss Rebbitt's Primary, Harrison College and the Lodge School.

On leaving school Mr. Symmonds worked with British West Indian Airways as a cargo clerk before leaving Barbados in April 1962 to join the British Army's Royal Corps of Signals. He became a telegraphist, and over the following four and a half years, he was assigned first with the 'Far East Land Forces' in Singapore, Thailand, Malaysia, and then in Borneo where he earned the 'General Service Medal' for active service, before returning to the United Kingdom; after which he served as a trainer in Germany.

Mr. Symmonds was one of but a few non-commissioned officers, who were not British, to be engaged in the encryption and decryption of classified communications.

Mr. Symmonds has known the experience of 'service' ever since he was 14 years of age when the island was struck by hurricane Janet. He recalls going out into the village with his father, the late McDonald Symmonds with crocus bag over his head, assisting the aged and some of the less fortunate. Throughout his life his motto has been "THERE BUT FOR THE GRACE OF GOD GO I" and it is that commitment to service which led him to accept an invitation to become a member of the Lions Club of Barbados South in 1984, where he has served Lionism and the

After graduation, he joined The West Indian Tobacco Company Limited in Trinidad and Tobago as an Agronomist involved in tobacco and food crop production. He progressed within the Company to be appointed Chairman and Managing Director in 1980 and retired from that position in 1998.

His field of endeavours was not limited to the Tobacco Industry, for he was involved in assisting the development of the Private Sector as an essential partner in a developing country and the CARICOM region. He served as Chairman and Board member in many State Companies under three (3) Government Administrations in Trinidad and Tobago. MR. MONTAGUE DELISLE FITZCRITCHLOW BARROW, BSS, J.P., was born on February 24, 1936. He received his primary education at the Roebuck and St. Giles Boys' Schools. He received his secondary education at Harrison College (1949-1953) and his tertiary Education at Codrington College (1979-1982) where he graduated with a Diploma in Theology.

After leaving school the young Mr. Barrow migrated to St. Lucia where he worked as a Journalist from 1955 - 1957. He returned to Barbados in 1957 and joined the Transport Board where he worked as a Senior Clerk from 1957 - 1966. He later went into the Private Sector, before starting his own Commission Agency, "Barrow Brothers".

He was a member of the Barbados Boys Scouts' Movement attached to the Y.M.C.A Troop as a Patrol Leader, a Cadet with the No. 1 Corps of Harrison College, and Member of the Barbados Regiment (1957 to 1961). He was a member of the Junior Chamber of Commerce (Jaycees) from 1960-1976 where he chaired a number of committees, including Chairman of the Committee which supervised the Life Guard Stations.

Mr. Barrow worked as Chaplain Assistant at the Queen Elizabeth Hospital (1982 - 2002) and assisted with services at H.M. Prisons (1998 - 2001). MR. GOULBOURNE ADDINTON FORDE, BSS, was born on September 26, 1945 and received his primary and secondary education at the St. Mark's Boys' School and the Lodge School, and his tertiary education at Erdiston Teachers' Training College (1969 - 1971) and the University of the West Indies, Cave Hill Campus (1974 - 1978).

He joined the Barbados Advocate in 1965 for 18 months, before moving to Princess Margaret Secondary School in 1968 to teach English and Physical Education.

In 1984 he was seconded to the National Cultural Foundation as a Field Officer, joining permanently in 1986, first as Cultural Officer for Barbadian Folklore, then as Research Officer/Documentalist.

At the NCF, Addinton got to hone his interest in Barbadian heritage, an interest which began in 1962, when for the 'O'level English examination, he wrote on the topic "Superstitious beliefs in your country". This writing was to continue during the 1970s and 1980s, with a large number of newspaper articles on topics of local cultural interest.

So far he has done research on more than 100 topics of Barbadian heritage, published 10 books which include "De Mortal Pestle", a collection of Barbadian proverbs; "Folk Beliefs of Barbados"; "The 1937 Disturbances of Barbados", which is a summary of the Dean Commission of Enquiry into what was perhaps the most important event in this island's modern history; he has also published "Bajan Quizzes"; "Place Names of Barbados", explaining the origins of some 500 local names; "Nicknames of Barbados", "It Happened in Barbados", "True Stories of Barbadian Folk", and "Ossie Moore", a collection of jokes about Barbados' best loved folk character.

Addinton is also co-author of a number of books, which include "Insight Guide to Barbados", "Barbados just Beyond your Imagination" and the "A to Z of Barbados Heritage".

He is currently preparing to publish three others, "The Chattel House of Barbados", "Monuments of Barbados", and "Warri - the African Board Game of Barbados and Antigua".

A fine artist as well as an accomplished photographer, he does many of the illustrations and photography for these publications.

Addinton Forde has played a major role in the resurgence of local kites, by teaching the craft to hundreds of Barbadian children, publishing a monograph on the topic, and helping to organize and judge the annual kite flying competition from 1986 to 2000.

In the field of calypso, he was a founding member of the now defunct Conquerors Calypso Tent and has been credited with introducing to it, one calypsonian with the unusual name of Red Plastic Bag.

Addinton willingly shares his wide and in-depth knowledge of the Barbadian Heritage with individuals, groups, students from primary schools to university, journalists, as well as governmental and non-governmental organizations. He gives lectures, sits on panel discussions, organizes events, prepares and conducts quizzes, and acts as master of ceremonies. He also judges competitions in literary arts, fine arts, craft, dance, theatre arts and music, even Easter bonnet parades and dress making.

Addinton Forde has been referred to by a number of names "the Kite Man", "The Warri Man", "The Sticklicking Man", "The Cultural Man", "The Culture Guru", "A National Icon".

With that in mind, his wife joined him two years later but he was soon to return to Barbados. While in England he worked as a carpenter and a joiner and in 1965 when his wages were at their highest and his wife was studying to be a nurse, the Lord called the two of them back to Barbados to do work for Him.

After furthering his education at the International Evangelistic Fellowship, Alfred Vaughn and his wife returned to Barbados and in 1966 established the Caribbean Evangelistic Fellowship. #### THE BARBADOS BRAVERY MEDAL

For acts of bravery in hazardous circumstances.

MR. ROLSTON EDRICK McKINLEY WILLIAMS, BM, was born on January 10, 1970, the last of seven children born to Cynthia Williams. He received his early education from Pine Primary and his secondary education from the Coleridge & Parry School.

After leaving secondary school, Mr. Williams was recruited into the Barbados Defence Force, where he spent twelve years from 1990 to 2002. While in the Barbados Defence Force he received invaluable training from such units as the United States Navy Seals, the United States Green Berets and also participated in several external commando courses. Mr. Williams attained the ranks of Substantive Corporal and Section Commander. His extensive experience in the military is not limited to home but also abroad as he has represented the Government of Barbados during the United States led Operation Restore Democracy in Haiti in 1994. His last attachment before leaving the Barbados Defence Force was to the Coast-Guard unit.

On January 16, 2004, Mr. Williams joined the staff of the elite five diamond Sandy Lane Resort as a security officer. During his tenure at Sandy Lane, Mr. Williams has exhibited honesty, integrity and bravery on several occasions. In June 2005 he was involved in saving the life of a gentleman at Sandy Lane's beach. In June 2006 Rolston rescued a small child (a guest of the hotel) who was choking. On August 30, 2006 Mr. Williams performed CPR on a visitor who had been washed ashore on the beach of the Almond Beach Hotel. Mr. Williams pulled the visitor up from the surf. He checked for a pulse and found none, and he checked for a heartbeat and found none. There was absolutely no response from the visitor. Mr. Williams immediately administered CPR but still there was no response. After 15 minutes the visitor responded. He fell unconscious again. A tired Mr. Williams administered CPR once more for three minutes before the Police arrived on the scene. The visitor was rushed to the emergency facility in Sunset Crest and later the Queen Elizabeth Hospital. The visitor survived.

The award of **BARBADOS BRAVERY MEDAL** is being made in recognition of his involvement in the successful resuscitation of a visitor who encountered difficulty while swimming during the early hours of August 30, 2006.
