Flood of Investors Come

The expected flood of investors from overseas has started", says the excited Principal Director of U-Vistract announcing that many people from overseas are now ringing to come and invest in the high interest investment programs of the Royal International Bank of Meekamui and the Royal Central Bank of Meekamui.

"I expected this to happen, and they are ringing me in numbers everyday", says the King, who launched the full operation of four of his high yielding banks three weeks ago.

"The excitement has been created, and many overseas investors want to come mainly to invest in the long-term investment programs", said the King.

He said they cannot invest in the short term investment program because there is no where for them to stay, but guest houses are being built in Tonu to accommodate those who do come.


The King said work has started to build three guest houses, one as the female quarters and the other two as general transit houses.

He said the overseas investors will have to transfer their money into PNG and turn it into hard cash and bring it to invest, until the communication system is finalized for them to transfer their money electronically.

"PNG should be very happy because it will benefit greatly from the foreign exchange that will be brought in, boosting the economy of the country", said the king adding that he could have chosen to transfer these people's money through Fiji or Solomon Islands but chose PNG because of existing links.

He said PNG may not have enough hard cash to accommodate all the money transferred in, so the investors will bring only small amounts at a time.

The King said most of the overseas investors ringing him are his contacts of



his networks who are royal families and people of high profile representing many other investors.

"These people are looking for banks where they can park their money on long term basis, getting back high interest, and with high level of confidentiality", he said.

He said some are also withdrawing their money from Swedish and Irish banks which are internationally renowned for strict confidentiality, to re-invest in the U-V Royal International banks.

"A twin-otter belonging to Regional Air, which has connections with Airlink is being organized to station in Buka to fly them to Tonu to do their investments", he said.

He said work has started to build guest houses for the foreign investors.

He said U-V is also speeding up the establishment of its bank branches in Arawa, Buka and Port Moresby, to cater for the overseas investors, due to the long trip to Tonu.

Straight Forward Percentage

No deductions like Conventional Banks


"We pay straight forward interest percentage on investments, without any unnecessary deductions", says a senior banker of the Royal International Bank of Meekamui.

"What-ever investment the people make, we pay them straight forward percentage interest, which is very different from conventional banks which deduct a lot of money from the interest and give very little to the investors", says Salatiel Lambulai who has been hard at work at the tellers box for the last few weeks paying out invested monies and the interests, especially in the short term program of the bank.

Mr Lambulai who has almost fifteen years banking experience with the conventional banks said in the conventional system, the people invest their money with the bank, which is then lent out to borrowers, who pay high interest.

He said from the interest paid by the borrower, the bank gets about 80 percent and give only twenty percent back to the investor or owner of the money.

Mr Lambulai said most banks do not have any money of their own, and only make money from the monies



put in by their customers in the savings and other types of accounts.

He was resounding similar sentiments by the Principal Director of U-Vistract, HM King David Peii II, which own the Royal International Bank of Meekamui and the Royal Central Bank of Meekamui, which went into operation with two other banks this month, offering not only straight forward percent interest payout, but are the highest interest being paid out by any bank.

The Director described the conventional banks as "shams" only making money from the peoples investments,

The king said however, the opening of his banks with high interest rates, is like opening the flood gates, and many people will withdraw their money from the conventional banks to re-invest in the Meekamui banks.

The King also declared that the conventional banking and monetary systems will eventually die out, as his banks spread around the world and many people withdraw their money from the conventional systems to re-invest in the Meekamui banks.

The interests being offered for hard cash investments in the short term investment programs are:

- 1. 2.5 % on-the-spot
- 2. 5% for hourly
- 3. 10% for daily
- 15% for overnight
- 5. 100% monthly
- 6. 500% six months
- '. 1000% yearly.

Other interest percentage for time durations in between will be made known over the counter.

The long term savings and other personal or company accounts which also offer high interest are also available.

Outsiders Regret -Want to join

"Many people who did not want to be part of the Twin Kingdom Government, now regret their decision and want to join.

"And, they are blaming the Autonomous politicians for fooling them to stay away from Meekamui", says the Siwai District Manager and Minister for Village and District Affairs in the Siwai District Government, Hon. Thomas Wawoitu. He said many want to become part of Meekamui, only because the U-Vistract Banks are now in operation and giving lot of interest money in its high interest investments programs to its members.

Regional Governments our Priority

"Establishment of U-V Governments in the countries of the Asia-Pacific region are on our priority, because they are our closest neighbors and ones we will be doing a lot of business with", says the Principal Director, HM King David Peii II.

"Among them are Paradise islands (PNG), Fiji, Solomon Islands, Singapore, Australia and New Zealand", he said.

He said Singapore is special because most of the U-V business activities transacting from the Western World and Asia regions are transpiring through Singapore.

The King said as soon as the U-V funds are in full circulation, the Governor for the Asia/Pacific region, Sir Uwau Imani, will take up his post to start establishing his government operations in Singapore.

The King said he is also moving, fast to appoint Chief Governors,



Provincial Governors, Administrators, Governor-Generals and Central Bank Governors in Paradise Islands, Fiji and Solomon Islands, while the governors appointed in other countries will appoint their own provincial governors and administrators.

He said the chief governors of Fiji and Solomon Islands will bring their selected provincial governors and administrators to Tonu in several weeks time for formal appointment.

He said special business deals have already been signed with Fiji for the engagement of a troop of Christian soldiers from Fiji to help in providing training, escort, guard duties and maintain checkpoints.

Fiji Security Forces Engaged

The Royal Twin Kingdom governments of Meekamui and Papala on the island nation of Bougainville have enlisted the support of the Fiji Islands Security Forces through its subsidiary, ASK TRIUNITY, a Christian-based company to uphold the social welfare and lives of their people.

The Siwai Council of Chiefs in representing their district in the Twin Kingdom governments, signed a general consensus and approval for the engagement of the Fiji Security Forces saying they were expressing their free will under the powers vested upon them, by their ancestors by divine authority.

In signing the document the 14 chiefs said they support peace, harmony and goodwill for all their citizens on the island nation and that

they fully understand the roles and responsibilities of the Fiji Security Forces to uphold social welfare and the lives of their people.

"We hereby support the agreement between the two authorities being the Royal Twin Kingdom governments and the Government of Fiji for the provision of the Fiji Security Forces and special bodyguards for our Royal Twin Kingdoms", the chiefs said.

The signing of the agreement by the Siwai chiefs was witnessed by the U-Vistract appointed Chief Governor for the Fijis Islands, Sir Fereti Rokodi and his Royal Chief Governor for Finance, Sir Semi Baroi.

Among 50 plus village chiefs who also witnessed the signing of the agreement were the Siwai District Manager in the Twin Kingdom Government and Village Chief Thomas Wawoitu and the Commander of the Siwai Command of the Meekamui Defence Force, Commander, Colonel Gunther Uming.

Among Security and bodyguards to be deployed by the Fiji Security forces to Bougainville are men and officers with strong Christian character who have behind them many years of peace keeping experiences and skills, earned from similar assignments overseas.

Some of them were actually awaiting agreements to be formalized for their engagement in peace keeping duties in Iraq and Kuwait, when they were signed up by the Royal Twin Kingdoms of Meekamui and Papala on Bougainville Island. pc

Appointments Ceased Governors

Appointments as U-Vistract provincial Governors in Paradise Islands (PNG) has been ceased, while those wanting to be appointed must show commitment to the organization through monetary terms.

"From now on every person seeking appointment must show real commitment and their sacrifices will be assessed and valued in monetary terms, or they may invest K100,000-00 or more in our banks to prove themselves", says the U-Vistract Principal Director HM King David Peii II.

"Our dreams and visions have now become a physical reality, and so those wanting appointment to governorship must show physical sacrifice and prove themselves in monetary terms", he said.

He said the time of random and casual appointments of people has ceased, because many of those appointed did not show commitment in helping the cause of U-V in their countries and provinces.

The King said among them are Central, Hela (West Southern Highlands), Sandaun, West New Britain, Western tem comes on line and electroni-Highlands and Simbu.

"For some reasons they could not attend the formal investiture ceremony in May this year and missed out on the golden opportunity', he said. "The only way to seek reappointment now is by investing minimum of K100,000 each in our banks to prove themselves", he said.

Meanwhile, the King has announced the appointment of Andrew Liliura as the Acting Governor of the Central Bank of Paradise islands.

And, the king has assured customers especially from Port Moresby and nearby provinces that they will be able to withdraw money from their access accounts and re-invest in Treasury Bills of the U-V Central Bank of Paradise Islands, as soon as it becomes fully operational.

He also announced that the trialing of inter-bank cash transfers and clearances is continuing with the various branches in Paradise islands with the pc second trial to be carried out next

week with the Madang branch.

"When our communication syscally hooks up all our branches, we will go into full operations in all the centres", he said.

The King also expressed satisfaction over the recruitment of bankers in all the centres, and called on the provincial governors to arrange ticketing to send them for training at the Royal International Bank of Meekamui headquarters in Tonu, before they return to kick-start the operations in their branches.

"It is essential that they come to learn the operation procedures of the new investment products we have launched", he said.

The King also announced that some banking officers being trained in Tonu will be sent out to head branches in Buka, Kavieng and Lae, as soon as five or six new bankers are recruited to replace them at Tonu.

V Not a Finance Company

"U-Vistract Organization is a Christian Ministry, and is not a finance company out to make money", says the Governor of the Royal Central Bank of Meekamui, Sir Peter Lising.

"The U-Vistract Organization is a Christian Ministry with the mandate to bless the people of God, and is a gift to them", said the Governor while expressing concern about the possible misuse of the money being paid out in high interest rates to the investors of the banks owned by U-V.

He said the accounts of some investors and helpers were stopped because they broke the rules of the organization by engaging in immoral activities, for which they must go through



counseling to sort out before their accounts are re-activated.

The accounts were stopped for people found guilty of rape, drunkenness and fighting.

Speaking to U-V staff during a prayer fellowship, the governor said it is the responsibility of the staff to educate customers and investors to use their money responsibly for the wellbeing of their

families and the general advancement of their communities.

He said the customers and investors who misuse their money and break moral rules of the Ministry have only themselves to blame if their accounts are stopped.

The U-V Principal Director, HM King David Peii II, is especially concerned that people paid large sums of money may leave their wives and engage in immoral activities, finally destroying themselves.

Over a hundred members of Meekamui who had their accounts stopped were refused service when the U-V organization through four of its banks went into full operation this month.

Of the 24 International Banks owned by U-Vistract 4 went into full operation three weeks ago, including the Royal International Bank of Meekamui and the Royal Central Bank of Meekamui. pc


TAKE CARE WITH CASH

People investing in new products of the Royal International Bank of Meekamui, have been warned to take care when handling cash from their investments, to avoid holdups and similar incidents which could result in them losing money.

They were told that such incidents could be mounted by people from their own communities who may be disappointed that they do not have money to take advantage of these investment opportunities.

In sounding the warning, Siwai District Manager in the Meekamui government, Hon. Thomas Wawoitu, urged investors to deposit monies they



make from their investments with the RIBM, into their bank accounts and carry only enough cash for their daily needs.

Mr Wawoitu was addressing investors in front of the Tonu based bank,

where investors are already investing larger amounts of money in short term high yielding investments, just two weeks after the bank introduced a number of new products.

By the end of the second week of the bank introducing these new products, more than one billion kina has been transacted between it and customers who have been investing in, On The Spot, Hourly, Same-day and Overnight products.

From just one to two hundred kina in investments in the first few days following the October 3rd introduction of these products by the RIBM, investors are now handling larger amounts of money from which as a direct result, they are picking up substantial amounts of money in interests.

MADANG LEADS THE WAY

Papua New Guinea's Madang province is leading the way in U-Vistract's clients committee leadership in just over three months from the formal commencement of the organization's financial year on the first of July this year.

The Madang clients committee is ably assisted by a 6 member assistants committee in mounting awareness on the organization's universal aims and objectives and soliciting helpers funds towards the cost of funding its work.

I got my degrees on the streets

Not with-in the conventional system

When you are out to establish a whole new Government, Monetary and Banking system, you have also to have your own operational laws and principles that may not be consistent with the normal conventional systems.

No wander, many learned professors and academics of the current conventional system found HM King David Peii II, hard to handle because the wisdom and knowledge he displayed, according to them, was completely out of the ordinary and out of this world.

He makes no secret of it, but says many times that the knowledge and wisdom he has, which are the basis of what he is doing, is complete new and comes from God Almighty, founded on laws and principles of God which not many people understand. The King says many professors and learned academics have challenged him with knowledge and wisdom of this world, but have found him hard to handle basically because they cannot match the level of understanding and wisdom he displays in what he says.

The King has told his staff at the U-V headquarters many times masters degree in 'Universal that he has attended many internet conferences of learned academics around the world through the internet, and raised points and issues on topics, which the learned people found hard to comprehend and answer

So then, how did he get this knowledge and where did he get

"I got my degrees, doctorates and professorships after learning from the schools of the streets", he declares talking about his walk with God in prayer, fasting and listening and learning principles and laws of God while living like a fool amongst street dwellers in Port Moresby, Brisbane and Fiji.

The U-Vistract system, which now owns 24 International Banks offering the highest interest rates with the mandate to bring prosperity and blessing to the people of God, was born in the schools of the streets.

"I got my first degree in 'Wilderness Studies' on the 30th June 1998 after studying for 4 years on the streets of Port Moresby", he says.

He said only his family and brother, the present U-V Chairman, HRH Meshach Autahe, were there to celebrate with him with a "big rooster" and icecream, while the others he invited only laughed at him.

"Eight days later, on the 8th of July, U-Vistract went into full operations, which I officially dedicated to God on the 26th of May", he said.

The king says he obtained his Studies' in a small motel room in Fiji on the 12th of September, 1999.

The King said he obtained his Doctorate in 'Mountain Studies' in Brisbane, Australia, on the 6th of November 1999, after studying the meanings and aspects of overcoming obstacles and achieving heights in fields of study and know-how.

"I am now a professor and Doctor in these fields of study, which no one else has mastered, which is why they do not understand me", he said.

"In all my years of study, I have come to the same conclusion as the wise King Solomon, recorded in Ecclesiastes 12:13-14, which is "Man must fear God and obey his commandments for afterwards is judgment", he said.

The King said his final achievement was when he received his Professorship in "Universal Justice & Rulership", ten days later on the 16th of November.

"That is where I am now, on top of Mount Vistract, having defeated all my enemies, I am professor of my system- and I can do anything", he said.

"I have knighted people, given masters, doctorates and honorary degrees in U-Vistract, and will eventually establish my own university for people to study for masters and doctorates", he said.

Ultimately, God rules my system through his Son Jesus Christ as King of Kings and Lord of Lords", he said.

LONG WALK NO HASS

Walking long distances to accomplish one's wish may be over stretching a person's physical ability, but when it means staking one's life on it in term of securing their financial security, this task is proving to be no hassle for U-Vistract helpers in the Nagovis area of Bougainville.

Since UV's monetary and banking system through the Royal International Bank of Meekamui introduced several new short term high yielding products on the 3 rd of October, its helpers both from far and near have been checking out these new products by investing money in them.

Many of these helpers have already received their bulging bank statements and cards and it was just a matter of deciding what product they wanted to invest in and the bank facilitated their request.

For Nagovis based helpers this meant having to walk up to about a day and half to get to the bank at Tonu to either physically invest cash in short term high yielding products or to



transfer funds from their Access Accounts in Treasury Bills investments.

The walk can be long and tiring depending on who one walks with. Men and boys only can take just 10 hours but if they walk with their women and children it could take up to a day and half.

Either way Nagovis helpers to UV have no problems traveling to and from the RIBM at Tonu because their lives depend on their investments with the bank and they are prepared to shoulder the task.

Thomas Rata who is in his mid fifties is one village elder from Osirada village in the Nagovis area who was among other men, women and children from his area who visited the RIBM on the 18th of October to do their banking.

"The long walk to and from Tonu to do our banking is no problem to us even at this early stage as we have a lot of hope to improve our lives and those of our communities with the financial blessing we expect from U-Vistract", Thomas said.

Thomas said there is no doubt in his people's minds that their financial future is guaranteed through their connection with U-Vistract.

Passport Entries to Bougainville


The National Government of the Twin Kingdom on Bougainville is now in the process of organizing a passport/visa system, to control outsiders traveling into Bougainville to invest in the U-Vistract high yield investment programs.

"Embassies and immigration offices will be set up in Port Moresby, Rabaul and Buka to process and issue visas to visitors", says the U-V Principal Director and King of the Papala Kingdom, HM King David Peii II.

The king urged investors especially from Paradise islands (PNG) to wait until the branches of the Royal International Bank of Meekamui are fully operational, from where they will be able to conduct their investments.

He said work is now progressing well to have the branches fully operational, as soon as their communication systems are installed.

U-Vistract is working towards installing a state-of-the-art broadband system to hook up all its branches, as they expand through-out the world.

"We are in the process of installing another Israeli made communication system for the time being, while waiting for the broadband", said the king.

Roadway Bougainville To Handle All Road Works

All road works and associated activities to be funded by the Twin Kingdoms of Papala and Meekamui, will be channeled through a 100% Bougainville owned company, Roadways Bougainville.

The company owned by Edwin Moses, son of former fiery president of the Bougainville Mining workers Union, is the 101 company to obtain registration under the Royal Kingdom of Papala's Office of the Registrar of Companies.

Royal Kingdom of Papala, Registrar of Companies, Mr.Gideon Taima confirmed this week that Roadway Bougainville was given registration by his office on the 10th of October.

In effect Mr Taima said Roadways Bougainville will be given first preference to bid for all major road



works contracts tendered by the Twin Kingdoms.

Upon wining such contracts the company can decide from time to time to sub contract part of the work to other companies it considers having the capabilities to handle such work.

One of the first major contracts

Roadways Bougainville is expected to handle is the planned extension to the current 800 meter long Tonu airstrip in south west Bougainville, for the RKP.

A contract to engage the company in the work is expected to be signed between officials of the two parties soon. *pc*



PROTECTING OUR FREEDOM

Welcome to King's Corner this week. Last week we looked at why our funds will NEVER run out! We saw from a number of angles that it is impossible for our funds to run out. Time being the best judge will definitely prove this to our scoffers.

Now that we have a universal system fully established and operational on the ground with already more than a thousand satisfied clients in less than three weeks let me just briefly discuss how we can keep our freedom intact. The Bible urges us "not to entangle ourselves again with the yoke of bondage" (Gal 5:1).

We have struggled for so many years to arrive where we are today. Since our colonial days Bougainville and Papua New Guinea have been under a certain international domineering power that influenced our mindsets and ways of thinking. They introduced us to a new international government, monetary and banking system and made us subject to their control and manipulation in the name of goods and services, etc. Of course the colonial era also brought us the "Good News of Jesus Christ" for which we must be thankful.

Further back into history thousands of years ago Adam of Eden in the northern tip of the African continent lived a very happy, fulfilling and satisfying life of abundance and overflowing surplus. He even had rulership over the fish of the sea, the birds of the air and the animals in/on the earth. However, one day his mindset changed from abundance and surplus to nakedness, lack and scarcity as a result of his disobedience to the Word of God. His children began competing and Cain murdered Abel., and so on.

Disobedience to God's Word is the only thing capable of causing us to miss our target. As long as we live a life of holiness and purity before our God we will continue to experience more than enough blessings upon our lives.

Let me remind us again that "Meekamui" in Nasioi language means "holiness" - holy ground/land, holy people, holy nation - that God is holy and I am holy". Therefore, since we are standing on holy ground we must always ensure to conduct our lives accordingly and refuse to do anything unholy, always giving praise and honour to our God. Secondly, "Papala" in original Siwai language refers to "God who is our origin or source of existence". It is one of the 14 names of God Almighty who appeared to our ancestors at Siwai in exactly the same way as He appeared to the children of Israel in Canaan. Today Papala also refers to a certain physical location on Bougainville/Siwai where our ancestors were said to have originally lived and where God came and provided them food, laws, principles, doctrines, music, etc. (Refer to my earlier columns of the chronicles).

Anyone with a discerning eye should already make out why "Meekamui" and "Papala" have been put together in such a unique and mysterious way. Our God cannot make mistakes for He is God who is Omniscient. He is the Master Architect, Designer and Coordinator of the universe. When I proclaimed independence/sovereignty of the Royal Kingdom of Papala on 21st April 2000 in Port Moresby, PNG, I did not know that God had already prepared a launching pad for what I was doing. All I knew was that Kingdom of Papala meant Kingdom of God in my original Later, as things turned lanauaae. out through the process, I realized that God had prepared the Meekamui
