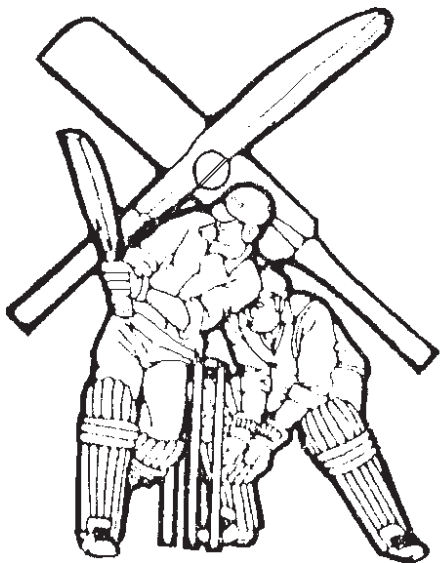

## WELCOME

As we begin the 2010 season of the Strathmore and Perthshire Cricket Union competitions, we must pause to reflect on the loss of several people who have graced the Union's grounds over the years. This edition of the handbook contains tributes to Mike Walton and Eck Daniel and I am grateful to the people who have supplied the moving tributes which appear elsewhere in the booklet. We also have the sad duty to report the death of Forthill stalwart T M Smith and of the former Norwood and Kirriemuir player, Ladson Hayes, whose sudden passing at the end of March robbed those of us who knew him of a much valued friend. The Union extends its sympathies to the families of all these men and to those of any other players whose passing has not been notified to us.

The Union continues to provide attractive and competitive cricket and this is reflected in the number of clubs who seek to join us. This year, we welcome Freuchie to our ranks for the first time. By entering a team in Division Three, the Fife village is hoping to find an outlet for the continued development of their youngsters by providing them with regular organised cricket of a decent standard. I am sure that they will find the experience both welcoming and worthwhile and trust that they will have an enjoyable beginning to their Union career.

From one new face to an old one - the return to the Union of Gordonians is a very welcome development. The Countesswells club were members from 1940 until 2000 winning the First Division in 1994 and the Three Counties Cup on four occasions. Indeed, they won the cup on their debut in 1939, before they were granted full membership. The committee then were obviously impressed enough to let them in to the fold for the following season. Having withdrawn after the 2002 season after two years amalgamated with Aberdeen Grammar, the club now feels ready to attempt to reclaim its place in the Union's top tier and will be striving hard to begin to achieve that goal during the coming season. It will not be an easy task for them and I'm sure that the level of competition in Division Two will be all the stronger for their entry.

I write this introduction as I embark on my second period as President of the Union, conscious of becoming the first person since the war to serve more than one term in office. Grateful as I am to the clubs for the

honour, I cannot help but be concerned that we are finding it a constant struggle to attract people to join the Management Committee or to serve as Office-bearers. One of the great strengths of the Union has been its policy of restricting the post of President to a single two-year term. By doing so, we have avoided the pitfall of many other organisations who have become moribund due to a lack of fresh blood and new ideas emanating from the top. While it is tempting to allow a few willing workers to soldier on year after year, rotating the chain of office around the table, it is not healthy for an organisation such as ours. At the last AGM, we were left without sufficient nominations to fill all the vacancies on the Management Committee and we have been obliged to co-opt Allan Baxter and William Ferguson to fill two current vacancies. What we really need is for some current players, particularly from the Premier Division Clubs, to put their names forward before the next AGM. Without an infusion of new, younger people, your Committee runs the risk of becoming out of touch with the needs of the current and future generation of players. The work of the Management Committee is not onerous but it can be rewarding in terms of the knowledge that you are making a contribution to the future of cricket in this area. Being on the Committee does not force you to become President in due course even though it sometimes looks that way. There is a place for people who just want to give the Union the benefit of their ideas and experiences. With 28 clubs in membership, there should be plenty of people who could make a difference. Please, think about giving up a few evenings a year to help us keep driving the Union forward.

I would like to thank our sponsors and advertisers for all the support they have given us over the years. In particular I would like to express our gratitude to Monitor as the sponsors of the Cup competitions and to Dukes for their eighteen seasons of sponsorship of the League. Without their contributions, the Union would be a very different and poorer organisation. I also pay tribute to David Bridges for all his work as Secretary and to the Committee members for their efforts.

Finally, this booklet would not appear without the efforts of Ian Chisholm who for the last 35 years has been compiling the Union's statistics. The volume and the quality of his work is amazing and we are very lucky indeed to enjoy his services.

Strathmore and Perthshire Cricket Union  
(Instituted 1929)

- 1.1 The Union shall be called “The Dukes Strathmore and Perthshire Cricket Union”, an amalgamation in 2003 of the Strathmore Cricket Union, Instituted 1929, and the Perthshire Cricket League, Instituted 1963.
- 1.2 The Union shall consist of two or more Divisions as approved by a General Meeting of the Union. The minimum number of teams in the top Division shall be eight and the maximum number of teams in the top Division shall be twelve. No two teams from the same club shall compete in the same Division with the exception of the lowest Division.
- 1.3 The Committee shall be vested with full powers to vary the titles of each Division at the commencement of each season.
- 2.1 All affairs and management of the Union shall be in the hands of a Management Committee, the members of which shall be elected at the Annual General Meeting. The Committee shall comprise a President, a Vice-President, a Secretary, a Treasurer (the latter two offices may be co-joined) and five other members, all being from clubs in full membership of the Union. The retiring President shall continue as an ex-officio member of the Committee for one year after his term of office expires. The Committee shall have, in addition to their general powers, the power to fill any vacancy in their numbers during the year and, additionally, the power to co-opt up to two additional members to assist with specific projects.
- 2.2 The Committee shall be vested with full powers to conduct all competitions under the auspices of the Union and to regulate the choosing of teams for all representative matches played by the Union. The members of the Committee shall be entitled to vote at all General Meetings.
- 3.1 Any club desirous of entering a team to the Union must make application in writing to the Secretary on or before 1st October. Such application will be considered at the next Annual General

Meeting and will be approved only with the consent of two-thirds of the members represented and voting. Any club withdrawing from the Union should intimate withdrawal to the Secretary in writing on or before 1st October.

- 3.2 Any team from the North of Scotland to be relegated from the lowest Division of the Scottish National Cricket League shall be admitted, if it so wishes, to the top Division of the Union.
- 3.3 At the end of each season, the winners of the Premier Division shall participate in a play-off competition for admission to the lowest division of the Scottish National Cricket League, provided always that it is able to conform to the Rules of the SNCL.
4. The Subscription from each club in each Division shall be such a sum as may be fixed at the Annual General Meeting. Subscriptions shall be payable at the Annual General Meeting.
5. A General Meeting of the Union shall be held annually in the month of November. Notice of General Meeting shall be given to each club in membership at least 21 days before the date of the meeting. The Secretary shall call a Special General Meeting on the instructions of the Committee or upon receipt of a requisition to do so, signed by any five clubs in full membership of the Union. Such requisitions must state the reasons for calling a Special General Meeting and the subject or subjects to be discussed.
6. Each club shall be entitled to send two voting representatives to a General Meeting. A quorum shall be 50 per cent of all clubs in the Union.
7. At the Annual General Meeting the Union may appoint Honorary Presidents and Honorary Vice-Presidents who shall be entitled to attend all General Meetings of the Union.
8. A financial statement of income and expenditure, duly certified, shall be presented at the Annual General meeting. A copy of the financial statement shall be circulated to all clubs at least 21 days before the date of the Annual General Meeting.



9. Matches shall be played under MCC Laws of Cricket and under such rules and regulations as (may be) approved by the Annual General Meeting of the Union. The ball used in all League matches shall be a ball approved by the Committee.
- 10.1 League placings will be determined by expressing the points awarded as a percentage of the results points for a win in all completed matches. In the event that more than one team shall have an equal percentage at the end of the season, the team which has the greater ratio of matches won to matches played shall be placed above the other teams. In the event that this does not separate the sides, the points gained in the matches between the sides will determine the final placings.
- 10.2 The leading team in the league table shall be the winner of the championship and shall retain possession of the Championship Trophy for one year. All trophies shall be returned to the Secretary of the Union not later than **1st September**.
- 10.3 The team finishing first in Division One will be promoted to the Division above, subject always to the provisions of Rule 1.2 being met. The teams finishing second in Division One and first and second in Divisions Two and Three shall have the right to be promoted to the Division above if they so wish, subject always to the provisions of Rule 1.2 being met.
- 10.4 Relegation from, and further promotion to each Division shall be decided by the Committee at the conclusion of each season subject always to the provisions of Rule 1.2 being met.
- 11 All players should be bona fide members of the clubs they represent. No player may play in a Union match for more than one team, in the same Division, during any one season unless with the consent of the Committee. However, junior players (aged 16 and under) may be allowed to play for more than one club, even in the same division, provided both clubs are in agreement.
- 12.1 No team may play more than one 'paid player' and one 'overseas amateur', as defined below, in any S&PCU league or cup match.

- (a) A 'paid player' shall be, for the purposes of these rules, a player who receives any of the following as a fee for playing, or as an inducement to play, or to facilitate their playing cricket for the team concerned:
- (i) payment in cash or in kind;
  - (ii) accommodation whether free, subsidised, or otherwise assisted;
  - (iii) employment whether full-time or part-time;
  - (iv) payment, in whole or in part, of fares to the United Kingdom from that player's place of abode.

For the purposes of these rules:

- (i) the payment of reasonable travelling expenses is permitted without any player being deemed a 'paid player'.
  - (ii) a physical education teacher or a coach whose work is solely educational and who is not paid directly or indirectly for playing cricket for a member team is not a 'paid player'.
- (b) No player, other than a Scottish player as defined in Appendix 1, may play as an amateur for a team of any club in any division of the S&PCU if he has been a paid player at any time in the three calendar years preceding that year, other than with the permission of the Committee obtained prior to such player participating in any league or cup match. Permission shall only be granted in special circumstances. No player who has been registered as a paid player may qualify for amateur status within the same season.
- (c) For the purposes of these rules, a person shall be deemed to be an Overseas Amateur in any season unless he has been resident in the European Economic Area (EEA) for 183 days immediately prior to the match in which he intends to play (except a local player normally resident in Scotland who has spent the winter months overseas). In addition, an overseas player shall be deemed not to be an amateur player if:
- (i) he has played first-class cricket in the last two years and has featured as a first-class cricketer in any of the last two published ACS Cricket Year books, or
  - (ii) he will attain the age of 23 years on or before the 31<sup>st</sup> August of the said season.

Consideration may be given by the Committee to waive this rule in suitable cases where the player has moved to Scotland through work or study. [Please refer to Appendix 2 for further guidance]

### **Appendix 1** (Scottish Player – eligible to play for Scotland)

A Scottish player must meet **one** of the following eligibility criteria:

- (a) Born in Scotland;
- (b) Resident in Scotland for at least 183 days in each of the previous four years;

### **Appendix 2** (Overseas Amateur Guidelines)

1. Each club shall be allowed one overseas amateur (non-UK/EEA) player per team.
2. An overseas amateur must not have previously appeared as a first-class cricketer or featured in any of the last two published ACS year books.
3. Eligible overseas amateurs must be under the age of 23 years on the 31<sup>st</sup> August of the forthcoming season.
4. All overseas amateurs must be registered by the club with the S&PCU before participating in any competitive fixtures.
5. Clubs must only play the overseas amateur once permission is obtained.
6. Permitted assistance by clubs:-
  - (a) Clubs may help an overseas amateur by providing accommodation with a bona-fide club member. The club may also help in identifying suitable rented accommodation. The club shall not contribute financially to either of the above.
  - (b) Clubs shall not provide financial assistance towards air fares.
  - (c) Clubs may help in obtaining part-time or full-time employment for an overseas amateur within the local community. Work directly relating to the cricket club or paid by the cricket club shall not be permitted.
7. Clubs may apply to the league to register more than one overseas amateur but this will only be granted in exceptional

- circumstances relating to work and study. A minimum of 120 days residence in Scotland prior to application will be required.
8. Any overseas player who qualifies as a local player under Rule 12.1(b) will be deemed once again to be an overseas player unless he remains resident within the EEA for at least 10 calendar months during the period of one year ending on the date fixed by the Committee as the date of the first Premier Division league match of the season.
  9. Failure to comply with the above guidelines will result in disciplinary procedures as laid down in Rule 17.
- 12.2 A registered professional or overseas amateur who would normally play in a higher division of the Union or in the SNCL or equivalent league, is **NOT PERMITTED** to play for a lower ranked team.
13. Detailed results of each match shall be communicated in writing by the home club to the Union Statistician, or his named deputy, not more than 14 days after the match date. The home club is also responsible for telephoning the result to the Union within 48 hours of the completion of the match. Failure to properly report a match as detailed will result in the deduction of Five Points from the club's league total.
  14. In event of any dispute, protest or the like, the decision of the Committee shall be final. Protest must be communicated to the Secretary of the Union in writing and must be accompanied by a deposit of £20 (Twenty Pounds Sterling) which shall be retained according to the finding of the Committee. Protest relating to matches must be intimated in writing to the Secretary of the Union within seven days of the match.
  15. Union fixtures shall be arranged each year for the top two divisions following publication of the SNCL fixtures. In divisions where the fixtures are not arranged by the Union, each team **must** arrange home and away fixtures against **all** other teams in the division. Fixtures not arranged by the Union should be arranged by teams competing in that division and forwarded to the secretary before February 1<sup>st</sup>. Rearrangement of fixtures after that date should be intimated to the Secretary of the Union in writing by the clubs involved. Dates on which Union representative

matches are to be played should be avoided by clubs for Union fixtures. All Premier Division fixtures must be completed on or before the published date of the last set of Premier Division fixtures. All league fixtures in the other divisions must be completed on or before the 19<sup>th</sup> September in any year

16. Where any fixture is postponed due to the involvement of either club in a Cricket Scotland Senior Competition or the finals day of a Scottish Junior Competition, the clubs involved may rearrange the fixture. If no suitable date can be agreed, the match will be null and void.
17. Any breach of Rules 4, 9, 11, 12, 13 or 15 will be adjudicated on by the Committee and may result in a points deduction or the match(es) being awarded to the non-offending club.
18. No rule or regulation contained in this Constitution and Rules shall be altered, rescinded or added to except at an Annual General Meeting and then, only with the consent of two-thirds of the members represented and voting. Any such proposed alterations or additions must be lodged in writing with the Secretary of the Union not later than **1st October**.
19. The Strathmore and Perthshire Union will adopt a flexible approach to its league structure.
20. The Rules and Regulations of the Union shall be displayed in a prominent position in each club's pavilion.
21. This revised Constitution and Rules supersedes the Constitution and Rules published in October 1952 and all amendments since that date.

## YOUNG CRICKETERS

Clubs are reminded that all teams must comply with the safety guidelines issued by Cricket Scotland in respect of the wearing of helmets and fielding restrictions by young players. The fast bowling directives in respect of players who are Under 19 must also be observed in all Union matches. These are given on Page 16.

Any club which does not have a copy of the latest regulations should contact Cricket Scotland immediately.

## CONDITIONS OF PLAY

### PREMIER DIVISION

**DURATION OF MATCH** - Each match shall be on the basis of 90 overs unless completed earlier. Each team will bat for a maximum of 45 overs. Any match which is uncompleted shall be null and void. The side batting first may declare its innings at any time but the side batting second will not receive the unused balance of their overs.

**START OF PLAY** - All matches shall be scheduled to commence at 1pm and shall be completed on the day of commencement. If play is not possible by 3.00pm due to inclement weather, the match will not take place. Where play starts before 2.00pm, the match shall be the full 90 overs duration. Where play starts between 2.01pm and 2.30pm, the match shall be reduced to 80 overs with bowlers limited to 9 overs each. If play begins between 2.31pm and 3.00pm, the match will be reduced to 70 overs and bowlers limited to 8 overs each. If play is not in progress due to inclement weather at 8.30pm, no further play shall take place in the match.

### FIELDING RESTRICTIONS

1. For the first 15 overs of an innings, a maximum of 2 fieldsmen, and thereafter 5, can be placed outside an area bounded by 2 semicircles centred on each middle stump (each with a radius of 30 yards) and joined by a parallel line on each side of the pitch. It is recommended that the area is marked by painted white dots 5 yards apart covered by circular white plastic or rubber discs 7 inches in diameter.
2. There shall be no more than 5 fieldsmen on the leg side at any time in an innings.

**POINTS** - Points, known as 'Result Points' and Bonus Points, shall be awarded as follows:

## RESULT POINTS

Win	25 Points
Tie	5 Points

## BONUS POINTS

1 batting point for every 25 runs in excess of 75 runs, up to a maximum of 7 batting points.

1 bowling point at the fall of the 1st, 3rd, 5th, 7th and 9th wicket with an additional 2 points for taking the 10th wicket.

No bonus points shall be awarded to the team which wins the match.

**BOWLING RESTRICTIONS** - No bowler may bowl more than 9 overs in any one match.

## DIVISIONS ONE & TWO

**DURATION OF MATCH** - Each match shall be on the basis of 90 overs unless completed earlier. Each team will bat for a maximum of 45 overs. Any match which is uncompleted shall be null and void. The side batting first may declare its innings at any time but the side batting second will not receive the unused balance of their overs.

**START OF PLAY** - All matches shall be scheduled to commence at 1pm and shall be completed on the day of commencement. If play is not possible by 3.00pm due to inclement weather, the match will not take place. Where play starts before 2.00pm, the match shall be the full 90 overs duration. Where play starts between 2.01pm and 2.30pm, the match shall be reduced to 80 overs with bowlers limited to 9 overs each. If play begins between 2.31pm and 3.00pm, the match will be reduced to 70 overs and bowlers limited to 8 overs each. If play is not in progress due to inclement weather at 8.30pm, no further play shall take place in the match.

No bonus points shall be awarded to the team which wins the match.

**BOWLING RESTRICTIONS** - No bowler may bowl more than 9 overs in any one match.

## **DIVISION THREE**

**DURATION OF MATCH** - Each match shall be on the basis of 80 overs unless completed earlier. Each team will bat for a maximum of 40 overs. Any match which is uncompleted shall be null and void. The side batting first may declare its innings at any time but the side batting second will not receive the unused balance of their overs.

**START OF PLAY** - All matches shall be scheduled to commence at 1pm and shall be completed on the day of commencement. If play is not possible by 2.30pm due to inclement weather, the match will not take place. If play is not in progress due to inclement weather at 8.30pm, no further play shall take place in the match.



**POINTS** - Points, known as 'Result Points' and Bonus Points, shall be awarded as follows:

## **RESULT POINTS**

Win	25 Points
Tie	5 Points

## **BONUS POINTS**

1 batting point for every 25 runs in excess of 25 runs, up to a maximum of 7 batting points.

1 bowling point at the fall of the 1st, 3rd, 5th, 7th and 9th wicket with an additional 2 points for taking the 10th wicket.

**BOWLING RESTRICTIONS** - No bowler may bowl more than 9 overs in any one match.

## **COMMON CONDITIONS**

### **UMPIRES**

1. The Union may appoint an umpire or umpires to officiate at any match it deems appropriate. No team may object to a Union-appointed umpire officiating at any match.
2. Where only one Union umpire is appointed for a match, he may officiate continuously from the bowler's end or, at his sole discretion, alternate between the bowler's end and the striker's end with a second umpire, but only if that second umpire is available to umpire the **whole match**.
3. Where one side provides a non-playing umpire, who has not been appointed by the Union to officiate in that game, and he is the only umpire, he shall alternate with a player umpire between the bowler's end and the striker's end, unless both captains agree to him officiating continuously from the bowler's end.

4. Where a team offers to provide **TWO** non-playing umpires, the agreement of the opposing captain is required.
5. When umpiring duties are undertaken by participating players, their alternating between the bowler's end and the striker's end shall be at the discretion of the batting team's captain.
6. Where the two captains have agreed an umpiring format for a match, it shall pertain for the whole of the match unless exceptional circumstances create the need for unavoidable change.

**WICKET COVERS** - Clubs with wicket covers will be allowed to use them in the event of bad weather intervening during the course of play.

**DATE OF MATCHES** - All Union Premier Division matches shall take place on the dates set by the Management Committee unless with the prior consent of the Management Committee.

**ARTIFICIAL WICKETS** - Where a match is to be played on an artificial wicket, all players shall wear non-spiked footwear.

**OVER RATES** - The Union Management Committee requests that all clubs attempt to maintain an over rate of 18 overs per hour.

# Allan Daniel

Cricketers throughout the Union will have been saddened to learn of the death of one of Brechin's most colourful characters. Allan Daniel passed away in February aged 45. Allan's funeral took place at St Andrew's Church in the city and not surprisingly there were many past and present members of Brechin Cricket Club in attendance to pay their last respects. Allan's mother Grace told "The Brechiner" that Allan had requested that the wake after his funeral be held in the Brechin Cricket Club Social club and that a collection at the funeral would see the proceeds going to the continued support of youth cricket at Guthrie Park, something Allan was a huge fan of.

Just after his passing, Grace said: "The past week has been very difficult for everyone who was close to Allan and he made many friends over the years, especially in the cricket world. It's something I didn't know anything about, but it was also something that gave him an awful lot of enjoyment for as long as he was able to play. His love of the game increased when we moved into Guthrie Park and from the age of about ten or eleven, his loves were football in winter and cricket in the summer. He won numerous trophies with Brechin and played the game for as long as he possibly could."

Allan had spells as captain of both the club's Under-18 sides and the BCC 2nd XI and he picked up numerous amounts of silverware, largely for his efforts as a bowler. After he was forced to retire from the game through injury, he also spent time coaching the club's younger members at under-13, under-15 and Under-18 level. Allan, or "Eck" to his friends, started his working life as a slater upon leaving Brechin High School at 16. He initially worked with local firm Winks and subsequently with William Duthie. However, a fall off a roof with his first employer was to curtail his working life. Grace continued: "Allan was always very accident prone, even as a kid and when he suffered the fall off the roof, he severely injured his back and was never quite the same after that. Not being able to work full-time really had a bad effect on him, although he was always cheery and light-hearted when he was around his friends and family. His disability had an affect on him, no doubt about it. He

hated not being able to work on a full-time basis. However, after he stopped the cricket he continued with his other loves of pool and darts and watching football, rather than playing it.”

Gordon Morton, a team-mate of Allan's at BCC in both first and second elevens added: “This is very sad news and will be a real downer for everyone who had the opportunity to play alongside Eck. He was the sort of individual whom everyone wanted in their team, bringing a great will and desire to win every game. I remember as his skipper when he was a young lad he was sitting very quietly in the changing room at Guthrie Park, probably a bit nervous. I went over to him and introduced myself and I'll never forget the answer. He said ‘My name is Allan, but you can call me Eck!’ He was a great bowler. However I also recall a game against RAF Leuchars. he came in to bat with me and said to me, ‘Gordon, I am just going to pat the first one back to the bowler’. The bowler ran up and promptly had the ball smashed back over his head for six. That was “Ecky”, never predictable. A lovely lad, who people probably didn't know as well as we did at the Cricket club and he will be sadly missed by all of us.”

Alan is survived by his mother Grace, stepfather Alan, father Dennis, brother Billy and son Glen.

I played both with and against Eck for the best part of 20 years, firstly as an opponent and then for five years as a team-mate at Brechin. As a bowler, he was always tough to face as he could move the ball late and he certainly claimed my scalp on many occasions. As a team-mate, he was an ideal companion when things were tough as he never knew the meaning of the word surrender.

We had a great respect for Eck at Lawside although we did doubt his ability as a judge of cricketing talent when he declared Deek McDonough to be a great batsman who could hook, pull and drive. There was a suspicion that his eyesight, which was never great, might have been even less sharp than usual when he arrived at that opinion! What couldn't be denied was his enthusiasm and spirit - we enjoyed many rare battles at Guthrie Park and at the Park at Lochee. If anyone could have been an honorary Son of The Desert, Eck would have been top of the list. He will be sadly missed by all of us.

One hundred years old in 2008, Freuchie Cricket Club has always been a typical village cricket club, a real focal point in the life of our village. We are unashamedly proud of our achievements in recent years, whether on the pitch, in the community or through our youth development programme.

Our history is well charted in local historian Adrian Grant's excellent book "90 Not Out," published in 1998 to commemorate our ninetieth anniversary, with a particularly good account of our progress to triumph in the Village Cup final at Lord's in 1985. We are fortunate in having all the club's minute books dating back to 1908, together with many old photographs and other records; we are presently working on a DVD which we hope will complement Adrian's book, covering the last ten years and having a bit more to say about activities on and off the field, and, if we can do it, video clips and interviews with notable members.

We are particularly proud of our 'home-grown' players, two of them in the Scotland team in the 1990s, another a professional cricketer in England, yet others playing at various representative levels. Almost as important, we are blessed with the efforts of past players and present supporters, giving us one of the best clubhouses in Scotland, an award-winning groundsman and a park frequently chosen for junior internationals and 'neutral ground' matches.

We are enthusiastic supporters of what Cricket Scotland terms "whole club development" – that cricket is a year-round activity, not just something for the summer months, with a real focus on youth development. Most sports clubs lose a proportion of their promising players as they reach mid to late teens, and we are no exception. However, we recognise that those who develop into adult players are most often those whose parents are involved with the club in one capacity or another. We work hard to make it a place for families - all the year round. We want to have these young players coming through, but also to hold on to the award-winning groundsmen of the future.

## MICHAEL J. S. WALTON

1944 – 2009

It was with great sadness to his family and friends that Mike Walton passed away on 23<sup>rd</sup> August 2009. Mike played cricket for Forfarshire prior to coming and playing for Meigle Cricket Club in the early 1970's.



One of the best all round cricketers that ever played for Meigle CC and also within the Strathmore Union, Mike won many trophies with Meigle Cricket Club. An aggressive left-handed batsman and a quickish right-hand bowler, his greatest achievement was to win both the Strathmore Union batting and bowling averages in 1979, a feat previously done in 1935 by Willie Eddie of Brechin and only achieved once since, in 1982 by Jerry Moir of Aberdeen Grammar FPs. Both these men gained international honours for Scotland, something a player of Mike's talent might easily have emulated.

Mike's achievements in 1979 were outstanding; he scored 531 runs at an average of 59.00 per innings and took 46 wickets at an average of 7.20 each. This achievement was down to his natural ability as both batsman and bowler to out-think other players through the use of good eye and hand co ordination. Mike also had the great ability to read a game and be able always to be one step ahead of the opposition.

More than just a cricket player Mike had a natural talent for the game and was a charismatic individual who was very widely known and respected within and out with cricket circles throughout the country.

If you compare this table with the similar one for the old First Division between 1929 and 1998 which appears on Pages 48 and 49, you can see the impact of promotion and relegation which was introduced for the 1999 season. John Muckersie of Aberdeenshire would have been gratified to have seen that the scheme he worked hard to promote had produced the fluidity which he hoped to achieve.

In the first seventy years of its existence, the Union's top division was graced by a total of eighteen clubs, of whom no fewer than ten played in the Division every season from 1947 to 1998. In the eleven years since the opening up of the league structure, again, eighteen clubs have participated in the top division but only two, Huntly and Meigle, have been in the top flight in every year.

Of the six founder members of the Union from 1929, Meigle alone has retained its position in the top tier for the whole of the Union's existence.

## Rules of the mpower Cup and mpower Trophy

- 1 Ties should be played by the dates indicated on the respective draws with prompt starts before 6.30 pm required. A **Reserve Date** shall be agreed upon at the time of arranging the fixture. Dates and results of matches should be notified to the Cup Organiser as early as possible, preferably by phone. Scores and full team lists must be sent to Ian Chisholm.
- 2 Except for the Finals and the **mpower** Cup Semi-Finals, each match will be umpired by players from the clubs nominated in the official draw.
- 3 Ties should be played on the ground of the first-named club. The Finals will be played at venues arranged by the Management Committee.
- 4 The innings of each side shall consist of not more than 20 overs and no bowler shall bowl more than 4 overs. Standard Union balls must be used.
- 5 Bowler's run-ups shall not exceed 15 yards. A white line shall be marked on the ground 15 yards behind the bowling crease.
- 6 At the instant of delivery a minimum of 4 fieldsmen (plus the bowler and wicket-keeper) must be within an area bounded by two semi-circles of radius 30 yards, centred on each middle stump and joined by a parallel line on each side of the pitch. In the event of an infringement, the square leg Umpire shall call and signal "NO BALL". It is recommended that the area be marked by painted white dots, 5 yards apart, covered by circular white plastic or rubber discs 7 inches in diameter. **N.B. APPLIES TO mpower CUP ONLY**
- 7 Except the registered professional, any player who has appeared for a SNCL side in more than 50% of that club's Championship matches already played during the current season shall be ineligible to play in the **mpower** Cup.
- 8 Any player who has appeared in more than one SNCL match or in more than 50% of the league matches already played of a team participating in the **mpower** Cup during the current season shall be ineligible to play in the **mpower** Trophy.
- 9 All players in Cup Competitions must be bona-fide members of that club and representing that club within the Strathmore Union.
- 10 Under exceptional circumstances, a player ineligible under notes 7, 8 and 9 above may be given dispensation for a particular match on appeal to the Cup Sub-Committee or with the agreement of both captains.
- 11 If, at the completion of the match, the scores are tied, the winner shall be the side which has lost the least wickets. If this does not produce a winner, the scores at the end of each preceding even-numbered over (starting at 18) shall be compared until a winner be found.
