Indiana Debate Commission Announces Schedule for U.S. Senate Debates Three Venues Selected in Indianapolis, Fort Wayne and Vincennes

INDIANAPOLIS—The U.S. Senate candidates have agreed to participate in three televised debates in Indianapolis, Fort Wayne and Vincennes, which will be broadcast live through the Indiana Debate Commission's television partners.

The candidates are Republican Dan Coats, Democrat Brad Ellsworth, and Libertarian Rebecca Sink-Burris.
