Why are adults reading children's fiction? This book delves into the heart of the controversy over 'crossover fiction,' the fiction that crossed from children to adult readers over the millennial decade, and continues to do so today. I argue that crossreading cannot be explained by the increase of sophisticated marketing alone; on the contrary, we must look to broader changes in the social fabric to understand the phenomenon more fully. Crossover fiction may be understood as an extension of 'kiddultery,' the celebration of youth culture in a society which places a premium on speed, flexibility and rapid capital turnover. In other respects, though, it can be understood as capitalism's antithesis: the expression of a desire for roots, for more stable and communally shared verities, as this study demonstrates. Beginning with a broad overview of crossover fiction and cross-reading in the UK, this study goes on to analyse texts by leading British crossover authors, including Rowling, Pullman, Haddon, Almond and McCaughrean. I also consider the contexts of publication, presentation of paratexts to dual-aged audiences, and reader response, A final chapter discusses the rise in publication of re-edited classic children's literature, and analyses the dynamics of childhood reading with a particular focus on C.S. Lewis.

This book explores the idea that modern, Western secular cultures have retained a belief in the concept of Hell as an event or experience of endless or unjust suffering. In the contemporary period, the descent to Hell has come to represent the means of recovering, or discovering selfhood. These ideas have combined with earlier literary and religious models of katabatic narrative to produce the notion of a self made ethical by its encounter with the underworld. In exploring these ideas, this book discusses descent journeys in Holocaust testimony and fiction, memoirs of mental illness, and feminist, postmodern and post-colonial narratives written after 1945. A wide range of texts are discussed, including writing by Primo Levi, W.G. Sebald, Sarah Kofman, Anne Michaels, Lauren Slater, Marge Piercy, Angela Carter, Margaret

Atwood, Gloria Naylor, Alice Notley, Alasdair Gray, and Salman Rushdie. Drawing on theoretical writing by Bakhtin, Derrida, Charles Taylor, David Harvey and Paul Ricoeur, the book addresses such broader theoretical issues as: narration and identity; the ethics of the subject; trauma and memory; descent as sexual or political dissent; the interrelation of realism and fantasy; and Occidentalism and Orientalism. ### 3.4 UNDERGRADUATE TEACHING INNOVATION

In Feb-June 2002, I designed and developed a project called 'Kiddult Fiction', which aimed to explore the phenomenon of children's fiction being adopted by adult readers. This project involved 34 Sheffield English students working together with 50 local pupils, their teachers, and the University's Learning Development and Media Unit. Weekly workshops with the children were designed and run by students. A dedicated open web-site and WebCT site were developed for the module, the former having an open discussion board to which children from local and London schools contributed. The final workshop consisted of a video conference between University students, local children, and children from a school in Etobicoke, Ontario. <a href="http://www.shef.ac.uk/english/modules/lit210/kiddult/index.html">http://www.shef.ac.uk/english/modules/lit210/kiddult/index.html</a>

Kiddult Fiction was one of two projects in the School of English awarded a competitive Learning and Teaching Development (LDMU) grant. The total grant value was £3,334 plus the resources of the LDMU (to create the open web-site and educational video, and to formally evaluate the project). In 2002, the project was showcased on the University's LDMU web-site as an example of excellence and innovation in teaching and technology. This experimental project has now been incorporated into the regular English Literature curriculum as second year, elective module, 'Crossover Literature'; there has never been a semester when it was not

over-subscribed. Over the past five years, students have worked with pupils drawn from a range of schools across Sheffield; their projects have been described as the 'star event' of the University's Widening Participation activities.

Responsible for: overseeing the direction and development of the English Literature BA Programme, setting the agenda and chairing the bi-annual English Literature Programme Meetings; chairing the annual Course Review in September; problem-solving issues affecting the BA Programme, for example, implications of changing to a third year double-weighted assessment system; compiling results and reporting to the Department on student evaluations of the BA programme, and providing feedback to students; introducing Open Days.

As Programme Director, I have taken the lead in securing fair contracts and ensuring there is excellent teaching training for post-graduate and part-time tutors in the Department of English Literature. I designed the Teaching Practice module to provide in-house, practice-based teacher-training for postgraduate tutors. Recently, I

secured contractual rights for part-time tutors to be given 'honorary status,' entitling them to discounted use of University facilities, as well as full access to research and teaching materials.

## • Staff Editor, Route 57

The School of English hosts a creative writing e-journal, *Route 57*, which invites submissions from English students in five areas: poetry, fiction, experimental writing, non-fiction and radio drama. # • Convenor of Contemporary Literature, Level 3 core undergraduate module.

As Convenor of this core module, I select the contemporary texts (from 1945 to the present) that are studied by the majority of undergraduates at the School of English. I design and co-ordinate the lecture series and assessment methods, as well as overseeing the management of seminar groups, which are taught by a team of c. ten individual tutors.

# • Member of School of English Executive Committee

As member of this committee, I help the Head of School to decide on major issues governing the running of the School, such as drawing up academic plans for the department, finding equitable models for work-load distribution, and preparing material for external assessment (such as RAE 2008).

## • Member of School of English Teaching Committee

One issue that I am currently pursuing here is the decline of standards in written English (grammar, punctuation). I am in dialogue with the English Language Teaching Centre and the Centre for Inquiry-Based Learning, to find ways of counteracting this trend. My aim is to develop a grammar project with a small team of undergraduates, the results of which would be available on-line to all students with writing difficulties across the University.

As a member of Faculty Board, together with two other colleagues, I represent the School of English at the Faculty level, and raise issues (such as part-time tutors' rights) that pertain to Schools of Arts across the University.
