RESOLUTION INTRODUCING A LOCAL LAW AMENDING PROVISIONS RELATING TO SHADE TREE REGULATIONS IN THE VILLAGE OF NEW PALTZ

Mayor Nyquist opened the public hearing at 7:30pm.

Mayor Nyquist explained that the significant change to the law is that it shall be unlawful for anyone (Village included) to cut, top or remove any tree in the space or area measured 15 feet from the edge of the curb or road pavement. He further stated that the Shade Tree Commission will hold the authority to determine approval for tree removal requests. Building Inspector Murray pointed out that the Village will be responsible to maintain and remove trees where the trunk is located between an existing sidewalk and curb or within 4 feet of the paved portion of the roadway. A motion was made by Trustee Feldman, seconded by Trustee Elwell, to close the public hearing at 7:47pm.

Ayes 5 Motion approved.

A motion was made by Trustee Feldman, seconded by Trustee Elwell, to introduce a resolution approving a local law amending provisions relating to the Shade Tree Commission in the Village of New Paltz with the following corrections:

RESOLUTION APPROVING A LOCAL LAW AMENDING PROVISIONS RELATING TO THE SHADE TREE COMMISSION IN THE VILLAGE OF NEW PALTZ

Resolution introduced by Trustee Feldman and seconded by Trustee Elwell

WHEREAS, there was introduced to the Board of Trustees of the Village of New Paltz, on January 9, 2002, a proposed local law to amend certain provisions of Chapter 7 of the Municipal Code to clarify the responsibility for the maintenance of trees on what may be considered public property and for enforcement of provisions of the Chapter; and

WHEREAS, a public hearing of the adoption of the local law was conducted at the Village Hall on January 23, 2002, at which time all persons interested were given the opportunity to be heard; and

NOW, THEREFORE, be it

RESOLVED, that the proposed local law to amend provisions of §7.23, 7.24(b) and 7.25 of Chapter 7 of the Municipal Code, in accordance with the text of the local law annexed hereto, is hereby approved.

COMMENTS FROM THE PUBLIC

Debbie Kwiatoski presented the Board with an initial draft on revised Revolving Loan guidelines for their review. She will provide the Board with the original guidelines for comparison.

ADOPTION OF MINUTES

A motion was made by Mayor Nyquist, seconded by Trustee Elwell, to adopt the minutes of 1/9/02 as amended and 1/18/02 as written. Ayes 5 Motion adopted.

COMMITTEE REPORTS

Housing – Mayor Nyquist reported that according to a study by the Ulster County Planning Board on rental housing, 72.2% of Village of New Paltz homes are rentals. Also, the New Paltz rents fall within the top three of highest rents charged. Trustee Feldman reported that changes were made in the translation of Jon Simonson's proposed housing code changes when the local law was written. Mayor Nyquist suggested a meeting with himself, Trustee Feldman, Alison Murray, Suzanne Salend and Attorney Zand to resolve the interpretation issues prior to the public hearing on 2/13/02. Trustee Elwell reported concerns over the exemption from requirements for additional lot size in the zoning/density law for existing single family homes. She suggested the Board consider repealing the exemption. She also reported that Suzanne Salend will continue to investigate ways to regulate rooming houses.

Police – Mayor Nyquist reported that the chief was contacted about five unused police vehicles taking up valuable parking space in the lot.

NYCOM – Mayor Nyquist reported that he received correspondence from Ed Farrell at NYCOM stating that revenue sharing will not be cut.

Flags – Mayor Nyquist reported that a police report was filed when one of the flags was found in the Peace Park written on, slashed and burned.

Post Office – Mayor Nyquist reported that the New Paltz Post Office has stopped afternoon (3:00PM) mail pick-up. Board members have received letters from residents objecting to the change.

Computer – Trustee Cotton reported that the installation date at Village Hall for Road Runner will be on Monday 1/28/02. He also reported that DSL is not available to Village Hall yet.

Safety – Trustee Cotton reported that he is still investigating the alternate side of the street parking issue. He did admit that Ridge and Lincoln were empty on Martin Luther King Day.

Rescue Squad – Trustee Feldman reported that that he met with Supervisor Wilen and Councilman Ruelke from the Town to discuss the Rescue Squad issue. He reported that the Town has signed a contract extending the current contract to 5/31/02. Discussions will continue.

Planning Board – Trustee Elwell reported that the zoning commission established with regard to Mulberry Square recommends an R-3 zoning. Trustee Elwell to fax resolution to Attorney Zand.

Rail Trail – Trustee Elwell suggested that a rail trail committee member attend the next meeting to discuss encroachments.

Open Space – Trustee Elwell reported that RFP's have been solicited for the grant received at the Town.

Shade Tree – Trustee Elwell reported that she met with Kathy Feldman, Leonard Loza, Building Inspector Murray and Central Hudson regarding the damage Central Hudson did to Village trees during the last trimming cycle. She will send a follow-up letter to Central Hudson and the Public Service Commission.

Water/Sewer – Trustee Hebel reported that the Alpha GeoScience presentation has been postponed. He also reported that a sewer back-up on South Chestnut may require further investigation.

Executive Session

A motion was made by Trustee Feldman, seconded by Trustee Elwell, to go into executive session to discuss personnel issues regarding the Department of Public Works at 9:12pm. Ayes 5 Motion approved.

RESOLVED, that the said lands shall be annexed to and constitute a part of the Village of New Paltz as of the 1st day of February, 2002.
