WHEREAS William Ridley and Dolores Hinton Spaulding have resided in Ward Five for forty-five years as parents of three daughters, Deirdre, Michele and Angelyn and two grandchildren Felicia and Brian;

WHEREAS, William Ridley and Dolores Hinton Spaulding married after meeting at Howard University where he was an instructor in the School of Engineering and Architecture and she a music education major;

WHEREAS, William Ridley Spaulding served for three terms on the Council of the District of Columbia for Ward Five and authored the legislation establishing the University of the District of Columbia as the nation's only urban land grant institution, with its mandate to develop the "human capital" of our nation's urban areas;

WHEREAS, Dolores Hinton Spaulding served as a member of the District of Columbia Board of Library Trustees from 1979 to 1988;

WHEREAS, William Ridley Spaulding worked for the National Security Agency and taught evenings and weekends at Howard University and also the D.C. Public School system's veteran's program at Phelps, Bell and Armstrong High Schools, while he coached school basketball and baseball teams, and Dolores Hinton Spaulding taught in the Prince Georges County Public School system;

WHEREAS, William Ridley and Dolores Hinton Spaulding launched many community and school-based projects and in the 1960's they produced and directed a television show on WOOK-TV Channel 14 featuring local talent;

WHEREAS, William Ridley Spaulding served as a member of the Board of Directors for the Girl Scout Council of the Nation's Capital and Dolores Hinton Spaulding served for 25 years with the Girl Scouts as troop leader, service-unit chairman, association chairman, camp director and trainer;

WHEREAS, Dolores Hinton Spaulding was a parent volunteer at John Burroughs Elementary School and aided in establishing the school library and served as one of the volunteer part-time parent-aide librarians and after raising her family returned to teaching for 25 years and completed a Masters Degree in Counseling;

WHEREAS, William Ridley Spaulding presently is an urban systems consultant on the Board of Directors for the IDEA Public Charter School and Dolores Hinton Spaulding is a human relations trainer; and

WHEREAS, William Ridley and Dolores Hinton Spaulding celebrated their 50th Wedding Anniversary with family and friends on Monday, December 27, 2004.

To recognize and honor John K. Tanner, who served with excellence in the Civil Rights Division of the U.S. Department of Justice for 28 years and was recently given the Division's highest honor, the John Doar Award.

WHEREAS, the United States Department of Justice instituted the John Doar Award as the highest award in the Civil Rights Division, which is presented to U.S. Department of Justice attorneys who have served at least ten years in the Civil Rights Division and have demonstrated high standards of excellence and dedication throughout their career. The John Doar Award is named after the Assistant Attorney General for Civil Rights who served from 1960 to 1967 under John F. Kennedy. In 1961, Doar joined the Freedom Riders on their trip through the south. He accompanied James Meredith when Meredith enrolled as the first Black student at the University of Mississippi, and Doar attended the funeral of civil rights leader Medgar Evers, where he appealed to an angry crowd of mourners dissuading them from potentially erupting into violence;

WHEREAS, during his career, he brought the first "Election Protection" lawsuit challenging discriminatory treatment of African American voters by poll officials in Conecuh County, Alabama and discriminatory hiring practices by the County for its poll officials. He also brought the first challenge to racially selective litigation;

WHEREAS, in 1995, Mr. Tanner moved from the Voting Section to the Criminal Section where he prosecuted cases involving police brutality, racially motivated residential arson, telephone threats and church arsons. He also served on the Department's Hate Crimes working group and on the National Church Arson Task Force;

WHEREAS, when he returned to the Voting Section in 2002, Mr. Tanner immediately coordinated the Division's enforcement of the minority language provisions of the Voting Rights Act;

WHEREAS, John K. Tanner's work has opened the door to public office for literally hundreds of Black and Hispanic elected officials, and has brought minority language programs to hundreds of Asian, Native American and Hispanic voters. His enforcement of the Voting Rights Act has transformed the state legislatures of Alabama and Mississippi and paved the way for the election in 2004 of Vietnamese candidates in Houston, Texas, and Bayou la Batre, Alabama. Voters who had previously been harassed and insulted elected their own representatives to their

state and local governments;

WHEREAS, in recognition of this work, on December 15, 2004, the U.S. Department of Justice presented Mr. Tanner with the distinguished John Doar Award; and

WHEREAS, no one values the right to vote more than the citizens of the District of Columbia, who are still without full voting representation, so it is for his concerted efforts to enforce the provisions of the Voting Rights Act we honor the contributions of John K. Tanner.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "John K. Tanner Recognition and Appreciation Resolution of 2005".

WHEREAS, Reginald H. Berry earned a Bachelor of Science in Mathematics from Central State University and a Juris Doctorate from George Mason International School of Law;

WHEREAS, Reginald H. Berry served his country in Vietnam and was awarded two Distinguished Service Medals and a Bronze Star;

WHEREAS, Reginald H. Berry joined the District of Columbia government in 1986 and was the Acting Deputy Commissioner of the Insurance Administration and Program Manager of the Life and Death Division within the Department of Insurance and Securities Regulation;

WHEREAS, Reginald H. Berry was responsible for planning and directing implementation of the policy for examination and actuarial analysis of all life and health insurance products antecedent to their use in the District of Columbia insurance market;

WHEREAS, Reginald H. Berry served as the Acting Commissioner and Deputy Commissioner of the Department of Insurance and Securities Regulation from 1997 to 2000;

WHEREAS, Reginald H. Berry was responsible for planning, directing, coordinating, and regulating the District of Columbia's insurance organizations and securities industries as well as vendors of workers' compensation;

WHEREAS, Reginald H. Berry served as the Assistant Director of Labor Standards at the Department of Employment Services from 2001 to 2004;

WHEREAS, Reginald H. Berry was responsible for planning, directing, and overseeing four unique program areas related to the protection and security of public and private workers, including private sector workers' compensation, hearings and adjudication, wage-hour, and

WHEREAS, Reginald H. Berry was a member of the Fellowship Lodge No. 26, Free and Accepted Masons; a member of the Jonathan Davis Consistory No. 1, 32nd Degree Mason; and a member of the Mecca Temple No. 1 of the Shiners, Washington, D.C.; and

WHEREAS, Reginald H. Berry passed away on November 5, 2004.

WHEREAS, John W. Finney joined the Washington Bureau on The New York Times in 1957 as a reporter and covered atomic energy, nuclear proliferation, the Pentagon, Capitol Hill and the debate over the Vietnam War;

WHEREAS, John W. Finney retired as news editor of the Washington Bureau of The New York Times and taught courses about the media for 15 years as an adjunct professor at Georgetown University's School of Foreign Service;

WHEREAS, John W. Finney served two terms on Advisory Neighborhood Commission 3D from 2000 to 2004;

WHEREAS, John W. Finney was chairman of ANC 3D in 2002 and 2003;

WHEREAS, John W. Finney established relationships with city agencies to increase community input into their decisions;

WHEREAS, John W. Finney was instrumental in obtaining road, sidewalk and other improvements for the Palisades community;

WHEREAS, John W. Finney was highly respected and admired for his devotion to his city and to the Palisades neighborhood and for his leadership and his enduring belief in grass-roots democracy; and

WHEREAS, John W. Finney passed away on October 29, 2004.

To posthumous commemorate the life of James Forman, former executive secretary of the Student Nonviolent Coordinating Committee.

WHEREAS, James Forman was born in Chicago on October 4, 1928 and graduated with honors from Chicago's Englewood High School in 1947;

WHEREAS, James Forman served honorably in the United States Air Force during the Korean War;

WHEREAS, James Forman graduated from Roosevelt University with a Bachelor's degree in public administration;

WHEREAS, James Forman became a reporter for the Chicago Defender and covered the resistance to court-ordered school segregation in Little Rock, Arkansas in 1957;

WHEREAS, James Forman worked as an elementary school teacher in Chicago;

WHEREAS, James Forman began to organize by working with families of sharecroppers who had been evicted from their homes for registering to vote in Fayette County, Tennessee, where he publicized the sharecroppers' plight, distributed food and registered voters;

WHEREAS, James Forman, in the summer of 1961, participated in a Freedom Ride to protest segregated facilities in Monroe, N.C.;

WHEREAS, James Forman served bravely and creatively as executive director of the Student Nonviolent Coordinating Committee, a front-line organization in the fight to bring racial equality to the United States;

WHEREAS, James Forman was a noted author, publishing a biography ("Sammy Younge Jr." The First Black College Student to Die in the Black Liberation Movement" in 1969), an autobiography ("The Making of Black Revolutionaries" in 1972 and 1997), and an essay ("Self Determination: An Examination of the Question and Its Application to the African American People" in 1984.)

WHEREAS, James Forman earned a master's degree in African and African American studies from Cornell University in 1980, and a doctoral degree from the Union of Experimental Colleges in 1982;

WHEREAS, James Forman was the father of Chaka Forman and James Forman, Jr., and the grandfather of Chaya Lillian Forman;

WHEREAS, James Forman was a civil rights pioneer who mentored a generation of young Americans who have become leaders in our nation and in our city, and

WHEREAS, James Forman was a resident of the District of Columbia for 24 years until his death at the Washington Home and Hospice on January 10, 2005.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Dr. James Forman Recognition Resolution of 2005".

WHEREAS, the first permanent church, a small brick building, was built in 1782 at the southeast corner of Bridge and Washington Streets (now M and 30th) and was called the Bridge Street Church, within ten years the congregation had outgrown it and two enlargements were undertaken - one in 1793 to which Thomas Jefferson contributed \$75, and another in 1801;

WHEREAS, in 1821, a contract was agreed upon to build a new church at the same location at a cost of \$20,000, and President James Monroe laid the cornerstone;

WHEREAS, in 1862, the church was used by the federal government as a hospital, and treated hundreds of soldiers, both Union and Confederate, wounded in the battles of Second Manassas and Fredricksburg;

WHEREAS, within a decade after the Civil War, the church moved and rebuilt at its present location on P Street (formerly West Street), utilizing as much of the original building material as possible, and a manse (residence) for the pastor was built next to the church;

WHEREAS, in 1873, President Ulysses S. Grant laid the cornerstone of the new West Street Church where the Reverend Dr. Samuel S. Howe served as minister; and
