THE FAUNA AND FLORA PROTECTION ORDINANCE (CHAPTER 469)

Order under Sub-section (4) of Section 2

BY virtue of the powers vested in me by paragraph (A) of Sub-section (4) of Section 2 of the Fauna and Flora Protection Ordinance (Chapter 469), I, Maithreepala Sirisena, Minister of Agriculture, Irrigation and Mahaweli Development and Environment, do by this Order -

- (1) declare the area of State land described in the First Schedule hereto to be a National Reserve for the purposes of the aforesaid Ordinance ;
- (2) declare that the limits of the areas of land declared by Order published in *Gazette* No. 309/4 of August 7, 1984, to be “Wasgamuwa National Park Lot 1” and “Wasgamuwa National Park Lot 11”, shall hereinafter be combined and together be called and know as the “Wasgamuwa National Park” ;
- (3) declare that the limits of the aforesaid Wasgamuwa National Park shall be altered by the addition thereto of the area of land described in the First Schedule hereto : and that the limits of the entire Wasgamuwa National Park as altered shall be as set out in the Second Schedule hereto.

FIRST SCHEDULE

LIMITS OF AREA OF LAND DECLARED TO BE A NATIONAL RESERVE

All that area of land situated within the Divisional Secretary's Division of Wilgamuwa of the Matale District in the Central Province, and bounded as follows:

- North :* From the point where the Herathi Oya meets the Kalu Ganga in an easterly direction along the Herathi Oya, to the point where it meets the Dunuwila Oya ;
- East :* From the point where the Herathi Oya meets the Dunuwila Oya in a southerly direction towards the area where the state forest land is situated and thence along the jeep track through the forest upto the point where it meets the ela ;
- South :* From the last mentioned point, in southerly direction along the jeep track across the Himbiriyaakada state forest to the point where it meets the Nikapelessa Ela, from there along the Nikapelessa Ela upto the point where it meets where it meets the Nikawathura Oya and from there onwards along the Nikawathura Oya upto the point where it meets the Kalu Ganga ;
- West :* From the point where the Nikawathura Oya meets the Kalu Ganga in a northerly direction towards the Kalu Ganga and along the Kalu Ganga to the point where it meets the Herathi Oya.

SECOND SCHEDULE

LIMITS OF AREA OF LAND TO BE ADDED TO THE WASGAMUWA NATIONAL PARK

All that area of land situated within the Divisional Secretary's Division of Wilgamuwa of the Matale District in the Central Province, and bounded as follows :

- North :* From the point where the Radavige Oya meets the Amban Ganga at the village of Angammedilla, along the Amban Ganga in an easterly direction upto the point where it meets the Mahaweli Ganga ;
- East :* From the point where the Amban Ganga and the Mahaweli Ganga meet and thence along the Mahaweli Ganga in a southerly direction towards the point where it meets the Muthuwangana Oya ;
- South :* From the point where the Muthuwangana Oya meets the Mahaweli Ganga and thence in westerly direction along the Muthuwangana Oya towards point where it meets the jeep track in the Thopwalapitiya state forest and from there onwards along the jeep track to the point where it meets the Dunuwila Oya, from there along the Dunuwila Oya to the point where the Gamburu Oya crosses the jeep track within the state forest from there onwards along the jeep track to the point that it meets the ela and from there along the ela in a southerly direction along the jeep track across the Himbiriyaakada state forest to the point where it meets the Nikapelessa Ela, from there along the Nikapelessa Ela upto the point where it meets the Nikawathura Oya and from there onwards along the Nikawathura Oya upto the point where it meets the Kalu Ganga ;
- West :* From the last to the point where it meets the Amban Ganga and from there onwards along the Amban Ganga in a northerly direction upto the point where it meets the Northern Boundary.

SCHEDULE

LIMITS OF THE GODAWAYA SANCTUARY

All that area of costal land approximately 3.85 Kilometers in extent, situated within the Divisional Secretary's Division of Tangalle in the Administrative District of Hambantota of the Southern Province, and bounded as follows :-

- East* : 500 meters towards the sea and 100 meters towards the land, from a North Latitude of 7⁰ and 16' and a East Longitude of 79⁰ and 53' on High Water Level (Godawaya) ;
- West* : 500 meters towards the sea and 100 meters towards the land, from a North Latitude of 7⁰ and 14' and a East Longitude of 79⁰ and 52' on High Water Level (at the meeting point of the Waduruppa canal and the sea) in a parallel line ;
- North* : From a horizontal line connection the last point towards the sea on the eastern boundary and the last point towards the sea the western boundary ;
- South* : From a horizontal line connection the last point towards the land on the eastern boundary and the last point towards the land on the western boundary.

SCHEDULE

LIMITS OF THE REKAWA SANCTUARY

All that area of costal land approximately 4.52 Kilometers in extent, situated within the Divisional Secretary's Division of Tangalle in the Administrative District of Hambantota of the Southern Province, and bounded as follows :-

- East* : 500 meters towards the sea and 100 meters towards the land, from a North Latitude of 7° and 5' and a East Longitude of 79° and 49' on High Water Level (Belawattegoda) :
- West* : 500 meters towards the sea and 100 meters towards the land, from a North Latitude of 7° and 03' and a East Longitude of 79° and 48' on High Water Level (Kapuhewela) in a parallel line :
- North* : From a horizontal line connection the last point towards the sea on the eastern boundary and the last point towards the sea the western boundary ;
- South* : From a horizontal line connection the last point towards the land on the eastern boundary and the last point towards the land on the western boundary.
