#### **REPORT OF THE MEETING OF THE STATES PARTIES**

1. The Meeting of the States Parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May be Deemed to be Excessively Injurious or to Have Indiscriminate Effects (CCW) held at Geneva on 18 and 19 November 2004 decided, as contained in paragraph 29 of its Report (CCW/MSP/2004/2), "to commission follow-up work under the oversight of the Chairperson-designate of a Meeting of the States Parties to the Convention to be held on 24 and 25 November 2005 at Geneva in conjunction with the Seventh Annual Conference of the States Parties to Amended Protocol II." For that purpose the Meeting of the States Parties to the Convention decided that the Group of Governmental Experts would continue its work in the year 2005.

2. The Meeting of the States Parties decided, as contained in paragraph 25 of CCW/MSP/2004/2, that the Working Group on Explosive Remnants of War would continue its work in the year 2005 with the following mandate:

"To continue to consider, including through participation of legal experts, the implementation of existing principles of International Humanitarian Law and to further study, on an openended basis, with particular emphasis on meetings of military and technical experts, possible preventive measures aimed at improving the design of certain specific types of munitions, including sub-munitions, with a view to minimising the humanitarian risk of these munitions becoming explosive remnants of war. Exchange of information, assistance and co-operation would be part of this work. The Group will report on the work done to the next Meeting of the States Parties."

3. The Meeting of the States Parties decided, as contained in paragraph 26 of CCW/MSP/2004/2, that the Working Group on Mines Other Than Anti-Personnel Mines would continue its work in the year 2005 with the following mandate:

"1. To consider all proposals on Mines Other Than Anti-Personnel Mines put forward since the establishment of the Group of Governmental Experts with the aim of elaborating appropriate recommendations on Mines Other Than Anti-Personnel Mines for submission to the next Meeting of the States Parties to the Convention.

2. Meetings of military experts shall also be conducted to provide advice on these activities."

4. The Meeting of the States Parties decided, as contained in paragraph 27 of CCW/MSP/2004/2, that "the Chairperson-designate shall undertake consultations during the intersessional period on possible options to promote compliance with the Convention and its annexed Protocols, taking into account proposals put forward, and shall submit a report, adopted by consensus, to the States Parties."

5. The Meeting of the States Parties decided, as contained in paragraph 28 of CCW/MSP/2004/2, that "the Chairperson-designate shall undertake consultations during the intersessional period on the preparation of the Third Review Conference of the States Parties to the Convention and shall report to the next Meeting of the States Parties."

6. The Meeting of the States Parties decided, as contained in paragraph 32 of CCW/MSP/2004/2, "to re-designate Ambassador Gordan Markotić of Croatia as Chairperson of the Meeting of the States Parties to be held in 2005". Furthermore, the States Parties decided to re-appoint Ambassador Jayant Prasad of India as Coordinator on Explosive Remnants of War and Ambassador Markku Reimaa of Finland as Coordinator on Mines Other Than Anti-Personnel Mines

7. The Group of Governmental Experts held three sessions during 2005. The deliberations and activities of all three sessions of the Group are reflected in CCW/GGE/X/5 of 16 March 2005, CCW/GGE/XI/4 of 9 September 2005 and CCW/GGE/XII/4 of xxx November 2005, respectively.

8. The Meeting of the States Parties to the Convention was held at Geneva on 24 and 25 November 2005.

9. The following States Parties to the Convention participated in the work of the Meeting: Argentina, Australia, Austria, Bangladesh, Belarus, Belgium, Bolivia, Brazil, Bulgaria, Cambodia, Canada, Chile, China, Colombia, Croatia, Cuba, Cyprus, Czech Republic, Denmark, Ecuador, Estonia, Finland, France, Germany, Greece, Guatemala, Holy See, Hungary, India, Ireland, Israel, Italy, Japan, Jordan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Mauritius, Mexico, Morocco, Netherlands, New Zealand, Norway, Pakistan, Peru, Philippines, Poland, Portugal, Republic of Korea, Romania, Russian Federation, Senegal, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sweden, Switzerland, The former Yugoslav Republic of Macedonia, Turkey, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America and Venezuela.

10. The following Signatory States to the Convention also participated in the work of the Meeting: Egypt and Vietnam.

11. The following States which are not parties to the Convention participated in the work of the Meeting as observers: Azerbaijan, Côte d'Ivoire, Democratic Republic of the Congo, Kazakhstan, Kuwait, Libyan Arab Jamahiriya, Madagascar, Malaysia, Qatar, Saudi Arabia, Singapore, Syrian Arab Republic, Thailand, United Arab Emirates and Yemen.

12. The representatives of the United Nations Development Programme (UNDP), United Nations Institute for Disarmament Research (UNIDIR) and United Nations Mine Action Service (UNMAS) took part in the work of the Meeting.

13. The representatives of the following international organisations also participated in the work of the Meeting: Geneva International Centre for Humanitarian Demining (GICHD), International Committee of the Red Cross (ICRC).

14. The representatives of the following non-governmental organisations also participated in the work of the Meeting: Actiongroup Landmine.de, American Bar Association, Cluster Munition Coalition, Danchurchaid, Geneva Call, Handicap International (France), Human Rights Watch, International Campaign to Ban Landmines (ICBL), Landmine Action UK, League of Iraqi Doctors (LOID), Mines Action Canada and Pax Christi International.

15. The Meeting of the States Parties was opened on 24 November 2005 by the Deputy Secretary-General of the Conference on Disarmament and Director of the Department for Disarmament Affairs, Geneva Branch, Mr. Enrique Román-Morey.

16. The Meeting of the States Parties held three plenary meetings. At its first plenary meeting, on 24 November 2005, the Meeting of the States Parties confirmed by acclamation the nomination of Ambassador Gordan Markotić of Croatia as Chairperson of the Meeting.

17. At the same plenary meeting, the Meeting of the States Parties adopted its agenda as contained in Annex I.

18. At the same plenary meeting, the Meeting of the States Parties adopted the Rules of Procedure as adopted and used by the Second Review Conference (CCW/CONF.II/PC.1/1 with oral amendments).

19. At the same plenary meeting, the Meeting of the States Parties unanimously confirmed the nomination of Mr. Peter Kolarov, Political Affairs Officer, Department for Disarmament Affairs, Geneva Branch, as Secretary-General of the Meeting, who was assisted by Mr. Bantan Nugroho, Political Affairs Officer, as Secretary of the Meeting.

20. At the same plenary meeting, the Meeting of the States Parties agreed in the context of the short duration of the Meeting to have a streamlined bureau consisting of the Chairperson; the Group Coordinators, the representatives of China, Czech Republic, Germany and Jordan; the Working Group Coordinators, Ambassador Jayant Prasad of India as Coordinator on Explosive Remnants of War and Ambassador Markku Reimaa of Finland as Coordinator on Mines Other Than Anti-Personnel Mines; the Chairperson of the Meetings of the Military and Technical Experts on

Explosive Remnants of War, Ms. Vera Bohle of GICHD and the Chairperson of the Meetings of the Military Experts on Mines Other Than Anti-Personnel Mines, Maj. Gen. Ahti Vartiainen of Finland, on the understanding that this does not constitute a precedent for future meetings of the States Parties.

21. At the same plenary meeting, the Meeting of the States Parties heard a message from the Secretary-General of the United Nations, which was delivered by the Deputy Secretary-General of the Conference on Disarmament and Director of the Department for Disarmament Affairs, Geneva Branch, Mr. Enrique Román-Morey.

22. At the same plenary meeting, the Meeting of the States Parties considered the financial arrangements for the Meeting, agreed by the 2004 Meeting of the States Parties to the Convention, as contained in Annex II of its Report (CCW/MSP/2004/2).

23. At the same plenary meeting, the Chairperson of the Meeting of the States Parties, Ambassador Gordan Markotić of Croatia, reported the work of the Group of Governmental Experts to the Meeting of the States Parties for its consideration.

24. The following States participated in the consideration of the report of the work of the Group of Governmental Experts and general exchange of views: Australia, Austria, Belarus, Brazil, Canada, Chile (on behalf of Chile and Argentina), China, Croatia, Cuba, Denmark, Finland, Guatemala, Holy See, Ireland, Israel, Japan, Lithuania, Mexico, Morocco, New Zealand, Norway, Pakistan, Republic of Korea, Russian Federation, South Africa, Sweden, Switzerland, Ukraine, United Kingdom of Great Britain and Northern Ireland (on behalf of the European Union), United States of America and Venezuela.

25. The following State participated in the discussion on the issue of the Third Review Conference of the States Parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May be Deemed to be Excessively Injurious or to Have Indiscriminate Effects: France.

26. Following the decision of the Second Review Conference of the States Parties to the Convention as stipulated in Part II, Final Declaration, under "Review of the Articles, Article 8 (Review and amendments)" of its Final Document (CCW/CONF.II/2) "to convene a further conference five years following the entry into force of the amendments adopted at the Second Review Conference, but in any case not later than 2006, with preparatory meetings starting as early as 2005, if necessary", the Meeting of the States Parties decided to convene the Third Review Conference of the States Parties to the Convention from 7 to 17 November 2006 at Geneva in conjunction with the Eighth Annual Conference of the States Parties to Amended Protocol II.

27. Following the recommendations of the Group of Governmental Experts, as contained in paragraph 26 of CCW/GGE/XII/4, the Meeting of the States Parties decided that all necessary preparations for the Third Review Conference be undertaken within the framework of the existing Group of Governmental Experts.

28. Following the recommendations of the Group of Governmental Experts, as contained in paragraph 29 of CCW/GGE/XII/4, the Meeting of the States Parties decided that the intersessional work of the Group of Governmental Experts will be undertaken in three sessions at Geneva during 2006, as follows:

- 6 10 March 2006
- 19 23 June 2006
- 28 August 6 September 2006

29. Following the recommendations of the Group of Governmental Experts, as contained in paragraph 30 of CCW/GGE/XII/4, the Meeting of the States Parties decided to commission follow-up work under the oversight of the President-designate of the Third Review Conference of the States Parties to the Convention

30. The Meeting of the States Parties decided that the Working Group on Explosive Remnants of War would continue its work in the year 2006 with the following mandate:

To continue to consider, including through participation of legal experts, the implementation of existing principles of International Humanitarian Law and to further study, on an openended basis, with particular emphasis on meetings of military and technical experts, possible preventive measures aimed at improving the design of certain specific types of munitions, including sub-munitions, with a view to minimising the humanitarian risk of these munitions becoming explosive remnants of war. Exchange of information, assistance and co-operation would be part of this work. The Group will report on the work done to the Third Review Conference in 2006.

31. The Meeting of the States Parties decided that the Working Group on Mines Other Than Anti-Personnel Mines would continue its work in the year 2006 with the following mandate:

a) To continue to consider all proposals on Mines Other Than Anti-Personnel Mines put forward since the establishment of the Group of Governmental Experts with the aim of elaborating appropriate recommendations on Mines Other Than Anti-Personnel Mines for submission to the Third Review Conference in 2006.

b) Meetings of military experts shall also be conducted to provide advice on these activities.

32. Following the recommendations of the Group of Governmental Experts, as contained in paragraph 27 of CCW/GGE/XII/4, the Meeting of the States Parties decided that the President-designate shall undertake consultations during the intersessional period on possible options to promote compliance with the Convention and its annexed Protocols, taking into account proposals put forward, and shall submit a report, adopted by consensus, to the States Parties.

33. Following the recommendations of the Group of Governmental Experts, as contained in paragraph 28 of CCW/GGE/XII/4, the Meeting of the States Parties decided that the President-

designate shall undertake consultations during the intersessional period on the possibility to establish a sponsorship programme under the Convention and on the modalities of such a sponsorship programme, and shall report to the States Parties.

34. At its final plenary meeting on 25 November 2005, the Meeting of the States Parties decided to issue an appeal to all States that had not yet done so to take all measures to accede to the Convention and its annexed Protocols as soon as possible. The appeal is contained in Annex II.

35. At the same meeting, the States Parties to the Convention recommended that the Secretary-General of the United Nations, as Depositary of the Convention and its annexed Protocols, and the President-designate, on behalf of the States Parties, exercise their authority to achieve the goal of universality of the Convention and its annexed Protocols. To this effect, the Meeting of the States Parties requested the President-designate to consider reporting to the 61<sup>st</sup> session of the United Nations General Assembly on his endeavours.

36. The Meeting of the States Parties also called on the States Parties to promote wider adherence to the Convention and its annexed Protocols in their respective regions and in particular to consider organizing national or regional workshops, conferences or other events aimed at promoting the Convention and its annexed Protocols.

37. The Meeting of the States Parties addressed the issue of the dates and duration of the Eighth Annual Conference of the States Parties to Amended Protocol II and decided that it be held on 6 November 2006 at Geneva.

38. The Meeting of the States Parties decided to designate Ambassador François Rivasseau of France as President of the Third Review Conference of the States Parties to be held in 2006, and appointed Ambassador Edvardas Borisovas of Lithuania as Coordinator on Explosive Remnants of War and a representative of the Group of the Non-Aligned Movement as Coordinator on Mines Other Than Anti-Personnel Mines. The Meeting of the States Parties agreed that the principle of equitable geographical rotation among the regional groups shall be ensured when addressing the Presidency of future Review Conferences of the States Parties to the Convention.

39. At its final plenary meeting, on 25 November 2005, the Meeting of the States Parties adopted its report, as contained in document CCW/MSP/2005/CRP.1, as orally amended, which is being issued as document CCW/MSP/2005/2 and the cost estimates of the three sessions in 2006 of the Group of Governmental Experts and of the Third Review Conference of the States Parties to the Convention to be held in 2006, as contained in Annex III and Annex IV.

40. The proceedings of the Meeting of the States Parties as well as all the statements made during the discussions are reflected in the summary records of the Meeting of the States Parties which will be issued at a later date.

#### Annex II

#### An Appeal of the High Contracting Parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects (CCW) on the Occasion of the 2005 Meeting of the States Parties

We, the High Contracting Parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects, meeting in Geneva on 24 and 25 November 2005:

*Recalling with satisfaction* the adoption and entry into force of the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects, and the Protocol on Non-Detectable Fragments (Protocol I), the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby Traps and Other Devices (Protocol II) and its amended version (Amended Protocol II), the Protocol on Prohibitions or Restrictions on the Use of Incendiary Weapons (Protocol III), the Protocol on Blinding Laser Weapons (Protocol IV), as well as the amendment of Article 1 of the Convention by which the scope of application of the Convention and its annexed Protocols was extended to include armed conflicts of a non-international character;

*Recalling with satisfaction* the adoption of the Protocol on Explosive Remnants of War (Protocol V) at the Meeting of the States Parties held at Geneva on 27 and 28 November 2003;

*Recalling with satisfaction* the adoption without a vote at the 60<sup>th</sup> session of the United Nations General Assembly of resolution A/C.1/60/L.48 entitled "Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects" by which the Member States of the United Nations have renewed their call upon all States that have not yet done so to take all measures to become parties, as soon as possible, to the Convention and the Protocols thereto, as amended, with a view to achieving the widest possible adherence to these instruments at an early date, and so as to ultimately achieve their universality;

*Welcome* the fact that, as of 25 November 2005 100 States have adhered to the Convention, 98 States have notified the Depositary of their consent to be bound by Protocol I, 87 States have notified the Depositary of their consent to be bound by Protocol II, 85 States have notified the Depositary of their consent to be bound by Amended Protocol II, 93 States have notified the Depositary of their consent to be bound by Protocol III, 81 States have notified the Depositary of their consent to be bound by Protocol III, 81 States have notified the Depositary of their consent to be bound by Protocol III, 81 States have notified the Depositary of their consent to be bound by Protocol IV, 13 States have notified the Depositary of their consent to be bound by Protocol IV, 14 States have adhered to the amended Article 1 of the Convention;

*Emphasize* the importance of achieving universal adherence to the Convention and its annexed Protocols;

*Urge* all States that have not yet done so to take all measures to become parties, as soon as possible, to the Convention and its annexed Protocols.

# ESTIMATED COSTS OF THE 2006 THIRD REVIEW CONFERENCE OF THE STATES PARTIES TO THE CONVENTION ON PROHIBITIONS OR RESTRICTIONS ON THE USE OF CERTAIN CONVENTIONAL WEAPONS WHICH MAY BE DEEMED TO BE EXCESSIVELY INJURIOUS OR TO HAVE INDISCRIMINATE EFFECTS

as adopted at the final plenary meeting on 25 November 2005

1. The Meeting of the States Parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects, held in Geneva on 24 and 25 November 2005, decided to convene the Third Review Conference of the States Parties to the Convention from 7 to 17 November 2006.

2. This document is submitted pursuant to the above-mentioned decision of the States Parties and provides estimated costs in the amount of US\$961,800 for convening that meeting. A breakdown of these costs is provided in the attached table.

3. It should be noted that the costs are estimated on the basis of past experience and anticipated workload. The actual costs will be determined after the closure of the meeting and completion of related work, with all relevant expenditures recorded in the accounts. At that time, any adjustments in contributions by the participants sharing the costs will be determined accordingly.

4. With regard to the financial arrangements, it will be recalled that, in accordance with the practice followed on the occasion of previous multilateral disarmament conferences and related meetings, and as reflected in their Rules of Procedure, the costs are shared among the States Parties participating in the conferences, based upon the United Nations scale of assessment pro-rated to take into account the number of States Parties participating in the meetings. States that are not States Parties but that have accepted the invitation to take part in the meetings share in the costs to the extent of their respective rates of assessment under the United Nations scale of assessments.

5. Subject to the States Parties' approval of the estimated costs and cost-sharing formula, assessment notices will be prepared based on the overall estimated costs and applicable cost-sharing formula. Since the above-mentioned activities shall have no financial implication for the regular budget of the Organization, States Parties should proceed with the payment of their share of the estimated costs as soon as assessment notices have been received.

1. The Meeting of the States Parties to the Convention on the Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to have Indiscriminate Effects, held in Geneva on 24 and 25 November 2005, decided that the Group of Governmental Experts should continue its deliberations in the year 2006 and will meet for three sessions as follows: 13<sup>th</sup> session – from 6 to 10 March 2006, 14<sup>th</sup> session – from 19 to 23 June 2006 and 15<sup>th</sup> session – from 28 August to 6 September 2006.

2. This document is submitted pursuant to the above-mentioned decision of the States Parties and provides the estimated costs of those sessions.

3. The costs of the sessions are estimated at US\$1,356,300. A breakdown of the estimated costs is provided in the attached tables.

4. It should be noted that the costs are estimated on the basis of past experience and anticipated workload. The actual costs will be determined after the closure of the sessions and completion of related work, with all relevant expenditures recorded in the accounts. At that time, any adjustments in contributions by the participants sharing the costs will be determined accordingly.

5. With regard to the financial arrangements, it will be recalled that in accordance with the practice followed on the occasion of previous multilateral disarmament conferences, and as reflected in their Rules of Procedure, the costs of such conferences, including those pertaining to preparatory meetings, would be shared among the States Parties participating in the conferences, based upon the United Nations scale of assessment pro-rated to take into account the number of States Parties participating in the conference. States that are not States Parties but that have accepted the invitation to take part in the meeting would share in the costs to the extent of their respective rates of assessment under the United Nations scale of assessments.

6. Subject to the States Parties' approval of the estimated costs and cost-sharing formula, assessment notices will be prepared based on the overall estimated costs and applicable cost-sharing formula. Since the above-mentioned activities shall have no financial implication for the regular budget of the Organization, States Parties should proceed with the payment of their share of the estimated costs as soon as assessment notices have been received.
