TRADE AGREEMENT¹ BETWEEN THE KINGDOM OF DEN-MARK AND THE PEOPLE'S REPUBLIC OF ALBANIA FOR THE PERIOD 1 JULY 1971–30 JUNE 1972

The Government of the Kingdom of Denmark and the Government of the People's Republic of Albania, desiring to encourage and facilitate the development of trade relations between them, have agreed as follows:

Article I

The two Governments shall accord each other the most favorable treatment possible in respect of the issue of import and export permits and shall facilitate the exchange of goods and services on a basis of mutual advantage in accordance with the laws and regulations in force in each country and with list A (Albanian exports to Denmark) and list D (Danish exports to Albania) annexed to this Agreement.

Article II

Danish and Albanian goods not mentioned in list D or list A may also be exchanged between the two countries.

Article III

Payments between Denmark and Albania shall be made in Danish kroner or any other convertible currency in accordance with the laws and regulations in force in the two countries.

Article IV

This Agreement shall enter into force on 1 July 1971 and shall remain in force until 30 June 1972.

DONE at Tirana on 23 June 1971 in duplicate in the Danish and Albanian languages, both texts being equally authentic.
