CHANGES TO CLASSES

Class 40 and IRC Big Boats

Many of the exciting Class 40 and really big IRC boats that are taking part in the Rolex Fastnet Race will be joining us for three days of racing from Tuesday 9 to Thursday 11 August.

The Class 40 is a modern breed of racing machine, designed for long distance, shorthanded events. The IRC big boat fleet will include a host of the largest and most glamorous boats from around the world.

Cruisers

Following interest from a number of cruisers whose owners want to take part, we have reinstated the ISCRS cruiser fleet for the whole week.

We are also continuing the IRC no-spinnaker class for a second year to give those who want less frenetic racing a chance to join in.

Sunsail F40

The Sunsail charter fleet has been completely renewed since last year and the fleet is now comprised of Sunsail F40s, built by Beneteau. We expect to have all 40 of these new boats racing at Aberdeen Asset Management Cowes Week this year.

Mixed Dayboat Class

Following the success of this class in 2010, the 707, 1720 and Sonata fleets will once again be amalgamated into a single mixed dayboat class together with modified J/80s which are owned by the RYS and RThYC. The fleet will use the same class flag and have the same starts, courses and finishes but will have separate one design fleet results.

Sportsboat (SBR) class

As the SBR system has been discontinued, boats that might have raced in the SBR class in the past should instead be able to race within the IRC fleet. Any that do not comply with the ORC Category 4 Special Regulations should email stuart.quarrie@aamcowesweek.co.uk.

J/Sprit

After discussions with J-Boats UK, it has been decided to amalgamate all J-Boats into the normal IRC fleets.

NOTICE OF REGATTA

ORGANISING AUTHORITY

The Organising Authority is Cowes Week Limited (CWL).

2 RULES

- 2.1 Racing will be governed by the 'rules' as defined in the Racing Rules of Sailing 2009 – 2012 (RRS), with Royal Yachting Association (RYA) Prescriptions and, as appropriate:
- 2.1.1 For boats racing under IRC, IRC Rules Parts A, B & C except that:
 - a) IRC Rule 21.1.5(e) shall not apply during Aberdeen Asset Management Cowes Week 2011, thus allowing the use of a spare mainsail as a racing replacement.
 - b) For the purposes of IRC Rule 21.1.5(d), this is a regatta run on consecutive days (so the sails on board while racing must remain the same throughout).
- 2.1.2 MOCRA Rating Rule.
- 2.1.3 ISCRS (Island Sailing Club Rating System).
- 2.1.4 Class Rules for one-design entries, including crew limits (if any).
- 2.2 Sentences in italics within this Notice of Regatta are guidance notes for information only.
- 2.3 Safety regulations

2.3.1 Black Group

- a) Boats shall comply with the ISAF Offshore Special Regulations for Race Category 4 Monohulls or Multihulls (as appropriate).
- b) Any boats that do not comply fully with the requirements may apply to CWL for written dispensation.
- c) Paragraphs 4.23.2(b), 4.26.4(g) and 5.01.1(c) of the Offshore Special Regulations shall not apply.
- d) Copies of the Special Regulations are obtainable from the ISAF website at www.sailing.org/specialregulations.php, and extracts are reproduced in The Solent Book.

2.3.2 White Group

- a) Boats shall comply with their class safety regulations (if any) and with the current CWL Safety Regulations for Dayboat Classes.
- b) Boats shall carry a marine band VHF transceiver for use in emergency.
- c) Copies of the CWL safety regulations are obtainable online at the Official Website at www.aamcowesweek.co.uk or from CWL and will be included with the Sailing Instructions.
- 2.3.3 Anchors shall not be carried forward of the stem or with any part outboard except when anchoring.
- 2.4 All boats are strongly encouraged to carry a radio capable of receiving Cowes Radio broadcasts (FM87.7MHz).

2.5 Changes to the Racing Rules of Sailing & Rating Rules

- 2.5.1 Changes are as detailed in this Notice of Regatta or in the Sailing Instructions . This changes RRS J1.2(1).
- 2.5.2 Alternative penalties will apply to infringements of RRS Part 2 as detailed in the Sailing Instructions. A yellow flag will be required.

3 ELIGIBILITY

3.1 One design boats

3.1.1 One-design boats shall have a valid class certificate and/or registration document and comply with class rules (see 2.1.4).

- 3.1.2 Boats for which one-design class racing is provided in Table 2 or Table 3 are not normally permitted to race in a rated class. A request for dispensation from this rule must be made in writing and will be considered by CWL whose decision shall be final.
- 3.1.3 Notwithstanding 3.1.2, any Black Group boat may race on the final Saturday under IRC or ISCRS as appropriate.
- 3.1.4 One-designs and/or specific types of boat racing within the rated classes may be given additional results listings (but normally not CWL prizes) at the discretion of CWL. Class associations wishing to request this option should apply in writing to CWL.

3.2 Ratings and rating changes

- 3.2.1 Boats racing under ISCRS that have not already been allocated a rating in 2011 or who are planning to change any aspect of their setup since obtaining their 2011 ISCRS rating must have applied for one by 1200 on Sunday 17 July. *Please contact the Aberdeen Asset Management Cowes Week entries office for instructions on applying for a rating.*
- 3.2.2 Boats racing under either of the other rating systems (IRC, MOCRA) shall have a valid rating certificate issued by 1700 on Tuesday 2 August. For IRC ratings, contact the RORC Rating Office at www.rorcrating.com. For MOCRA ratings, contact Simon Forbes at simonforbes3@gmail.com.
- 3.2.3 New ratings or changes to a rating will not be accepted after the times stated in 3.2.1 and 3.2.2 as appropriate unless the rating change is:
 - a) due to an error made by CWL, RORC, UNCL, ISC or MOCRA. In such a case the rating shall be corrected for all races;
 - b) as the result of a rating protest, when RRS 64.3 will apply together with the rules applicable to the rating system;
 - c) at the discretion of RORC, UNCL, ISC or MOCRA as appropriate.

3.3 Crew lists and crew numbers

- 3.3.1 A boat sailing as a one-design shall comply with her class crew limitations, unless these have been modified by the class association for Aberdeen Asset Management Cowes Week. As decided by the J/109 class, the crew number for J/109s during their points series shall be 10 but there shall be no crew weight limit.
- 3.3.2 Except as detailed in NoR paragraph 3.3.1, there shall be no restrictions on crew numbers or crew changes during the regatta. IRC Rule 22.4.2 shall not apply.

3.3.3 Crew details

- a) Prior to the start of the regatta, every boat shall provide CWL with details of all the crew likely to be racing on the boat, including their full names and email addresses. This shall be done online and can be completed either at the time of entry or at any time up to the start of the regatta.
- b) Entrants are required to take all reasonable steps to ensure that the crew information provided to CWL is accurate and up to date.
- c) Changes made during the regatta should be notified to the emergency contact described in 3.3.4.
- 3.3.4 Prior to racing, each entrant is required to supply CWL with the details of an emergency contact ashore who shall keep an accurate record of the details of all crew sailing on the boat on each day during the regatta.

3.4 Classes

3.4.1 The regatta is open to boats and classes listed in Tables 2 and 3, and to any other classes accepted by CWL.

NOTICE OF REGATTA

3.4.2 Mixed Dayboat Class

- a) The Mixed Dayboat class is designed to accommodate dayboat fleets where the number of entries for Aberdeen Asset Management Cowes Week does not merit their own class.
- b) Fleets within the Mixed Dayboat class will start and race together under a single class flag but will be given separate results (there will be no combined Mixed Dayboat dass results).
- c) The class is open to the following one-designs which shall comply with their own class rules: 707, 1720, Sonata and modified J/80s owned by the RThYC and RYS.
- 3.4.3 CWL reserves the right to:
 - a) Combine the start of one class with another.
 - b) Subdivide any class.
 - c) Cancel racing for any class or amalgamate classes if the number of entries is less than ten.
 - d) If one design classes are amalgamated for race management purposes (starting, courses, finishing), they will be given a coloured pennant to display over their class flag to indicate the mixed class in which they are racing.

4 ENTRY

4.1 Entry

- 4.1.1 All entrants (except as detailed below) should enter online at the Official Website.
- 4.1.2 Exceptionally, entries may be made in person or by telephone at the Regatta Centre when a member of staff will complete the entry on your behalf. Note that some basic details about your entry will be viewable on the Official Website and may be changed or added to online by the entrant after the initial entry.
- 4.1.3 Sunsail F40 entries will be completed by Sunsail UK.

4.2 Late Entries

Late entries will be accepted until 1700 the day prior to a race so long as they are accompanied by the full entry fee. Entries after 1700 on Thursday 4 August must be made in person at the Regatta Centre.

4.3 Entry Cancellation and Refunds

If written cancellation of entry is received at the Regatta Centre by 1700 on Sunday 31 July, the whole fee less a £75 administration charge will be refunded. Thereafter, refunds will be made only in exceptional circumstances.

4.4 Race Abandonment or Cancelled

In the event of a race being abandoned or cancelled, entry fees will **not** be refunded.

4.5 Mobile telephones

- 4.5.1 The race committee will text courses (and other information) to a single mobile telephone number that has been registered to the boat. To enhance this service, all such telephones should use a UK based service provider. Additional numbers may be registered for the additional fee of £10 per number.
- 4.5.2 A mobile telephone may also be used by competitors to declare at the end of each day's racing. This too needs to be registered and may be the same number as described above or a different number.
- 4.5.3 Numbers may be altered at no extra charge if a registered telephone becomes unusable. At the latest, a new number can be registered by 1700 on the day before the new number is to be used.

5 REGISTRATION AND SKIPPERS BRIEFING

- 5.1 The Sailing Instructions will be available on the Official Website from early July as a downloadable pdf file. One copy on ordinary paper will be posted to each entrant prior to the regatta and a further copy, printed on waterproof paper, will be given to all entrants at registration.
- 5.2 It is likely that there will be some amendments to the NoR, Sailing instructions and Schedule of Racing. Changes to be included in Amendment Number 1 will be posted on the Official Website in draft form as items are noticed. This amendment will become final at 1400 on Thursday 4 August when registration opens.

The entry fee for Black Group boats racing on the final Saturday is included free of charge for boats racing 4 or more days earlier in the week. Otherwise there is a £50 entry fee for this day, regardless of boat size.

- 5.3 Race registration packs containing sponsor decals/pennants, class numerals (if ordered), Racing Guide, waterproof Sailing Instructions and any initial amendments to the NOR or Sailing Instructions will be available for collection from the Regatta Centre from 1400 on Thursday 4 August.
- 5.4 All entrants or their representatives shall register in person at the Regatta Centre before their first race.

5.5 Skipper's briefing

There will be a voluntary skipper's briefing during the evening of Friday 5 August (1830 for White Group and 1930 for Black Group). The venue will be confirmed at registration. Note that among other things, these briefings will look at some of the main areas where competitors incur avoidable penalties for Cowes Week specific infringements and are thus aimed at those with little prior experience of the regatta.

6 RACING SCHEDULE

- 6.1 The first start each day is scheduled for 1000 or later. The schedule of starts for all classes will be detailed on the Official Website from mid-July and in the Racing Guide.
- 6.2 IRC class splits and the starting schedule will be confirmed by 1700 on Sunday 31 July. These details will be promulgated on the Official Website and by email to all entrants who have registered an email address with us. They will also be available at registration.
- 6.3 All classes, as detailed in Tables 2 & 3, will have one race scheduled per day from Saturday 6 to Saturday 13 August, except as follows:
- 6.3.1 Sunsail F40, Ondeck Ocean Racer, RS Elite and Victory: Sat 6 to Fri 12 Aug.
- 6.3.2 IRC Big Boats and Class 40: Tues 9 to Thur 11 Aug.
- 6.3.3 Contessa 32, Sigma 33, Sigma 38, J/109, First 40.7, Quarter Ton and IRC (no spinnaker): Sat 6 to Fri 13 Aug, except that these boats may race on Sat 13 Aug within the appropriate IRC or ISCRS fleet.
- 6.4 Overall Points Series for Black Group classes (except IRC Big boats and Class 40) will run from Sat 6 to Fri 12 Aug with special trophies for the final Saturday when all boats will race in either MOCRA, IRC or ISCRS as appropriate.
- 6.5 Overall Points Series for Laser SB3, RS Elite, Victory and J/80 will run from Sat 6 to Fri 12 Aug. Overall Points Series for all other White Group Series will run from Sat 6 to Sat 13 Aug.

7 ADVERTISING

- 7.1 Boats may carry advertising as allowed by the ISAF advertising code unless their class rules further restrict what may be carried.
- 7.2 Boats intending to carry advertising must indicate this on their entry form, along with the names of companies and/or products to be advertised.
- 7.3 Notwithstanding the classes listed in Tables 2 & 3, CWL reserves the right to refuse entry to any class of boat that carries advertising in conflict with any of the regatta sponsors. Any class considering accepting sponsorship that might be affected by this rule is advised to contact CWL as soon as possible. For the avoidance of doubt, this rule does not apply to individual entries, only to whole classes.
- 7.4 As permitted by the ISAF advertising code, boats will be required to display official event sponsor decals or pennants as follows:
- 7.4.1 Boats in the Daring, Dragon, Redwing, Seaview Mermaid, Solent Sunbeam, Squib, Swallow, Victory and XOD classes will be required to fly sponsor pennants from their backstays. All other classes will be required to display sponsor decals on both sides of their hulls in the forward 20%.
- 7.4.2 Competitors may apply in writing for dispensation not to display sponsor decals if doing so would be likely to damage the hull. Dispensation will not normally be given to any boat that carries other advertising decals or stickers on her hull. Any boat given such dispensation will instead be required to fly a sponsor pennant from their backstay.
- 7.5 Boats may not carry or display advertising other than official event sponsor decals on the forward 20% of their hulls.

8 SCORING SYSTEM & PRIZES

8.1 Daily trophies & prizes:

- 8.1.1 Daily prizes will be awarded to the first three boats in all classes listed in Tables 2 & 3. Prize winners will have the option of either a small keeper prize (engraved glass) or a voucher from the regatta's clothing partner, Gill.
- 8.1.2 Daily perpetual trophies will be awarded by the member clubs of Cowes Combined Clubs and by class associations, in accordance with the trophy list for each day as detailed in the Racing Guide.
- 8.1.3 Special trophies and prizes will be awarded by the Island Sailing Club and Royal Southern Yacht Club for the final Saturday.

NOTICE OF REGATTA

8.2 Overall series & trophies

- 8.2.1 **Overall class trophies** will be awarded to the first three boats in each class listed in Tables 2 & 3.
- 8.2.2 **The Overall Winner** of Aberdeen Asset Management Cowes Week will be awarded a special trophy.
- 8.2.3 **Overall Black Group and overall White Group trophies** will be awarded to the best performing boat in each of Black and White Groups.
- 8.2.4 **The Young Skipper's Trophy is o**pen to any skipper who is under 25 years on Saturday 13 August 2011.
- 8.2.5 IRC and ISC overall trophies will be awarded to the overall winners of these divisions for the final Saturday.
- 8.2.6 **The Nautor's Swan Trophy is o**pen to any Nautor's Swan sailing in an IRC class.
- 8.2.7 **The Liz Earle Close Shave Trophy** will be awarded to the class winner who beats the second placed boat in the class by the smallest margin.
- 8.2.8 The Commodores' Challenge Trophy is open to challenges from any boat in an IRC class owned or sailed by a present or past commodore of a yacht club in Britain or the USA. Full details can be obtained from CWL.
- 8.2.9 **The Royal Southern Ariel Trophy** will be awarded to the boat with the best result on the final Saturday with a lady helm.
- 8.2.10 Scoring for the award of CWL trophies will use a modified form of the RRS Appendix A low points system. This, together with the detailed scoring for special trophies, will be detailed in the SIs.
- 8.2.11 White Group classes and the Contessa 32 class will use the series and discards as determined by their class associations. All other Black Group Classes will use the races from Saturday 6 to Friday 12 August with one discard if 6 or 7 races are sailed and no discards if 5 or fewer races are sailed.

9 CLASS FLAGS, CLASS NUMERALS & SAIL NUMBERS

- 9.1 It is the responsibility of each boat to provide its own class flags, number dodgers and class-distinguishing numerals or letters as described below. Advice on where it is possible to purchase these items can be given by CWL on request.
- 9.2 Class flags (see tables 2 & 3) shall be displayed by all competitors unless specific dispensation has been given in writing by CWL. Class flags shall be of the following minimum sizes:
 - a) For White Group boats 20cm x 15cm.
 - b) For Black Group boats either 30cm x 23cm for rectangular flags or 61cm x 15cm for numeral pennants.
- **9.3** All Black Group boats are required to display a sail number dodger with numerals and suffix letters at least 375mm high for boats of 8.5m or greater LOA, and at least 300m high for boats less than 8.5m LOA. The dodger does not need to include national letters. Alternatively, equivalent sized sail numbers with suffix letters may be displayed on both sides of the hull in such a way as to be visible to the race committee at the start and finish.
- 9.4 Class-distinguishing numerals or letters are required for IRC classes 0-7 and for the Quarter Ton and ISCRS classes (except for boats sailing in these classes only on the final Saturday). Each numeral shall be black or blue on a white background and shall be at least 300mm high (available from CWL for a fee of £20).

9.5 Black Group boats that do not have guardrails fitted may apply in writing for dispensation from NoR 9.2 and 9.3 above. Boats granted such dispensation must still display their sail number on their mainsail (or by other means if no mainsail is carried).

10 COURSES

- 10.1 White Group courses will be located in the central Solent area as further defined in the Sailing Instructions.
- 10.2 Black Group courses will be located in the Solent and its approaches *(approximately Anvil Point to Nab Tower)*. A full list of marks will be included in the Sailing Instructions and will be available for download from the Official Website.
- **10.3** Admiralty small craft chart folio SC5600 ('The Solent') is recommended.
- 10.4 All boats will be issued with a laminated chartlet of the racing area, together with the marks to be used thereon. However, these are diagrammatic only and should not be used for navigation. Note that, subject to availability, any charts that delaminate in normal use and are returned will be replaced free of charge and that additional laminated charts may be purchased for £5 each.

11 DISCLAIMER OF LIABILITY

- 11.1 It is a condition of entry that, prior to the boat's first race, the person in charge of each boat and/or his authorised representative shall, at registration, sign a disclaimer of liability and declaration that they will comply with the RRS. If the person in charge will be under 18 years old on the first day of the regatta then a special disclaimer, available from the Regatta Centre, shall also be countersigned by a parent or guardian.
- 11.2 A boat is entirely responsible for her own safety, whether afloat or ashore, and nothing, whether in the Notice of Regatta or Sailing Instructions or anywhere else, reduces this responsibility. It is for the boat to decide whether she is fit to sail in the conditions in which she will find herself. By launching or going to sea, the boat confirms that she is fit for these conditions and that her crew is competent to sail and compete in them.
- 11.3 The boat is responsible to ensure that she is equipped and seaworthy so as to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and that the crew knows how to use it. The fact that the organisers conduct inspections of a boat does not reduce the responsibilities of the boat set out in this paragraph.
- 11.4 The boat is required to hold adequate insurance and in particular to hold insurance against third party claims including cover for racing in the sum of at least £2,000,000 sterling (or near equivalent in foreign currency). Entrants shall declare when entering that such cover will be maintained in full force throughout the regatta.
- 11.5 Nothing done by the organisers can reduce the responsibility of the boat nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the race and the event, and include the organizing authority, the race committee, the race officers, patrol boats, beachmasters and sponsors. The provision of patrol craft does not relieve the boat of her responsibilities.


