### **INMATES ESCAPE FROM PRISON IN GOLDEN VALLEY – ADDITIONAL INFORMATION**

The prison escape is being investigated by the investigation units of the Arizona Department of Corrections. Please contact them regarding details of the escape and information regarding the inmates.

Mohave County Sheriff's Office is warning the public of three inmates that have escaped from the Arizona State Prison in Golden Valley Friday (7/30) night.

At about 9:45 p.m., the State Prison advised that three male subjects escaped from the prison. MCSO Deputies, K-9 Units along with Arizona Department of Public Safety Helicopter responded and immediately began the search.

At about 12:00 a.m. Saturday (7/31) morning Casslyn Welch, 44, of Mesa, Arizona, has been identified in assisting McCluskey and Province in hi-hacking an 18 wheeler truck which was occupied by two male drivers, at milepost 44 on Interstate 40, outside of Kingman, Arizona, which is approximately 10 miles east of the prison. The subjects were armed with handguns. Approximately 5:00 a.m., the two truck drivers were released and the suspects fled from the hi-jacked 18 wheeler in Flagstaff, Arizona.

Casslyn Welch, an accomplice, was seen at the prison driving a vehicle prior to the incident. The vehicle she was driving appears to be a 1996 Chrysler Concord 4 door sedan Blue in color with a faded hood and roof (see enclosed picture) with an Arizona registration ABL7584. This vehicle has not been located; therefore the suspect(s) could possibly still be using the vehicle.

Mohave County Sheriff's Office is seeking warrants for Casslyn Welch, John Charles McCluskey and Tracy Alan Province for kidnapping and armed robbery.

The three escaped inmates are still outstanding and have apparently split up. Inmates listed with their charges:

- Tracy Alan Province, 42, was incarcerated for 1<sup>st</sup> degree murder. Province is a white male, 6'01 at 184 lbs, with brown hair and blue eyes.
- John Charles McCluskey, 45, was incarcerated for 2<sup>nd</sup> degree murder. McCluskey is a white male, 6'01 at 160 lbs, with brown hair and blue eyes.
- Daniel Kelly Renwick, 36, was incarcerated for 2<sup>nd</sup> degree murder. Renwick is a white male, 5'11 at 190 lbs, with brown hair and hazel eyes.

The public should not approach these suspects as they are armed and dangerous. Province was last seen wearing dark blue jeans, dark purple polo shirt with red stripe and white tennis shoes. McCluskey was last seen wearing light color blue jeans, white button up shirt with horizontal and vertical blue stripes and white tennis shoes.
