I. SUMMONS

IX. GOVERNOR'S ADDRESS AND MOTION OF THANKS THEREON

Justice Selvi. M. Fathima Beevi, Governor of Tamil Nadu addressed the members of the Eleventh Tamil Nadu Legislative Assembly assembled in the Legislative Assembly Chamber, Secretariat, Chennai at 9.30 a.m. on Wednesday, the 17th February, 1999.

XIV. FINANCIAL BUSINESS

The Budget for the year 1999-2000 was presented to the Legislative Assembly by Hon. Kalainar M. Karunanidhi, Chief Minister at 9.30 a.m. on Wednesday, 17th March 1999.

The General discussion on the Budget took place for 6 days on the following dates:

20th March 1999, 22nd March 1999, 23rd March 1999, 25th March 1999, 26th March 1999 and 27th March 1999.

Thirty-four members including the Leader of Opposition took part in the General discussion.

The Hon. Chief Minister replied to the debate on the 27th March, 1999.

Discussion on the Voting of Demands for Grants took place on the following dates:

31st March 1999, 1st April 1999, 5th April 1999, 6th April 1999, 7th April 1999, 8th April 1999, 9th April 1999, 12th April 1999, 13th April 1999, 15th April 1999, 16th April 1999, 19th April 1999, 20th April 1999, 21st April 1999, 22nd April 1999, 23rd April 1999, 28th April 1999, 29th April 1999, 30th April 1999, 3rd May 1999, 4th May 1999, 5th May 1999, 6th May 1999, 7th May 1999, 10th May 1999, 11th May 1999, 12th May 1999 and 13th May 1999.

Voting of Demands lasted for 28 days from 31st March, 1999 to 13th May, 1999.

Out of 4706 Cut Motions received, 4404 were admitted of which only 601 were actually moved in the House. After the discussion on the Demands for Grants was over, the Cut Motions were either withdrawn by the members or deemed to have been withdrawn by leave of the House. All the 61 Demands for Grants were discussed and voted by the House. The dates on which the Demands were moved and voted are given in the Annexure. (Page No. 57)

The Tamil Nadu Appropriation (No. 2) Bill, 1999 (L.A. Bill No. 21 of 1999) relating to the Budget for the year 1999-2000 was introduced in the Assembly on the 13th May 1999 and was considered and passed on the 14th May, 1999.

(2) On the 26th March, 1999, Hon. Kalaignar, M. Karunanidhi, Chief Minister laid on the Table, the Demands for Advance Grants (Vote on Account) for the year 1999-2000.

The Demands were moved and voted by the House on the 30th March 1999.

The Tamil Nadu Appropriation (Vote on Account) Bill, 1999 (L.A. Bill No. 5 of 1999) relating to the Demands for Advance Grants (Vote on Account) for the year 1999-2000 was introduced in the Assembly on the 30th March 1999 and considered and passed on the same day.

(3) On the 26th March 1999, Hon. Kalaignar, M. Karunanidhi, Chief Minister, presented to the Assembly the Final Supplementary Statement of Expenditure for the year 1998-99. The discussion on the Final Supplementary Statement of Expenditure for the year 1998-99 was fixed on the 30th March 1999. 306 Cut Motions were received out of which 166 were admitted. However, due to the sudden demise of Thiru M. Andi Ambalam, a sitting Member, the Cut Motions admitted were not moved and the House voted the Demands for Final Supplementary Statement of Expenditure for the year 1998-99 on 30th March 1999 without discussion.

The Tamil Nadu Appropriation Bill, 1999 (L.A. Bill No.6 of 1999) relating to the Final Supplementary Statement of Expenditure for the year 1998-99 was introduced on the 30th March 1999 and was considered and passed on the same day.

XV. GOVERNMENT RESOLUTIONS

(1) On the 20th February 1999, Hon. Kalaignar M. Karunanidhi, Chief Minister, moved the following Resolution:-

"Article 81 of the Constitution of India as amended by the Constitution (Forty second Amendment) Act, 1976 provides that the number of Lok Sabha seats for each State will remain frozen till the figures of first census taken after the year 2000 are published.

This provision ensured that the States that have performed well in the implementation of nationally important programme of Family Welfare do not suffer from reduction in the number of elected members in the House of People on this score.

The year 2000 is approaching and it is apprehended that if remedial measure is not immediately taken, Tamil Nadu's representation in Lok Sabha may be redused by 6 seats because of lower annual average growth rate of population achieved. This will in the long run affect the implementation of Family Welfare Programme not only in Tamil Nadu but in other States as well.

Therefore, this House resolves to urge the Government of India to ensure that the number of seats in the Lok Sabha allotted to every State remains unchanged for another fifty years and to amend the Constitution of India accordingly."

The above Resolution was taken up for discussion on 22-2-1999. Eleven Members including the Leader of Opposition took part in the discussion. At the end of debate, Hon. Chief Minister moved again the Resolution with amendments. The Resolution as amended was put to vote and adopted nem con.

(2) On the 11th May 1999, Hon. Thiru Samayanallur S. Selvarasu, Minister for Adi-Dravidar and Tribal Welfare, moved the following Resolution:-

"Whereas, this Assembly considers that it is desirable to have a uniform law throughout India for eliminating the dehumanising practice of manual scavenging of human excreta by declaring employment of manual scavengers for removal of human excreta an offence and thereby ban the further proliferation of dry latrines and for regulation of construction and maintenance of water-seal latrines and for matters connected therewith or incidental thereto;

And whereas, the subject matter of such a law mainly falls within the scope of Entry 6 (Public health and sanitation;......) of the State List in the Seventh Schedule to the Constitution of India and the Parliament has no power to make such a law for the State with respect to the aforesaid matters except as provided in articles 249,250 and 252(1) of the Constitution of India;

And whereas, in pursuance of resolution passed under clause (1) of Article 252 of the Constitution of India, by all the Houses of the Legislatures of the States of Andhra Pradesh, Goa, Karnataka, Maharashtra, Tripura and West Bengal to the effect that the aforesaid matters should be regulated in those States by Parliament by Law, the Parliament has enacted the Employment of manual Scavengers and Construction of Dry latrines (Prohibition) Act, 1993 (Central Act 46 of 1993);

And whereas, this Assembly desires that the aforesaid Employment of manual Scavengers and Construction of Dry latrines (Prohibition) Act, 1993 (Central Act 46 of 1993) should be adopted in the State of Tamil Nadu;

Now, Therefore, in exercise of the powers conferred by clause (l) of Article 252 of the Constitution of India, this Assembly hereby resolves that the Employment of manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993 (Central Act 46 of 1993) should be adopted in the State of Tamil Nadu".

The above Resolution was taken up for discussion along with the Demand for Grant relating to Adi-Dravidar Department and adopted by the House on the 11th May 1999.

(3) On the 18th May, 1999, Hon. Kalaignar M. Karunanidhi, Chief Minister moved the following resolution:-

"WHEREAS, the Tamil Nadu Legislative Assembly considers that it is desirable to have a uniform law throughout India for the regulation of Public Debt of the States and for all matters connected therewith or ancillary and incidental thereto:

AND WHEREAS, the subject matter of such a law is relatable mainly to the matter enumerated in entry 43 in List II in the Seventh Schedule to the Constitution of India:

AND WHEREAS, Parliament has no power to make such a law for the States with respect to the matter enumerated in entry 43 in List II aforesaid except as provided in Article 249 and 250 of the Constitution of India:

AND WHEREAS, the Public Debt Act, 1944 is applicable for marketable loans raised by Reserve Bank of India on behalf of both the Union and the State Governments:

AND WHEREAS, it is felt desirable to repeal the Public Debt Act, 1944 and replace the same with a new Legislation viz. "Government Securities Act" in order to enable the Reserve Bank of India to render efficient and improved service to the holders of Government Securities.

Now, Therefore, in pursuance of clause (l) of Article 252 of the Constitution of India, this Assembly hereby resolves that the Parliament be empowered to regulate by law matters relating to Government Securities and all other matters connected therewith or ancillary or incidental thereto".

The above Resolution was put to vote and carried.

(4) On the 18th may, 1999, Hon. Thiru Ko. Si. Mani, Minister for Rural Development and Local Administration moved the following resolution:-

"The following draft of amendments to be made by the Governor of Tamil Nadu under sub-section (l) of section 305 of the Tamil Nadu district Municipalities Act, 1920 (Tamil Nadu Act V of 1920), omitting rules 11 and 28, altering rule 12 and inserting rule 26-B in Part I of Schedule IV to the said Act, be approved as required by section 305-A of the said Act:

DRAFT AMENDMENTS

In Schedule IV to the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) under Part-I,-

- (i) Rule (11) shall be omitted;
- (ii) In rule 12, for the expression '9,10, or 11', the expression "9 or 10" shall be substituted;
 - (iii) After rule 26-A, the following rule shall be inserted, namely:-
- '26-B. Any appeal against the decision of the Taxation Appeals Committee may be filed within thirty days from the date of receipt of the order of the Taxation Appeals Committee in the District Court concerned'; and
 - (iv) Rule 28 shall be omitted."

The Resolution was put to vote and carried.

XVI. PRIVATE MEMBERS' RESOLUTIONS

During the period under Review, three notices of Private Members' Resolution were received and admitted.

Two of them were listed in the Agenda of which only one was moved and discussed. The rest lapsed due to the prorogation of the session.

The Business Advisory Committee allotted 18th May, 1999 for transacting Private Members' business. Thiru K. Subbarayan moved the following resolution and spoke on the same:-

"About 40,000 private transport workers are deprived by the respective Private Transport Undertakings the benefits accruing from the Central and State enactments. Non-enforceability of these Acts continues to exist in the Private Transport Undertakings.

Hence, this House resolves that a tripartiate Committee be constituted to recommend to the Government after a thorough review of the implications for enforcing the Acts in the Private Transport Undertakings".

The Minister for Labour replied to the debate. The resolution was later on withdrawn by the Member.

XVII. GOVERNMENT MOTIONS

(1) On the 20th February, 1999 Hon. Prof. K. Anbazhagan, Leader of the House (Minister for Education) moved the following motion:-

"That rule 32 of the Tamil Nadu Legislative Assembly Rules which provides that the first hour of every sitting be available for 'Question and Answers' be suspended on the 22nd February, 1999, and the House do resolve to transact Government Business".

The motion was adopted nem con.

(2) On the 24th February, 1999 Hon. Thiru Arcot N. Veersamy, Minister for Health and Electricity moved the following motion:-

"That under Rule 25(1) of the Tamil Nadu Legislative Assembly Rules, the House be adjourned today (24.02.1999) and meet again at 9.30 a.m. on 17th March, 1999".

The motion was adopted nem con.

(3) On the 20th March, 1999 Hon. Prof. K. Anbazhagan, Leader of the House (Minister for Education) moved the following motion:-

"The House do suspend Thiru P.R. Sundaram for a week from participating in the proceedings of the House for the wrongful doings like tearing off the copy of the Budget speech while the Hon. Chief Minister presenting the Budget for the year 1999-2000 and for showing a Black cloth and shouting slogans".

The Motion was put and carried.

(4) On the 22nd March, 1999 Hon. Thiru Arcot N. Veerasamy, Minister for Health and Electricity moved the following motion:-

The motion was adopted nem con.

(8) On the 30th March, 1999 Hon. Prof. K. Anbazhagan, Leader of the House (Minister for Education) moved the following motion:-

"That Rule 32 of the Tamil Nadu Legislative Assembly Rules which provides that the first hour of every sitting be available for "Question and Answers' be suspended today (30.03.1999) and the House do resolve to transact Government Business".

The motion was adopted nem con.

(9) On the 30th March, 1999 Hon. Prof. K. Anbazhagan, Leader of the House (Minister for Education) moved the following motion:-

"That the Tamil Nadu Legislative Assembly Rules 30, 130 and 132 be suspended and the Tamil Nadu Appropriation (Vote on Account) Bill, 1999 (L.A. Bill No. 5 of 1999) and the Tamil Nadu Appropriation Bill, 1999 (L.A. Bill No. 6 of 1999) be taken up for consideration and passing today (30-03-1999) itself'.

The motion was put to vote and carried

Election of Sixteen Members to the Committee on Estimates

(10) On the 23rd April, 1999, Hon. Prof. K. Anbazhagan, Leader of the House, (Minister for Education) moved the following motion:-

"That with reference to Rule 195 of the Tamil Nadu Legislative Assembly Rules, this Assembly does proceed, on a date to be fixed by Hon. the Speaker to elect Sixteen Members to be Members of the Committee on Estimates for the year 1999-2000".

The Motion was put to vote and carried.

Election of Sixteen Members to the Committee on Public Accounts

(11) On the 23rd April, 1999, Hon. Prof. K. Anbazhagan, Leader of the House (Minister for Education) moved the following motion:-

"That with reference to Rule 203 of the Tamil Nadu Legislative Assembly Rules, this Assembly do proceed, on a date to be fixed by Hon. the Speaker to elect Sixteen Members to be Members of the Committee on Public Accounts for the year 1999-2000".

The Motion was put to vote and carried.

Election of Sixteen Members to the Committee on Public Undertakings

- (12) On the 23rd April, 1999, Hon. Prof. K. Anbazhagan, Leader of the House, (Minister for Education) moved the following motion:-
- "That with reference to Rule 211 of the Tamil Nadu Legislative Assembly Rules, this Assembly do proceed, on a date to be fixed by Hon. the Speaker to elect Sixteen Members to be Members of the Committee on Public Undertakings for the year 1999-2000".

The Motion was put to vote and carried.

Election of Fourteen Members to the Committee of Privileges

- (13) On the 23rd April, 1999, Hon. Prof. K. Anbazhagan, Leader of the House, (Minister for Education) moved the following motion:-
- "That with reference to Rules 227 of the Tamil Nadu Legislative Assembly Rules, this Assembly do proceed, on a date to be fixed by Hon. the Speaker to elect Fourteen Members to be Members of the Committee of Privileges for the Financial year 1999-2000".

The Motion was put to vote and carried.

(14) On the 11th May, 1999, Hon. Prof. K. Anbazhagan, Leader of the House, (Minister for Education) moved the following motion:-

"That Rules 185(2) of the Tamil Nadu Legislative Assembly Rules be suspended and the Government Resolution on the adoption of 'The Employment of Manual Scavengers and Construction of Dry latrines (Prohibition) Act, 1993 (Central Act 46 of 1993) in the State of Tamil Nadu 'be taken up for the discussion and adopted today (11-05-1999)".

The Motion was put to vote and carried unanimously.

(15) On the 11th May, 1999, Hon. Thiru Arcot N. Veerasamy, Minister for Health and Electricity moved the following motion:-

"That Rule 32 of the Tamil Nadu Legislative Assembly Rules which provides that the first hour of every sitting be available for 'Question and Answers' be suspended on the 12th May 1999 and the House do resolve to transact Government business".

The motion was adopted nem con.

(16) On the 17th May 1999, Hon. Prof. K. Anbazhagan, Leader of the House, (Minister for Education) moved the following motion:-

"That Rule 32 of the Tamil Nadu Legislative Assembly Rules, which provides that the first hour of every sitting be available for 'Question and Answers' be suspended on the 18th May, 1999 and the House do resolve to transact Government business".

The Motion was adopted nem con.

(17) On the 18th May, 1999 Hon. Thiru Arcot N. Veerasamy, Minister for Health and Electricity moved the following motion:-

"That under Rule 25(1) of the Tamil Nadu Legislative Assembly Rules, the House be adjourned sin-die".

The motion was adopted nem con.

XVIII. PRIVILEGE MATTERS

(1) On the 25th March 1999, Hon. Speaker referred to the Committee of Privileges for thorough investigation and report a privilege matter raised against former Chief Minister and AIADMK General Secretary, Selvi J Jayalalitha for her statement that the Speaker has hastily initiated action against Thiru R. Thamaraikkani under Pressure from Chief Minister.

The Speaker has rejected on previous day a notice of privilege motion given by Thiru S. Thirunavukkarasu against the former Chief Minister but allowed it today as she had made a 100 per cent false statements against the Presiding Officer of the Assembly.

(2) On the 25th March, 1999, Hon. Thiru Aladi Aruna, Minister for Law raised a matter of privileged against Thiru C. Karuppasamy of AIADMK for his allegations that the Law Minister had stamped him in the footwear and abused him mentioning his case name, when the fact was that the Minister was not at all present in the House when Thiru R. Thamaraikkani punched on the nose of Hon. Thiru Veerapandi S. Arumugam.

Hon. the Speaker said that as the issue involves another member of the House, Thiru C. Karruppasamy and in keeping with the best tradition of the House, he well get his remarks in the matter and then pronounce his order.

(3) On the 30th April, 1999, Hon. Speaker informed the House that Thiru C. Karuppasamy has sought two months time till 2nd June 1999 to reply to the notice, by which time, the Assembly would adjourned sine die and then prorogued thus rendering the notice in fructuous. Hence, Hon. Speaker referred the matter to the Committee of Privileges for examination and report and directed Thiru C. Karuppasamy to send his explanation direct to the Committee.

XIX. NAMING AND WITHDRAWAL

- (1) On the 17th March 1999 Hon. the Speaker named Thiruvalargal R. Thamaraikkani, P.R. Sundaram and C. Karuppasamy for persistently defying the Chair and shouting slogans in the House and asked them to withdraw from the House. When they refused to do so, the Marshal and Watch and Ward were called in and the Members were evicted out of the House.
- (2) On the 17th March, 1999, Hon. Speaker named Thiru A. Venkatachalam for defying the Chair and asked him to withdraw from the House. When he refused to do so, the Marshal was called in and the Member was removed from the House.
- (3) On the 20th March, 1999, Hon. the Speaker named Thiru A. Venkatachalam for obstructing the proceedings of the House and asked him to withdraw from the House. When he refused to do so, the Marshal was called in and the Member was whisked away from the House. as the Member has been named for the second time in the session, he has to absent himself for the reminder of the session, but as a gesture of magnanimity, Hon. the Speaker announced that the Member will attend the House from 22.3.1999 onwards.
- (4) On the 16th April, 1999, Hon. the Speaker named Thiru P.R. Sundaram for defying the Chair and asked him to withdraw from the House. when he refused to do so, the Marshall and the watch and ward were called in and the Member was evicted out of the House.
- (5) On the 18th May, 1999, Hon. the Speaker named Dr. K.Krishnasamy for repeatedly defying the chair and asked him to withdraw from the House when he refused to do so, the Marshall was called in and the Member was evicted from the House.

XX. SUSPENSION OF MEMBERS

- (1) On the 20th March, 1999, Thiru P.R. Sundaram was suspended from the service of the House for a period of one week from 20.03.1999 on a motion moved by the Hon. Leader of the House and adopted by the House for having torn the copy of the Budget Speech and shown a black cloth inside the House on 17.3.1999.
- (2) On the 22nd March 1999, Thiruvalargal R. Thamaraikkani and C. Karuppasamy were suspended form the service for the House for remainder of the session on a motion moved by Hon. Thiru Arcot N. Veerasamy, Minister for Health and Electricity and adopted by the House for having committed a criminal assault on Hon. Thiru Veerpandi S. Arumugam, Minister for Agriculture and causing injury to his nose.

Thereafter, Hon. the Speaker directed Thiru R. Thamaraikkani, to vacate his room in the Legislator's Hostel till the remainder of the Session.

XXI. ANNOUNCEMENT BY HON. SPEAKER

- (1) On the 22nd March, 1999, Hon. the Speaker announced in the House that he well initiate action against Thiru R. Thamaraikkani for his act of criminal misconduct for assaulting Hon. Thiru Veerapandi S. Arumugam, Minister for Agriculture after going through the proceedings and convention and that till then he be arrested and lodged in Central Prison, Chennai.
- (2) On the 23rd March, 1999, Hon. the Speaker announced in the House the decision taken at the meeting of the Leaders of all Legislature Parties awarding fifteen days simple imprisonment to Thiru R. Thamaraikkani for his grossly misconduct act and breach of privilege and that the Leader of the House will move a motion in this regard.
- (3) On the 23rd March, 1999, Hon. the Speaker announced in the House the message received by him from the Commissioner of Police, Chennai that in Pursuance of warrant of arrest issued by him against Thiru R. Thamaraikkani the warrant was executed at 18.15 hours on 22.3.1999 at Appollo Specialty Hospital, Teynampet and the member was produced before the Dean, Government General hospital for General Checkup and then lodged in the Central Prison at 20.50 Hours.
- (4) On the 24th March, 1999, Hon. the Speaker announced in the House that the General Discussion on the Budget would continue on Saturday, the 27th March 1999 and that Hon. Chief Minister would reply to the discussion on that day.
- (5) On the 25th March, 1999, Hon. the Speaker announced in the House that the High Court of Madras has ordered the release of Thiru R. Thamaraikkani setting aside the order of the Speaker for keeping him in Central Prison.
- (6) On the 25th March, 1999, Hon. the Speaker announced in the House that the Thiru P.R. Sundaram, M.L.A., of Rasipuram Constituency was arrested along with eight others and remanded to Judicial custody and were sent to Central Prison, Vellore.
- (7) On the 6th April, 1999, Hon. the Speaker announced in the House the message received by him from the S.P. Vellore in regard to the arrest of Thiru C. Gnanasekaran, while indulging in a rail-roko agitation.
- (8) On the 6th April, 1999, Hon. the Speaker announced that a two days seminar for Legislator's under the auspices of the Tamil Nadu branch of C.P.A. will be held on 7th and 8th April at the Conference Hall, Namakkal Kavignar Maaligai and requested all the members to participate without fail.
- (9) On the 12th April, 1999, Hon. the Speaker announced that the Calling Attention notice listed on that day would be taken up on the 13th April, 1999.

XXII. SPEAKER'S DIRECTIONS

On the 19th April 1999, Hon. the Speaker drew the attention of Hon. Ministers to the 1916 Questions awaiting replies and directed various Departmental Secretaries to make answers available to this Secretariat expeditiously.

XXIII. SPEAKER'S WARNING

On the 15th April, 1999, Hon. the Speaker strongly rebuked Thiru P.R. Sundaram fro displaying the "hangman's noose" without the permission of the Chair and issued a final warning that any such future behavior will be viewed seriously and directed the frisking of such member before entering the House.

XXIV. EXPUNCTION OF REMARKS

On the 22nd April 1999, Hon. the Speaker directed the expunction of remarks made in the House by the Hon. Chief Minister M. Karunanidhi and Thiru K. Subbarayan, a member of CPI pertaining to the stay granted by the Madras High Court in a case relating to private companies providing computer science training in Government Schools. The Madras High Court took serious objections to the remarks "non-application of mind" made by Hon. Chief Minister in relation to a case, though what the Chief Minister meant by the remarks were that Government might have failed to place the facts before the Court. Hon. Chief Minister has said that he has no objection to the expunction if his remarks had hurt the feelings of the Court.

Hon. the Speaker observed no one in the Assembly meant any offence to the court and hoped just as he had respected the sentiments of the Judiciary, the latter would reciprocate the gesture towards the House to safeguard it sovereignty.

XXV. FELICITATIONS

- (1) On the 20th February, 1999, Hon. the Speaker on behalf of the House extended a warm welcome to His Excellence Mangala Moonasinghe, High Commissioner of Sri Lanka in India who was then witnessing the proceedings of the Assembly from the Speaker's Gallery.
- (2) On the 13th May, 1999, Hon. the Speaker complimented on behalf of the House the State Government headed by Dr. M. Karunanidhi, Chief Minister on successful completion of its three years rule and commencement of the fourth year.
- (3) On the 18th May, 1999 Hon. the Speaker on behalf of the House felicitated the Hon. Chief Minister on his seventy-sixth birth day falling on the 3rd June, 1999 and wished him many happy returns of the day.

XXVI. MLA'S SYMPOSIUM

A two days seminar was organised for the Legislators on 7-4-1999 and 8-4-1999 under the auspices of the Tamil Nadu Branch of the Common Wealth Parliamentary Association. It was inaugurated by the Hon. Thiru Parithi Ellamvazhuthi, Deputy Speaker on 07-04-1999. Thiru P.V. Rajaraman, I.A.S. Secretary to Government, Finance Department highlighted the different aspects of the budget. Thiru Mohandas, Director of Anna Institute of Management spoke on Indian Economy and Thiru Chandramohan, Director of Evaluation and Applied Research spoke on the state Economy.

XXVII. DIVISION

On the 17th May, 1999, when the motion moved by the Minister for Rural Development and Local Administration, 'that the Tamil Nadu Panchayats (Fifth Amendment) Bill, 1999 (L.A.Bill No. 16/1999) be passed' was put to vote of the House, Thiru S. Balakrishnan, Leader of the Opposition pressed for a Division.

The Division was taken as required by rule 99 of the Tamil Nadu legislative Assembly Rules, and the House divided as follows:-

Hon. the Speaker declared that the motion moved by the Hon. Minister for Rural Development and Local Administration has been carried.
