## CONDITIONS OF SALE

All NEW ASTON MARTIN and LAGONDA motor cars, chassis, and parts thereof supplied by Aston Martin Lagonda Limited (hereinafter called "the Company"), are sold subject to and with the benefit of the following Conditions of Sale, whether such goods are sold direct to the user, or through or by a Distributor or Dealer:—

A Distributor, Area Dealer, Retail Dealer or Trader is not a representative or agent of the Company and is not authorised to pledge the credit of the Company nor to transact business on its account in any way whatsoever, nor is a Distributor, Area Dealer, Retail Dealer or Trader authorised to make any warranty or representation on the Company's behalf.

The Company shall use its best endeavours to deliver in accordance with a customer's requirements, unless prevented by Strikes, Lockout, War or other causes out of its control, but delay in delivery beyond the delivery date quoted by the Company shall not give the customer any right to damages.

Payment shall be made at time of delivery at the Company's Works.

Each of the Company's Motor Goods is sold subject to the condition that it shall not be resold except at the price prescribed from time to time by the Company.

The Company reserves the right to change the price of its cars, chassis and parts thereof, at any time, and all cars, chassis and parts thereof, are sold subject to prices ruling at the time of delivery.

The Company reserves the right to discontinue the manufacture of any model(s) at any time and to cancel any unexecuted orders in respect of such model(s). The Company may from time to time and without notice make such alterations in the specification of cars by them as it deems in its sole discretion to be necessary.

All sales of the Company's Motor Goods are subject to the condition that no car or chassis or part thereof shall be exhibited at any Motor Exhibition held within Great Britain, without the approval of the Company.

## GUARANTEE

ASTON MARTIN LAGONDA LTD. (hereinafter called "the Company") gives the Guarantee set out below to any purchaser of a new Aston Martin or Lagonda car, namely:

**Guarantee:** If, within the Guarantee period any defect in an Aston Martin or Lagonda car shall become apparent as a direct result of the use by the Company of defective material or bad workmanship in any part of an Aston Martin or Lagonda car, the Company will, free of charge (subject to the terms set out below), either repair or replace (as it shall in its sole discretion determine) such part, either at the Company's Service Department or the place of business of the nearest authorised Aston Martin Lagonda Distributor or Dealer.

**Guarantee Period:** The Guarantee Period shall be:

(a) Chassis and Body: 1 year after delivery to the first registered owner.

(b) Parts: 90 days after delivery of such parts to the original purchaser for use, or until the expiration of the Guarantee Period for the chassis and body, whichever is the longer.

**Limitations:** The benefit of this Guarantee is subject to the following terms and conditions:

- (a) No parts shall have been fitted other than the Company's approved parts.
- (b) The defect must not be due to fair wear and tear, misuse or negligence.
- (c) The Aston Martin or Lagonda car shall not have been used, maintained, altered, repaired or adjusted otherwise than in accordance with the instructions given in the appropriate Instruction Manual, nor in a manner which, in the opinion of the Company, would prejudice the reliability of the Aston Martin or Lagonda car.
- (d) The Company's Routine Maintenance Schedule shall have been carried out at the intervals prescribed therein.
- (e) The Aston Martin or Lagonda car shall not have taken part in any road or track racing events, reliability trials, hill-climbing or speed tests or other competitions of a similar nature and shall not have been used for commercial service or hire, except with the written consent of Aston Martin Lagonda Ltd.
- (f) Any claim under this Guarantee shall be made immediately on the discovery of the defect to the Company or to an authorised Aston Martin Lagonda distributor or dealer and if so required the Aston Martin or Lagonda car or the defective part(s) shall be returned to the Company or to the nearest authorised Aston Martin Lagonda distributor or dealer.
- (g) The Aston Martin or Lagonda car shall not at any time have been used for the purpose of towing caravans or trailers.
- (h) The Aston Martin or Lagonda chassis shall not have been fitted with a body which, in the opinion of the Company, is unsuitable.

**Liability:** The Company's liability is limited to the terms of the Guarantee. Neither the Company nor its servants and agents shall be liable for personal injuries or consequential or resultant damage or loss however occurring.

**Exclusions:** The obligations of the Company under this Guarantee do not extend to tyres or to any non-standard accessories nor to normal service maintenance operations.

This Guarantee excludes any other express or implied condition, statement or warranty statutory or otherwise. Furthermore, the Company neither assumes nor authorises any other person to assume for it any other liability in connection with the sale of its motor cars, chassis or parts.

**Construction:** The construction and legal effect of this Guarantee shall be determined in accordance with the Laws of England. All disputes arising out of this Guarantee shall be referred to arbitration in London, England, under the Provisions of Arbitration Act, 1950, or any statutory modification or re-enactment thereof. This Guarantee may not be changed or terminated orally or the benefits transferred without the Company's written consent having been obtained.
