Mr. Baez:

It is my understanding that on Friday, July 25, 2008 you requested that members of the Orange County Sheriff's Office contact me about possible use immunity for your client if she were to make another statement to law enforcement concerning her daughter Caylee Anthony.

The investigators advised that you did not disclose the nature of what testimony your client may give. In turn, I agreed to meet with you to discuss this matter but would expect that you could proffer anticipated testimony before any further discussion of immunity would take place.

To date, I have not heard from you on this issue. Nevertheless, the matter was pursued further by my office in hopes of actually moving forward to find this child. We are prepared to discuss giving your client use immunity for truthful testimony that would lead investigators to the child. However, we would require your client to waive, in writing, derivative use of any evidence obtained as a result.

As you have stated in your pleadings, time is of the essence. While I will be out of town on a family matter beginning tomorrow, Robin Wilkinson, Homicide Division Chief, and Joseph Cocchiarella, Felony Bureau Chief, are prepared to discuss this with you immediately.
