Privacy Policy

The Blue Card is sensitive to the privacy of those that visit our web site. We recognize the need for appropriate protections and management of your personal information that is provided to us via this Web site. The Blue card has therefore established this Privacy Policy to assist you to understand what information we collect and how that information is used.

This Web site is owned and controlled by The Blue Card. By accessing this Web site, you acknowledge the terms and conditions set forth herein. We reserve the right to change these policies from time to time, without notice and at our sole discretion.

1) What personally identifiable information does The Blue Card collect from you?

In general, you can visit The Blue Card Web site without telling us who you are or revealing any personal information about yourself. We track visiting domains, internet addresses of the domains from which people visit us to track a user's session and the user's browser also lets us know the type of computer and operating system being used. This allows us to analyze the information as to which parts of our site users spend their time and their length of stay but does not give us any personal information about the user. Specifically, a user's session will be tracked, but the user will be anonymous. The Blue card does not knowingly collect or maintain any personal information from children under the age of 13. In addition, no part of our sites is designed with the purpose of attracting any person under age 13.

Sometimes however, we will ask you to voluntarily provide information about yourself. Generally this information is requested when you are asked for one or more of the following: 1) signing up for a mailing list 2) filling out a contact form. Occasionally, we may use this information when we notify you about important changes to the Web site. The Blue Card does not collect any personally identifiable financial or health-related information. However, you may be asked to provide information, including but not limited to, your name, e-mail address and postal address.

2) How does The Blue Card collect information and use information collected?

The Blue Card is the owner of the information collected on this site. We will not sell, share, trade or rent this information to others in ways different from what is disclosed in this privacy policy. The Blue Card collects information from several points on our website.

Unless you otherwise consent, we will use your personal information only for the purpose for which it is submitted, such as to reply to your emails, handle your complaints, and process billing and business requests related to program participation, and we will use such information to provide operational notices, in program record-keeping and to conduct research on industry marketplace practices. Our research may lead to the publication of aggregate demographical data but will not result in the reporting or publication of any personal information provided to us. At certain points where personal information is collected on our site, there may be a box where you may indicate you would like to be on a mailing list to receive information about other Blue Card programs and services and about ways to support The Blue Card.

4) What options do you have regarding collection, use and distribution of your information?

5) What security measures does The Blue Card have in place to protect personal information?

This Web site takes every precaution to protect our users' information. All of our users' information is restricted in our offices. Only employees who need the information to perform a specific job are granted access to personally identifiable information. The servers used to store personally identifiable information are kept in a secure environment.
