



RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO  
(1) APPROVING A FREEWAY AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR FREEWAY 180 FROM CHESTNUT AVENUE TO 0.4 MILES WEST OF TEMPERANCE AVENUE AND (2) AUTHORIZING THE PUBLIC WORKS DIRECTOR OR HIS DESIGNEE TO SIGN THE AGREEMENT ON BEHALF OF THE CITY OF FRESNO

WHEREAS, on December 18, 1963 the California Highway Commission, by resolution, declared that the future alignment of State Highway Route 180, from Brawley Avenue to 0.1 miles west of Highland Avenue be designated a freeway; and

WHEREAS, the California Transportation Commission, on January 17, 1996, in Resolution HRA96-4, rescinded a portion of State Highway Route 180 as a freeway from North Fowler Avenue to 0.1 miles west of Highland Avenue, previously adopted December 18, 1963 and adopted a segment of State Highway Route 180 as a freeway from North Fowler Avenue to 0.2 miles west of De Wolf Avenue; and

WHEREAS, the State of California and County of Fresno have entered into a Freeway Agreement dated March 25, 1969, relating to that portion of State Highway Route 180 between First Street and 0.3 miles east of Clovis Avenue; and

WHEREAS, the City of Fresno has subsequently annexed certain areas including portions of subject freeway covered by the Freeway Agreement between the State of California and County of Fresno dated March 25, 1969; and

WHEREAS, this agreement supersedes in its entirety the Freeway Agreement between the State of California and the County of Fresno dated March 25, 1969; and

WHEREAS, this agreement supersedes that portion the Freeway Agreement with the County of Fresno, dated January 11, 2000 from Chestnut Avenue to 0.4 miles east of Temperance Avenue; and

WHEREAS, no freeway agreement exists from 0.3 miles east of Clovis Avenue to 0.4 miles west of Temperance Avenue; and

WHEREAS, a revised plan map for the subject freeway segment from Chestnut Avenue to 0.4 miles west of Temperance Avenue has been prepared showing the State Department of Transportation plan as it affects City of Fresno streets; and

WHEREAS, it is the mutual desire of the parties hereto to enter into a new Freeway Agreement in accordance with the revised plan of said freeway.

NOW, THEREFORE, IT IS RESOLVED BY THE COUNCIL OF THE CITY OF FRESNO AS FOLLOWS:

1. The City Council approves the Freeway Agreement with the California Department of Transportation for Freeway 180 from Chestnut Avenue to 0.4 miles west of Temperance Avenue.
