


Mission

American College Test Results

The composite student ACT score is the average score of the number of students tested in Reading, English, Math, and Science Reasoning during their junior or senior year. A perfect score is a 36. The ACT was taken by 67% of Wisconsin graduates with an average composite score of 22.3; 73.6% of Greendale graduates took the test.

The WKCE is administered in the fall semester to all public school students in Wisconsin. The percentages represent the number of students scoring proficient or advanced on the state assessment.

Advanced Placement Results

Advanced Placement (AP) Testing is offered to high school students through The College Board. Earning a 3 or higher on the test qualifies students for placement or credit for college courses at most universities. 192 students took 335 AP exams. 83% earned a 3 or better.

Senior Scholarships Awarded

Class of 2010 received over \$1,300,000 in scholarship awards.

Post Graduation Plans

Over 95% of the Class of 2010 planned to attend a two-year or four-year college.

Financial Information

Increase in All-Funds expenditure budget of 5.44% over last year.

Increase in mill rate over last year from \$11.42 to \$12.23 per thousand of equalized value which results in an increase of approximately \$162 on a \$200,000 home before state levy credits are applied.

State aid increase of \$559,043, or 5.6%, from prior year.

Tax levy increase of 1.67% from last year.

Moody's Rating Service upgraded the district's bond rating to Aa3 in 2007 saying, "The Aa3 rating and upgrade reflects the district's well managed finances characterized by sound reserves, mostly mature suburban Milwaukee tax base and average debt burden with no future borrowing plans. Moody's expects the district's financial position to remain sound due to the presence of healthy reserves and prudent financial management as evidenced by strong forward financial planning."
