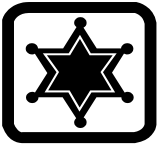

It gives me great pleasure to bring you a report of the work this past year by the almost two thousand men and women of the Shelby County Sheriff's Office. Our employees have dedicated themselves to bring the department to new levels of service and dedication.

It is always good to end a year in positive ways. In 2009, we noted an overall drop in crime of almost 7% in neighborhoods patrolled by Sheriff's Deputies. Federal judicial oversight of our jail ended in October after many years of intense scrutiny and many dollars spent.

To help our community, our employees exceeded their United Way contributions by raising almost \$88,000. The Sheriff's Office also raised enough money through our charity golf tournament to benefit students at Klondike Elementary School, assist two needy juvenile outreach programs and avoid any layoffs due to budget cuts.

As we enter 2010, I want to thank you and our fellow citizens by assisting us to report crime and work in partnership with us through community associations and neighborhood watch groups. It is this spirit of cooperation that helps make the Sheriff's Office so unique and highly regarded by our citizens.

## **Shelby County Sheriff's Office Mission Statement**

The Shelby County Sheriff's Office is a full-service law enforcement agency and the pre-trial custodial keeper of those who are charged with crimes.

It is the mission of the Shelby County Sheriff's Office to protect the lives and property of the citizens of Shelby County, Tennessee, to preserve the peace, to maintain a safe and secure jail and to prevent crime and disorder while constantly guarding personal liberties as prescribed by law.

This must be done with honor and integrity, while conducting ourselves by the highest fiscal and ethical standards to maintain public confidence.



## About The Shelby County Sheriff's Office

**T**he Sheriff, as set forth by the Tennessee State Constitution, is the chief law enforcement officer of the county. The Sheriff's Office works in partnership with all law enforcement agencies throughout the 775 square miles of Shelby County.

**A**lthough various cities within the county have their own police forces, Sheriff's Deputies are a vital resource for each of these agencies. Deputies serve arrest warrants, patrol the streets and share responsibilities with these police agencies through "Metro" and "Task Force" units. As an example, the Metro D.U.I. Unit is comprised of officers from the Sheriff's Office and Germantown Police Department. Other deputies serve on various federal task forces regarding narcotics, retail theft, theft from transportation companies and internet crimes.

**O**ther law enforcement duties fulfilled by the Sheriff's Office include capturing fugitives, serving court documents and providing courtroom security in the General Sessions, Criminal, Chancery, Circuit and Probate courts.



## Protecting those in our care and custody at the Shelby County Jail

**T**he Sheriff's Office operates the Shelby County Jail. There are two facilities, one for men downtown at 201 Poplar and the other for women in East Memphis at 6201 Haley Road. Juveniles facing adult charges are also housed in separate areas at the Shelby County Jail.

**C**lose supervision is given to inmates to ensure their physical, mental, and spiritual needs are met while awaiting trial. The jail is a resource for all Shelby County municipalities.

**S**taff training and operational standards are constantly monitored to ensure those in our care are provided safe living conditions and fair treatment.



## Significant Events at the Sheriff's Office January-December 2009



### January

- Deputies arrested ten people and issued 117 traffic violations during a traffic enforcement initiative on New Year's Day
- Burglars smashed through the front window of an east Shelby County convenience store and stole an ATM machine
- Deputies and Emergency Services volunteers searched the riverbank near the Interstate 40 Bridge for a man feared to have committed suicide. His body was never recovered
- Three cars were damaged after someone hurled rocks at them from a bridge along Highway 385
- Snow and Ice weather caused more than ten crashes on Highway 385 and other Shelby County streets
- Fourteen Reserve Deputies and thirty-four Corrections Deputies graduated from the Sheriff's Office Training Academy
- Three gang members were arrested by Narcotics Deputies after guns and drugs were found in their Binghampton home

### February

- Sheriff Mark H. Luttrell, Jr. was presented the *Ferris E. Lucas Award for Sheriff of the Year* by the National Sheriffs' Association
- Deputies assisted the F.B.I. with the arrest of 20 people suspected of being part of a drug cartel
- Sheriff's Office Bomb Technicians assisted the West Memphis, Arkansas Police Department when a medical doctor was critically hurt after a car bomb exploded
- Metro D.U.I. Squad Officers issued 301 violations during traffic safety initiatives
- Shelby County Corrections Deputy Sharon Milburn was recognized as "Corrections Officer of the Year" by the American Jail Association
- ALERT Squad Deputies arrested four people after raiding five stores that sold counterfeit merchandise
- Sheriff's Narcotics Officers arrested a man after they raided a convenience store that was used as a front for a marijuana growing operation

### March

- **Deputies discovered guns and stolen property stored at a Northaven daycare center**
- **Metro D.U.I. Squad Officers arrested twelve clerks who sold beer to minors at area convenience stores**
- **A man committed suicide after he murdered a former glamour model who lived in Bartlett**
- **Deputies arrested two men for running a gambling operation at a Shelby Forest convenience store**
- **Metro D.U.I. Squad officers issued 248 traffic violations during two safety initiatives**
- **Sheriff's Narcotics Deputies arrested a man who ran a pot farm from his midtown home**

### April

- **Metro D.U.I. Officers arrested ten clerks for selling alcohol to minors at area convenience stores**
- **Sheriff Luttrell and Deputies from several Sheriff's Office bureaus took part in the annual "Fallen Heroes Memorial Service" at Memorial Park Cemetery**
- **Thirty volunteers began their service as technicians in the Sheriff's Office Emergency Services Bureau**
- **Metro D.U.I. Squad Deputies issued more than 159 traffic violations during an enforcement initiative**
- **Deputies arrest a man for selling more than \$60,000 worth of counterfeit merchandise**
- **A man barricaded himself for several hours inside his apartment as Deputies attempted to serve a domestic violence warrant. The suspect later surrendered to SWAT and Sheriff's Office Hostage Negotiators**

### May

- Sheriff Luttrell and other members of the department remembered the 13 Officers from the Sheriff's Office who died in the line of duty at the annual "Fallen Heroes Memorial Service" at Memorial Park Funeral Home and Cemetery
- The Memphis and Shelby County Optimist Clubs honored Sergeant Travis Taylor as "Deputy of the Year"
- Metro D.U.I. Squad Officers issued 215 traffic violations during safety initiatives
- Sheriff's detectives arrest a Memphis man for robbing an Indiana bank

### June

- The Shelby County Jail's MRT program was recognized as a national model for inmate rehabilitation
- A double shooting near Millington left a woman dead and a man critically injured
- The Metro D.U.I. Squad issued more than 400 traffic violations during an enforcement initiative
- Twenty-two people graduated from the Sheriff's Office Citizens' Academy
- Sheriff's Deputies and Emergency Services volunteers assisted the community when a tornado hit the Shelby County area

### July

- Deputies searched for a man who raped a woman in her Cordova apartment
- Deputies watched for people “texting” while driving after a new state law took effect
- The Sheriff's Office took part in the Southern Christian Leadership Conference's national “Teen Summit”
- Eleven teenagers graduated from the Sheriff's Office Explorers Academy
- The Sheriff's Office assisted in the shut down of a Millington area bar determined to be a “public nuisance” by the Shelby County District Attorney's Office
- The Sheriff's Office and Memphis Area Legal Services teamed up to educate people about foreclosures and evictions

### August

- Sheriff Luttrell, his command staff and Deputies from several Sheriff's Office bureaus visited more than 20 neighborhood meetings that held “National Night Out” activities
- Shelby County Jailers and students who visited Memphis from the University of Florida took part in lots of activities to benefit students at Klondike Elementary School, the Sheriff's Office “Adopt-A-School”
- The Tennessee Bureau of Investigation released a composite of the serial rapist who raped a Cordova woman and two others in Martin, Tennessee
- The Metro D.U.I. Squad issued more than 200 violations during traffic safety initiatives

- **Thirty-five full-time Deputies graduated from the Sheriff's Office Training Academy**
- **A woman was killed and her son critically injured when a car collided with an empty school bus on Hacks Cross Road at Shelby Drive**
- **The Memphis Kiwanis Club honors Sergeant Travis Taylor as "Deputy of the Year"**
- **A mother and her 8-month-old unborn son were murdered at her Arlington home by her ex-boyfriend**
- **A man was killed when his car veered off the road and crashed into a tree on Holmes Road**
- **Sheriff's Detectives assist in the indictment of 30 people on various felony charges**

### October

- **Sheriff's detectives arrested a physician for sexually molesting a nurse who works with him at a local hospital**
- **Sheriff's Narcotics Deputies, assisted by Tipton County Deputies, arrested a man for storing stolen property and methamphetamine at his house near Millington**
- **Officials from the county jail in Lubbock, Texas visited the Shelby County Jail to adopt "best practice" policies and operating procedures**
- **Sheriff's Deputies raid the Memphis Animal Shelter after complaints were received about possible animal abuse**
- **A pit bull dog attacked and seriously injured a woman and her dog as they walked in their Cordova neighborhood**

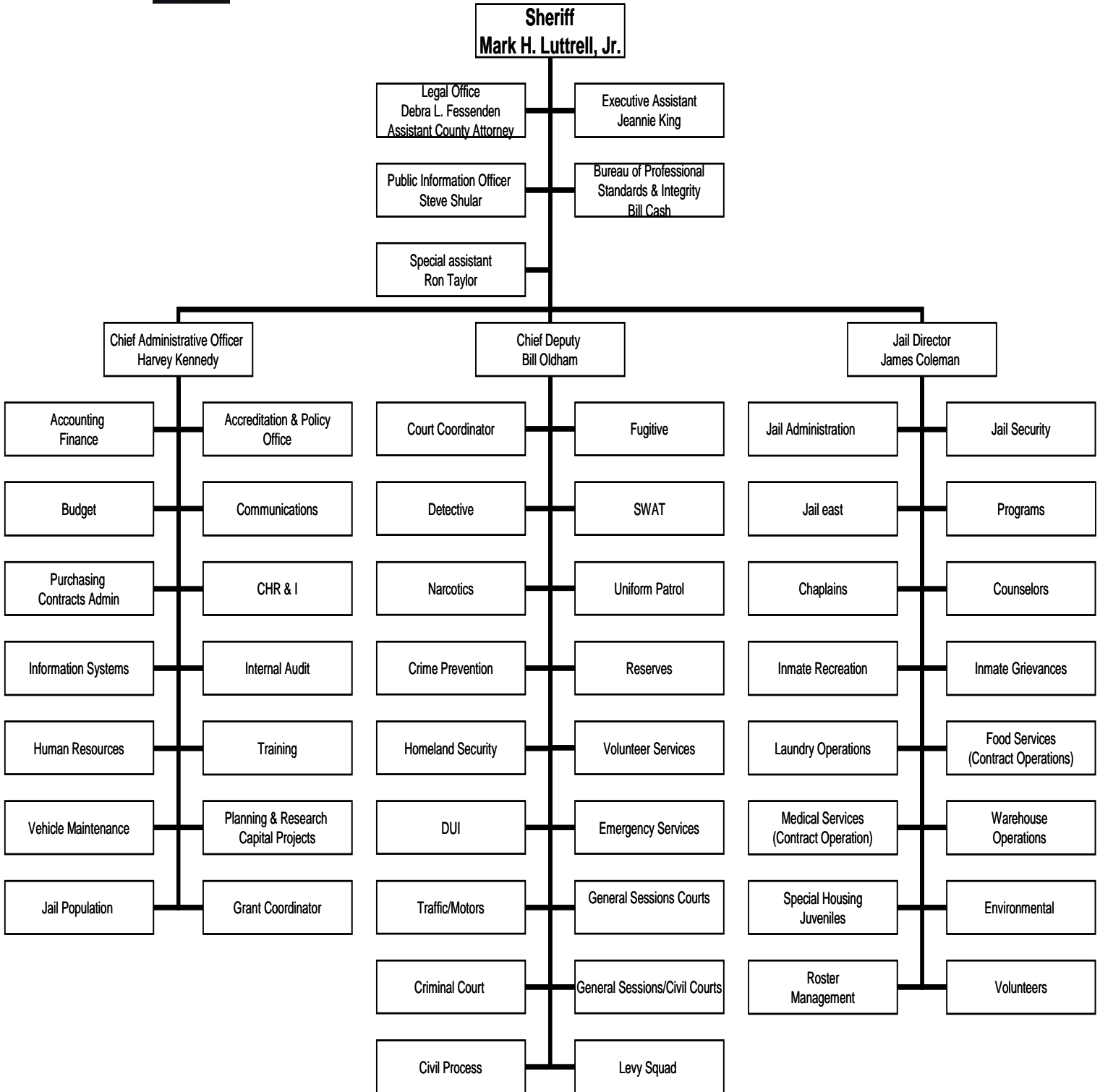


### November

- Sheriff Luttrell announced new crime prevention and intervention initiatives to help combat juvenile crime

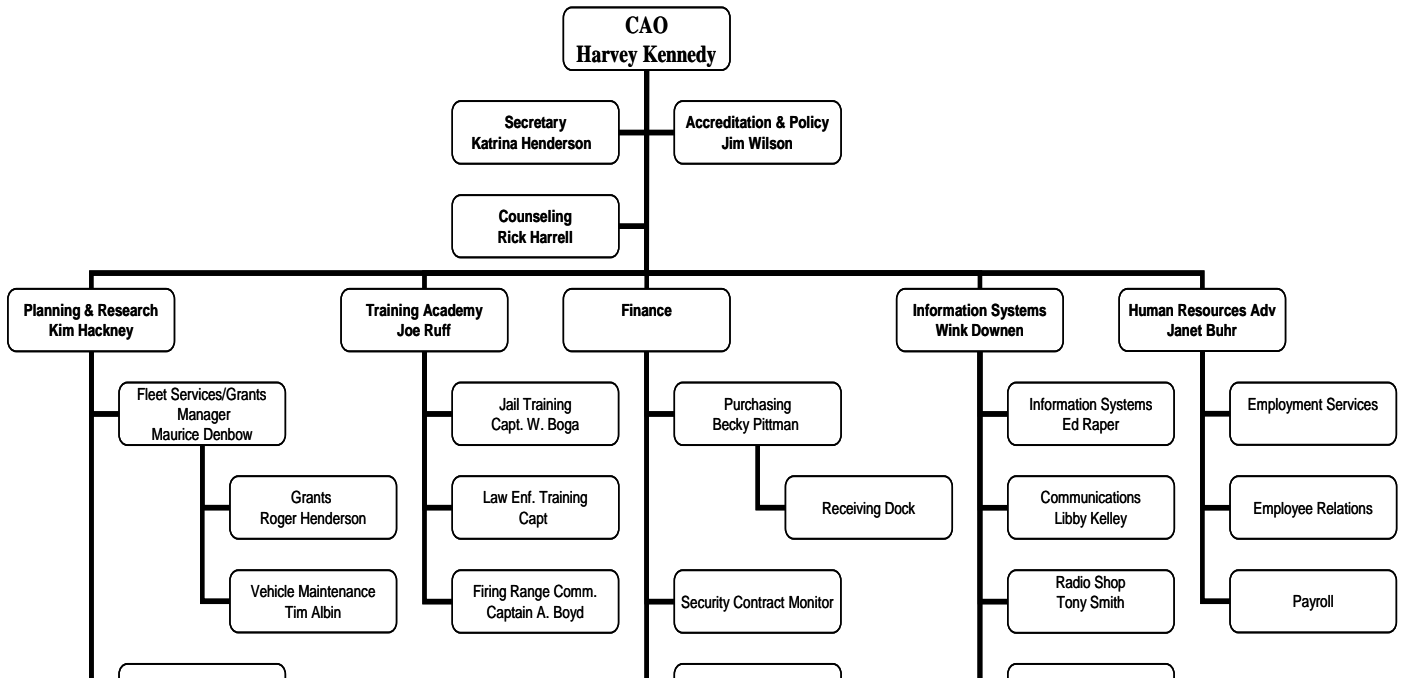
### December

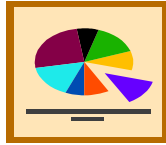
- Klondike Elementary School honors the Sheriff's Office with a "Thank You" party for its assistance to students during 2009

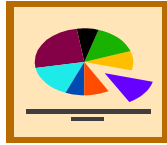

**In February, the National Sheriffs’ Association (NSA) chose Shelby County Sheriff Mark H. Luttrell, Jr. “*Sheriff of the Year.*” The award designated Sheriff Luttrell as the top Sheriff in the association’s membership of 20,000.**

**The award specifically mentioned Sheriff Luttrell’s leadership to get the Sheriff’s Office law enforcement division, the men’s and women’s jails and the medical units at the facilities nationally accredited.**

**“I feel honored and enjoy working with the dedicated staff of the Sheriff’s Office which led to this award,” said Sheriff Luttrell.**

**In June of 2008, the Shelby County Sheriff’s Office received the “*Triple Crown Award*” from the National Sheriffs’ Association for demonstrating outstanding commitment to public safety, security and well-being of jail inmates and efficient business practices.**

**Optimist Club “Deputy of the Year” and  
Kiwanis Club “Deputy of the Year”**

In May, the “Respect for the Law Committee” of the Memphis and Shelby County Optimist Clubs named Shelby County Sheriff’s Office **Sergeant Travis Taylor** “Deputy of the Year.”

The Optimist Club has, since the 1960s, given awards to deserving officers for their exemplary service to the community. **“We are grateful to the Optimist Club for taking time to honor Sergeant Taylor. He is an excellent officer and truly exemplifies the professional standards of the Shelby County Sheriff’s Office,”** said Shelby County Sheriff Mark Luttrell, Jr.

Sergeant Taylor is assigned to the Sheriff’s Office Special Operations Bureau, *FBI Gang Task Force*. Sergeant Taylor led two major drug investigations last year, *Operation Titan* and *Operation Jetta*. *Operation Titan* concluded with 70 arrests and the seizure of 6,000 pounds of marijuana. Additionally, twelve criminal enterprises involving street gangs, drug trafficking, alien smuggling and prostitution were dismantled or disrupted.

During *Operation Jetta*, also a drug case, 23 people were arrested and 40 kilograms of cocaine were seized along with 15 firearms. A marijuana growing operation was also dismantled as well as several drug trafficking enterprises.

**“Every detective assigned to these investigations has stated that Sergeant Taylor has improved their ability as investigators and taught them valuable lessons that will improve and assist them for their entire careers. His outstanding mentorship will be felt in the department for decades to come,”** said Inspector Mark Dunbar, who commands the Sheriff’s Special Operations Bureau.

Sergeant Taylor was also chosen “Deputy of the Year” by the Memphis Area Kiwanis Clubs during 2009.

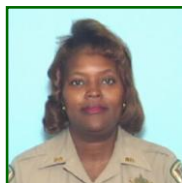

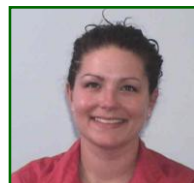

## Training Academy



The fundamental mission of the Sheriff's Office Training Academy is to provide professional training curriculums designed to improve the quality of regional law enforcement and correctional services. The Sheriff of Shelby County, the Director of Training and the staff provide practical application in all segments of basic, in-service and specialized training.

All officers must attend a forty-hour basic Peace Officer Instructor Development School. The curriculum has been certified and approved by the State of Tennessee Peace Officer Standard and Training Commission. Some of the schools held at the academy are:

- Enforcement procedures for full-time deputies and reserve deputies
- Correctional Facility Training procedures for deputy jailers
- Required "In-Service" refresher training held each year for full-time deputies, reserve deputies, and deputy jailers

**Information Systems is a support unit of the Administration and consists of:**

**Communications, Records and Identification, AFIS (Automated Fingerprint Identification), Jail Population Management, Compstat (Computer Crime Statistical Reports), Report Center and Information Systems.**



### **Communications Section**

**In 2006, the Sheriff's Office made great strides with the department's two-way radio communication system. Significant progress was made in up-grading equipment. The new system is now fully operational.**



### **Compstat Report Center**

**The report center generates crime reports and arrest documents. This bureau, housed at the Sheriff's Office Crime Analysis Center at the Criminal Justice Center at 201 Poplar, greatly assists the department in documenting crime incidents.**



## Records & Identification

**The Shelby County Sheriff's Office Records and Identification consists of two components:**

- **The records unit serves as the keeper of criminal arrest records for the Shelby County Sheriff's Office and the Memphis Police Department. This unit's primary function is to maintain, update, and release criminal arrest information to the public and law enforcement agencies**
- **The technical unit has the primary responsibility for the positive identification of all arrested persons and suspects which involves fingerprint classification, verification, and analysis**

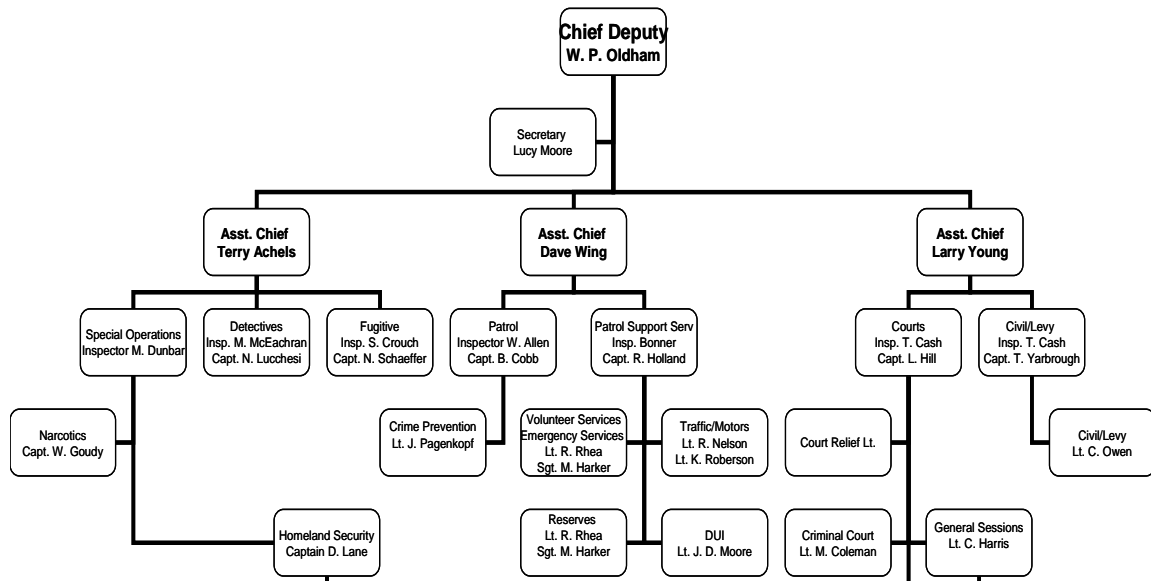
## Calls for Service In 2009

## Law Enforcement Initiatives to **Combat** Crime



The Sheriff's Office continued tracking crime in 2009 through the "Data Smart Policing" program tracked by the Crime Analysis Bureau.

Commanders from all Sheriff's Office bureaus used the tracking system to know the **location, specific time** and **day** certain crimes occurred. Weekly meetings were held by bureau commanders to discuss the crime trends so officers, both uniform and undercover, could respond to neighborhoods needing the most attention. The Public Affairs Bureau then shared the statistics with neighborhood association leaders and the news media. Deputies in the Crime Prevention Bureau then conducted meetings throughout Shelby County neighborhoods to discuss the trends and ways residents could reduce their chances of being victims of crime.

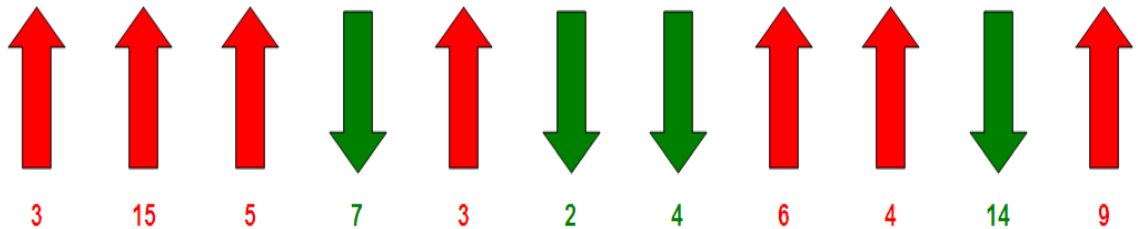

### Enforcement Tactics



#### Patrol Bureau

- The Uniform Patrol Bureau's new FTO (Field Training Officer) program was put to the test in 2009 with the graduation of the new recruit class in September. While there will be further enhancements & modifications made to the program, overall it was a success & has resulted in better trained field deputies
- In May, the Uniform Patrol Bureau conducted the "*Shelby County Sheriff's Office Citizen Survey*". One thousand Shelby County citizens that had a recent interaction with a SCSO Deputy were randomly selected & asked to rate the division's performance & other measures. The responses revealed an overall positive response of **91%**
- The Uniform Patrol Bureau added 27 new CIT (Crisis Intervention Team) trained Deputies to the patrol shifts. These special trained deputies respond to calls involving mentally distressed people
- The specialized P.C.R.U. (Patrol Crime Response Unit) has continued from its success in 2009 and made **146** arrests for burglary, theft & other crimes
- Patrol Bureau commanders continued to watch the "Hot Spots" for criminal activity in Shelby County and respond with specific tactics. Their efforts helped lead to an almost 7% drop in the crime rate in the more serious crimes investigated by Deputies

## 2009 Accomplishments Snapshot



### Traffic Bureau



- During 2009, the goal of the Traffic Division was to keep Shelby County roads as safe as possible. That was accomplished by tougher enforcement actions. Citations were up 23 %. Additionally, Deputies issued an additional 14.9 % in Courtesy Citations over 2008
- Officers conducted 86 “enforcement saturation” events which focus on seat belt usage and other violations, an increase of 17.8%
- The Tennessee Governor’s Highway Safety Office, once again, recognized the Shelby County Sheriff’s Office for the outstanding efforts in aggressive traffic enforcement, recognizing problems, and correcting traffic related issues

## 2009 Accomplishments Snapshot



### Metro D.U.I. Squad

- The Metro D.U.I. Unit is comprised of officers from the Sheriff's Office and the Germantown Police Department. Total arrests for impaired driving decreased in 2009. More and more drivers realize officers are taking the "zero tolerance" approach to impaired driving
- Working undercover throughout the year, officers conducted **7** "Beer Stings." Officers and underage persons visited **136** liquor stores, grocery stores, bars, convenience stores and other businesses checking for alcohol sales to minors. Of the businesses checked, **63** clerks sold beer and/or alcohol to people under the age of 21
- D.U.I. officers also conducted **4** adult and **11** youth impaired driving educational programs
- Officers personally visited **4** prom night events and conducted traffic saturations in the area of prom night events to discourage students from using alcohol and conducted **23** additional traffic enforcement saturations during holiday periods in an effort to decrease injuries and deaths related to driving under the influence of intoxicants



**"Project Safe Prom"** was conducted at Shelby County High Schools. Students, teachers and parents got to experience "virtual reality" of driving under the influence. They drove golf carts through an obstacle course using "blurred vision" goggles that simulated the sensation of driving drunk. Special "impaired driving" demonstrations were presented at several schools during prom season to remind students about safe driving and the dangers of impaired driving. D.U.I. officers also personally visited prom night events to discourage students from using alcohol.

## 2009 Accomplishments Snapshot



### Detective Bureau

The Detective Bureau followed up the outstanding performance of 2008 by surpassing virtually all of the statistical benchmarks set last year. Innovative operational procedures such as the Crime Scene Team concept provided the impetus for an aggressive approach to criminal investigations. The team concept and cooperative efforts of both Personal and Property Crimes detectives likewise contributed to the achievements in overall crime reduction and successful prosecution of perpetrators. Training was also a factor in that a number of detectives attended specialized criminal investigation classes and have applied that knowledge to their jobs. No review of accomplishments would be complete or accurate if it did not include a very specific recognition and commendation to the men and women of the Detective Division whose work ethic and esprit de corps have made this success possible

- The national clearance rate for all agencies according to FBI Uniform Crime Report has risen to the 19 percentile. The SCSO Detective Division reached and exceeded the 34 percentile

### Detective Bureau



- The Personal Crimes Detectives continued the success of 2008 with 100% of Homicide cases in Shelby County being positively cleared in 2009



- The Detective Division “Case Officer/Crime Scene Investigative Unit” that was implemented in 2008 has proven to provide an effective and very efficient crime scene command and control unit delineating specific responsibilities. This was an integral part of the perfect clearance rate for Homicides and the overall 34.2% for the Division



- **Detectives have been provided with enhanced technological and cyber-crime training to effectively utilize the ever evolving computer related tools available**

### Detective Bureau



- **Additional emphasis has been placed on intra-departmental cooperation and communication with special kudos to Chris Harris, Chip Bartlett and all of the Street Crimes officers as well as Det. Bierbrodt with the White Collar Crimes Task Force who have continued to provide invaluable assistance on numerous investigations**



- **In 2009, there were Two Hundred Eighty Seven (287) items of pawned property located by the Detective Division. The total amount of recovered property exceeded \$90,100.00. There were 65 subjects charged with theft or burglary in Shelby County and a further 32 individuals charged in other jurisdictions**

- An inner office blend of Personal and Property Crimes Detectives was created with the acronym IMPAACT which had considerable success with pro-active initiatives and research projects culminating in numerous arrests and successful prosecutions



## 2009 Accomplishments Snapshot



### Detective Bureau



- Domestic Violence, Elder Abuse & Sex Crimes were removed from the Personal Crimes umbrella & placed under separate command in order to enhance productivity through teamwork, training and communication. Shelby County Sheriff's Office entered in talks with management of the Family Safety Center, in regards to the participation in the project. The Family Safety Center is a community initiative to provide a "One Stop Shop" for victims of Domestic Violence & Sexual Assault. Once the center opens it will house 20 plus public and private organizations providing & coordinating services needed by victims of domestic violence and sexual assault. The facility will house 1 supervisor, 1 secretary and 6 DV/Sex Crimes investigators from SCSO, rent-free for 3 years. The movement of these personnel will free up much needed work space in the GIB offices and provide a more efficient service delivery and coordination of the appropriate services for victims of Family & Sexual Violence
- Investigators from the Sex Crimes Unit were instrumental in the capture of the "Big Belly" rapist. The investigation covered most of West TN & came to a conclusion in Weakley County Tennessee with the arrest of Bruce Tuck

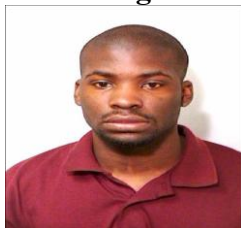

### Boyfriend Arrested in Pregnant Woman's Murder



Tarence L. Nelson

In September, Sheriff's Deputies arrested the boyfriend of a pregnant woman and her unborn child who were shot to death at her Arlington home. Tarence L. Nelson, 26, who lives in Murfreesboro, Tennessee, was charged with two counts of First Degree Murder.

He was arrested by Deputies with the Rutherford County Sheriff's Office. Shelby County detectives believe Nelson killed Tonya M. Johnson, 36, and her eight-month-old unborn child at 5686 Wolf Pack Drive. She was discovered dead in the living room by neighbors after they noticed an open garage door.

Deputies believe the shooting resulted from an argument involving the unborn baby. Witnesses gave statements to detectives indicating Nelson is the suspected father of Johnson's child and that he and Johnson had often argued about whether she should deliver the baby or have an abortion. Tarence Nelson remains at the Rutherford County Jail and will soon be brought back to Shelby County to face the double murder charges. Nelson, formerly of Memphis, has been previously arrested on theft of property and traffic charges.

#### **Shelby County Sheriff's Office Investigated Memphis Animal Shelter at the Request of District Attorney General-Facility Closed during the Investigation**

In October, Shelby County District Attorney Bill Gibbons and Shelby County Sheriff Mark Luttrell temporarily shut down the City of Memphis Animal Shelter located at 3456 Tchulahoma Road as part of an investigation into alleged animal abuse and cruelty. District Attorney Gibbons requested the Sheriff's Office investigation of the City of Memphis Animal Shelter after receiving a tip from a citizen on the conditions at the shelter.

Allegations were made that animals had been deprived of food and water. Additionally, the warrant said shelter employees kept dogs that are to be quarantined for rabies with dogs that are not required to be quarantined in the same kennel.

"The information we received about the conditions of the Memphis Animal Shelter clearly warranted a criminal investigation, and it is very possible that one or more individuals could face criminal charges based on the outcome of the investigation," said District Attorney Gibbons.

**"Animals bring comfort and compassion to countless families. Animals often depend on others for their safety and protection. Once we were contacted by the Shelby County District Attorney's Office, our detectives immediately investigated the allegations of possible abuse,"** said Sheriff Luttrell.

Animals brought to the facility during the raid were transferred to another shelter in Shelby County. Trained investigators with ASPCA (American Society for the Prevention of Cruelty to Animals) and emergency responders with the American Humane Association assisted deputies.

Volunteers from both ASPCA and the American Humane Association also cared for the animals while the shelter was temporarily closed for business.

**A.L.E.R.T.**  
**AREA LAW ENFORCEMENT AND RETAILERS TEAM**

The **A.L.E.R.T. Squad** is the Sheriff's Office special unit to investigate economic crimes. Began in 2004, detectives work closely with retail establishments, business owners, banking institutions, area home builders, other local, state, and federal law enforcement agencies to combat crimes associated with retail theft, fraud and counterfeit items. The unit also focuses on the growing problem of theft from construction sites and maintains a website for retail businesses and other law enforcement agencies. Suspect information, including store security pictures, is shared among the team.

### Investigation highlights:

In 2009, the ALERT Unit made 224 arrests, recovered ~~\$1,172,977.00~~ in stolen property, seized \$50,620.00 in cash, seized 10 vehicles, and recovered 13 weapons. The Unit also seized property that was used in criminal activity valued at \$52,350.00 and seized counterfeit merchandise with a street value of \$2,869,013.00

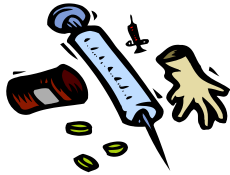

#### 2009 Case Highlights



- **“Operation Jetta”** was a multi law enforcement agency investigation led by the F.B.I. that dismantled a major Mexican drug trafficking organization. The investigation led to 23 arrests, 14 indictments, 52 kilos of cocaine, 15 firearms, \$3.2 million in cash and a marijuana growing operation
- Deputies initiated and jointly worked with Drug Enforcement Agency Agents in the largest illegal prescription case involving a physician in Tennessee. The defendant was responsible for illegally distributing almost 3 million narcotic pills in the Shelby County area. The doctor and another person were arrested and \$375,000 in cash and 2 vehicles were seized
- Sheriff’s Detectives jointly worked with the United States Postal Service Inspectors to shut down an illegal drug plant distribution ring. The plant, “Khat,” which is chewed or brewed like tea by users, produces euphoric “highs.” The investigation netted 10 arrests and 7,500 pounds of Khat which is shipped to the United States from the west coast of Africa. Also during the investigation, 10 vehicles and \$50,000 in cash were confiscated
- Two other joint law enforcement agency investigations involved the criminal gang, “Memphis Mob.” This cocaine operation was linked to several murders and an illegal cocaine distribution business. The case produced 6 Federal Indictments and 4 cold-case murders were solved. Additionally, Deputies confiscated \$100,000 in cash, seized several vehicles along with 150 kilos of cocaine

### **DISTRICT ATTORNEY'S OFFICE FILED PUBLIC NUISANCE ACTION AGAINST SHELBY COUNTY BAR; SHELBY COUNTY SHERIFF'S OFFICE, WEST TENNESSEE DRUG TASK FORCE CLOSE PROPERTY**

In July, Shelby County District Attorney Bill Gibbons and Shelby County Sheriff Mark Luttrell announced that agents with the West Tennessee Drug Task Force and Shelby County sheriff's Deputies closed a north Shelby County bar where rampant drug use and drug sales allegedly occur on a regular basis. The agents and deputies secured the property by court order after a public nuisance action was filed against the establishment's owner.

The D.A.'s Office filed a new nuisance action against Imbibrios Bar, located at 6353 Navy Road just outside of the Millington city limits. The nuisance action is the result of undercover investigations by the West Tennessee Drug Task Force and the Shelby County Sheriff's Office Narcotics Division. Environmental Court Judge Larry Potter ordered Imbibrios Bar temporarily closed and the bar's operator, Thorne Peters, ordered to court to answer to the allegations in the petition.

According to the petition filed against Imbibrios Bar, the Shelby County Sheriff's Office investigation began in November of 2008. Deputies conducted undercover operations inside the bar in which they observed blatant and repeated use of marijuana inside the bar by patrons and the bar's operator, Thorne Peters.

**“The Sheriff's Office will aggressively pursue those involved in drug trafficking. Our deputies have, and continue to investigate allegations of drug sales throughout Shelby County. Let this be a warning to any other persons involved in this kind of activity. We will find you and you will go to jail,”** said Sheriff Luttrell.

Last year, more than 1,000,000 visitors to the Shelby County Administration Building, Criminal Justice Center and the Shelby County Courthouse were screened for contraband.

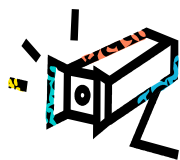

#### Deputies Arrested 48 During South Memphis Crime Sweep



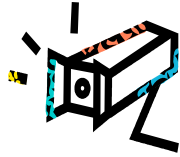
In August, Homeland Security Bureau Deputies organized a multi law enforcement agency initiative to target crime in south Memphis neighborhoods. **“We received calls from residents who asked for our assistance. After meeting with them, we analyzed crime data and designed a specific plan to address gang activity, illegal drug sales and other crimes,”** said Shelby County Sheriff Mark H. Luttrell, Jr.

Agents with the F.B.I. and United States Secret Service assisted Deputies in an area bounded by Brooks Road on the north, Shelby Drive on the south, Elvis Presley Boulevard on the east and Weaver Road on the west. The United States Marshal’s Service Task Force also worked alongside of Deputies to arrest fugitives.

Deputies with the Sheriff’s A.L.E.R.T. Squad (Area Law Enforcement Retailers Team) seized counterfeit merchandise from area businesses and flea market vendors. Other Deputies focused on traffic safety. Almost 200 traffic tickets were issued. Many reserve Deputies took part in the crime sweep along with Corrections Deputies from the Shelby County Jail who processed and transported prisoners. Volunteers from the Sheriff’s Office Emergency Services Bureau and an officer from the Memphis Animal Shelter also assisted in the crime suppression initiative.

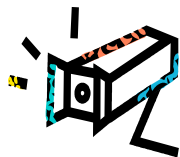

### Sheriff's Deputies and Police Agencies Round-Up Fugitives



In October, the Homeland Security Bureau organized a joint law enforcement agency initiative and arrested almost one hundred (100) people wanted on criminal charges.

For seven (7) hours, almost 200 Deputies, Officers and support personnel looked for more than 1400 fugitives known to frequent north Shelby County, particularly neighborhoods in the 38127 and 38128 zip codes.

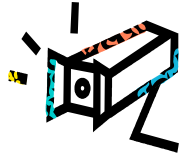
**“We appreciate Officers from several police departments assisting our Deputies. This kind of initiative reassures the public of our desire to help keep our community as safe as possible,”** said Shelby County Sheriff Mark H. Luttrell, Jr.

The 1,424 arrest warrants were split up among the various police agencies. Sheriff's Deputies and Memphis Police Officers fanned out to look for 1140 people wanted on charges involving their departments. Bartlett Police Department Officers targeted 190 persons, Germantown Police 48, Millington 35 and Collierville Police searched for 11 persons.

Coinciding with the fugitive round-up, undercover detectives with the Tipton and Shelby County Sheriff's Office jointly investigated reports of stolen property that have been linked to home burglaries and vehicle break-ins in both communities. During the round-up, Deputies and Officers also documented any criminal gang involvement of those arrested.



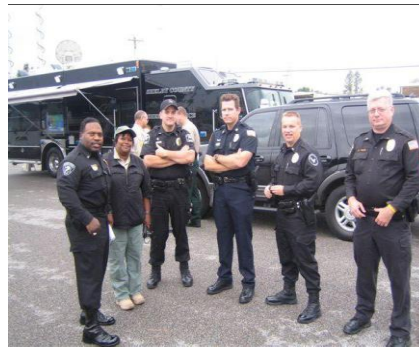

### Courts Bureau

- Court Deputies' positioning and demeanor inside the courtrooms were evaluated. Weekly inspections and closer supervision resulted in a more professional appearance and tighter security. New stools replaced chairs to give the deputies an elevated tactical advantage and provided a better alternate to rest during long court sessions
- Meetings with the Bar Association were scheduled to address security issues inside the courtroom that the attorneys could assist us with
- The Court Deputies' training was enhanced by adding on-site active shooting scenarios inside a courtroom in addition to the annual court specific training received in in-service
- New equipment to respond to active shooting situations in the courts were purchased and put into place. This allows the court deputies the equipment to address critical incidents until additional resources arrive
- Cameras have been funded for securing the judges arriving and leaving the building

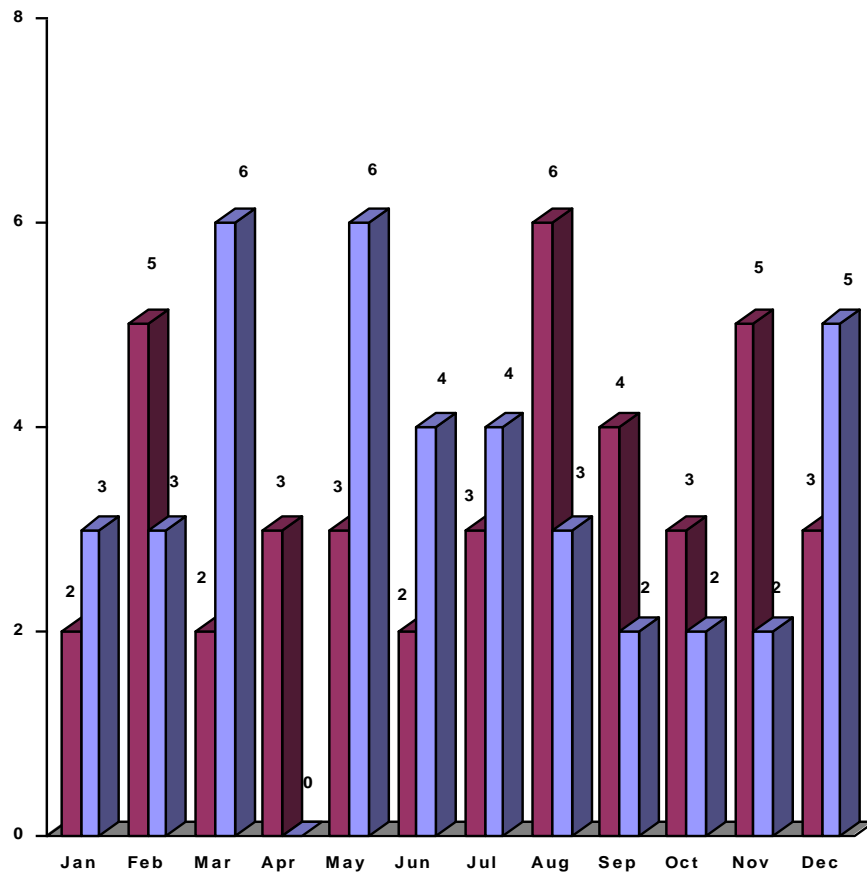

### Emergency Services

Another specialized group of volunteers work every day to help save the lives of people needing medical attention. These volunteers patrol the streets of Shelby County to assist with traffic crashes, respond to medical emergencies and conduct search and rescue missions.



### Special Services Squad

## **Major Accomplishments in 2009**

- For the first time in almost two decades, the Shelby County Jail was released from operational oversight from the United States Department of Justice
- The Shelby County Jail received re-accreditation from the ACA (American Corrections Association)
- New cameras were installed in the jail's maximum security area to better monitor movements of inmates and staff
- Two new transport vehicles and a handicapped accessible bus were added to the fleet
- Visitation procedures were updated to better serve families and friends of inmates
- Improvements were made in the "use of force" policy to better coordinate investigations involving shift commanders, unit managers and the Bureau of Professional Standards and Integrity
- A "stun cuff" was obtained to better manage the behavior of unruly inmates during court appearances

- A huge evacuation drill was conducted to test the effectiveness of internal staff and outside agency response should there be a crisis at the men's facility at 201 Poplar Avenue
- Each transportation vehicle is equipped with restraints for inmates at all times
- Correctional Officers established "book clubs" to help encourage reading among inmates
- A juvenile rehabilitation program director was hired to work with young inmates being held on "adult charges"
- Establishment of a comprehensive preventive maintenance program

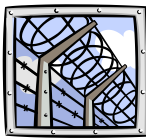

## Sheriff's Corrections Deputy Receives National Honor



Last year, a Shelby County Sheriff's Office Corrections Deputy was named "*Female Correctional Officer of the Year*" by the **American Jail Association (AJA)**. Officer Sharon Milburn, who works at Jail East, the women's facility of the Shelby County Jail, was recognized for creating a literacy program to help female inmates learn to read.

**"This calls attention to Officer Milburn's dedication to help those she serves and further emphasizes the Shelby County Sheriff's Office has one of the best operated jails in the nation,"** said Shelby County Sheriff Mark H. Luttrell, Jr.

Last year, Corrections Deputy Milburn took it upon herself to work with inmates with special needs, especially the illiterate. In one instance, she worked daily with a 20 year-old inmate who later, for the first time, learned to read. That story was featured in newspapers and on television stations which led people from across the nation to send Officer Milburn letters of encouragement and hundreds of books for the jail's library.

**"Officer Milburn has inspired many people through her efforts. She knows inmates who learn new skills while in jail are less likely to repeat their criminal behaviors,"** said Chief Jailer James Coleman.

Officer Milburn received her award April 29, 2009, at the **AJA Awards Banquet** in Louisville, Kentucky. Corrections Deputy Milburn has been with the Shelby County Sheriff's Office since 1997.

## Crime Prevention Bureau

The Shelby County Sheriff's Office Crime Prevention Bureau offers a variety of crime prevention programs and services to help residents and businesses reduce crime in the community.

The philosophy behind crime prevention is to increase citizen awareness with training in specific crime prevention measures. The intent of crime prevention is to reduce a criminal's opportunity to commit crime.

The Crime Prevention Bureau provides speakers on various topics such as Neighborhood Watch, Business Security, Child Safety, Senior Safety, and 22 other topics of interest. All programs are FREE to the public.

Crime Prevention also has the responsibility of all Shelby County Schools. We have seven (7) officers assigned to the high schools and three (3) officers assigned to the middle schools. The School Resource Officer's responsibilities are:

- Preventing juvenile delinquency through close contact with students and school personnel
- To establish a liaison with school principals, faculty, and students
- To participate in the parent-teacher-student meetings
- To provide security for all campus activities, student organizations, and athletic events
- To protect lives and property for the citizens and public school students
- To enforce all criminal laws, ordinances, and Shelby County Board of Education student conduct policies and administrative regulations
- To investigate criminal activity on or near school property
- To provide traffic control during the arrival and departure of students
- Make arrests or issue citations when laws are broken

## Keeping the Media Informed

- Planned and conducted a crime forum sponsored by the “Operation Safe Community” initiative
- Fielded 2,644 news media requests
- Attended 287 community association meetings
- Conducted 77 code-enforcement tours through Memphis and Shelby County neighborhoods
- Through a partnership with the Neighborhood Christian Center, 130 food baskets were obtained for the Special Services Bureau for home-bound citizens

**Fallen Heroes Service at Memorial Park Cemetery**



Memorial Park Funeral Home and Cemetery again hosted the *Fifth Annual Fallen Heroes Memorial Service* on Monday, May 4, 2009 at 9:30 a.m. The ceremony was held at the Fallen Heroes Monument, just west of the Poplar Avenue entrance to the cemetery.

Sheriff Mark Luttrell joined various mayors, chiefs of police, fire chiefs, other officials and dignitaries at the event. Last year, Memorial Park paid tribute to more than 80 family members representing law enforcement officers, firefighters and emergency workers who have given their lives for others since the late 1800s.

**“We were fortunate to have had Tipton County Sheriff J. T. “Pancho” Chumley as our keynote speaker. Sheriff Chumley shared comments about the loss of his brother, C. Lanny Bridges, who was killed in the line of duty while serving the Covington Police Department,”** said *Dennis Hamilton, General Manager of Memorial Park Funeral Home and Cemetery.*

The primary agencies recognized were the Memphis Police Department, Shelby County Sheriff’s Office, Memphis Fire Department, Tennessee Highway Patrol, Fayette County Sheriff’s Office and Covington Police Department.

## Shelby County Sheriff's Office Explorer Program

The Sheriff's Office Law Enforcement Explorer Program provides young people with first-hand knowledge of the inter-workings of the Sheriff's Office. Explorers attend two "post meetings" each month and perform 16 hours of service that include working within the various bureaus of the Sheriff's Office, monthly training and community service. In addition, those 16 years of age and older are eligible to ride periodically with Deputy Sheriffs on patrol. Explorers *do not* perform any law enforcement duties and are closely supervised while working with Sheriff's Office personnel.

### Membership Qualifications:

- Be between 14 and 20 years of age
- Have parental/ legal guardian approval
- Pass a criminal history background check
- Pass a physical assessment
- Obtain School Affiliation Letter
- Attend the Explorer Recruit Academy (seven week training session)
- Maintain a 2.0 grade point average in every school subject
- There is a one-time application fee of \$20.00
- Yearly dues are \$10.00



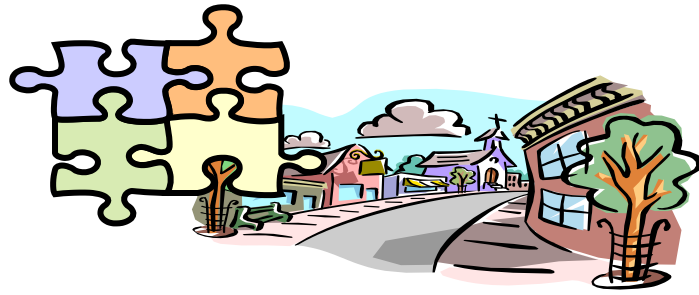

**Sheriff's Office Created New "Community Councils"**

During 2009, the Sheriff's Office helped organize and facilitate three new community partnerships in Memphis and Shelby County neighborhoods near South Memphis, Southeast Shelby County and LeMoyne-Owen College. The Sheriff's Office Public Affairs staff assisted with the facilitation of a similar partnership initiative a couple of years ago in the North Memphis area near Chelsea and Hollywood.

The "community councils" target neighborhood crime and code violations in the areas. The meetings are held monthly and attended by neighborhood association leaders and code enforcement inspectors from Memphis and Shelby County housing, health and zoning code bureaus.

The monthly "hot spots" meetings were recognized by The Commercial Appeal newspaper for their effectiveness in addressing crime and eliminating community blight.
