### **America's Homeless:**

### More Than Just a Project

Has your chapter been participating in projects to benefit the homeless this year? It's more than just the national president's project for this year; it's a national tragedy that we all need to think about and work towards solving.

This story recently appeared in the Wall Street Journal. I think it will shock you....

"One day last winter, a new neighbor appeared at a busy street corner in the affluent neighborhood of Lincoln Park (Chicago). The man sat down on a bus-stop bench, folded his hands and hunched his head, and there he remained, in the worst rains and bitterest cold.

"Whatever brought the homeless old man to that particular bench at Clark Street and Deming Place, he wouldn't say. He talked to almost no one, and he refused spare change or offers of help. He just sat, filthy and disheveled, day after day, stirring community unease and resentment.

"He told a priest his name was

Jim, but in his tattered ponch and gray beard, he looked more like an unwashed Moses. He warily guarded his piles of junk, stacked beside him in rusted shopping carts. To residents of his fashionable neighborhood, he was an eyesore who tested compassion, and prompted frequent complaints to the police.

"Even on subzero days, Jim was seldom invited into nearby stores; shopkeepers said his odor drove customers away. He shocked passers-by by urinating into plastic antifreeze jugs that he pulled under his poncho. And he infuriated many bridal parties by showing up uninvited for weddings at a nearby church.

The article continues in this vein, chronicling many residents attempts to dislodge Jim from his "home," describing his regular attendance at a nearby Catholic church. He once told a priest that he was of German descent and carried an ice pick under his poncho for protection. That was all anyone knew about him, but that was


far more than neighbors wanted to know. The residents of this affluent, yuppie neighborhood were outraged by his mere presence, and considered him a public nuisance to be gotten rid of, but were human enough to feel occasional twinges of guilt for this cold, indifferent behavior towards him.

Sadly enough, this is all too often the way our homeless are treated today, like so much garbage to be swept out of sight so we can go on with our own lives without having to feel guilty over someone's obvious misfortunes.

Even with all of our sisters across the country working together to help solve this problem, realistically we won't even put a dent in the hordes of homeless and their plight. But keep this in mind, sisters. If we save on person from freezing to death, if we feed a handful of people a hot meal someday, if we help one other human being regain his dignity, we have made a substantial contribution.

Keep up the good work.



Expansions Director (1 year)

Every office has two year terms. President, Treasurer, Publications Editor and Membership Director are elected in odd-numbered years. Vice President, Executive Secretary, Alumnae Administrator, and Expansions Director are elected in even-numbered years. Two NAA directors are elected every year.

This year, Alumnae Administrator Leanne Wells was unable to complete her term. Expansions Director Terry Beebe was appointed to serve as Alumnae Administrator, in addition to her current office, until elections. Terry has announced that she would like to finish the remaining year of office for Alumnae Administrator and plans to run for the office. Both the Expansions Director and Alumnae Administrator positions, therefore, will be available to candidates interested in completing the current office terms.

Who can run for office?

Any active member of a chapter and any ative alumnae.

Candidates for National President must have served for one year as a member of the National Executive Board.

- Candidates for National Alumnae Administrator must be an active alumnae.
- All candidates for National Office must have been an active of the sorority for a period of one year after their activation date.

Any member of the National Executive Board who is not an active member must be a lifetime member of the National Alumnae
Association.

How do I run for office?

You should send in a Petition for National Office to Executive Secretary Sally Craddock by May 15, approximately three months prior to convention. This shows serious forethought and your name and desired office can be published in the summer *Chevron*.

During the first day of business meetings at Convention, nominations are opened to the floor, and petitions can also be submitted at that time. Each nomination requires the acceptance by the nominee and a second.

When? Where?

Elections will be held at Summer Convention at Bowling Green on August 7. You do not have to be there in person, but it would probably help your campaign if you are.

Why would I want to run for office?

So you can continue to enjoy the sisterhood of your sorority while playing an active role in supporting the cardinal principles of Friendship, Leadership, and Service!







## Is Active/Inactive Enough For a Growing Sorority?

Several chapters have recently asked about the possibility of a new membership status recognized on a National level. Currently there are two statuses: active and inactive, defined in the constitution. The by-laws add another status: semi-active. However, there is a lot of confusion since several chapters also recognize as associate status. In addition. Delta has requested a status for sisters who are active on a local level but not on the national level. To further confuse the issue, we sometimes refer to "neophytes" when we are speaking of a sister who has not yet met all the qualifications for active membership. And then, of course, there are the pledges, who also have not yet completed all national qualifications for active membership.

I hope that every chapter will give some serious thought to this matter. With constitutional revisions up at convention, this will be a perfect time to add additional statuses to the constitution. When reviewing national statuses, however, keep in mind that the national constitution cannot distinguish between active/inactive status on the local level if the sister chooses not to be active on the national level. If a sister is not active by national standards, then she is inactive. Different levels of active participation can be redefined in any of a number of ways. I recommend the following:

Active-To be eligible for active membership a student must be duly enrolled in the college or university in which the chapter is located. Active membership shall be granted to those students having completed the National pledge requirements as prescribed by the National By-Laws (Art III, Sect 1 &2 of the constitution). Active members shall have the power to vote, decide chapter questions, to be delegates to convention, to hold office, to have a little sister, and to participate in chapter functions, both service and social. (Art III, Sect 1 of the by-laws).

Associate—An associate member shall be a member in good standing with the chapter who meets all national requirements as well as

those local requirements as defined by the individual chapter. Semi-Active—Delete all reference to this status from the constitution and by-laws.

Pledge—A pledge member shall be a student in the process of fulfilling requirements to become an active member. Until all requirements, both local and National, are fulfilled, the student would be considered a pledge. (Art III, Section 3 of the constitution).

Inactive—An inactive in good standing shall have no rights other than those expressly given to them by the chapter. An inactive in poor standing shall be denied these rights (Art III, Sections 2 & 3 of the constitution).

Lifetime—Lifetime membership shall be granted to any member who pays a fee as prescribed by the National Alumnae Association (Art III, Sect 4 of the constitution).


