1. Introduction

1.1 What is this Demographic Profile?

The demographic profile provides statistics and a description of the key population characteristics on Census Night 2006 (Tuesday March 7, 2006). There is information on the people who live in Lower Hutt City including their age, ethnicity, employment, income, their homes, and more. The demographics of the area can be useful to a wide range of people and organisations; from individuals and community groups, right through to businesses trying to identify their potential market, and service providers such as the Council.

1.2 Source of Data

The national Census of Population and Dwellings is carried out every five years by Statistics New Zealand. The area unit, territorial authority, and New Zealand information included in this Profile is from the 2006 Census data provided by Statistics New Zealand.

The totals for Petone and Stokes Valley have been generated from the area unit data. Data for the Wards is provided by Statistics New Zealand. Due to various rounding procedures, some of the area unit totals do not add up to the Ward totals.

1.3 Definitions and Terms Used

Geographical Areas

Meshblock is the smallest geographical area that Statistics New Zealand uses to process and release Census information. A geographic area defines a meshblock. In urban areas, meshblocks usually include either part of a street block or a complete street block. There are 1062 meshblocks within Hutt City.

Area Unit is the smallest geographic area included in the demographic profile. Area units are defined by Statistics New Zealand. Statistics New Zealand makes no attempt to have area units of equal size, either in terms of land area or population. In urban areas, area units generally represent a suburb or part of a suburb. Hutt City contains 43 area units. The 2006 data saw the addition of the area units of Tirohanga and Seaview Marina, both of which were not present in the 2001 census.

Petone is an aggregation of the area units: Wilford, Esplanade, and Petone Central.

Stokes Valley is an aggregation of the: Tawhai, Holborn, Delaney, and Manuka area units.

Wards are the boundaries used by Hutt City Council for electoral purposes. The six ward

boundaries in Hutt City encompass identified communities within the territorial authority boundary. The Local Government Commission must approve the final boundaries.

Territorial Authority is the area governed by a city or district council. New Zealand has 74 Territorial Authorities, 15 City Councils and 59 District Councils. The Local Government Commission considered the 'community of interest' when setting the current boundaries in 1989. For comparison, totals for Upper Hutt City, Wellington City, Kapiti Coast District, and Porirua City are included in this Profile.

New Zealand totals have also been included in this Profile for comparison.

Terms Used

Mean average is the sum of all the responses divided by the number of the responses.

Median average is the middle value of all the responses when the responses have been ranked from smallest to largest.

Total Response is a term used by Statistics New Zealand to describe when multiple answers were allowed for a Census question and all the responses have been included in the Census data. Percentages in the total response tables have been based on the population of the area rather than the total number of responses.

Usually Resident Population is a count of the people who usually live in the area. Statistics New Zealand also produces Census Night Population figures based on the number of people in the area on Census Night. This profile uses the Usually Resident Population rather than the Census Night population.

Workplace Population is based on the physical address where the person 'mainly worked', for the job that they 'worked the most hours in', rather than where a person lives.

1.4 Notes on Interpretation

Within Hutt City, meshblocks can be aggregated into area units, area units into wards, and wards into the territorial authority area. This is not the case for all territorial authority areas. For the majority of Census variables, this Profile includes totals for the geographical areas at area unit level and above.

The area unit and territorial authority data is randomly rounded to base three. The Petone, Stokes Valley, and ward totals may contain rounding errors carried forward from the area unit data. Statistics New Zealand randomly rounds all the Census data that it releases to base 3 to protect individual identities. The only data that does not get rounded are averages.

The random rounding is the reason that in some cases the totals for the same information do not

match. For instance, the territorial authority population for Hutt City is 97,701 but the total area unit population for Hutt City is 97,710. Statistics New Zealand provided both totals. In some cases, totals do not match the sum of individual area unit or category data due to the random rounding. The differences caused by this system do not materially affect the analysis in this profile.

The averages for Petone and Stokes Valley were calculated from area unit data and not the individual responses. There may be differences between the true averages and the averages calculated by this method.

The area units vary significantly in size. Some, such as Gracefield and Seaview Marina have a small population and so the percentages can over-exaggerate the actual numbers and/or changes over time. The change in population between 2006 and 2001 is an example of this. Seaview Marina had a 100% increase in population, but the population count only increased by 15. Homedale had the largest population increase (633) and a 25% increase. Therefore, caution must be used when comparison is made between the different area units. Due to the small population of Seaview Marina (only 15), this area unit is often excluded from the figures and discussions on comparisons between the different area units.

Between the 2001 and the 2006 Census, the area unit of Tirohanga was home to a large new subdivision, which resulted in a population of 1200 and Tirohanga being classified as an area unit.

Any comparisons with previous Census data are based on the 2006 Census boundaries. Where there has been a boundary change between the historic Census area and the 2006 Census area the historic data was recalculated (by Statistics New Zealand) to match the 2006 boundary.

Categories such as 'Not Stated' and 'Unidentifiable' are generally excluded from the tables in this Profile. This and rounding errors explains why some of the percentage tables do not add up to 100%. Total Response tables will also not add up to 100%.

Some Census data only includes the population that is aged 15 years and over. This includes the Income, Qualification, and Employment data. The Industry, Occupation, Workplace, and Means of travel to Work variables are also limited to only the portion of the population that is gainfully employed.

Statistics New Zealand states that there was approximately a 2.0% undercount in the 2006 Census, estimated at 81,000 people. No allowance has been made in this Demographic Profile for the undercount.

2. People

2.1 Population

Figure 1 shows that Lower Hutt City is the tenth largest territorial authority in the country. This is a drop from ninth place in the last Census.

2.2 Population Change


Hutt City experienced a population increase of 2,223 residents (2.3%) between 2001 and 2006. This is the lowest growth of any city in the Wellington region over this period and is significantly lower than New Zealand's overall population growth of 7.8%.

However, this growth is higher than growth between 1996 and 2001, when Hutt City's population was fairly static.

Figures 2 and 3 show that within Hutt City there are considerable differences in population growth between the individual area units. The area units Tirohanga, Homedale East, Taita South, Waiwhetu South, and Naenae North have all experienced significant growth. By comparison, Homedale West in Wainuiomata experienced significant decline, as did Belmont area unit. However, it is important to note that the change in Belmont is due to the reclassification of Belmont into both Belmont and Tirohanga.

2.3 Gender




Figure 4: Gender by Ward

Hutt City is identical to New Zealand in terms of gender breakdown. Like New Zealand, Hutt City has more females than males. Figure 4 shows that within the Wards, the greatest gender discrepancy occurs in the Central and Eastern Wards, with more females than the other wards.

Within the areas, the largest deviation from an even gender mix occurs in Woburn South where 55.7% of the population are female (Figure 5). In terms of the actual numbers the largest difference occurs in Hutt Central where there are 222 more females than males. Woburn South, Avalon West, Waiwhetu North, Hutt Central, and Boulcott also have a higher than usual proportion of females ranging from 53.9% to 53.0%.

Gracefield had the highest proportion of males, with 55.0%. However, this is due to the very small number of total residents in Gracefield. The actual difference is only six more males than females.

2.4 Age Profile

Hutt City, like New Zealand, has an aging population. However, unlike the previous census, the aging trend is now showing in all area units within Hutt City. In the previous census, the median age of some area units had been decreasing. Almost all the area units now show an increase in the median age, and only a few show no change. With respect to age distribution, Delaney has the highest percentage of children under five years old.

The Central Ward has the oldest average population of the six wards, shown in Figure 6 (39 years). This is not surprising as the Central Ward is predominately flat and is the closest to amenities such as the Central Business District (CBD) and Hutt Hospital. Within the Central Ward, the Hutt Central area unit has the highest proportion of residents aged over 65 years.

By comparison, Wainuiomata Ward and Northern Ward had the lowest median age (32 years). Within these two wards, Glendale, in Wainuiomata, has the lowest average age (median age of 28) followed closely by the Northern Ward's area unit of Taita North (median age of 29).




Figure 7: Age Profile

It is evident from Figure 7 that the median age in Lower Hutt is rising, with a number of area units showing a median age at 40 or higher. These are Avalon West at 47, Eastbourne and Haywards-Manor Park at 43, Hutt Central at 42, Woburn North at 41, and Woburn South at 40.

Figure 6: Median Age of Population by Ward

2.5 Ethnicity






Figure 9: Major Ethnic Groups

The Census ethnicity question allowed for multiple responses to be given. This meant that people could mark down every ethnic group that they felt they belong to. For this reason the values in the ethnicity tables do not add up to 100% or the total city population. The percentages in Figures 8 and 9 have been calculated on the basis of what percent of the population identified themselves as belonging to the ethnic group. However, the percentages in Figure 8 were created by recalculating the figures as a percentage of the total number of answers not the total number of residents (to total 100%).

Hutt City has a similar ethnic breakdown to New Zealand, with the vast majority identifying themselves as New Zealand European. The only significant difference is that Hutt City has a higher proportion of people identifying as belonging to "Pacific Peoples' Ethnic Groups", and a slightly higher proportion of people identifying as belonging to "Māori Ethnic Groups".

There is considerable variation in ethnic make up between the different wards and areas units. Figure 9 shows that the Western Ward is dominated by the European groups with "Other" ethnicity groups the next highest. The proportion of Māori in the Wainuiomata, Northern, and Eastern Wards are higher than for Hutt City as a whole. The Northern Ward also has a significantly higher proportion of Pacific Peoples. The largest proportion of Asians is found within the Central Ward.

At the area unit level, there are larger percentages of Māori in Glendale, Arakura (and most of urban Wainuiomata), Delaney, Taita, Naenae, Waiwhetu North, Gracefield, and Moera. By comparison, the Western Ward as a whole, Woburn North, Avalon West, Eastbourne, Korokoro, Hutt Central, and Waterloo West all have a low percentage of people who identify themselves as Māori.

Figure 8: Ethnic Diversity

2.6 Religious Affiliation

There is a diversity of religious affiliation in Hutt City. Figure 10 shows the main religious groups. The 'Not Elsewhere Included' category includes any responses that Statistics New Zealand does not recognise as a religion (e.g. Jedi). Again, Hutt City is very similar to the responses for New Zealand, although there is considerable variation between the different areas of Hutt City. For instance, only 2.4% of people in Hutt City identify as Hindu. However, 11.8% of Moera residents identify as Hindu. Similarly, 0.8% of people in Hutt City identify themselves as Islam/Muslim, but in Avalon East the percentage is 5.1%. This is due to the large groups of Somali and Iraqi residents in this area unit.

2.7 Years Since Arrival in New Zealand

The immigration patterns to New Zealand have changed over the last twenty years. Figure 11 represents the residents of Hutt City who were born overseas and compares this with other cities in the Wellington Region as well as New Zealand. The figure below shows that just over one third of overseas born residents of Hutt City arrived in New Zealand less than 10 years ago, reflecting the recent rise in immigration levels. This percentage is similar to Porirua and Upper Hutt, but significantly higher than residents of the Kapiti Coast District. On the other hand, this figure is much lower than Wellington City and the rest of New Zealand.

Within the individual Hutt City wards, the number of years since arrival in New Zealand is quite similar across all the wards, with the exception of Wainuiomata ward, that had a comparatively smaller percentage of more recent immigrants than the other five wards. This difference is particularly pronounced when Wainuiomata Ward is compared with Harbour Ward, where 40 percent of residents arrived in New Zealand less than 10 years ago, compared with Wainuiomata's 27 percent who arrived in a similar period.

2.8 Migration

Figure 12 shows the population of the Territorial Authority compared to where they lived five years ago. Only the population that is aged over five years old is included the comparison and figures for the number of residents who have moved within the same Territorial Authority are not available. New Zealanders appear to be a reasonably mobile group of people. Hutt City residents appear as mobile as most of the other Cities in this region, with only 47 percent of residents of Hutt City living at the same usual residence that they lived in five years ago. Residents of Wellington City stand out as being particular mobile, with only 38 percent living at the same address that they lived in five years ago.

3. Social and Economic

3.1 Average Personal Income

The average personal income information that Statistics New Zealand releases as Census data includes everybody in the area over the age of fifteen. This is regardless of whether or not they are in the workforce or receive any income. It does not represent an average wage/salary.

Figure 14 shows that Hutt City has the seventh highest median personal income for territorial authority areas in New Zealand. At \$27,300, this is higher than the New Zealand median of \$24,400. There is considerable variation across different areas of Hutt City. Normandale (\$38,600), Korokoro and Eastbourne (\$37,000 each) had the highest median personal income. Taita North (\$17,900) and Naenae North (\$19,700) have the lowest median personal income.

3.2 Average Household Income

In terms of median household income, Hutt City does not rank as highly as it did for median personal income compared to other cities in New Zealand. At \$56,700 Hutt City is ranked 12th, although it has a somewhat higher mean household income than the New Zealand mean of \$51,400. As with personal income, Wellington City has the highest median household income of all the territorial authority areas in New Zealand.


Figure 16: Ten Territorial Authorities with the highest Household Income

There is a great disparity in terms of average household income over the different areas of Hutt City. There are areas both well above and well below the New Zealand average. Figures 17 and 18 show the locations of both extremes across Hutt City.

Figures 17 and 18 show that Tirohanga and Woburn North have the highest median household income at \$95,400 and \$94,000 respectively. Normandale, Eastbourne, and Belmont all have high average incomes of above \$80,000. Taita North reported the lowest median household income at \$33,500. The next lowest median household income is somewhat higher, being Moera and Naenae North at almost \$38,000.

3.3 Sources of Personal Income

The Census asked people to identify all their sources of income. The percentages are calculated on the population of the area rather than on the number of responses given. This means that the percentages in Figure 19 will not add up to 100%, as many people receive income from more than one source. For example, a person may report that they received income from wages and also have self-employment income.

The majority of Lower Hutt residents get most of their income from wages and salary, accounting for 61.1 % of all income sources. Next highest was returns from interest, dividend and rents. Among the different area units, return from interest, dividends and rents also had the greatest variation –ranging from 6.7% in Taita North, to 45.7% in Eastbourne.

The rural nature of Pencarrow would explain why Pencarrow has a high percentage in the 'self employment or business' category. Eastbourne, Belmont, Tirohanga, and Woburn North also have a high percentage in the 'self employment or business' category. The area units with the highest average household income also have the highest percentages in the 'interest, dividends, rent, other investments' category; shown in Figure 19.

Taita North had the highest percentage in the category 'Unemployment benefit' category. In that category (7.7%), while, Naenae North and South, Avalon East, Glendale, Delaney, and Taita South, also had high percentages. When compared against the New Zealand totals, Hutt City had a higher percentage in the unemployment benefit category and a higher percentage receiving the 'Domestic Purposes Benefit'.

Avalon West had a very high percentage of residents who receive Superannuation (32.4%), which is almost twice as much as the next highest proportion of 21.0% in Haywards-Manor Park. These two areas also had very high percentages of the population aged over 65 years.

3.4 Participation in Unpaid Activities

The participation in unpaid activities question in the Census allowed for multiple responses to be given. As such, responses do not total 100%.

Participation in unpaid activities and median household income appear to be somewhat correlated i.e. the wealthier the household, the higher their participation in unpaid activities. For example, the second wealthiest area unit (Normandale) has the lowest percentage of residents who do "no voluntary activities" (5.4%), compared with 14.0% in Taita North which has the lowest median household income.

Figure 20 shows that most unpaid work is carried out within the person's own household. 'Household Work ... for own household' was by far the common form of unpaid activity undertaken.

3.5 Marital Status




Figure 21: Social Marital Status By Ward

Figure 21 shows that the marital status percentages for both Hutt City and New Zealand are very similar. At a ward level, residents of the Eastern Ward are least likely to be socially partnered (i.e. married, civil union, same sex, de-facto etc.) By comparison, residents of the Western Ward were mostly likely to be partnered. The residents of Petone Central are the most likely to have never been married. The highest rates of married couples are found within Tirohanga, Woburn North, Normandale, and Eastbourne. Avalon West residents are the most likely to be separated, divorced, or widowed.

In terms of social martial status, Taita North and Gracefield residents are the most likely to be single (non-partnered). The residents of the Western Ward, Pencarrow, Tirohanga, Maungaraki, and Normandale have a higher rate of being partnered than the other areas.

3.6 Family Type

The Census 'family type' describes the presence of couples (with or without children) or one parent and their child(ren) who are living within the same household. The 'children' can be of any age but cannot have a partner or their own children living in the same household.

The highest percentage of sole parent families was found in Naenae, Taita, and Delaney.

In Hutt City, both the number of couples without children and the number of one parent families have increased slightly between 2001-2006. The highest occurrence of families made up of two parents and child(ren) is in Tirohanga followed by Belmont. Couples in Melling and Gracefield are the least likely to have children.

3.7 Highest Qualification

When interpreting the Census highest qualification data, attention must be made to the fact that there is a high percentage that falls within the 'Not Elsewhere Included' category. Only people aged 15 years and over are included in the highest qualification data.

There are no significant differences between the Hutt City and New Zealand percentages. Figure 24 shows that Eastbourne, Normandale, and Woburn North residents are most likely to have gained a bachelor degree or higher qualification. Glendale, Taita North and Naenae North residents are the most likely to have not gained any qualification.

4. Households

4.1 Occupied Dwellings

Figures 25 shows the change in the number of occupied dwellings since the 2001 census. Waiwhetu South experienced the greatest increase in the number of occupied dwellings since the last census. This is because of the three new subdivisions that were built near Bell Road (Moana Grove, Mandel Mews and Leighton Meadows). On the other hand, the biggest decrease in the number of occupied dwellings is in Belmont. However, this is not a real decrease in the number of dwellings in the Belmont area unit, but a reclassification of part of the Belmont area unit into Tirohnaga whose size has grown sufficiently to qualify it to become a separate area unit in the 2006 Census.






Figure 26: Occupied Dwellings

4.2 Household Composition, Size, and Number of Bedrooms

The intention of this section is to explore the extent of overcrowding in Lower Hutt and the Wellington region in comparison with the rest of New Zealand. With regards to the number of families living in one household, there are relatively few occurrences where there is more than one family in a household. As Figure 27 shows this is the situation in both Hutt City and New Zealand.

At an area unit/suburb level, Taita North and Naenae North were the most likely to have three or more families in the one household, although there was only 6 families in each area (this number is rounded to base 3 according to Statistics NZ protocols, so the actual number may be slightly more or less than six). Gracefield had the highest proportion of two person families in the same household, followed by Naenae North (16.7% and 5.3% respectively).

Statistics NZ has only released rounded figures for this data in 2006. As such, there appears to be no real change over the census years. This is not surprising, particularly for number of bedrooms, as the vast majority of housing stock in Lower Hutt City was built several decades ago. At the suburb level, however, Tirohanga stands out with a higher average number of bedrooms than the rest of the city (4 bedrooms compared with 3 in all other areas). By comparison, the smallest houses are found in Gracefield, Moera, Woburn South, and Melling.

4.3 Tenure & Nature of Landlord


Just over half the residents of Lower Hutt City own their own homes (53.1%), slightly higher than the New Zealand average (51.2%). Family trusts (11.1%) were slightly more common in Lower Hutt compared with other cities in the Wellington region with the exception of Kapiti Coast. However, the Lower Hutt percentage is comparable with the New Zealand average of 11.5% for dwellings owned by a private family trust.

Compared with the 2001 Census, home ownership in Lower Hutt has declined. In 2001, 64.6% of usual residents owned or partly owned their dwelling. However, it is important to note that the 2006 census split this ownership into dwelling owned by usual residents and a separate category for dwelling held in a family trust by usual residents. If these two percentages are combined in 2006, the home ownership figures jump to 64.2%, a figure very comparable to the 2001 64.6% ownership.

With regards to ownership statistics in the individual Lower Hutt City Wards, the Western Ward clearly has the highest rate of home ownership, followed by Wainuiomata Ward. Moera, Melling and Taita North had the lowest rate of home ownership. Figures 29 and 30 show the rate of ownership for occupied dwellings where somebody within the household owns or partly owns the dwelling.

Figures 29 and 30 show that the highest rate of home ownership was in the area unit of Manuka (Stokes Valley), where 72.9% of residents owned (or partly owned) the dwelling they live in. However, if ownership in a family trust is added to ownership by private persons, Tirohanga has the highest proportion of home ownership at 88.9%, followed by Normandale at 84.6%.

4.4 Rent

The average weekly rent in Lower Hutt City is 19 percent higher than it was in 2001.Compared with the rest of New Zealand in 2006, average weekly rent in Lower Hutt is considerably lower than the rest of New Zealand, and Wellington City in particular. However, it is important to note that there is a comparatively large proportion of dwellings (just under a third of all rental properties—29%) in Lower Hutt City that are owned by Housing New Zealand Corporation. For these dwellings, rent is calculated according to the occupants' income. This is perhaps artificially driving down the mean cost of rents in Hutt City. Average rental costs for privately owned dwellings are outside the scope of this document and have not been released by Statistics New Zealand and as such the comparison cannot be illustrated here.

Figure 33 shows that there has been significant variation within individual area units. The highest increase in rent between 2001 and 2006 occurred in Korokoro (\$63) and Waiwhetu North (\$61). The rents in Normandale and Petone Central also increased by a sizeable \$56.

There were no decreases in rent, but Woburn South only had an increase of one dollar in the mean weekly rent figures between 2006-2001.




Figure 32: Mean Weekly Rent

Figures 32 and 33 show that the highest average rents are charged along the Western Hills, near the Central Business District and within the Eastbourne area unit.

4.5 Motor Vehicles per Private Dwelling

Figure 34 shows that the access to a motor vehicle has increased in Hutt City, in line with New Zealand. Compared with New Zealand, however, Hutt City has a lower percentage of households that do not own a motor vehicle.




Figure 35: Number of Motor Vehicles per Household

Figure 35 shows that in 2006, Gracefield had the highest proportion of households with no motor vehicle. This is followed by Moera, Taita North and Naenae North.

The Western Ward (Belmont, Kelson and Tirohanga) and Pencarrow all have the lowest percentage of homes without access to a motor vehicle. Pencarrow, Manuka, Normandale, Belmont and Tirohanga also had the highest proportion of dwellings with access to three or more motor vehicles, as shown in Figure 35.

Figure 34: Access To A Motor Vehicle By Ward

4.6 Access to Telecommunication Systems

The Census question relating to telecommunications allowed for multiple responses. There were also some responses that fell within the 'not elsewhere included' category. Note that the Census question only asks whether there is access to telecommunication systems from the dwelling, not whether an individual has access.

Overall, very few households have no access to telecommunications systems, reflecting the national trend. However, only 60% of households have access to the internet in Lower Hutt. Although this is slightly higher than the lower than the national average, it is significantly below the rate of access in Wellington City (69%).

Taita North, Gracefield and Moera have the lowest rate of access to the Internet, while Normandale, Tirohanga and Belmont have the highest. It should be noted that people may have Internet access at work but not at home.

The access to a fax machine follows a similar pattern to the access to the Internet, and again appears to be related to household income.

As Figure 36 shows, Taita North, Gracefield, Moera, Melling and Delaney are the areas the least likely to have access to a telephone.

4.7 Means of Heating

The means of heating Census question also allowed multiple responses.

In 2006, the percentage of homes who use electricity for heating in Lower Hutt has increased to 76.6% up from 73.1% in 2001. Conversely, the percent using coal has dropped from 5.7% in 2001, to 4.3% in 2006. Wood consumption has also slightly decreased from 29.4% in 2001 to 28.4% in 2006

As Figure 37 shows, in 2006, Lower Hutt City has a much lower proportion of households that use wood for heating than New Zealand (28.4% compared with 39.0% for New Zealand). Instead Hutt City has a higher proportion of households that use mains gas and electricity. Mains gas is not available in all areas of New Zealand, and this may explain why Hutt City's use of this form of heating is higher than the national average,

Pencarrow has an exceptionally high proportion of dwellings that use wood for heating. This is likely to be because this is the only rural area unit in Hutt City.

5.1 Labour Force Status

For Lower Hutt, the percentage of people in fulltime employment increased between 2001 and 2006 (49.3% in the 2001 Census compared with 51.8% in 2006 for Lower Hutt City), while the percentage not in the labour force decreased to 28.9% in 2006 from 30.2% in 2001.

At the area unit level, the highest unemployment rate is in Taita North (8.0%), followed by Delaney, Taita South, Naenae South, and Gracefield.

Normandale, Kelson and Petone Central and the area units that have a high percentage in full time employment. Taita North, Avalon West and Haywards-Manor Park have the highest representation in the 'not in the labour force category'.

5.2 Place of Work




Figure 39: Main Centres of Employment

The Census shows that 36,927 people work within Hutt City. The main centres of employment within Hutt City are described below and shown in Figure 39.

• Hutt Central (19). The Central Business District (CBD) is completely within this area unit. Therefore much of the employment within this area is related to retail, offices, and the accompanying services.

- Petone. Includes the area units of Petone Central (39), Esplanade (40), and Wilford (41). Petone has a wide range of industrial, trade, and business activities that includes factories as well as smaller businesses and workshops. The Te Puni Mail Centre, Weltec (formerly Hutt Valley Polytechnic), and computer and telecommunications companies are located in Petone. There is also a large amount of retailing along Jackson Street and in Annie Huggan Grove, along with a growing restaurant and café culture in Jackson Street.
- Gracefield (35). Includes the Crown Research Institute (former DSIR), Woburn Railway Workshops, Oil Company Storage Tanks, freight, storage and transport industries, and a range of factories and wholesale trade.
- Epuni West (17). Has a high number of people employed within the Health and Community Services associated with Hutt Hospital.
- Taita South (13). There are a number of industrial, business and warehouse activities situated along Peterkin Street and the Eastern Hutt Road between the Wingate and Taita railway stations.
- Alicetown (21). Has a number of small business operations along with industrial operations along Hutt Road, Wakefield Street, Victoria Street and Cuba Street.

5.3 Industry

There are two different population counts carried out in the Census with regard to employment. Both populations are limited to people aged 15 years and over and those people gainfully employed (both full and part time). In Figure 40 the sectors of industry have been ranked according to which sector employs the largest number of Hutt City residents (usually resident population).

Statistics New Zealand provides the figures for persons who gave the address of their place of employment. This is reported as the "workplace address population", and consists of people working in Lower Hutt. The usually resident population column shown below, includes only the people who live at a Hutt City address and are therefore "usual residents" and work in each of the industrial sectors shown in the graph below. The difference between the two columns shows that 12,468 people who live in Hutt City have a workplace address outside Hutt City, and therefore commute out of the city to work.

There were 49,398 Hutt City residents gainfully employed in 2006. This represents an increase of 3912 from 2001, when the number of gainfully employed residents was 45,486. The 'manufacturing sector employs the largest number of Hutt City residents. Other sectors that experienced significant growth include the health and community services, construction, and education.

The manufacturing industry had the largest decrease in the number of Hutt City residents that it employs (down from 5838 in 2001). However, Manufacturing is still the largest employer and the largest employer of people who live and/or work in Hutt City. Other sectors that faced significant decreases were the retail trade, down by 585 since 2001. On the other hand, Health Care and Social Assistance experienced the greatest increase in workplace population, up by 453 since 2001.

5.4 Occupation

Figure 41 has been ranked to show which occupations employ the largest number of Hutt City residents.

One fifth of Hutt City residents are employed in occupations classified as professional. This is followed by clerical and administrative workers. Machinery operators and drivers make up the smallest percentage of Hutt City residents.

5.5 Hours Worked

The hours worked information includes the total hours worked in all jobs. Figure 42 shows that just over half the working age population in Hutt City are employed full time. The Western Ward has the highest proportion of full time employed residents, while Northern and Central Wards have the lowest rates. By comparison to the rest of New Zealand, Hutt City has a higher rate of full time employment.

5.6 Main Means of Travel to Work on Census Day

The main method (based on distance travelled) used to travel to work on Census day is recorded for people gainfully employed. This also gives some indication of the people who worked at home on Census day.




Figure 44: Change in Main Method of Travel to Work between 2001 -2006

Figures 44 and 45 show an increase in the number of residents who drove to work using a private vehicle since 2001 on Census Day (Census day was the first Tuesday in March for each Census). On the other hand, there was a decrease in the number of people who cycled to work, and with the drop in unemployment figures, the expected decrease in the number of people who did not go to work on Census day.

6. Smoking Status

The 2006 Census included a question on smoking status. There are 16,233 regular smokers in Lower Hutt City, equivalent to 21.5% of the population 15 years and over. This is a slight drop from the 23.3% in the 1996 census when this question was last asked. The decline in smoking prevalence is also evident in the New Zealand figures as well as the figures for the cities in the Wellington Region.

At the area unit level in Lower Hutt City, the table below shows there are distinct differences in the number of regular smokers. For comparison purposes, the percentage of regular smokers in 1996 is shown where available. Smoking prevalence has decreased in all the area units, with the exception of Naenae, Gracefield (caution, small population size), and Homedale West.
