Improve Road Safety, fix streets and potholes, rail service to BART, expand Ferry Commute Service, synchronize traffic signals, increase commuter buses, build I-80 reliever route, upgrade local roads and interchanges, improve transit-seniors and disabled, expand bicycle routes, limit administrative expenses to 0.05%, an appointed Citizens Oversight Committee.

SONOMA 11/3/98 Measure B Pass

Shall the Board of Supervisors enact a 1/2 cent sales tax for general county purposes, with the following mandatory restrictions; the sales tax must expire after 20 years; an independent audit will be conducted to review all sales tax expenditures; an annual sales tax expenditure report by the County Auditor shall be made available for public inspection?

SONOMA 11/3/98 Measure C Fail

Shall the people of Sonoma County enact an ordinance requiring voter approval of any amendment to the County General Plan that increases the density or intensity of land uses allowed in the Petaluma/Novato Community Separator during the next 20 years?

SONOMA 11/3/98 Measure D Pass

This measure does not increase taxes. Should new voter-approved sales tax contribute funding for the following transportation projects within the next 20 years: Widen/improve Highway 101 from Windsor to south-county line; implement passenger rail service between Sonoma/Marin Counties; fix streets/roads/potholes; upgrade Highway 116 in east/central county; expand bus service including rail linkage; improve senior/disabled transit; expand bicycle/pedestrian routes; and limit administrative expenses to 1%?

SUTTER 6/2/98 Measure II Fail (2/3 required)

Should Ordinance No. 1 of the Sutter County Flood Protection Authority imposing a countywide sales tax of one-half (1/2) percent, for not to exceed 30 years, to provide countywide flood protection be adopted?

SUTTER 11/3/98 Measure JJ Fail (2/3 required)

Shall approval be given to an ordinance of the Sutter County Flood Protection Authority imposing a 1/2% sales tax for 30 years or until the Authority receives \$153,000,000? The ordinance requires that the tax revenues be used only for specified flood-protection projects and restricts use for administration. It also requires that an annual audit be available to the public and that the Grand Jury be asked to report annually on how revenues are used.
