Letter From the Editor

Recent UFO activity months in the Midwest has been quite spectacular to say the least. I can't remember a busier time in the greater Kansas City Area, and many reports have come in from other states including Kansas, Indiana, Illinois, and others.

April, May, and June sightings and close encounters have kept the UFO investigators in the greater Kansas City area very busy. I have had a difficult time keeping up with all of the reports, not to mention the media attention by KCTV 5, KCMO 710 Radio, KMOX Radio in St. Louis, and The Examiner, as well as a number of radio shows that wanted information on these sightings. 24 witnesses to date on the Missouri side of the greater K.C. area have reported UFOs to my office. Some of these came through MUFON. Several people did not want to file a report through MUFON but wanted someone to know what was going on.

The reports include three very large grey metallic discs with lights, a large orange round UFO, two small round orange UFOs, a large V-shaped grey metallic UFO, three abductions, (and a possible fourth abduction), missing time, and mul-

multiple orange balls of light along I-435 highway. In one case 125 orange balls were reported by an insurance agent. Multiple witnesses in most of these cases make for unusually good documentation of these events.

I have my own sighting report to make, but need to get it completed before making the details public. This happened in Southeast Missouri on the way to the Piedmont UFO Revival June 16. The MUFON Star Team has assigned Debbie Ziegelmeyer to investigate this case and as soon as the investigation is complete I'll write an article about it, which should appear in the next issue of UFO Midwest Magazine.

I'd like to thank the contributors to this issue including Roger Marsh, Dennis Balthaser, Debbie Ziegelmeyer, Art Campbell, and Emma Woods for their great articles. The magazine continues to grow thanks to our contributing writers, and I sincerely appreciate it.

Thanks to Missouri MUFON for participating in the skywatch on June 25. Even though it was cloudy, there were several anomalous objects spotted.

What Some Say About the Existence of UFOs

The debate whether UFOs exist or not has been discussed for decades, and the simple answer has always been yes they do exist. If it's flying and is unidentifiable it's a UFO. The more complex question I suppose, is trying to ascertain what it is that is flying and unidentifiable. Over and over many of the reported UFOs have in fact been identified, creating the term IFO, (Identified Flying object.) 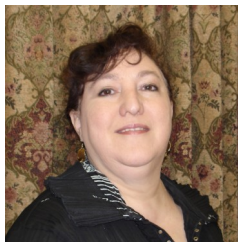

San Augustin Crash Site Metal Report - “Not of this Earth”

Midwest UFO Conference To Get First Disclo- sure on Open Minds’ San Augustin Metal Report

We did not think much of the thin pieces of foil found in the arroyo below the highway. Research indicated that we had foil used to package candy and cigarettes, etc. since 1914. In earlier days before WWII, local residents would put household discards into the arroyos and let high water and flash floods take the debris out of sight. Consequently, in many arroyos near the highways, one can find all kinds of small debris, and small thumbnail sized pieces of foil are not unusual. Some distance away at what we were to later call the gap, we found larger pieces of foil, which we eventually picked up. In 10 years or so, we had several square feet of it. Even though we were not expecting to find any “Jessie Marcel memory metal,” picking it

up at first seemed pointless. You could cut it, tear it, wad it up, and throw it, and it behaved just like your average kitchen foil.

Not thinking much of it, but not wanting to “throw the baby out with the bath,” we decided to research it to see if it was from local sources. Sometime one is so sure of something, you just want

to get it out of the way to eliminate it. I am afraid that was the case with the foil we picked up. As part of the elimination process, we looked up the metallurgical content of standard Reynolds or Alcoa aluminum foil. We found it to be 99% aluminum, 0.5% silicon, and 0.5% iron. We found that aluminum foil for

households was a byproduct of the aluminum aircraft industry in WWII, and first introduced in 1947. This was obviously what we had, we thought – ordinary store bought aluminum foil.

One day, we had some in a box and a ranch wife picked it up and said, “Where did you find this?” We told her, and she said, “you do not see much of this around here.” We asked, “Why?” She explained that western people’s food preparation relied on a lot of frying and baking, and in the early 1950s or so, women did not have much use for it. She said Reynolds or someone sent a free box of it to her high school home economics class about 1949 or ’50 and it languished in a cupboard most of the school year until one girl baked cookies on it and it soon disappeared. “It was expensive compared to the wax paper we knew and were used to.”

I asked her about food storage and leftovers. She smiled and said, “Table scraps went to the

dogs. We did not see foil around here until the mid-1950s or so when we got our first barbecue." She said, "When we finally got decent power and we could put in home freezers, we used it then to prevent freezer burn."

The foil we were finding had nowhere near the percentage formula that was introduced in 1947. We knew what we were finding here and there did not resemble the formula for domestic foil. We knew it was different, but we did not know why. Whenever we would find a piece, it was saved. Six small pieces were sent to a metallurgist in the late '90s. He

confirmed it was not domestic and said, "It was very complex, and it seemed to him the samples had come off of the floor and were tailings from a processing operation."

Then in 2004, things began to change when I invited Chuck Wade to the site. I met Chuck at the 2004 Aztec UFO Conference. He brought a crew of Navajos down to the site from Gallup. In 4 days, 3 crews dug 28, 1-meter square holes that were 20 centimeters deep. The crews started finding larger pieces of foil, and by 2010, Chuck had contacted Dr. Roger Leir and his L&M Group

that helped Dr. Leir finance the removal of what many believe are alien implants.

A Piece of Cake

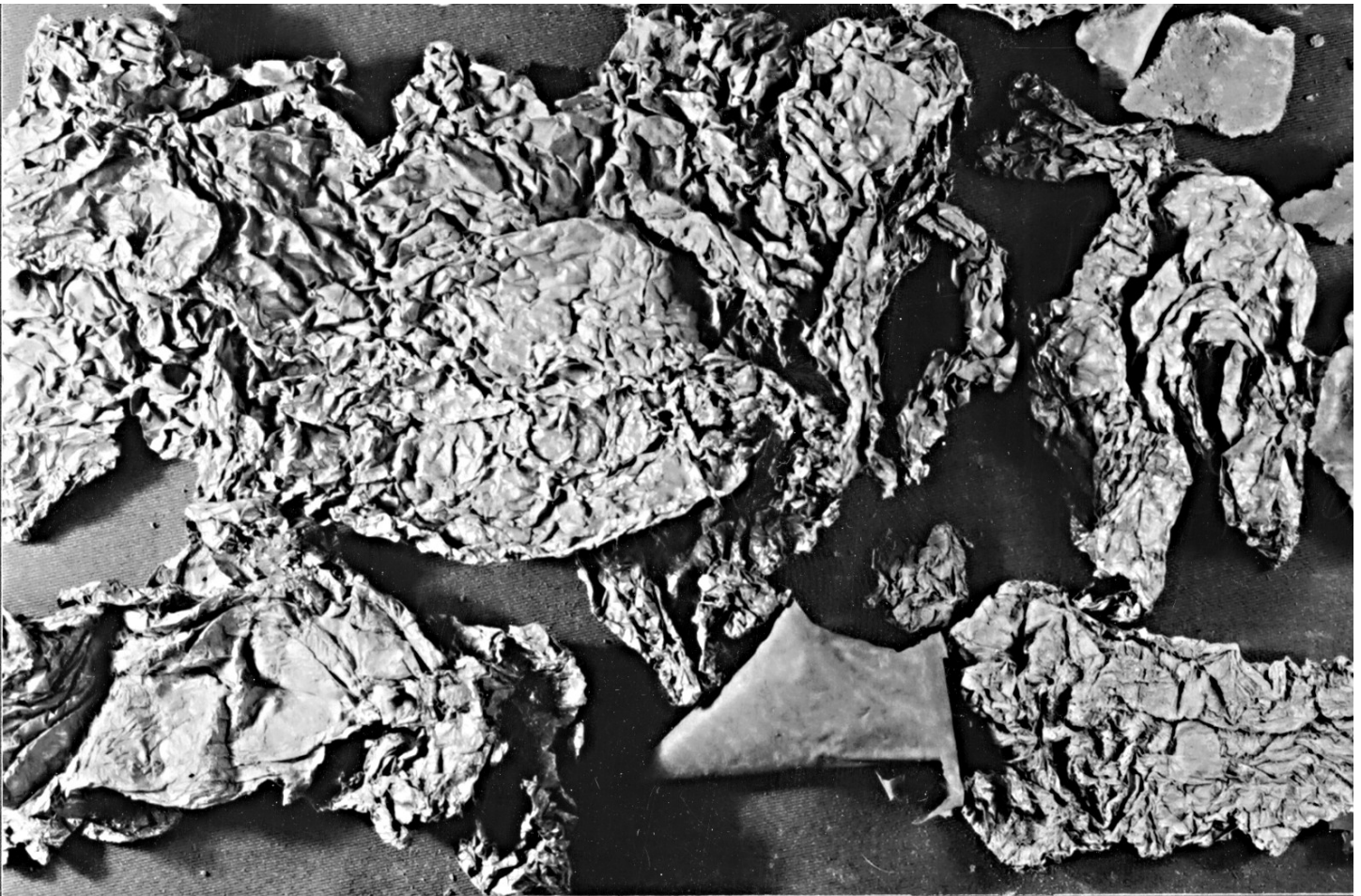
As a result of their interest, six pieces of Chuck's metal were analyzed by Steve Colbern, a chemist/materials analyst at a major West coast laboratory. The project was sponsored and funded by the Open Minds organization of Phoenix, Arizona. We soon found out why the earlier metallurgists thought, "the foil had been scraped off of the processing plant floor." As it turned out, that was an understatement. Colbern, using the latest ICP-MS (inductively coupled plasma, mass spectrometry) equipment identified 40 to 50 separate elements in a coating on one side of the foil. Each separate piece of the six initial foil pieces were analyzed and each had had 40 to 50 or more of the same elements (plus or minus a few more) in exotic coatings.

The Icing

Colbern had given us the remarkable analysis of advanced metal technology that certainly could not have come from Earth in 1947 or the present. Now he was to give us the cake's icing. While using an Energy Dispersive X-Ray Analysis on the sample W-1, and the ICP-MS process, he was able to isolate three elements: antimony (Sb), copper (Cu) and nickel (Ni) that were suitable enough to perform isotopic abundance calculations upon. Steve's tests showed extremely skewed isotopic ratios and indicate that these three metals from the sample W-1 could not have originated

on Earth.

Security Considerations

When we look at the relatively short timeline of equipment development and knowledge needed to assess the crash site material, we can see possibly why there is still secrecy about UFO crash sites. We needed to go back to 1939 and Albert Einstein's famous letter to FDR, which led to the super secret Manhattan Atomic Energy project. It was not until 1940 that isotope research got underway at Columbia University studying uranium isotope separation. It was not until seven years later in 1947 that the Roswell and Plains crashes occurred. Six years later in 1953, the scan-

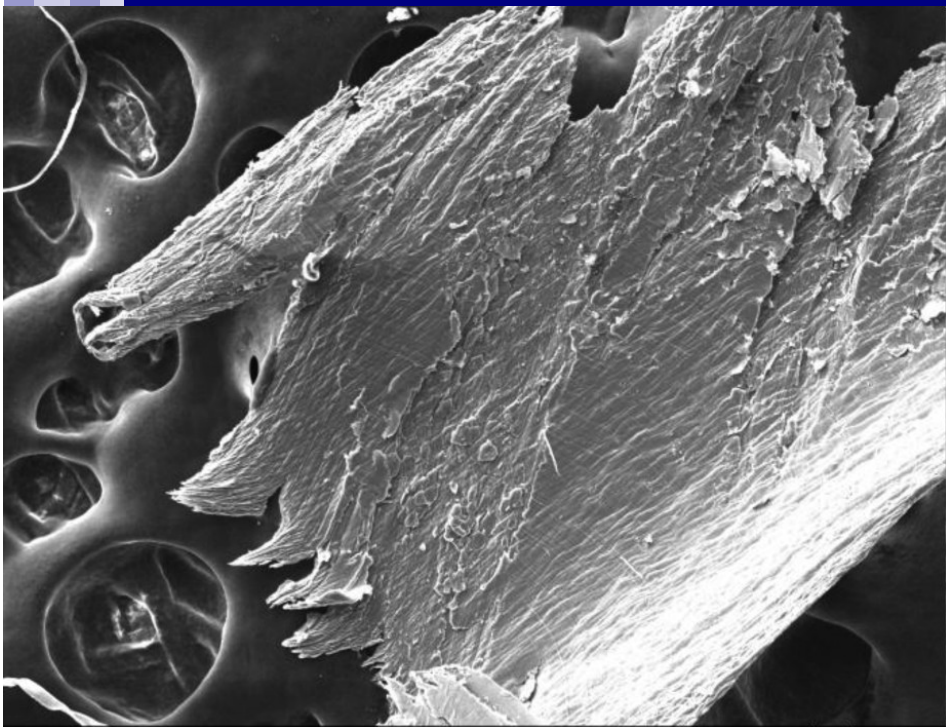
ning electron microscope (SEM) was developed and only 36 years later (in 1989) that the ICP-MS technology was developed.

Scientist's Conclusions

- 1) These samples contain very unusual alloying elements, which were **not present in aluminum alloys in 1947**. If these samples are from an aircraft, which crashed in that year, they are very unusual on that basis.
- 2) The coatings on the samples are also unusual because conformal coatings of this type, which are blended with the metal, and rich in silica, titania, magnesia, sulfate, phos-

phate, and chloride, were almost **certainly not available in 1947**. The coatings on the samples are also somewhat similar to coatings on implants removed from people claiming alien contact.

- 3) The carbon nanotube indications observed in the Raman spectra of the samples indicates the possibility that the samples may be "smart metal" materials, which contain carbon nanotubes as electronic components, or to strengthen the materials. Since the mechanical strength of these samples was not unusual, they should be tested for unusual electrical characteristics.
- 4) The isotopic ratios of three

elements in sample W-1 (antimony, copper, and nickel) were extremely skewed [Editor's note: *In this instance, "skewed" refers to metal formulations not known on earth.*], with respect to the terrestrial ratios for these elements, and there is therefore a high probability that **the samples came from an extraterrestrial source**. These extremely skewed isotopic results are again reminiscent of those obtained from alleged alien implants, and from an alleged piece of the Roswell crash debris which was analyzed by the late Dr. Russell Vernon Clark.

- 5) The results of the pendulum test indicate that samples W-1 and W-6 may still be emitting gravitational, or magnetic energy, which greatly increases the probability these samples

are **nanotechnological "smart metals" and of probable alien origin** as well.

- 6) Further microscopic testing should be done on these materials to determine their internal structures. More testing should also be done to determine the existence, extent, and profile of any gravitational, magnetic, or electric fields the samples may be emitting, and their source of energy.

The results of the isotopic analysis of the ICP-MS results from sample W-1 indicate that the isotopic abundances of each of the elements tested (antimony (Sb), copper (Cu), and nickel (Ni)) **differed significantly** from the isotopic composition of the same elements derived **from terrestrial sources**.

For elements heavier than boron, differences in isotopic composition of more than approximately 1% from the usual terrestrial isotopic abundance pattern, indicates a high probability that **the material originated from a non-terrestrial source**.

All of the elements tested differed from the terrestrial abundances by much more than this. These elements in sample W-1 therefore **may not have originated on Earth**.

This research is just beginning as we are doing the analysis of the metal foil shards found on the Plains of San Augustin. Many other things of interest were found: a tiny shoe sole, something that may be an artificial body part, and other items. This leaves us with some questions. What research, if any, was done in 1947 or 1948 or shortly thereafter to match today's sophisticated analysis that we show in Colbern's 2010 report?

If the shards were analyzed prior to 1989, what procedures were used that were available to give them similar results? A witness said there was foil on the ground at the crash site. Most of it was apparently picked up, but some was left for this researcher, his friend, and a crew of Navajos.

Are there possibly some boxes on a forgotten shelf in a govern-

ment warehouse with more of the arroyo metal shards waiting for that future day when they might get a more proper analysis?... Perhaps. If this is true, then this independent private research may be the first to discover the sophisticated and varied coatings on the strange New Mexico arroyo foil.

Remote Viewing Results on the San Augustin Artifacts

After spending the day interviewing Art Campbell during his visit to Kansas City in September of 2009, Art mentioned that he had some artifacts with him from the San Augustin crash site, and asked if I'd like to remote view the objects to see what I could find out about them. I had no knowledge of these artifacts and was very curious about them.

Art handed me each object, which was sealed in a Plexiglas container, one at a time. The first item was a tan color object that looked like it had once been larger and had collapsed. The instant Art handed it to me I felt myself as a short alien being with a heart in my abdomen, rather than in my chest. I "saw" a thin copper wire attached to the heart and to a metallic button on the outside of a blue uniform. **Art and others believe that this object was a heart.**

The second object was what I thought was part of the flat button that used to be part of the uniform.

The third object was a tiny shoe sole, but at the time I did not get any information about it. With remote viewing, sometimes the information comes later, which is what happened in this case.

A couple of months ago, I was thinking about this case and had a dream about a little girl in Los Angeles who was carrying a doll, and was taken by aliens in a UFO.

This girl and her doll were on the craft when it crashed at San Augustin. I experienced the

crash, and heard two alien beings yelling about crashing. It was unavoidable. Something happened suddenly that caused the crash and they could not maneuver out of it before hitting the ground. There was some reference to "earth beings" causing the crash with a new device.

The human child was on the UFO when it crashed. I saw one alien—the pilot—crushed during the accident. The shoe sole is a mystery, though. It has a natural rubber sole with nine layers of cotton and other unknown substances. It is not leather and it is shaped strangely for a human foot. Art does not believe it belongs to a child's or doll's shoe. I am of the opinion that the sole is either from an alien shoe or the doll's shoe.

Imagine my surprise when Art contacted me recently and said that he found some old unprinted color negatives of some starch residue inside the possible body part. He had prints made and saw a **blue fiber** in one of the photos!

What does this tell us about remote viewing? Quite simply, that sometimes remote viewers can help UFO investigators find answers to their questions. RV work is not always 100% accurate, but it can be another tool to use to solve mysteries.

I use this technique when doing my own UFO and paranormal Investigations, and sometimes relive an experience that someone else had. By doing so I know what others have gone through.

Recap of the Piedmont UFO Revival

The Piedmont UFO Revival held July 17 & 18 in Patterson, Missouri was a huge success. The event commemorates the 1973 UFO Flap in the Piedmont area, which continued for two years with over 500 sighting reports, and ongoing sightings that continue to date.

Celebrity speakers included Mark Rutledge, who spoke about his father Dr. Harley Rutledge's work "Project Identification: A Historical Perspective." Dr. Rutledge was the first person to scientifically investigate UFOs using his method; Denny Hovis, a radio talk show host that did interviews during the 1973 flap played audio recordings of interviews; Earl Mullins, Director of the space Museum in Bonne Terre, Missouri did a rocket science demonstration; Lowell Grissom, son of astronaut Gus Grissom, talked about his brother's life as an astronaut and showed NASA films; Debbie Ziegelmeyer, State Director for Missouri MUFON, discussed several extraordinary UFO cases in Missouri; and Margie Kay, Assistant State Director for Missouri MUFON spoke about possible Ley Lines and Portals in Missouri.

The Science and Tech Career Exploration had a SLCC Mobile Tech Center on site, and CAAW had a display of all of the original 1973 and 1974 newspaper articles from the Piedmont UFO flap. These articles were from nationwide coverage and include photos of UFOs taken by witnesses in and around the Piedmont area and in and over

Stillwater Lake nearby. The event was sponsored by the Cultural Arts Alliance for the Wayne Ozark Region. The Website for the organization is www.caawcaaw.com. Dawn Allen and Barbara Decker from CAAW say they will likely repeat the festival in 2012 due to public interest in the event.

Those of us from Kansas City and St. Louis were pleasantly surprised at how well this event was planned and the number of high-profile speakers that participated. We were unaware of how much UFO activity and reports were happening in the early 1970's and learned a great deal at this conference. Thank you to the coordinators!

Underwater Mysteries

I received my May issue of Sport Diver and noticed an article on the front cover that seemed unusual for a scuba magazine. Listed as being on page 46 was an article entitled “Did Aliens Build Japan’s Coolest Dive?”

I decided this needed further investigation and in light of the recent earthquakes and the tsunami that followed, the first step was to determine if this sight had survived the devastation.

Yonaguni is part of a chain of islands known as the Ryuku Islands located south of Japan just off the

northeastern coast of Taiwan in the Pacific Ocean. Most of the earthquake and tsunami damage to Japan occurred off the northeastern coast of Japan extending south only as far as mid-country. I check several Scuba diving websites offering trips to Yonaguni and found no reported damage to the dive sight or cancelled area diving due to earthquake or tsunami damage.

These underwater Yonaguni monuments were discovered by diver Kihachiro Aratake in 1985. The formations are 100 feet deep with a 250 foot base rising 80 feet tall to just 20 feet below the surface. The smoky blue underwater structures have sharp edges, angles, an arch, possible steps, and several

passageways with the largest structure in the group resembling a stepped pyramid that rises from about 82 feet deep. Said to resemble the Sacsayhuaman and Qenko structures located in the Andes Mountains of Peru, the sight was thought by some to be over 8,000 years old. Others who have explored the site believe these ruins could be the missing continent of MU, fabled Pacific civilization rumored to have vanished beneath the waves possibly due to an ancient earthquake and the tsunami which followed.

The first scientist to do an extensive investigation of the underwater structures was Masaki Kimura, a marine geologist and pro-

fessor at Ryukyu University in Okinawa. The professor has been diving at the underwater site measuring and mapping for over 15 years, and has come to the conclusion that the ruins are most likely an ancient Japanese city sunk by an earthquake about 2,000 years ago. Kimura has discovered quarry marks in the stone, characters etched onto caved faces, and rocks sculpted into animal likenesses. One example is described as an underwater sphinx which resembles a Chinese or ancient Okinawan king. Professor Kimura has identified ten structures off Yonaguni and five related structures off the mainland of Okinawa. The ruins cover an area spanning 984 feet by 492 feet and include the ruins of a castle, a triumphal arch, five temples, and at least one large stadium. These massive underwater structures are connected by what seem to be roads and water channels protected by what could be huge retaining walls.

Professor Kimura has concluded that the mysterious five-layer structure was man-made and not manufactured by nature.

If occurring naturally according to Professor Kimura, “the structure would have debris from erosion collected around the site.” The professor is convinced that the remains are that of a 5,000 year old city.

Toru Ouchi, supports the findings of Professor Masaki Kimura. Ouchi is an associate professor of seismology at Kobe University and has been to the dive site documenting the possibility of past tectonic activity.

Professor Ouchi has touched the pyramid and states that Professor Kimura’s findings are “not exaggerated at all.” Since March of 1995, divers have located eight

separate similar sites in the waters around Okinawa and beyond to the small island of Yonaguni. They have discovered what appears to be a road surrounding the structures which would be further evidence that these were man-made.

Pyramids can be found in several parts of the world including Peru, Mexico and Egypt. As of 2008 there were 138 pyramids discovered across Egypt with the oldest being the Pyramid of Djoser in Saqqara thought to be from the 3rd dynasty dating between 2650-2575 BC approximately. Mexico and the Mayan Peninsula are also well known sites for pyramids and ancient cities dating back to the Pre-Classic Era of 1800 BCE-200CE. According to Wikipedia, the shape of pyramids by definition is thought to represent the primordial mound from which the Egyptians believed the Earth was created representative of the descending rays of the sun.

The idea of alien influence in the construction of these underwater structures could stem from the theory that the ancient pyramids of Egypt were built with other worldly assistance. The Yonaguni site’s estimated construction dates are around the same estimated era as the building of the Egyptian pyramids.

So the age old question is still, who influenced the building of pyramids, why were they constructed in different parts of the world, how can it be that similar structures were being built on different continents by different civilizations which had no recorded contact

or influence on each other, and how was the construction of these structures possible with the limited tools of the era?

If that long question doesn’t boggle your mind, visit Richard Hoagland’s website “Enterprise Mission” and take a look at the pictures of the pyramids on Mars. If this truly million dollar question is ever legitimately answered, it could in fact change history turning the questions into millions of dollars worth of answers in the form of books, documentaries and TV deals.

OWLS

ET Connection

In 2009 I began what was to become an on-going investigation into UFO and paranormal events in and near Butler, Missouri, and where my first Owl report occurred. Most UFO investigators have encountered witnesses who see owls during or after a close encounter and know that many UFO abductees and contactees have reported seeing owls around the same time of an event, so I wasn't too surprised when the witnesses from Butler told me about the strange owl encounters they had.

One evening in September of 2009, a couple driving on a rural road Southeast of Butler, stopped on a bridge to take photographs. There, they saw a three-foot tall owl standing on the limb of a tree

just 25 feet from the bridge. After seeing the owl, the couple returned to their car and drove home.

However, when they arrived at their house in town they played back the tape recorder that the husband had in his shirt pocket and were surprised to hear themselves saying things they don't remember. The couple realized that they had missing time and that this may have been an abduction experience.

On the tape, the husband says "Wow, that is a big owl. He does remember saying that, but not the following: "Gee, that owl is really really huge! Hey, it is coming towards me! Oh no, that is NOT an owl, that is NOT and owl!" (in a very panicked voice) Then there is no more talking on the tape, even though it keeps running for a

while. I knew that this couple had several close encounters and abduction experiences. The couple seemed genuinely surprised when I told them about the common reports of owls among abductees, so The owl sighting lent more credibility to their story.

Shortly after I started working on the Butler case, things started heating up for me and my family as well. In early 2010, my daughter and her three sons were stargazing at their home in Independence, Missouri when one the boys noticed a large owl in a nearby tree in a vacant lot and told the others about it. The four also noticed Venus in the sky and talked about it.

The next thing they knew, the family was home and the boys were told to go to bed. My daugh-

ter went to the window of her youngest son's bedroom and noticed that Venus was no longer visible in the sky, and had moved too far for the amount of time they had been gone. When she looked at the clock it was much later than she thought.

The youngest, then two years old, turned his head towards the wall and seemingly went to sleep. My daughter then got up and went to the window and looked out for a few minutes, trying to figure out what had just happened to them. Suddenly, her son turned back and said in an adult voice "Mom, that planet you are looking for is way over there now," as he pointed across the room. "And Grandma is going to be visited by twelve—a dozen—aliens." Shocked, my daughter asked him to repeat what he said, which he did, then turned and fell asleep. My daughter called me immediately and said she was shaking at hearing what my grandson just said. He barely knew how to count to ten, and certainly did not know what a dozen meant. She said his voice sounded like he was completely grown up and very confident, unlike his little boy voice.

Needless to say, this shocked us, and was very concerning. Not long after that, I had my first alien encounter. I awoke at 11:30 pm on May 1, 2010 to a sharp pinch in my left leg. I clearly saw three alien beings standing at the foot of my bed apparently working on my leg, which I had been having trouble with. I was amazed and shocked, and actually screamed when I saw them. This encounter was very disturbing. Any recollection of encounters with aliens had been, to this point, under hypnosis only.

Next, two aliens visited me on November 9, 2010. They were a

different type altogether and had glowing gold skin. Then in April of 2011 I had a strange dream where a new alien being took me aboard a craft and showed me a future event where the Earth is struck by a comet or asteroid. While I remember this as a "dream," the circumstances around the event lead to it being a real encounter.

So that means that six more aliens will visit me if my grandson is correct. I don't yet know the reason for these encounters, but hope to find out under regression, which is scheduled for the next few weeks.

I asked my 10-year-old grandson to draw a picture of the owl he saw in 2010, which he did very quickly and without much thought. While he believes that he saw a real owl, I have my doubts. It makes a chill run down my spine when I look at the picture he drew.

Owls were a prominent part of the film *Fourth Kind*, starring Milla Jovovich, Elias Koteas, Will Patton and Hakeem Kae-Kazim. In the film patients of a fictional psychologist Dr. Abigail Tyler in Nome, Alaska describe seeing an owl outside their window. Although the film was fiction it was likely based on common reports by witnesses who have had close encounters.

Many abductees report that aliens can shape-shift at will, often appearing initially as animals. Eagles, raccoons, deer, and owls are the most commonly reported creatures. Later, under hypnosis, the abductee often recalls seeing an animal first, then an alien.

More research needs to be done on the number of persons who see owls related to ET encounters.

2011 Roswell Festival Lecture Cancelled

My sister Debbie and I were scheduled to lecture at the Roswell UFO festival in July 2011, releasing the latest information from our investigations. We were lecturing for a coalition of businesses called, "The Roswell UFO & Alien Merchants Association" who wanted to start their own lecture series bringing in more of a variety of speakers to the festival.

On May 19th I was contacted by a representative from the "RUAMA" and informed that they were forced to cancel the lecture series. The cancellation was pressured by the newly appointed Mayor, Del Journey. The mayor felt their lecture series was in direct competition to the lecture series offered by the International UFO Museum.

The "RUAMA" speakers were to include: Dr. Jesse Marcel Jr., Astronaut Story Musgrave, Dennis Balthaser, Peter Robbins, Paola Harris, Dr. Donald Burleson, Noe Torres, Debbie and me. Obviously all cancelled now. Why would the mayor do this?

Most people visiting the festival are unaware of the constant disagreements which are and have taken place between the museum and the festival committee. When I first got involved with lecturing at

Roswell, museum affiliates who disagreed with the City Council referred to them as "Red Coats," not because they actually wore red coats, but because they were considered enemies. Of course I laughed when I heard the story, but soon realize they were serious. What a shame.

In late 2010 news spread throughout the internet claiming the City Council was going to cut funding for the 2011 festival thus possibly putting the festival in jeopardy. Then at the last minute the head of the UFO Museum, Julie Shuster, became the new committee's co-chair and funding was granted.

You see based on the average hotel/motel statistics from previous festivals, capacities were generally at 98% filled throughout the four day festival. This capacity usually means an excess of 15,000 "UFOites" visiting Roswell. This not only generates a lot of revenue for the city's businesses, but for the museum as well.

The problem always seems to be, who should have the authority to run the festival and reap the majority of the benefits? The museum which is the "UFO" main attraction, has always believed they should be allowed to run the festival. Local merchants disagree because they claim the museum only cares for their own longevity and not the local businesses. Here's an example.

The museum plans to move away from the down town location to a much larger site just outside the business district. The downtown merchants are afraid this would cause a "Wal-Mart" effect in which visitors will be focusing their visits away from the down town area to the museum's new location. The new location would be designed more like a convention center with complete food and shopping. This "all in one" structure could cause the demise of smaller businesses in the downtown area resembling the effect Wal-Mart's have caused in small towns nationwide.

The merchant's association, for whom I was going to lecture for, wants to start their own professional lecture series, thus starting a new tradition which will attract visitors back to the downtown area once the museum moves. I guess the mayor sees it differently.

This inter-dimensional city fighting has gone so far now, that not only has the Mayor intervened, but sources have told me the museum has actually reserved the Civic Center's lecture hall with no intention of using it. This would in turn make it impossible for any other lecture group to use, thus leaving it empty throughout the festival.

So let's sum up.

The head of the UFO museum is the committee's co-chair for the festival committee. The mayor and possibly committee's members are keeping other Roswell residents from starting their own lecture series, giving the museum carte-blanc for offering lectures. Who is in charge, Roswell residents or the museum? And, who does the new Mayor really answer to, the people or the museum?

Who does this hurt? Well, obviously the people visiting the festival who want more than an amusement park atmosphere. As an investigator I've personally seen people venturing to Roswell during the festival to look for an answer to a question deep within themselves which they've been afraid to ask. Usually during the festival, they'd have the opportunity to speak with investigators getting these unanswered questions answered. Now, the majority of patrons won't get their questions answered because the basic logistics of this possibility will be denied.

Why? Let me explain.

The museum may only be able to satisfy 300 or so guests at one time through multiple lectures at different locations. I know this sounds a little farfetched, but if all 15,000 people wanted to at least sit in on one lecture, well let's do the math.

15,000 visitors divided by 300 being able to see a lecture at one time, leaves 50 lectures available. If each lecture was an hour long with a 15 minute question and answer, with guests entering and exiting the lecture rooms, there would have to be (12.5) 75 minute lecture spots per day for four days. That's over a 900 minutes, or a (15.5) hour day!

Ok some more logistics.

In past festivals when there were multiple lecture series going on at once throughout Roswell, the museum still experienced such high quantities of visitors that the fire marshal had to step in to keep the building safe. If the museum is the only place offering lectures, then it is realistically impossible to satisfy the needs of the majority of visitors while keeping them in a safe environment.

But alas, these controversies won't stop my sister and me from

visiting Roswell this year even though we won't be lecturing. What the museum has to worry about is that while their investigators are busy lecturing three or four times a day and signing books in between to satisfy the 15,000 or more guests they'll be encountering, my sister and I get to play!

We play by visiting current investigative sights, looking for new ones, and possibly meeting new eye witnesses.

This is a win, win, situation for us, but maybe a losing situation for the city of Roswell. If Roswell can't get their act together, then possibly their good neighbor, the city of Corona (which is closest to the debris site) may just take over this event making this a festival again rather than the farce it's become. End

However, UFO researchers have reason to believe otherwise, due to the comments alluding to UFOs and ETs that President Reagan made while he was in office.

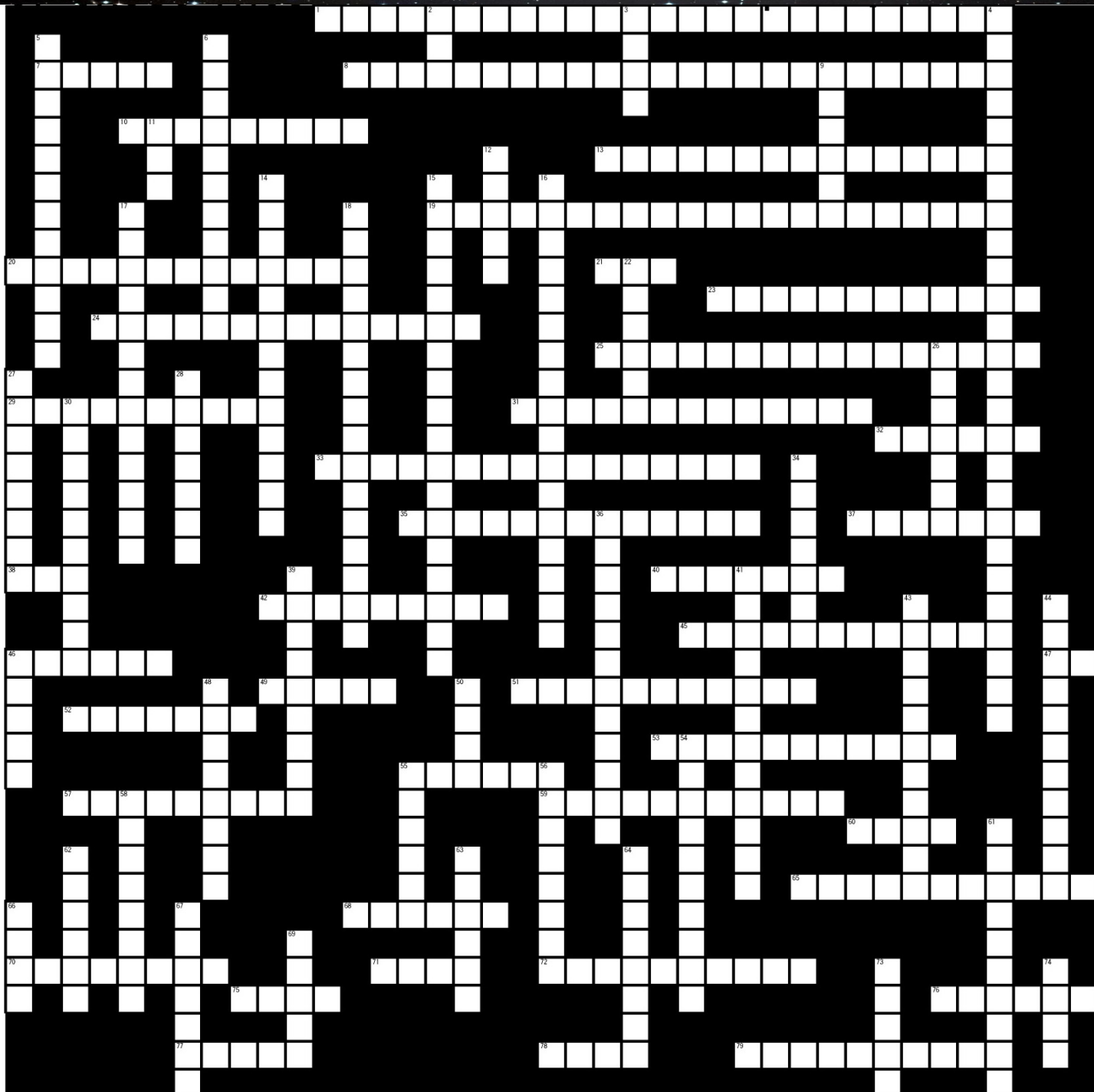
The witness is identified only as putua76. The following is his unedited statement.

For a number of years, I was a research subject of "alien abduction" researcher, Dr. David M. Jacobs, of Temple University. He conducted ninety-one hypnotic regressions with me during thirty-seven hypnosis sessions, from December 2004 through February of 2007.

During that time Dr. Jacobs' behavior towards me became increasingly bizarre and psychologically abusive. I am currently taking action in regard to his, in my opinion, misconduct towards me as his research subject.

I have provided here information about Dr. Jacobs' work with me, as I believe that it is matter of public interest. I hope that by providing this information, that I can help to prevent similar abuses occurring to other research subjects in the future.

I am one of many people who have had experiences throughout their lives that cannot be explained in conventional terms. My own experiences fit patterns which, in our culture, are often explained as "paranormal", "UFO" or "alien abduction" experiences. I have an agnostic view of these cultural explanations; I am neither a "believer" nor a "skeptic". However, I think that the underlying

experiences giving rise to these explanations are both real and anomalous, whatever their actual origin.

In order to gain a deeper understanding of my own experiences, I compiled a detailed chronological record of them. For a period of one year, I collected additional physiological data relevant to some of the theories about the "alien abduction" phenomenon, to correlate with them. Once my action in regard to Dr. Jacobs', in my opinion, misconduct towards me as his research subject is concluded, I will publish my research on my anomalous experiences on my website at www.ufoalienabductee.com.

Introduction: Throughout my life until the present day I have had experiences that I could not explain. I was born in Africa in 1961 and I first became aware of the experiences as a young child. Among many others, these include:

- As a child in the mid 1960's, I saw a short non-human person in my bedroom during the night.
- As an adolescent in the late 1970's, I awoke during the night to find a tall thin person standing next to my bed wearing a robe and hood. The person communicated with me telepathically and gave me a metal key. I found the key on my pillow when I woke in the morning

- In my thirties in the mid 1990's, while with a friend driving across country, we inexplicably found ourselves on a different road to the highway on which we had been. Then, my friend suddenly turned off the highway and drove up a hill without either of us having any idea why. When we eventually arrived at our destination, we were six hours late and, in spite of the unexplained detours, were unable to account for several hours of missing time.

My experiences have had a major impact on my life. Most of my memories of my anomalous experiences are fragmentary and I am aware that there is much that I do not understand about them. Nevertheless, the experiences have had a major impact on my life. In part, this is because of my inability to have complete recall of them, and also because I have had no framework within which to understand, process and assimilate them.

I have been assessed as psychologically normal. For about ten years between 1992 and 2002 I saw a therapist, Justin Armstrong (pseudonym), who helped me work through some of the personal issues that arose because of having these experiences. Mr. Armstrong considers me to be psychologically normal and not delusional or suffering from mental illness. My current therapist, likewise, considers

me to be psychologically normal.

I realized that my experiences fit the "alien abduction" pattern. In the late 1990's I read a magazine article which listed indicators of possible "alien abduction". At that point, I suddenly realized that, whatever the actual cause, my experiences fit that pattern. I wondered if they might be related to the "alien abduction" phenomenon. At the time, however, I could not cope with the possible implications and I tried not to think too deeply about it.

I decided to explore "alien abduction" as the cause of my experiences. In early 2001 I reached a crisis point where I realized that I had to face the experiences directly and deal with them, or I would never gain control over their effects on me and my life. I read a book about the "alien abduction" phenomenon: 'Witnessed', by "alien abduction" researcher, Budd Hopkins. It included a letter that a woman had written to Mr. Hopkins in which she told him about a vision she had of a shrouded or hooded person next to her bed.

I was amazed because that is what I remember and I had never heard of anyone else having an experience like that. I was even more astonished to read that memories of a hooded figure are a common component of the "alien abduction" phenomenon.

I realized that I needed to look seriously at the "alien abduction" pattern of experience, whatever the actual cause, in order to understand my own experiences. I also decided to explore the possibility that "alien abduction" was the origin of my experiences.

I began my longitudinal study of

my experiences. In 2001, at Mr. Armstrong's suggestion, I began to write a chronological history of my anomalous experiences and keep a record of my current experiences as they happened. I interviewed people who witnessed parts of some of the events and tried to find as much corroborating evidence as possible.

I decided to suspend my judgment, and record every event that was consistent with any of the theories I knew about that attempted to explain the cause of these types of anomalous experiences, whether I personally thought that the event or the theory were relevant or not. In addition, I decided to record every event that was unusual or incongruent in any way, whether I personally thought it was anomalous or not. This was to bypass as much as possible my preconceptions as to what was relevant and what could be causing the experiences, which might otherwise influence my decisions about which events to record. In addition, I hoped to avoid some of the problems inherent with perception and memory in the data that I had been unaware of.

I made contact with Budd Hopkins and Dr. David Jacobs. In early 2001 I wrote to Budd Hopkins, and I spoke to him on the telephone the following year. Mr. Armstrong contacted "alien abduction" researcher, Dr. David Jacobs, on my behalf in mid 2002, and I made contact with him myself soon afterwards. Both Mr. Hopkins and Dr. Jacobs provided Mr. Armstrong and me with information about the "alien abduction" phenomenon.

My former therapist assisted me with my research. Mr. Armstrong retired as a psychological therapist

at the end of 2002, but because he was interested in my longitudinal study, he continued to assist me with it and provide me with valuable feedback, help, and support until late 2006. He said that he did not understand what was happening to me, but that it was obvious to him that something unusual was going on that warranted investigation. So, I continued with my personal research.

By 2003 I had decided to make a detailed record of my experiences so that I could gain a deeper understanding of them and of their effects on my life. I discussed the best ways of doing this with Mr. Armstrong and Dr. Jacobs. As a result, I kept a detailed daily record of my anomalous experiences for one year during 2004. Dr. Jacobs suggested that I take note of my dreams, as he considered that they could be memories of "alien abduction" events. I have an open mind about whether this is the case or not. Therefore, during that period I also recorded all of my remembered dreams. In addition, I collected physiological data relevant to some of the theories about the "alien abduction" phenomenon to correlate with my experiences.

Dr. Jacobs conducted ninety-one hypnotic regressions with me between December 2004 and February 2007. The sessions were on average about five hours long. He told me that I am one of three research subjects with whom he has done the most extensive amount of hypnosis. I have provided detailed summaries and sketches of what I remembered during the hypnotic regressions in Hypnotic Regressions with Dr. Jacobs.

Some of my hypnotically retrieved memories may be confabulation:

Later, in mid-late 2009, an analysis of the recordings of all of the hypnotic regressions that Dr. Jacobs conducted with me showed that he engaged in extensive leading and suggestion, which I was not fully aware of at the time. It is probable that many of my hypnotically retrieved memories were confabulated as a result of this. The detailed summaries and sketches that I have presented of what I remembered should be viewed with this in mind.

At the same time, I was able to confirm that some of the everyday events that I recalled under hypnosis, such as the date that an event occurred, which I had forgotten, were, in fact, accurate. Therefore I know that hypnosis assisted me in recalling at least some accurate memories.

In addition, when I first read Dr. Jacobs' book, 'Secret Life', about the anomalous experiences of "alien abductees", prior to contacting Dr. Jacobs, I was struck by how similar they were to my experiences. These factors appear to mitigate against all of my hypnotically retrieved memories of my anomalous experiences being the result of suggestion, whatever their actual origin.

My relatives' experiences: Dr. Jacobs told me that the "alien abduction" phenomenon is usually intergenerational. When speaking to my relatives about my situation, I was amazed to discover that some of them, including my father, had also had a lifetime of anomalous experiences of which I was unaware, and that my father had

seriously considered the "alien abduction" phenomenon as the cause. Others said that they had never had any anomalous experiences themselves. Some were open to the idea of "alien abduction" being the cause and others were skeptical.

I trusted Dr. Jacobs as an academic researcher.: During the years that I worked with Dr. Jacobs between 2002 through 2005, he seemed to me to be professional in his approach. I understood that he was doing scholarly research under the auspices of Temple University in America. Consequently I put a great deal of trust in him and I disclosed intimate details about myself and my life as part of my work with him.

I told Dr. Jacobs that if he was ever in the area where I live, that I would introduce him to people who had witnessed aspects of my anomalous experiences. I provided him with audiotapes of my relatives and friends corroborating some of them. Mr. Armstrong signed statements confirming that he had witnessed unexplained marks on my body, as well as other events, and I gave Dr. Jacobs signed copies of them. Mr. Armstrong also had a number of telephone conversations with Dr. Jacobs. During much of 2004 I recorded myself with a video camera while sleeping. In addition, I put the video camera in my window for several weeks. Aspects of a number of strange occurrences were caught on the video recordings, and I gave Dr. Jacobs copies of the video clips.

Dr. Jacobs told me that he thought that my record of my anomalous experiences would make a good contribution to the field of "alien

abduction" research. In late 2005 / early 2006, he suggested that I publish it anonymously on his website. He told me that his webmaster, Elizabeth Smith (pseudonym), who was also his research subject, who would put my work on his website, was completely trustworthy and that she would guarantee my anonymity. (Elizabeth also uses, amongst others, the pseudonyms "Becky", and possibly, "Karen".)

Dr. Jacobs involved me in an abusive psychological "game":

Once Elizabeth became involved in my work, however, I was pulled into a bizarre situation regarding her own experiences. Dr. Jacobs began receiving communications from her computer via email and AOL Instant Messenger which she told him were from alien-human "hybrids". These communications referred to me and to my record of my anomalous experiences on a number of occasions. I came to the opinion that this was a hoax, and that Elizabeth was writing the communications. Dr. Jacobs, however, said that he believed that they were authentic. In hindsight, I am of the opinion that he was, in fact, engaged in an abusive psychological "game" with her, that he subsequently involved me in.

Dr. Jacobs' behavior towards me during this period became increasingly peculiar. At one point he asked me to write my emails to him pretending that I had Multiple Personality Disorder, so that hostile "aliens" would not know that he was researching my case. The effects of his behavior on me were compounded by the vulnerable position that I was in as his research subject being regularly hypnotized by him, and eventually caused me severe stress.

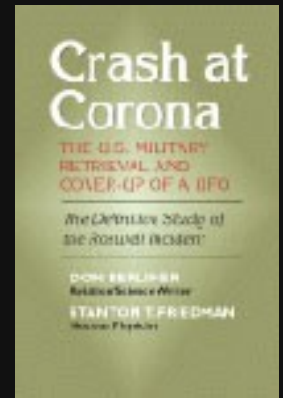

I have a sleep disorder, in which I do things in my sleep, which sometimes occurs when I am under stress. In late 2006, the strain of the events triggered my sleep behavior, which exacerbated the situation.

I finally made the decision to end my work with Dr. Jacobs in early 2007. I am currently writing a full account of what occurred which will be available in the future. In the meantime, I have provided some preliminary information in Dr. David Jacobs' Account of a "Hybrid" Warning - Audio Clip and Conversations with Dr. David Jacobs - Audio Clips on my website.

The ending of my working relationship with Dr. Jacobs was personally difficult for me, as he was the only person in my life who was familiar with my category of experiences, whatever their actual

origin. I subsequently took time out to recover from the stress of the previous year. **I decided to publish my longitudinal study on my website:** In mid 2007, I began working on my longitudinal study of my anomalous experiences again. The events of 2006 and 2007 taught me a painful lesson that I had to tread carefully in the field of "alien abduction" research. I realized that I could not openly trust people as I had before. After everything that had happened, I questioned whether it was worth continuing with my research. I made the decision to persevere as I had collected a large amount of data in the process, and it was personally important to me as a way of coming to terms with my experiences. I decided to publish it myself.. My relatives' anonymity: As I am of the opinion that Elizabeth is almost certainly a hoaxer, and she

knows my identity and the location where I live, I have taken extra care to preserve the anonymity of my living relatives and friends in this longitudinal study. In cases where they also had anomalous experiences, I have not stated their relationship to me and I have changed some biographical details. Readers who previously read my account of my experiences on Dr. Jacobs' website may therefore notice that I have changed a number of biographical details between that account and the one that I have presented on this website.

My experiences and the "alien abduction" phenomenon: Although I have come to believe that my anomalous experiences fit patterns of experience that, in our culture, are often explained as "alien abduction", I have not, at this time, formed an opinion about what is

New Technique Captures Daytime UFOs

W. Patrick, an aircraft engineer in Wichita, Kansas, tried to get photos of UFOs for years before discovering this technique, which has proved to be very successful.

Patrick has captured film footage and still photos of thousands of UFOs during daylight hours. He believes these objects are in our skies all the time, but we don't normally see them due to the glare of the sun and other factors that place the UFOs out of our normal field of vision.

The UFOs may be in the Ultra-

Violet spectrum, which is just outside the range of sight for humans. W. Patrick found that by using polarized A-B UV spectrum sunglasses, viewing of UFOs is possible.

A pair of A-B UV sunglasses is held close to the front of the camera lens, and the photographer should wear a second pair of the same type of sunglasses while looking through the viewfinder. This is essential—DO NOT LOOK INTO THE SUN while using this technique!

W. Patrick showed slides and film to the Kansas City MUFON attendees at the May meeting in Kansas City.

The audience was shocked to see hundreds of UFOs appear on the screen, shooting by very quickly. They made impossible maneuvers at an extremely high rate of speed. Some of the UFOs have wedge cuts in their sides, which are similar to the UFOs captured by the space shuttle camera during the famous 12-mile long tether flight. That film is available on YouTube.

Sun Blocked Viewing Technique:

Acquire several (two) quality pair of sunglasses for you to see through and one to take photos through with digital camera. Polarized, Dark Tinted (works best), UV A & B protection a must.

- Acquire a digital camera. 8.1 or better mega pixels recommended. Set camera for distance (if equipped) and light intensity reception to highest setting. Move to professional mode (if equipped) to take multiple photos in sequence (one second apart works best).
- Conditions. The weather must be clear. Little Haze and Partly Cloudy. Best time to view is between 12 PM and 3 PM local time.
- Northern Hemisphere. Stand on North side of building or structure in shade.
- Look up at edge of building or structure at approximately 30-40 degrees above where the sun would be visible. **DO NOT LOOK DIRECTLY INTO THE SUN.** This is not necessary. Some people have reported the ability to see what appear as white objects moving or flashes high in the sky around the bright area near the sun. Do not be confused by dust or particles low in the atmosphere. Look beyond that. Orbs/Ships appear to be from 1000 ft. to as high as 30,000 ft. altitude.
- Hold camera up and looking through second pair of sunglasses (camera view finder if equipped) start to take multi-

ple photos in sequence. You may be able to see the Orbs/Ships when looking through view finder. If you have video mode try that also. This should work best beginning with infinity and move to 4x power zoom (optical or digital) or greater. Remember the field of view narrows as the power zoom increases. Orbs/Ships appear to be from 1000 ft. to as high as 30,000 ft. altitude.

- Your results should show Orbs/Ships that are white in appearance with some being just out of focus when seen with 4x power zoom. At 37x power optical zoom you will see greater details of the

Orbs/Ships. These Orbs/Ships can move at a remarkable speed and appear and disappear quickly. This is the need to have the professional mode taking multiple sequences still photos or run all in video mode.

Patrick has captured photographs of at least 27 different types of UFOs, including round, rectangular, star-shape, saucer-shaped, rods, and more.

behind them, other than that I believe that it is something real and anomalous. I know that at least some of my experiences are not psychological in origin as there are other witnesses, material artifacts and physical traces associated with them (although there may also be psychological aspects to some of them.) Whatever their origin, my longitudinal study has deepened my understanding of my own experiences. I hope that it can also assist others in exploring this mystifying phenomenon.

Acknowledgements: I would like to extend my thanks to the wonderful people in the UFO community who have helped me through a difficult time, and who continue to do so.

Brian Reed helped to sustain me through the long period when no one wanted to hear. He is assisting me in ways that I cannot divulge, but which are incredibly courageous, driven by his high integrity. I owe him a debt I can never repay.

Kim Carlsberg did so much in first bringing the serious ethical issues involved in Dr. Jacobs' work with me as his research subject to the attention of the UFO community. She displayed such courage, integrity and humanity in the process.

Next, I heard a little girl talking and heard the name Becky. The owner said that other investigators

have seen a little girl in this room.

Finally, I saw a tall man wearing a cowboy hat, boots, and two pistols walking around and saying they needed to go to Piedmont to round up a posse to go after the James Gang. I thought he was a Pinkerton. The owner confirmed that Jesse and Frank James did rob the train here and the money was never found.

Century-Old Watch Found in Tomb Sealed for 400 years

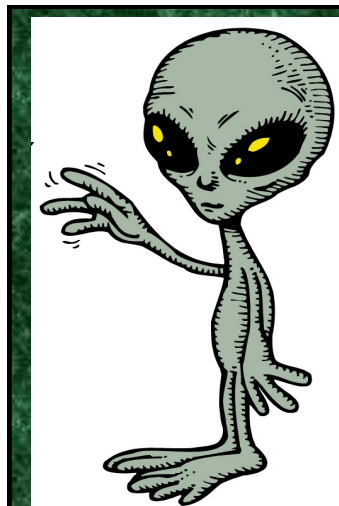

The ark is the length of a football field and four stories high. To get perspective, it is the size of a small cruise ship. He has included lifelike plastic animals throughout the vessel.

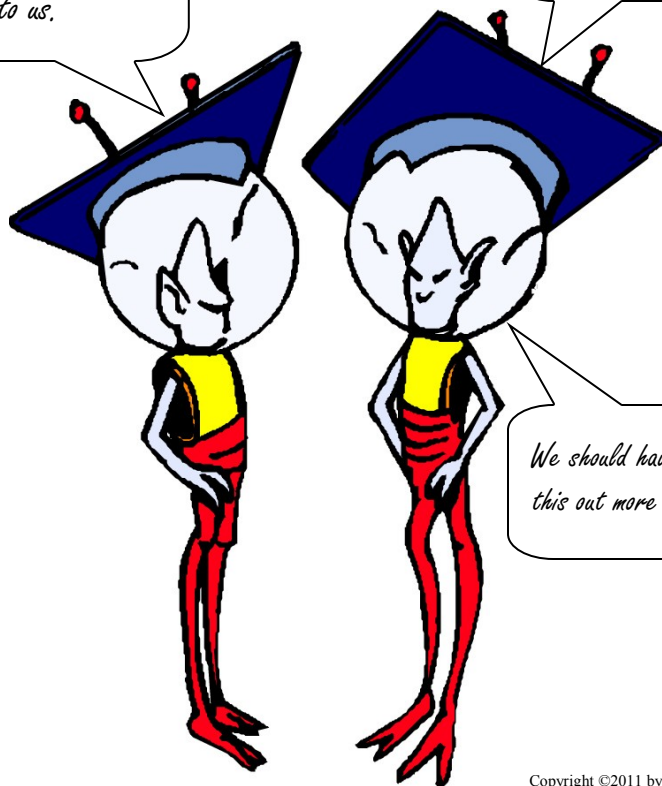
The ship is almost complete and Huibers plans to sail the ship up the Thames for the London Olympics next year. A video of the ark is on today.com.

These are voices of the post disclosure world. They explain and rebuke. They puzzle and ful-

minate. Some shout. Some cry while apologizing. Others retort, and still others express Joy mixed with Fury.

All the reactions to the new world that storms, riots and re-

It was the day when a thousand great ships dealt our world a wild card (that history always plays---just when most don't expect it). That day history smiled ironically and said: "Expect it."

But after initial elation and amazement wore off, a time of chaos began as well,and we grew up. The day of dazzling divide was

The Speakers Podium - The United States Senate

Senator Thompson was the first to speak on the record, and to formally engage the changed world, twenty-seven hours after the storm front of cosmic changes had hit the earth. He stood in the well of

Instead we failed and failed in such a spectacular fashion that may God help us in undoing this great failure. Eleven days post D-day, the omnibus panel, which included a greater number of executive and scientific

 “Mars Prophet Richard Hoagland has last laugh”
 “Moon Ruins of Crystal Towers ruin NASA reputation.”
 “Spook Caltech Panel Controlled JPL Programs.”
 “Congressional Probe of MSSS Scheduled”
 “Malin Space Science Systems—Vaulted Operation
 — Monthly Visit by Intel Spook Bobby Inman.”

The omnibus panel finally gaveled live at 11: 23 a.m. PST after nearly another hour delay. The director cleared his throat, and began:
 “Good morning... To all of you who have waited so long for this press session to materialize, it has been a long week for all concerned and...”

He seemed about to say something aside, when the Chief legal advisor gave him a piercing glance,

Certainly the Leaders of this body of national expertise, will fully cooperate and testify before congress, and we are preparing in a detailed fashion for the emergency hearings, secondly we will discuss the schedule of forthcoming imagery releases with analysis, dates and areas that have never been released — unprocessed by the...”

He paused and considered his words “operation at MSSS that do provide definitive evidence of both large areas of life, ancient ruins and the current resident conurbations of this world.”

The room fell momentarily silent at this rather casual affirmation of the flood of leaks and statements from the president in his oval office address a few days ago, the ESA Statements, the noisy Russian releases, and the many insiders who had spoken.

In another casual bomb, the director then admitted the secrecy methodology had employed two sides to the planetary program staff ---a black and white team division, with some overlap that monitored the potential whistle blowers.

At precisely 3: 18 a.m. in Ward 4 on the second floor the new “client “ who had been agitated and restless and awake, suddenly sat bolt upright and said in a loud voice:

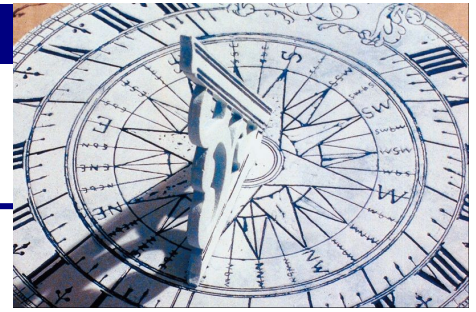
Many rumors swarmed around the Department after the fleet appeared, particularly around Dr. Nancy Flancy, known for her withering ridicule of abductees.

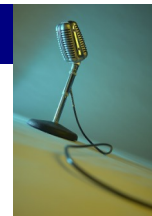

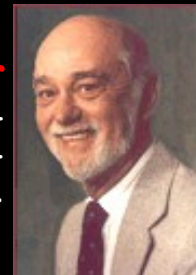
