# Salim Deal CPI(M)'s ideological bankruptcy and total downfall exposed once again

Buddhadeb Bhattacharjee, the CPI(M) politburo member and West Bengal chief minister accompanied by a large contingent of leading industrialists and senior bureaucrats, had been on a tour to Singapore and Indonesia last month to scout for mega scale FDI to the tune of around Rs.50,000 crore. After having a series of meetings with the president, prime minister and other top level government functionaries of Singapore, the CPI(M) leader also held discussions with the chambers of commerce and leading industrialists there. Then he went to Indonesia where he signed a memorandum of agreement (MoA) with the Salim group, the largest business house of that country. As per the agreement, the Salim will invest around Rs.44,000 crore in West Bengal on urban development projects and the West Bengal government will make available 5,100 acres of land to them for the purpose. Urban projects include real estate development to accommodate big posh housing and shopping complexes, IT hubs, amusement parks etc., which are meant to cater to the rich and affluent. Salim will also build the necessary infrastructure for a new

special economic zone (SEZ) where, as one is aware, the capitalist owners are offered a host of concessions including exemption from tax and labour laws, The CPI (M) leader also gave an open invitation to the Foreign Institutional Investors (FIIs) who operate in the speculative capital market, by saying, "We are not looking for industrial finance only. We want FIIs to pump into our state."

CPI (M) pitches for reforms, globalization

Lest there is an iota of apprehension about the CPI(M) led government's sincerity to buttress the business motive of the foreign monopolists, the CPI(M) leader was also forthright in enunciating the political view of his party. "We have to reform our policies", observed the CPI(M) leader, "otherwise we will not be able to survive. ... We cannot speak anymore about dogmas. ...We learn truth from the facts, not from books ... globalization is a must. ... We have changed ... we must reform or perish." The message was crisp and simple to be well communicated to the capitalist class, captains of industry, foreign Contd. on page 2

# SUCI Vehemently Protests Latest Escalation of Petrol-Diesel Price

Comrade Nihar Mukherjee, General Secretary, SUCI, in a statement issued on 6 September, 2005 vehemently opposed yet another steep hike in petrol-diesel retail tariff, sixth time in succession after the Congress-led CPI(M)-CPI backed UPA government was saddled in power just sixteen months back. Needless to say, said Comrade Mukherjee, that this escalation of fuel prices would have a snowballing effect in pushing the general price line of essential commodities to a record high while the common people of the country groaning under the yoke of ruthless capitalist exploitation stand totally incapacitated to bear the brunt any more. Comrade Mukherjee warned that Damocles' sword is also hanging on the prices of LPG and kerosene and a hefty increase could be announced any day.

Rejecting the government's plea that fuel prices had to be increased to bring them at par with the rising global tariff, Comrade Mukherjee emphatically stated that this ready-made Contd. on page 8

Calling upon the people to make this general strike a grand success, UTUC- Lenin Sarani, a party to the call, has issued an appeal. In the said appeal, it submitted the following brief analysis for clear understanding of the background the tasks ahead.

With each day passing in the

globalizationregime of liberalization unleashed by capitalists-imperialists, assaults from the ruling capitalist class on the working people get more and more intense and unbearable in every capitalist country, India no exception to it; capitalist exploitation, all over the world, has become yet more fierce and backbreaking. Needless to say, the aim and purpose of this economic policy have been the same from country to country of capitalist class rule and steps taken to implement it have also been, more or less, pre-planned and of similar nature, albeit varying

in details in conformity with local conditions. In India, to come to our concrete case, commercialization and privatization at random, closing down of public sector undertakings, with abolition of departments in central and state governments added to it, disinvestments and related attacks, have not only created unprecedented job insecurity among the public sector and government workers and employees but along with it, it has also brought down grave economic offensives on the life and livelihood of the common people of the country at large. In private sector too, the picture is

terrible. Rapid curtailment of workforce is taking place in the guise of modernization and downsizing being adopted in the name of structural economic reforms. Already, 305,000 workers have been thrown out of employment with VRS in industries including the giant ones like TISCO. TELCO, Siemens. Reliance, Grasim, etc. Alongside, 105,000 workers have lost their jobs in IT industry alone in 2000-01. According to another report, 700,000 small industries and 7000 medium scale and big industries Contd. on page 3

# Moribund capitalism can not spur industrialization

monopolists, spokespersons of global big imperialism and moneybags that they need not attach any importance to the 'communist' signboard which the CPI(M) carries as a subterfuge. Rather they were convinced that the CPI(M)'s is a submission candid sharply contrasted to any kind of prevarication or absurd contortion. Under the cloak of Marxism-Leftism, the party is committed to serve the interest of the capitalists, both foreign and home-grown. Impressed by the pro-reforms proglobalization stand of the CPI(M). the overseas business tycoons promptly equated the CPI(M) chief minister and his party with the Congress who initiated and has been meticulously pursuing policies of capitalist economic reforms and liberalization. Effusive in praise was Dr. Manmohan Singh, the Congress prime minister and the author of capitalist economic reforms in India. "I congratulate Bhattacharjee. I wish all chief ministers emulate him", said Dr. Even the chambers of Singh. commerce and leading industrialists of India burst forth in cheers and applause. Accolades were showered by the US ambassador in India as well. When reminded that the Salim group is not exactly a lily-white commercial operation and it was extremely close to former Indonesian dictator, Gen. Suharto, who butchered over 1 million communists, the CPI(M) chief minister nonchalantly remarked that he did not wish to see "the colour of the money." This sounded similar to the assertion of Deng Xiaoping, the capitalist-roader and chief architect of counter-revolution in China who is now the role model of the CPI(M) leaders that he did not mind whether the cat is black or white so long it catches mice.

When the bourgeois media seized this opportunity to pitchfork the CPI (M) chief minister as "christened Deng" for his determined reform drive and crusade against the basic tenets of communist ideology and projected the Salim deal as his brainchild, the CPI (M) politburo and central committee put a seal of approval to all his statements and actions thereby confirming that the West Bengal chief minister had only executed the policies and political directives of the party. The

CPI(M)'s open espousal for globalization-liberalizationprivatization and exuberant invocation to FDI caused exhilaration in the imperialistcapitalist camp no doubt but there was severe criticism and condemnation from the wellmeaning right thinking people round the country who could not tolerate this sickening sycophancy of exploiting oppressive capitalism spelling disaster in the people's life. Particularly the proposal to allot multi-crop yielding agricultural land to the foreign monopolists for real estate business by uprooting the peasants caused a row in the country. Even questions were raised at the lower rung of the CPI (M) as well as among its associates.

# How CPI (M) defends Salim pact

In the face of this rage and wrath against the decision to placate foreign monopolists at the cost of poor farmers, the CPI (M) leaders swung into an act of damage containment through hoodwinking. They argued that the proposed mega investment from Salim would foster industrial growth and create substantial job opportunities. So there would be all round development of the state of West Bengal and benefits would percolate down to the lower end of the economy. Hence there was no harm in acquiring agricultural land and hand it over to Salim. But can such FDI spur industrial growth as claimed by the CPI (M)? What is the experience of the people?

#### Grim Industrial scenario

The industrial scenario is plagued with worst kind of recession and stagnation. Right from the days of independence, the ruling Indian bourgeoisie, despite all efforts, could not bring the desired tempo in industrialization. Rather with the passage of time, the situation became bad to worse. Everyday thousand of existing mills and factories are getting closed throwing millions of people out of job. In West Bengal itself, around 1.5 million workers lost job in the last 5 years and shutters were downed in about 50,000 industries. Damocles' sword is hanging on many of the running units. In the existing industries, there is a spree of lay-off, retrenchment, forced termination, compulsory retirement and downsizing. There practically a moratorium on recruitment. Vacancies are abolished. As against permanent employment, contract and casual labour system at much lower wage is taking over throughout the country even in the public sector units and government departments. West Bengal government itself is appointing contract and casual labour, not filling up vacancies. Side by side, no new employment generating industries in the core and manufacturing sector are coming up. unemployment Hence skyrocketing everywhere. Only in West Bengal, there is over 7 million registered unemployed.

With of introduction globalization-liberalization, there is further curtailment in the job possibilities as more number of factories including a host of public sector units are being declared nonviable and hence either folded up or handed over to private monopolists after severe reduction in workforce and enforcement of stringent service condition of hire and fire removing the last vestige of job security. Foreign capital making forays in the domestic market through set up of limited highly mechanized capital intensive ventures mostly in the unproductive service sectors or real estate projects where manpower requirement is pegged down to almost nil. In the name of encouraging export promotion, bountiful of concessions including complete exemption from labour laws is granted to the entrepreneurs setting up projects in the SEZs.

### Crisis-ridden capitalism impeding industrialization

This slide in industrial growth began from the time capitalism entered moribund stage posing stumbling block before the need of industrial production and social progress. As a concomitant to the motive of earning maximum profit in the capitalist law of production, there has been continuous fall in the purchasing power of the people leading to market crisis of the capitalist owners. With the passage of time, this crisis went on being accentuated and has now become an hourly predicament of capitalism. Immersed in this insurmountable crisis, world imperialism-capitalism, in a frantic bid to survive, is taking recourse to several measures like increased militarization of economy,

indulging in massive speculation in capital market and other areas, formation of various business blocks like European Union (EU) and South Asia Regional Council (SARC), free flow of capital across the border in the name of globalization-liberalization. Yet it is unable to find any way-out.

This is the stark reality. In this third phase of general intense crisis of moribund world capitalism, there is no scope for job-creating industrialization at private initiative. Even rich G-4,G-7 countries like US,UK .France, Germany, Japan are so crippled by crisis as to abandon productive industrialization and talk of jobless growth. Unemployment is thus soaring in each and every imperialist-capitalist country. Our country being ruled by the national bourgeoisie, an inalienable part of moribund decadent world capitalism, is no exception to this. There has hardly been any industrialization worth the term under private initiative. Immediately after independence, under public pressure some basic and manufacturing industries were set up in the public sector with public finance at the instance of the government creating limited employment opportunities. But because of all-out crisis of capitalism, public sector units also gradually became sick and either went out of production or handed over to private monopolists at throwaway price rendering millions workers jobless. of After globalization, there is a spurt of such privatization under the pretext of transforming these sick units into viable ones by drastically reducing workforce so that the monopolists receive a readymade infrastructure at least of cost. Naturally this huge exodus from closed or privatized state-sector units coupled with the innumerable workers being retrenched, laid-off, compulsorily retired or terminated in the private sector is getting added to the vast multitude of unemployed craving for a job that is eluding them in the absence of any employment generating industry.

### Hoax of FDI-sponsored industrial growth

# Build up sustained organized struggle to resist capitalist onslaught

have already closed down affecting 10 million workforce during the decade after globalization started in Nineties. In fact, the fast worsening economic condition under 58 years exploitative capitalist rule since Independence, has been overtaken by a new type of horrid exploitation. destitution and deprivation during this regime of globalization. Now, capitalism aims at protecting and augmenting the maximum-profit-fetching interest of private enterprises in virtually all production activities of the country and by any and every means. Whatever little security of job and other fringe benefits were there, are being systematically robbed of

In fact, reforming labour laws and relations has been one of the most striking agenda of the globalization regime. Avowedly the aim is to bring about so-called 'labour flexibility'. This again includes two types of changes. First, changes in the law to allow easy retrenchment and closure, which the government termed as exit policy. Second, the replacement of permanent labour by contract and casual labour, whereby the former enjoying the various legal rights, in particular job security, are replaced by a workforce that can be hired at cheaper cost and fired at will. Here again, this is a feature in all capitalist countries. In India the last BJP-led NDA rule at the Centre marked an ominous beginning. It tried with much verbosity to introduce a bill in the Parliament, ostensibly with a view to promulgating a comprehensive labour law, that really meant nothing other than shameless robbing of all rights of the working people to uphold and defend their demands through trade unions. In the face of countrywide resistance, it retraced its steps, but the move was not withdrawn; the danger remains as yet to come down on the workers at any opportune moment, if they remain unaware and unalert. In addition to it, or rather being obstructed to implement it, the government has adopted another trick. Cunningly, it is creating, what it calls ' Special Economic Zones', one after another throughout the country. Their only speciality lies in the fact that these are the zones of economic activity, meaning business and industry of capitalists of the soil as well as of foreign lands, in which

the workers would not have any right whatsoever. As a fallout of this so-called 'labour flexibility', tens of thousands of factories have been closed without legal formalities. Even as the pool of job-seekers steadily rise each year, total jobs in organized sector jobs have declined considerably both on account of closure and retrenchment and the decision of not filling up vacancies. In the organized sector alone, total employment fell by 1.2 million between 1997-03. The collusion of subservient bourgeois governments at the Centre and in the states with the managements' illegal actions was crucial to the success of these heinous measures. In other words, even without changing the formal legal situation drastically, changes were achieved as part of a concerted political drive by the ruling classes, both directly and through their subservient governments, their pliant media and their political outfits.

Congress-led UPA The government, supported and backed by the CPI(M)-CPI and their allies assumed office at the Centre in May, 2004, in the backdrop of the BJP-led NDA rule of 6 years. During its ascendancy, it played upon and made use of the tremendous resentment and indignation of people against the BJP-led NDA rule with scores of sugar-coated tall talks and claims. But just within 16 months of its rule, it has betrayed its real character proving itself no better than its predecessor. Immediately after assuming office, it began implementing the agenda of globalization with all vigour and ferocity. It also let loose a series of sinister economic assaults, for example, by way of steeply hiking prices of petrol and diesel twice within a span of two months and six times during its spell of 16-months' misrule. It immediately cut down P.F. interest rate, enhanced the proportion of FDI (Foreign Direct Investment) in vital sectors of aviation and civil telecom. insurance. In the small-scale sector, the second largest employment generating sector of the country, it de-reserved 85 more items thus further squeezing the employment potential in the already abysmally squeezed job market.

This grave, ever-worsening situation thus left the working people with a singular alternative. For their survival and sustenance, for protection and preservation, let

alone extension, of their hard-earned rights against this ruthless onslaught of the ruling capitalists and their subservient governments, they have no choice but to develop sustained movement. UTUC-LS, in a letter addressed to all the central trade unions strongly urged for building up stage by stage this sustained movement of the workers. Comrade Krishna Chakraborti, Vice-President of the UTUC-LS, in course of his address in the National Convention held in Delhi on July 9, last categorically stated: We have to understand that the policies of globalization, liberalization and privatization, which are spelling disaster in people's life are the policies of the ruling monopolists of our country. These policies are wedded to safeguarding the vital interests of the ruling capitalist class and hence their implementation is not dictated by anybody's whims or mistaken notions. These are wellthought policies adopted in defence of the ruling class. Naturally, these policies cannot be changed at one stroke, simply by observance of one day's strike or so. The task is therefore to built up prolonged and powerful mass struggle bringing within its fold all section of toiling masses and working people gradually adding dimension to the struggle.

Unfortunately, the big trade unions like CITU or AITUC were not ready to accept this call for sustained movement. May be, as because their parents, the CPI(M)-CPI were co-operating with the ruling UPA government at the Centre and were sort of associated with it, their trade unions' were prompted to express unwillingness for sustained movement, lest that embarrassed their friends in power. The simmering discontent and seething indignation of the teeming millions of toiling people, however, compelled the CITU-AITUC, to accept ultimately at least the proposal of observing one day's countrywide general strike. Undeniably, the immediate task of the toiling people bearing heavily whole brunt of capitalist the exploitation, is to make the proposed countrywide General Strike on September 29, 2005 a total success as the first instance of resistance of the toiling masses against the onslaught. The charter of demands covers the most burning problems of life and livelihood of working people of the whole

country, and includes inter alia, the followings —

- (i) halt moves towards downsizing of work force and lift ban on recruitment;
- (ii) stop contractorization and casualization of labour;
- (iii) stop privatization and disinvestment of profit making and strategic sector, PSU-s including nationalized banks, telecom, airport, etc.;
- (iv) no privatization of public services and utilities;
- (v) revive sick units;
- (vi) constitute 6<sup>th</sup> Central Pay Commission;
- (vii) implement recovery of Non-Performing Assets (NPA) and unpaid tax arrears from corporate and big business houses;
- (viii) review 'The Electricity Act, 2003' and the National Electricity Policy;
- (ix) suitably amend the National Rural Employment Guarantee Bill to ensure employment guarantee for the rural and urban unemployed within a definite time frame;
- (x) enact comprehensive legislation on service condition and social security for unorganized sector workers in general and agricultural workers in particular;
- (xi) take adequate measures for enforcement of all labour laws including minimum wages.

But people, at the same time, must realize that a successful strike for a day is not the end. Occurrence of the Gurgaon massacre perpetrated by the Congress-led Haryana government, acting in open and naked league with the Japanese MNC Honda management has proven blatantly how ferocious and brutal the capitalists and their governments subservient can become. How bestial could they turn into even in the face of a demand for simple trade union right raised by the Honda workers and employees, was witnessed by the whole country vividly on TVscreen. In that case, can it ever be expected that a mere one-day general strike would help workers realize their demands? The answer is an emphatic no!

On September 1, 2005, Comrade Hariprokash, Secretary of Sonepat District Committee, SUCI, visited the Valmiki Bustee at Gohana in Haryana, saw the burnt down houses and spoke to those affected by the heinous incident of arson and looting which took place the day before by the BJP and Sangh Parivar goons.

Such planned arson and looting of the houses of the Valmiki Bustee people, is an atrocity perpetrated against human rights of living with honour and security. This is unimaginable in democracy. More condemnable is the fact that police and administration, instead of stopping the miscreants, practically instigated them when they were engaged in such nefarious acts. Sonepat District Committee of our party has strongly condemned these acts and demanded : (1) Strict punishment miscreants involved in arson and looting on August 31 and to the perpetrator of killing of Baljeet Singh. # SUCI pays glowing tribute to Comrade Mao

On September 9 last, on the occasion of 29th death anniversary of Comrade Mao Zedong, the great Proletarian leader and the architect of the Chinese Revolution, a memorial meeting was held at Esplanade in the heart of the city of Calcutta under the auspices of the West Bengal State Committee of SUCI. # Evicting peasants for jobless urbanization is criminal

mission to resolve our unemployment problem nor are they under any obligation to accept any term from any of the governments here. Salim or any such vendor of FDI knows very well that beggars are no choosers-the government will either have to accept its terms of offer or leave it. Their sole motive is to usurp maximum profit by exploiting the cheap labour, raw material and plethora of trade and commerce related concessions like SEZs that the recipient government provides them. Hence they canalize their investment only in selective highly capital-intensive tech-savvy projects where only a miniscule skilled workforce is engaged on casual or contract basis at stringent terms and low wage. The principle of appointment in such FDIsponsored ventures is "hire and fire". How many people were absorbed in the much clamoured Haldia Mitsubishi plant in West Bengal? May be a few hundred. As against the promise of providing jobs to half a million in Haldia Petrochemicals, the actual figure has not crossed even ten thousand. How do the recruitment figure in the much-hyped IT hub in Calcutta's special economic zone in Salt Lake compare with the millions of workers shunted out everyday from other industries?

In such a milieu, where is the scope for nursing illusion of employment generation through FDI-sponsored routes? Notably, the bourgeois media has also been lashing out propaganda that for spurring industrialization and development, door must be opened to foreign capital at any cost and any opposition to such moves is retrograding and smacks of dogmatic predilections. That is why the CPI(M) leadership is so desperate to prove that they are estranged from any such 'dogma' that impairs the class interest of crisis-stricken imperialismcapitalism gasping in its death throes and in return receiving profuse praise and extensive coverage in the media.

So it is clear that today, there can be no industrial growth at the initiative of private capitalists. Under the circumstances, only the government, if compelled by the pressure of people's movement, could take some efforts to establish job-creating industries on a limited

scale as happened after independence in compliance with people's demand. But neither the central government under the Congress, the BJP or any other combination nor the CPI(M) who has been running the West Bengal uninterruptedly for 28 long years took any initiative in this regard. Nor has the CPI(M) exerted any effective pressure on the central government to do so. On the contrary both the central and state governments raising the plea of sickness have been generously gifting away the state-sector units to the private monopolists accepting dismissal of the workers en masse. Even in neighbouring Assam, three oil refineries had to be set up in public sector to give some reckoning to the public opinion. But the CPI(M) had no intention whatsoever to walk that way. The same CPI(M) leaders now want people to believe that they are interested in mitigating the problem of unemployment and hence are providing red carpet to Salim and others. This is perfidy at its best.

#### Salim to promote urbanization for the rich

One should also not lose sight of the fact that Salim group is not transferring the money to the CPI(M) led government so that the latter could use the same for choosing its own technology and creating maximum number of jobs. The proposed outlay is for building projects on the land specified by the group, using technology of its choice to ensure that it generates maximum returns on the capital employed to be ploughed back as super profit for being taken outside the country. Moreover Salim is not investing for augmenting industrialization either. It is promoting, as we stated earlier, urbanization, realty, service activities of the luxury kind. The plan is to create a beehive of facilities like golf course, swimming pools, star hotels, glitzy shopping malls, entertainment plazas, modern housing complexes, world class health cities and so forth which will cater to the rich, affluent, moneyed business travelers and tourists. Even the few high-tech IT firms and food-processing units Salim is talking about will be in the SEZs which, as mentioned before, are to remain outside the orbit of national tax and labour laws enabling it to fleece and squeeze the workers at will.

#### CPI(M) foresees domestic help's job for evicted peasants

The CPI(M) leaders are claiming that Salim will create 30,000 jobs. Assuming the figure to be not an exaggerated one as is apprehended by many, what type of jobs would that be other than that of contract and casual labour at low wage in the SEZs? Therefore a question is correctly raised by some quarters including peripheries of the CPI(M). Will not the employments and earnings in fact decline if the loss of agricultural outputs and farm employment consequent to transfer of arable land is matched against precipitation of limited jobs in the SEZs? The CPI (M) leaders are of course too enthusiastic about a unique variety of egalitarianism that they have in store for the land losers in the Salim deal. According to them, the evicted peasants will be absorbed as barbers, gardeners and domestic helps in the proposed enclaves of the rich. To what low can one stoop to rejoice at owners of cultivable land being forced to become domestic hands.

### Ominous consequences of transferring agricultural land

Obviously the question that arises next is why then should arable agricultural land be acquired by displacing thousands of peasants who, in this harrowing job scenario, are at least trying to eke out a living from whatever little land they possess? Already there is galloping rise in the number of landless peasants and agricultural workers who do not have work even for two months a year. So precarious is the condition that even government is talking in terms of providing them 100 days' job. As per agriculture census, 2, 91,620 acres of cultivable land has already been lost in the country because of conversion for commercial use in last 5 years. Statistics also reveal that in West Bengal, 2.4 million peasants have landless agricultural become labourers in the past 15 years. Over and above this, if 15,000 more peasant families are uprooted from land because of Salim, where will the influx be absorbed? Had it been so that there was enough scope for permanent gainful employment of sufficient number of people including their progenies, there could have been no objection to such land transfer and mass eviction. But in absence of that, and knowing fully well that the Salim is no sorcerer to generate jobs through industrial growth, is not such a move to uproot the poor peasants from land tantamount to strangulating them to death?

### Eviction to turn peasants into beggars

The CPI (M) is propagating that the evicted peasants will receive adequate compensation and alternative employment. The CPI (M) minister of industries in West Bengal has even given a calculation as to how the bank interest from the deemed amount of compensation will generate a surplus income for the displaced peasants. But the facts of experience bear the other reality. Over 34,000 peasant families were forced to vacate their land holding including multi-crop yielding stretches to make room for sprawling township of Rajarhat and Bantala leather complex. A few hundred more families were dispossessed of land for the similar realtry projects in Howrah and Hooghly districts. They have either not received any payment so far or paid compensation much lower than prevalent market price. Contrary to the assurances of the government and the CPI (M) bigwigs, no alternative livelihood was made available to them. Moreover, in absence of any gainful engagement and enmeshed in debt-trap, can any of these families afford to save their money in banks? Rather, they will soon exhaust whatever paltry sum they receive and turn into beggars for generations.

### Pernicious fallout of extinguishing arable land

There is another very serious issue related to this deal. Experts of agriculture and food production are saying that currently agricultural production has come to a stalemate situation as fertility of the land is not increasing. According to them, law of diminishing return has set in. Despite so much hue and cry about technological development, the yield of crop in rural India is still at the mercy of the quantum of rainfall in monsoon. And having regard to the increase in population, it is incorrect to claim self sufficiency in food. In view of this, there is no Contd. on page 7

# SUCI hails victory of people's movement against power tariff hike in Delhi

The Delhi Government disgraced itself by threatening the RWAs with dire consequences if they went ahead with their civil disobedience movement. ... Finally, it bowed to people's pressure and withdrew the tariff hike, but with a completely unacceptable formula. Half of the deficit created by the withdrawal of the tariff hike will be met by a subsidy given by the Government, clearly helping private companies.

While hailing this people's victory and the energising effect it has on people's movements, SUCI feels that it is necessary to politically deepen and spearhead the current movement against the policy of privatisation itself....''

### Orissa Convention on September 29 General Strike

Sixteen point demands on which countrywide general strike has been called on September 29 next was discussed in the convention. They included a comprehensive legislation for unorganized workers particularly the agricultural workers, ban on disinvestments in profit-making industries, legislation for stopping atrocities on women, specially those working in factories etc. On behalf UTUC-LS of the Comrade Raghunath Das addressed this joint

gathering of workers and employees. He emphasized the need of immediate withdrawal of all antipeople policies of the UPA government, asserting simultaneously that there was no difference between the present government and the former NDA government insofar implementation of policies of globalization and curtailment of workers' and employees' rights were concerned. He also pointed out how the Congress-led UPA government is making calculated moves to give effect to its economic reforms policies. He urged upon the government to amend the Bill for 100 days' job so as to guarantee job unemployeds not just for for hundred days, but for the entire year and to withdraw the anti-farmer Seed Act, 2004. Souri Bandhu Kar, Bishnu Mohanty, Jogendra Tripathy, Radha Kanta Sethi and others also spoke on the occasion.

cogent reason for jeopardizing the current production level and that too in a state like West Bengal which is stated to be relatively better off in food production. Whatever might the CPI(M) leaders say, the truth is that in densely populated West Bengal it is impossible to identify fallow, unutilized or unutilizable plots that are contiguously arranged and add up to 5100 acres as requisitioned by Salim. So acquisition of multi crop yielding, fertile land in significant volume is inevitable. The same had happened while lands for Rajarhat and Bantala complexes in the agglomerate of Calcutta were taken over. The CPI(M) leaders contend that the had voluntarily peasants surrendered the land. But fact is their cultivable land was filled up with mud at the dead hours of night to complete the process of acquisition. In whose interest, the CPI(M) is sounding death knell for the peasants?

### Resist the sinister move tooth and nail

So viewed from all angles, the deal proves to be not only a farcical exercise to fool around people but fraught with serious ramifications. If this policy goes unchallenged, then more and more agricultural land will be transferred to serve the classinterest of the indigenous and foreign monopolists. Not only millions of peasants will become beggars, even food production will be affected. So the Salim package is a deliberate fraud on the people, consigning them into more misery, penury and ruination. It is nothing but a pre-election warming exercise to secure another term by foxing people with the illusion of spurt in industrialization financed by foreign imperialists and winning the confidence of the ruling capitalist class through total capitulation. This is what the CPI (M) leaders have "learnt from the facts" as enunciated by the revisionists and counter-revolutionaries like Deng Xiaoping, Khrushchev, Breznev, Gobachov, to "survive" in the corridors of power. The chicanery of these pseudo-Marxists has to be laid bare. The downtrodden oppressed people from all walks of life must come forward and organize massive movements to frustrate this pernicious move and sinister design of evicting poor peasants from land to subserve profit need of foreign the monopolists.

In the last week of August of 2005 Hurricane Katrina struck the southeastern coast of USA causing widespread devastation in Louisiana, Mississippi, Alabama and particularly New Orleans. According to estimates not less than ten thousand perished and thousands are still in hospitals, and lakhs of people are passing their days shelterless or have lost their shelters. People died like subhuman beings in New Orleans and elsewhere hit by the hurricane. The aftermath was no less horrible. Even after six days, in Louisiana three lakhs people remained confined in hurricane-hit complained Louisiana areas, Governor himself. In superdoms and convention centres where the calamity victims were provided with shelter, the conditions were worse than that of ghetoes. Totally bereft of any rescue measures, for want of food, medicine, oxygen in even hospitals, the surviving population in New Orleans ran amuck. Looting and killing gripped the populace unhindered, police went off the region. Dead bodies floated and were strewn on the streets even after six days of the calamity-a scene of 'hell' and 'doomsday' as described by the survivors. Curfew was clamped. At last even military was pressed into operation to tackle the law and order situation. In short, the whole scenario turned to be a horrible admixture of war in peace time and natural calamity in a 'most civilized' country on the earth!

People of the world beholding such scenes in TV and knowing it from the print media were astonished how such things could happen in a country which boasted of being the economically richest and technologically most advanced in the world. They asked: was this hurricane unwarranted or accidental like earthquake? Even it be so, does such cruelly messy affair happen even in a developing or underdeveloped country? Was there any dearth of men, money or material in the country to meet the disaster ? Everybody knows that the answer is emphatically NO.

Before hitting New Orleans on 28th August, the hurricane hit Florida on 26th and that it was building up in the Gulf of Mexico, was known to the US administration at least three days before August 28th. But the government took no precautionary measure before 28th and did not evacuate the vulnerable population. "Actually, the

government did not evacuate anyone. The authorities simply declared a mandatory evacuation and then left it to the people to get out", reports Workers' World, New York on September 8. But the poor people, mostly black had nowhere to go as they had no means of transportation, even bus fare. They, 70 % of the population, stayed put in the hurricane endangered areas knowing their doom was at their doorsteps. This was actually not a surprise. The local newspaper of New Orleans, Times-Picayune reported in 2002 that the city's 1,00,000 residents without private transportation were likely to be stranded by any big storm. Nearly 80% of New Orleans lies below sea level, more than eight feet below at places. After the hurricane, water reached 25 feet over parts of the city. Knowing this geographical position of the city and the very much hurricane-prone climate of the southeastern gulf coasts of the country, several newspapers National Geographic including Magazine in an issue in October 2004 warned of such possible disaster in a tale-telling description which tallies in toto with the condition on 28th August in New Orleans. Houston Chronicle of December 2001, siting a report of Federal Emergency Management Agency, also warned similarly. A consortium of government agencies recommended that three to four billion dollars was needed for projects to avert disaster if a hurricane swept New Orleans. But the US administration which spent 4 billion dollars per month in Iraq occupation and in the name of establishing democracy in other countries perpetrated unlimited destruction and annihilation of lakhs of people in countries like Afghanistan, Iraq and elsewhere did nothing for their own people.

Why was this criminal negligence and apathy to the people of New Orleans and other Katrinahit areas? Because, as revealed and widely alleged, 70% of the inhabitants of New Orleans are black and more so poor, ruthlessly exploited and dispossessed; 95% of the Katrina victims are poor black people denied of the minimum humane attention by the US rulers. That is why, the US administration so insensitive to the was approaching hurricane and relief was so inept, which was unthinkable even in a third world country. More serious and despicable side of this beastly act of Bush administration was that it scrapped emergency measures to pay for the predatory war efforts in Iraq. Even after the warning of the hurricane, 80% of flood prevention funds were slashed and work on levees for protecting New Orleans was stopped to finance the war. Such was the criminal attitude of the US administration and nature of its commitment to the security of lives of the people of their own country. Hurricane Dennis of category 5, more dangerous than Hurricane Katrina of category 4, had hit Cuba this year, but the socialist government of Cuba mobilizing the common people and the army successfully evacuated 1.5 million people and the casualty of lives was only 16, whereas the US administration evacuated practically none and the casualty was over 10000 lives. Again this socialist government of Cuba under ruthless economic embargo for over 40 years imposed by the US imperialists sent a team of 1000 doctors with 25 tons of medicines for relief of the New Orleans people! And imperialist US government had no option but to accept it to cope with the ghastly aftermath created by their apartheid character and sheer neglect to the poor.

According to US Census Bureau report of 2003, 36.5 million people, mostly black, in America is poor, which constitutes more than 12.1% of the total population. New Orleans people are only a part of it. US imperialism always preaches of democracy, claims it to be a 'heaven' of mankind and the protagonists of bourgeois cry hoarse of US democracy. But this Katrina Hurricane has now completely shattered the myth and unmasked the ugly face of the American democracy and the bourgeois democracy, as well, at one stroke. However this is quite natural because in every capitalist country the ruling class exploits the working class and the have-nots to the extreme, to fulfill the interests of the owning class. And they care for a fig for the loss of life and property of the downtrodden. Hurricane Katrina episode only proves this truth to the hilt

pretext is a hogwash as the government could, had it so intended, spare the people from such periodic price hikes by reducing the exorbitant tax and cess imposed on petrol and diesel. But what is more indignant is that the government is also not taking any step to mount vigorous international pressure upon the international oil cartel headed by the US imperialists who is arbitrarily and whimsically hiking the global oil price to squeeze the people world over, to force it desist from launching such offensives.
