

# The Peterborough (Reorganisation of Community Governance) Order 2010

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

*Made this 29 day of March 2010*

*Coming into force in accordance with articles 1(2) & 1(3)*

The PETERBOROUGH CITY COUNCIL ("the Council"), in accordance with section 83 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 21 December 2010:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council makes the following Order in exercise of the powers conferred by sections 86 of the 2007 Act.

## **Citation and commencement**

1.--(1) This Order may be cited as the Peterborough (Reorganisation of Community Governance) Order 2010

(2) Subject to paragraphs (3) and (4) below, this Order comes into force on the 1 April 2010

(3) Article 8 shall come into force on the ordinary day of election of councillors in the year 2010

(4) For the purposes of:

- (a) this article,
- (b) article 5; and
- (c) proceedings preliminary or relating to the elections of parish councillors for the parish of Hampton Hargate and Vale to be held on the ordinary day of election of councillors in 2010,

this Order shall come into force on 29 March 2010.

## **Interpretation**

### **2. In this Order--**

"map" means the map marked "Map referred to in the Peterborough (Reorganisation of Community Governance) Order 2010" and deposited in accordance with section 96(4) of the 2007 Act; and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

"new parish" means the parish constituted by article 4;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983(s); and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8(t) of the Representation of the People Act 1983.

## **Effect of Order**

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order

## **Constitution of a new parish**

4.--(1) A new parish, comprising the area shaded pink on the map, shall be constituted within Peterborough

(2) The name of the new parish shall be Hampton Hargate and Vale

## **Calculation of budget requirement**

5. For the purposes of regulation 3 of the Local Government Finance (New Parishes) (England) Regulations 2008 there is specified in relation to the parish of Hampton Hargate and Vale the sum of £30,765

## **Parish council for the parish of Hampton Hargate and Vale**

6.--(1) There shall be a parish council for the parish of Hampton Hargate and Vale.

(2) The name of that council shall be "The Parish Council of Hampton Hargate and Vale"

## **Election for the parish of Hampton Hargate and Vale Parish elections**

7. Elections of all parish councillors for the parish of Hampton Hargate and Vale shall be held on the ordinary day of election of councillors in 2010

**Wards of the parish of Hampton Hargate and Vale parish and numbers of parish councillors**

8.--(1) The parish of Hampton Hargate and Vale shall be divided into two (2) wards which shall be named Hargate ward and Vale ward.

(2) Each ward shall comprise the area designated on the map by reference to

(a) the name of ORH3 for the Hargate ward

(b) the name of ORH4 for the Vale ward

demarcated by thick black outline.

(3) The number of councillors to be elected for the Hargate ward shall be seven (7) and for the Vale ward shall be seven (7)

**Annual meeting of parish council**

9. The annual meeting of the new parish council in 2010 shall be convened by the Chief Executive of the Peterborough City Council. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish council take office.

**Electoral register**

10. The registration officer for the Peterborough City Council shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

**Transitional provision**

11. Until the councillors elected to the council of the new parish of Hampton Hargate and Vale at the elections to be held on the ordinary day of election of councillors in 2010 come into office, the new parish shall be represented by those persons who immediately before 1st April 2010 are the elected councillors for the Orton with Hampton ward.

**Order date**

12. 1 April 2010 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.
