We improve our families' financial lives.

At the Center's 39 tax sites, families get much more than a free tax return—they get the information, tools and training they need to put their tax refund to work. Typically the largest infusion of cash a working family will see all year, a family's tax refund provides an opportunity to pay down debt, start saving and give themselves some much-needed financial breathing room.



Our typical client receives a \$1,900 tax refund.

We are proven.

Since 1995, we've served more than 230,000 families, returning \$340 million in refunds—more than any other organization of our kind. We have also helped more than 6,500 families open bank accounts and cut their ties to predatory financial services.

We are local in service, national in voice.


Our direct service model has been so successful that we've begun to export it to our partners in cities as far away as Albuquerque, Raleigh and Boston, ensuring that families across the country have the best opportunity possible to make economic progress. High Impact, Broad Reach

During the 2009 tax season, the Center put \$52 million back into the pockets of more than 33,000 Illinois families and their communities. **We saved families** over \$6 million in tax preparation fees.

Our **1,200-member volunteer** corps contributed 37,000 hours **preparing** tax returns, **counseling** clients on their tax situations and **connecting** them to financial services to save them money.



Even families who find themselves owing money to the IRS can make progress by working with the Center's free tax clinic, which can help them set up a payment plan, and learn how to avoid future problems.

Walking through the halls of Truman College, Autumn looked like any other student there—busy. For Autumn, though, it had started to look like her first year would also be her last. With a disabled sister to care for, tuition bills coming due and a full-time work and school schedule, dropping out of college to pick up extra work seemed like the only option.

Fortunately for Autumn, she came to the Center's tax site at Truman College, where a volunteer helped her claim several tax credits worth thousands of dollars that she didn't know she was eligible for and introduced her to Free Application for Federal Student Aid (FAFSA) to help her pay for school. This year, she'll receive her nursing certificate and start a well-paying career.
