<u>H 60</u>, by State Affairs Committee, was introduced, read the first time at length, and referred to the State Affairs Committee.

<u>H 102</u>, by Revenue and Taxation Committee, was introduced, read the first time at length, and referred to the Local Government and Taxation Committee.

The Senate advanced to the Twelfth Order of Business.

## Second Reading of Bills

<u>S 1008</u>, <u>S 1009</u>, <u>S 1010</u>, <u>S 1011</u>, and <u>S 1012</u>, by Judiciary and Rules Committee, were read the second time at length and filed for third reading.
