His friends are invited to call at the parsonage this evening, between the hours of seven and ten, where he will be glad to see them all.

New Albany Tribune 08-25-1887 p4c3 DEATH OF REV. DR. ATTERBURY. **The Rev. John G. Atterbury** died at his residence in Detroit, Michigan, yesterday. This announcement though not unlooked for will cause a pang of deep regret in the hearts of his many and warmly attached friends in this city. From 1850 to 1867 he was the beloved and honored pastor of the Second Presbyterian church. His strong Christian character, marked by great practical wisdom and gentlemanly courtesy made him power for good throughout our entire community. He retained a strong partiality for the city where his life work was mainly performed. Ever manifesting the liveliest interest in all its great interests. He was born in the city of New York; a graduate of Yale University. After giving several years to the profession of the law in Detroit, he entered the Gospel ministry. He was first settled in Flint, Mich., whence he was called to this city. He was then Secretary of the Presbyterian Board of Education for the Ministry at New York, for some years. His daughter, Mrs. C. H. Conner and husband, of this city, were present, with other members of his family at the hour of his death. Dr. Atterbury was in the seventy-sixth year of his age. New Albany Daily Ledger 08-26-1901 p4c4 Charles H. Conner. A Native of New Albany, a Successful Business Man and a Christian Gentleman. Charles H. Conner was born in New Albany fifty-eight years ago, and died at Virginia Beach, Va., on Saturday, August 24, 1901, after an illness, following paralysis, of five years. He was a son of William Conner, a pioneer business man of this city. He was active, energetic and successful in business, popular in business, social and church circles, and a Christian gentleman, whose life and example is well worthy of emulation. He had been a member of the Second Presbyterian church of this city from his youth. In seeking relief from his malady that afflicted him, he sought the medical advice of the best physicians of this country and Europe, and while he improved for brief periods, there was a recurrence of the disease that finally claimed his life. He leaves a wife, three sons and four daughters. Mr. Conner was the founder of Winona, the noted Presbyterian resort on Eagle Lake, in Kosciusko county, and the first President of the Association. Owing to ill health he had to decline reelection. Mr. Conner's body will arrive in the city to-night and be taken to the residence of Mr. John P. Atterbury, a retired steel merchant of Detroit, Mich., and a brother of Wallace W. Atterbury, First Vice President of the Pennsylvania Railroad, died yesterday in his apartments in the Hotel McAlpin, where he had lived for the last three months. He was living at his home in Italy, the Villa Margarita, in Castlenarre de Stabia, when the war began and after traveling for a year and a half, had gone to live at the McAlpin. Mr. Atterbury was a son of the late Rev. Dr. John G. Atterbury, and was born in New Albany, Ind. He was in his sixtieth year, and before his retirement was widely known in Detroit and the Middle West. Mr. Atterbury was a Mason and a member of the Detroit Club, the Detroit Country Club, the Detroit Racquet and Curling Club, the Fine Arts Society, the Yonatega and the Old Clubs of Detroit. He was also a member of the Lambs Club of this city. His wife was with him when he died.

New Albany Tribune 09-21-1935 p1c1 NOTED RAIL HEAD NATIVE OF CITY. Stroke Proves Fatal In Long Illness; Served Nation In France During War. STARTED CAREER IN SHOPS. **Gen. William Wallace Atterbury**, 70, native of New Albany, retired president of the Pennsylvania Railroad and war-time transportation expert for the American government died Friday in Philadelphia where he resided. He passed away in Byrn Mawr Hospital after a long illness following a stroke of apoplexy. He had been ill since July, 1934. In April he retired from the presidency of the railroad he had held since 1925. Gen. Atterbury was born in New Albany, January 31, 1866, the son of the Rev. John Guest Atterbury, pastor of the Second Presbyterian Church, which was later succeeded by the Hutchinson Memorial Presbyterian Church. Dr. Atterbury held the local pastorate from August, 1851 to July, 1866. The year after his son was born, the minister died and the family removed to Detroit. Mrs. Charles Conner was a sister of the railroad executive.

In later years Gen. Atterbury took an active interest in politics for some time. He became a leader in Republican Party councils in Pennsylvania, was elected to the national committee and served as delegate to several conventions.

Gen. Atterbury was graduated from Yale University, in 1886, and received degrees from Vila Nova College in 1927 and Temple University in 1929. He began as a railroad apprentice in the shops at Altoona, Pa. He became road foreman on various divisions of the same road later and served as master mechanic of the Pennsylvania system at Ft. Wayne from 1893-96. He then served as general superintendent of motive power lines of the Pittsburg-Erie System from 1896 to 1903. From 1903 to 1909 he was general manager of the latter railroad and from 1909 to 1911 he served as fifth vice president of the Pennsylvania. In 1912 he was vice president of the same in charge of operations.

Granted a leave of absence August 1917, to direct construction and operations of the United States military railways in France he served until 1919 when he returned to this country and rejoined the Pennsylvania system. He was named vice president of the road without designation in 1924 and in 1925 he was elected president.

Gen. Atterbury also served as director of many large corporations, and was a member of the leading scientific, educational and commercial organizations of the country. Surviving are his widow and three of his sons, William Wallace Jr., a student at Yale, Malcolm Atterbury and George R., a Harvard student, and a daughter, Mrs. Elizabeth Connelly of suburban Radnor.

New York Times 12-05-1950 DR. L. CONNER DIES; HEART SPECIALIST. Department Head at Cornell Medical 16 Years Was Chief of Services at N.Y. Hospital. **Dr. Lewis A. Conner** of 11 West Eleventh Street, a leading American authority on heart disease, who was one of the original incorporators of the American Heart Association in 1924, died yesterday in New York Hospital after an illness of five weeks. He was 83 years old.

Born in New Albany, Ind., a son of Charles Horace Conner and the former Katherine Boudinot Atterbury, Dr. Conner received the degree of Bachelor of Philosophy from the Sheffield Scientific School of Yale in 1887. Three years later he was graduated from the College of Physicians and Surgeons of Columbia.

In 1898, the year of its foundation, Dr. Conner began his long association with the Cornell University Medical College here. He was appointed Professor of Clinical Medicine in 1900, occupying that chair until 1916, when he succeeded Dr. W. Gilman Thompson as Professor of Medicine. He held that post until 1932.

Since 1890, Dr. Conner had been connected in various capacities with the New York Hospital. As head of the department of medicine at Cornell Medical College, he was the guest of honor at the dinner given at the Waldorf-Astoria on April 21, 1932, celebrating the union of the Medical College and the New York Hospital. It was stated on that occasion that Dr. Conner had been head of the College's department of medicine since 1916, and was then an attending physician and chief of service at the New York Hospital.

It was recalled, also, that he had served in the Spanish-American War as a private, and in the first World War as a brigadier general, Army Medical Corps. Since 1932, when Dr. Conner retired from most of his active practice, he had limited his work largely to consultation.

Dr. Conner was the founder of the American Heart Journal, which he edited from 1925 to 1938. He was a fellow of the New York Academy of Medicine, a member of the American Association of American Physicians, the American Medical Association and the University Club.

He leaves his second wife, who was Laila Ann Coston at their marriage in 1923; their daughter, Mrs. George B. Rossiter of Dayton, Ohio; three children by his first marriage to the late Emma Witt Harris, Mrs. Anthony H. Brackett of Hingham, Mass.; Mrs. James Campbell and William H. Conner, and a brother, Charles Horace Conner. [d: 12-04-1950]
