## 1. Allied Healthcare Professionals' Licensure

Dubai Health Authority (DHA) issue the licensure for Allied Health professionals who meet the eligibility criteria for each title:

### 2.1 Anaesthesia Technician

#### 2.1.1 Qualification Requirements

Registered Nurse graduated from an anaesthesia nurse programme/ from an accredited educational institution, college or university

OR

Graduated from an anaesthetic technology course from an accredited educational institution, college or university e.g. Anaesthesia Diploma (minimum of two years course) with two years experience

OR

Respiratory therapist having graduated from an anaesthesia assistant programme from an accredited educational institution, college or university

#### 2.1.2 Experience Requirements

Minimum of two years experience in the same field

#### 2.1.3 Application for licensure

To apply as Anaesthesia Technician fill [Application for Health Professional Licensure](#) with the required documents

Professional license will be issued only in a Hospital or Day Surgical Centre

#### 2.1.4 Qualification and Experience Requirements

2.2.4.1 Certification by the American Anaplastology Association.

#### 2.1.5 Experience Requirements

Audiologist can work in one of the following categories: Hospital, Otorhinolaryngology clinic, Physical Medicine and Rehabilitation Centre or Special needs centre.

## **2.4 Audiology Technician**
