The writ petition of Shanmugam seeking CBI inquiry into the case of alleged intimidation of Ravi Subramaniam at the sub-jail would also be heard.

The Madras High Court held there was nothing to link two Kanchi Mutt lawyers to the complaint lodged by Chitra, wife of Ravi Subramaniam, accused-turned-approver in the Sankaraman murder case, that two women advocates had threatened her husband and tried to induce him to change his confessional statement. There was nothing to implicate either Shanmugam or Thiagarajan, lawyers defending accused in the murder case, Justice K P Sivasubramaniam said, when a writ petition filed by Shanmugam for a CBI probe into Chitra's complaint, lodged on February 19, came up for hearing.

Principal Sessions Judge P Murugesan modified the conditions stipulated earlier while granting anticipatory bail to Kanchi Acharya Sri Jayendra Saraswati. Granting the relief, the PSJ extended until March 14 (from the earlier March 10 date) the time for surrendering before the Kanchi Magistrate. He also permitted the Acharya to appear before the IO on every Saturday between 2 and 3 p.m. instead of between 10 a.m. and noon.

Raghu, who was also detained under the Goondas Act, had been lodged in the Chennai prison ever since his arrest in connection with the murder case on December 30 last year. With this, eleven people, including Senior Kanchi Seer Sri Jayendra Saraswati have been cited as accused in the assault case.

"If indeed the Law is equal for everyone, Jayalalitha should resign her Chief Minister post before she appears in the case," said Tamil Nadu Janata Party leader, Chandralekha. "When Kanchi Sankaracharya Sri Jayendra Saraswathi was arrested, Jayalalitha said 'everyone is equal before law'. Sri Jayendra Saraswathi is only charged. The charges against him have not been proven. Jayalalitha is going to appear in court in Bangalore for the case of accumulating wealth disproportionate to her income. In the Bangalore special court, a special lift and special entrance has been arranged for her.

The Tamil Nadu government said that if Sri Jayendra Saraswathi stays in Kalavai, he would tamper with witnesses. Therefore, he needs to be made to go to a Northern state. In Jayalalitha's disproportionate wealth case, there are 167 witnesses in Tamil Nadu. What guarantee is there that as Chief Minister, Jayalalitha will not tamper with these witnesses? If the Law is equal for everyone, then, before she appears in this case, she should step down from her post.

Nobody can destroy Hindu matham. Some are colluding with international powers to destroy Hindu matham. That won't work. Truth will prevail. Dharma will prevail", she said.

Justice K P Sivasubramaniam of the Madras High Court slammed the Special Investigating Team (SIT), Kancheepuram, probing the Sankararaman murder case, for its "fishing expedition tactics" and said he was considering excusing himself from all cases relating to the Shankara Mutt.

His sharp comments came in the course of a hearing on a writ petition seeking quashing of the summons to S Bhaskaran, a Chennai-based cardiologist attached to Sankara Nethralaya.

A visibly irritated judge told the prosecution, "If you need any information from anyone on anything, you may as well go to the person concerned and enquire instead of summoning them..."

Wondering whether the SIT wasn't engaged in a fishing expedition, the judge told the prosecution to advise their client to stick to the case before it instead of branching off in various directions.

Nearly three months after getting bail in the Sankararaman murder case, Kanchi Sankaracharya Sri Jayendra Saraswathi has moved the Supreme Court seeking transfer of the trial outside Tamil Nadu apprehending that he would not get a fair trial as the Chief Minister was showing "undue interest" in it.

The Sankaracharya, who was granted bail by the apex court on January 10 this year, said the atmosphere in the state was "not conducive for a fair trial" in the case as the prosecution appeared to be "under the influence" of the government headed by Chief Minister J. Jayalalithaa.

Citing an instance of unnecessary harassment, the Seer alleged that the police, who filed the chargesheet against him in the case on January 21, gave him a copy of the chargesheet after nearly three months.

Moreover, the investigating officers in the case have been handpicked by the Chief Minister, who had given statements that would prejudice the prosecution from presenting the case fairly before the trial court.

“Brutal Strength and Government decisions cannot break our faith”

**INJUSTICE TO PUJYA KANCHI
SANKARACHARYA MAHARAJ-
TERRIBLE ASSAULT ON HINDU DHARMA

The morning of Deepavali this year brought with it a terrible blow on the Hindu society. Pujya Jagadguru Shankaracharya of Kanchi Peeth, Sri Jayendra Saraswati Maharaj was arrested on a murder charge. The foremost Jagadguru of our religion was treated by the police in a manner shabbier than the way an ordinary criminal is treated. This sinful act was committed by confusing the public through spread of a web of unproven accusations via the media. The entire faithful society has become confused and inert by this sudden assault. This sinful act was roundly criticised all over the country by Dharmacharyas, saints and seers. The public organised protest meetings and morchas everywhere. For the first time in the history of independent India, a situation arose when top level politicians including an ex-president and two former prime ministers descended on the road for Dharna and participation in fast.

The courts should establish justice and the police should of course investigate crimes. However, in the judicial process of civilised society, manifestation of culture and good manners is expected. The way this arrest was carried out on the eve of Deepavali and the harshness with which Sri Maharaj was treated thereafter, all the pretences of civilisation have fallen off. The suspicion has also been strengthened that this is not investigation of a crime, but a disgusting form of barbarism of retaliation carried out through pre-meditated conspiracy.

What can be this conspiracy? On analysing this, many facets appear. The people who run the government of the day are dependent on irreligious communists. Foreign powers are controlling them. In Tamil Nadu, a majority of those in power trace their origin to leaders, who burnt images of Bhagavan Sri Ram. The present chief minister is so much against the Swamiji because the Peeth refused to sell to her associate a large hospital established by them for public service. Further, because of the total rout in the last elections, the chief minister, with an eye on the forthcoming elections, thought it essential to present to the

public a forward and secular face (?) instead of a religious face.

But this is not all. Behind this is the deep rooted conspiracy of American Christian missions. The Pope had said during his tour of India that they wish to spread Christianity in entire Asia in the third millennium. In their long term planning for a thousand years, the biggest obstacle was perceived to be the Kanchi Shankaracharya Peeth. This is because the anti-conversion bill was passed in Tamil Nadu under the inspiration of Pujya Maharaj, who also openly welcomed it. This Peeth has of course kept up the tradition of Poojas and rituals; but has also simultaneously expanded their service in all fields of society, which led to the dismantling of monopoly of service of Christian missions. TN's open disregard of Administrative fairness and integrity a grave threat to constitutional allegiance and national cohesion

Although the Senior Kanchi Seer Jayendra Saraswati has been released on bail by the Supreme Court after his two month-long incarceration in jail, the subject of his arrest and detention raises grave questions of constitutional fidelity and administrative fairness and integrity. The significant observations of the three Judge Bench of the Supreme Court while granting the bail should awaken the whole world to seriously consider whether Tamil Nadu State Executive, headed by Jayalalitha, has fulfilled the tenets of fairness, equity and integrity its Oath of Office demands or whether it has grievously violated these canons. Was the arrest "the most painful decision" as was confessed by the Chief Minister, or did it display total lack of impartiality and sobriety of insight, demanded from any Constitutional Administrative Functionary?

II

That the highest citadel of justice in our country has held that the grounds arrayed by the Prosecution are not tenable should jolt us into seeing the realities about mis-application of political power. For the Seer, who did not show any resentment or wrath against the deceased in spite of the numerous letters he allegedly wrote against the Seer, to turn suddenly a conspirator to murder him is quite unreasonable, held the SC Judges.

III

If this is what the highest Court has to say about the arrest and custody of the Kanchi Senior Seer, is it right to think of further tenability in the sudden arrest of the Junior Seer Sri Vijayendra Saraswati, after two months, on the same criminal charges, as if in hasty revenge and intriguing expediency?

It is noteworthy that the Prime Minister had written to the TN Chief Minister and also spoken to her during his recent visit to TN, to be prudent,

exercise caution and respect the feelings of the large following that the Kanchi Math has.

IV

The fact of law and order being a State subject does not behove any Chief Minister to act disregarding the Centre's place and view. Fairness and equity in political administration always warrant that the Prime Minister's words of caution and advice be rightly heeded by any State Govt., especially in matters concerning the feelings and solidarity of the people of the country at large. Tamil Nadu Chief Minister has disquietingly failed in this administrative prudence and integrity.

V

Jayalalitha seems to personify contradictions in that, while she is seen to be running regularly to Guruvayur Temple to worship the Lord with special offers, she chooses to act hastily to intercept grievously the daily worship of the Kanchi Lord, whose blessings also she used to seek periodically. Can there be graver conflict and disintegrity? Her actions are to speak the least, injudicious and inflammatory. This is nothing but pouring petrol to blazing fire.

VI

A far greater impersonal, impartial and equitable sense is called for to run public administration. This is a typical instance of a Chief Minister standing to threaten the Conscience and traditional feelings of a great multitude of the country. It is a crucial challenge to the Constitutional trust reposed upon the State and Central Executives, especially the Chief Minister and Prime Minister. All right-thinking citizens and political thinkers have to emergently address this question and ensure that the confidence and integral character of the billion over people of our country instead of being shaken, is strengthened and the nation's cohesion made stronger.
