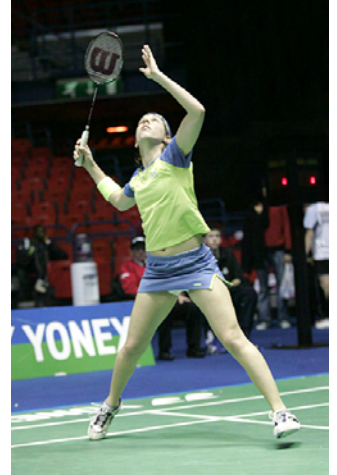

Shannon Pohl is excited to introduce her badminton program at Adversity Volleyball Center in Vernon Hills! Programming has been specifically designed for the student athlete who desires professional coaching, a competitive experience, challenging athletic development and a supportive, realistic, mentoring approach to sports. The Shannon Pohl Badminton Academy uses proven athletic development techniques to strengthen the body, expand sport-specific knowledge, challenge the spirit, instill confidence, self esteem and respect among student athletes—providing young athletes the opportunity to achieve their athletic goals.

Shannon was the highest ranked American badminton player in the world in women's singles in 2009. Her top ranking is #69 in the world in women's singles. Shannon was a member of the United States World Championship Badminton Team in 2005, 2006, 2007 and 2009. She has represented the United States in badminton tournaments in 45 countries.

Like many of you, Shannon didn't start playing badminton until high school. She attended Prospect High School and placed fifth in the IHSA State Tournament her senior year. While attending the University of Illinois she started, coached, and trained the first ever Illini Badminton Traveling Team which she led to a third place team finish at Nationals her senior year. She was named All-American and placed second in doubles at Collegiate Nationals.

Shannon has trained under some of the world's finest coaches from England, Denmark, Malaysia, China, and Indonesia and she is eager to share her knowledge with you. She recently returned from Denmark where she was training at the International Badminton Academy for the past two and a half years. While in Denmark she was head coach of two badminton teams in the Danish professional badminton league. Shannon is a USA Badminton Level 1 certified coach and she recently helped Badminton Chicago, World Sport Chicago, and USA Badminton develop a youth badminton program in the Chicago Park Districts for the first time. She has also coached many years at the Eastern Illinois University Junior Badminton Camp.

Shannon is happy to provide her services to players of any age. She has coached athletes ages 6 to 50 and will tailor lessons to meet the varied goals and objectives of the badminton playing community.

Shannon Pohl Badminton Academy Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement ("Agreement")

This Agreement is being entered into in consideration of my participation on/in _____ ("Activity/Program") and hereby represent that I understand the nature of this Activity/Program and that I am qualified, in good health, and in proper physical condition to participate in such Activity/Program. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity/Program. I fully understand that this Activity/Program involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, Activity/Program, the conditions in which the event, Activity/Program takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the Activity/Program.

I hereby release, discharge, and covenant not to sue The Shannon Pohl Badminton Academy, Adversity Volleyball Center, Shannon Pohl, its respective administrators, directors, agents, officers, volunteers, coaches, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity/Program takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or part by the negligence of the "Releasees" or otherwise, including negligent rescue operations and in the future agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, make a claim against any of the Releasees, I will indemnify, save, and hold harmless, each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim. Permission is also given to use my child's photo or endorsement for promotion.

The parties agree that the substantive laws of the State of Wisconsin shall govern all matters concerning the validity, performance, administration, and interpretation of this Agreement. The parties further agree that any judicial proceeding brought against The Shannon Pohl Badminton Academy on account of any dispute arising out of the Agreement, or any matter related hereto, shall be brought in the courts of the State of Illinois or federal courts sitting in the State of Illinois. If any term, part, or provision of this Agreement is declared illegal or invalid by a court or general jurisdiction or is superseded by a specific law or regulation, such law or regulation shall control to the extent of such conflict without affecting the remaining provisions of this Agreement and the rights and obligations of the parties.

WAIVER AND RELEASE OF LIABILITY

Note: This form must be read and signed before the participant is permitted to take part in event sessions. By signing this agreement, the participant affirms having read it.

In consideration of my involvement at the _Shannon Pohl Badminton Academy_ under the auspices of USA Badminton and the _Shannon Pohl Badminton Academy_, I acknowledge, appreciate, and agree that:

1. I risk bodily injury, including paralysis, dismemberment, disability, and death, and while particular rules of the sport, equipment, and discipline may reduce this risk, this risk of injury does exist, as well as the risk of damage to or loss of property.
2. I knowingly and freely assume all such risk; both known and unknown, even if arising from the negligence of the releases of others;
3. I willingly agree to comply with the state and customary terms and conditions for participation. If, however, I observe any unusual or unnecessary hazard during my presence or participation or if I observe any concern in my readiness for participation, I will immediately bring such to the attention of the nearest official and refrain from participation; and
- 3a. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless and promise not to sue USA Badminton, the committee, their sponsors, their officers, volunteers, staff, sponsors and/or agents, (“releasees”) with respect to any and all injury and loss arising from my participation, whether caused by the negligence of the releasees, the condition of the premises or otherwise, except that which is the result of gross negligence or wanton misconduct, to the fullest extent permitted by law.
4. I agree to be bound by the rules and regulations of the International Badminton Federation and those of USA Badminton and I hereby stipulate that I am eligible to play in the events for which I am applying and that I understand that the above mentioned make no representation or warranty with respect to the condition of the premises or the operation of the event.
5. I hereby grant to USA Badminton, it’s licensees and contractees including photographers, television and motion picture rights including to film or videotape me during matches, narratives, personal interviews, or comment thereon for any and all commercial, news or other purposes together with the right to transfer or grant their rights to others, all without remuneration or compensation to me whatsoever.
