Amendment of Conditions AC07-009 (Black Rock City, LLC: Amendment of Special Use Permits SW03-025, SW04-004, SW04-007, SW04-007 AND SB04-009 "Burning Man") Review and recommendations on the request to amend the identical conditions of approval on all approved special use permits to allow reconfiguration of each of the allowed uses within the existing fenced industrial area on the subject parcel, as authorized in Section 110.810.60 of the Washoe County Development Code. The project is located approximately 20 miles north of the town of Gerlach in northern Washoe County, approximately one mile past the end of pavement of State Route 34, and one-half mile east of the intersection of State Route 34 and Jackson Lane. The site is addressed as 88 Jackson Lane. The ±200-acre parcel is designated General Rural (GR) in the High Desert Area Plan, and is situated in a portion of Section 36, T35N, R23E, MDM, Washoe County, Nevada. The parcel is located in the Gerlach/Empire Citizen Advisory Board boundary and Washoe County Commission District No. 5.
