"The Executive Board.

Having taken note of the Director-General's Report on the activities of the Organization from April 1950 to May 1951, which is to be presented to the General Conference at its Sixth Session,

Expresses its satisfaction at the improved administrative machinery and methods as well as at the progress made in carrying out the programme,

Congratulates the Director-General on the work he has done and on the tireless zeal with which he has carried Unesco's message to all parts of the world,

Declares to the whole Secretariat its appreciation of the efficiency and devotion with which its work has been performed,

Hopes that Unesco's efforts, to the effectiveness and necessity of which this report testifies, will be increasingly integrated through ever closer co-ordination of the activities of governmental departments, national commissions and non-governmental international organizations with those of the Secretariat,

Recognizing the financial burdens which weigh upon Member States at the present time, but believing that no effort on behalf of peace can be judged negligible if its immediate result is to develop international co-operation and understanding through education, science and culture,

Recommends that the General Conference, having regard to the achievements shown in this Report and to those promised from plans already set in motion, should furnish Unesco with sufficient funds to enable its work to be pursued and its influence maintained at least at the present level,

Reaffirms its conviction that Unesco's aims cannot be attained by material means alone, but that they demand, in those who believe in them and wish to further them, the spirit of sacrifice inseparable from a genuine faith in the dignity of man and brotherhood of nations".

Affirms its conviction that the United Nations family of Organizations is potentially the most effective machinery the world has ever had for organizing international action to eliminate human suffering, but that it can only act efficiently and successfully with the support and active participation of Member Governments responding to international initiatives; and therefore that Unesco, together with the other Specialized Agencies and the United Nations itself, will only fully realize the aspirations of its founders when it enjoys the full collaboration of all nations in its work".

- (b) to instruct the Executive Board to include in the next draft programme,
 - (i) a plan for a long-term investigation of the various educational, scientific and cultural aspects of the relations existing between the peoples of Western Europe and the American continent.
 - (ii) a series of discussions between a small number of distinguished philosophers, historians, sociologists and educationists, who should be asked to suggest the best ways of strengthening intellectual and moral ties between the old and new worlds".
