The East Riding of Yorkshire (Parishes) Order 1999

Made - - - - 26th January 1999

Coming into force in accordance with article 1(2)

The Secretary of State, in exercise of the powers conferred on him by sections 14 and 23 of the Local Government and Rating Act 1997(a), and of all other powers enabling him in that behalf, hereby makes the following Order which, amongst other matters, gives effect to petitions sent to him under section 11 of the Act for the constitution as parishes of areas within the district of the East Riding of Yorkshire of which no part is within a parish, and for the establishment of parish councils for those areas:

Citation, commencement and interpretation

1. - (1) This Order may be cited as the East Riding of Yorkshire (Parishes) Order 1999.

(2) It shall come into force -

(a) for the purposes of this article, articles 2 and 3 and proceedings preliminary or relating to elections of parish councillors to be held on 6th May 1999, on the day after that on which it is made; and

(b) for the purposes of article 4, on 1st April 1999.

(3) In this Order -

"existing" means existing on the date on which this Order is made;

"the map" means the map prepared by the Department of the Environment, Transport and the Regions, marked "Map of the East Riding of Yorkshire (Parishes) Order 1999", and deposited at the office of the Secretary of State for the Environment, Transport and the Regions and at the offices of the district council; and

"the new parishes" means the parishes of Beverley and Cottingham constituted by article 2 of this Order.

Constitution of the new parishes

2. - (1) New parishes comprising -

- (a) the existing unparished area of the town of Beverley; and
- (b) the existing unparished area demarcated by a blue line on the map.

shall be constituted within the district of the East Riding of Yorkshire.

(2) The names of the new parishes shall be -

- (a) Beverley, for the parish constituted by paragraph (1)(a), and
- (b) Cottingham, for the parish constituted by paragraph (1) (b).

Direction to establish parish councils

3. The East Riding of Yorkshire District Council is hereby directed to establish parish councils for the new parishes.

Consequential alteration of district electoral wards

4. The area marked "A" on the map shall cease to be part of the district electoral ward of Wolfreton and shall become part of the district electoral ward of Cottingham South.

EXPLANATORY NOTE

(This note is not part of the Order)

Article 2 of this Order creates two new parishes, Beverley and Cottingham, in the district of the East Riding of Yorkshire. A map forming part of this note gives a general guide to the areas concerned.

Article 3 directs the East Riding of Yorkshire District Council to establish parish councils for the new parishes.

Article 4 makes consequential alterations to the district electoral wards of Cottingham South and Wolfreton.
