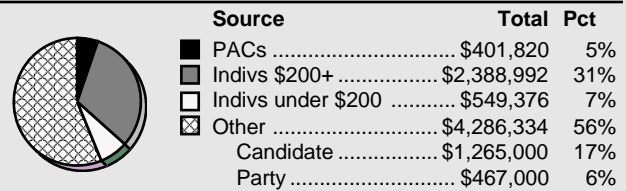

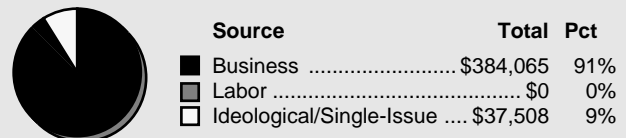

In-State vs. Out-of-State Contributions*



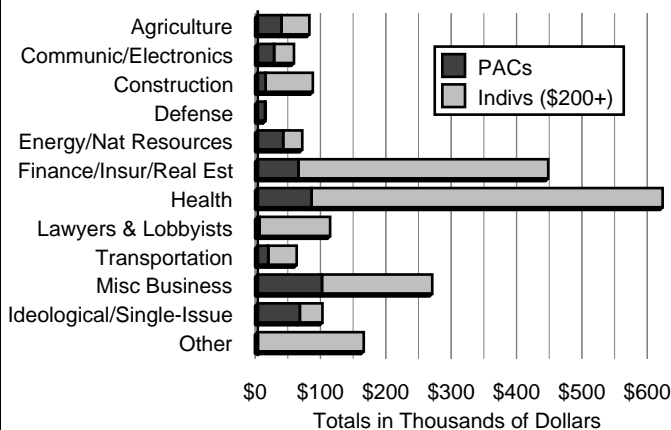

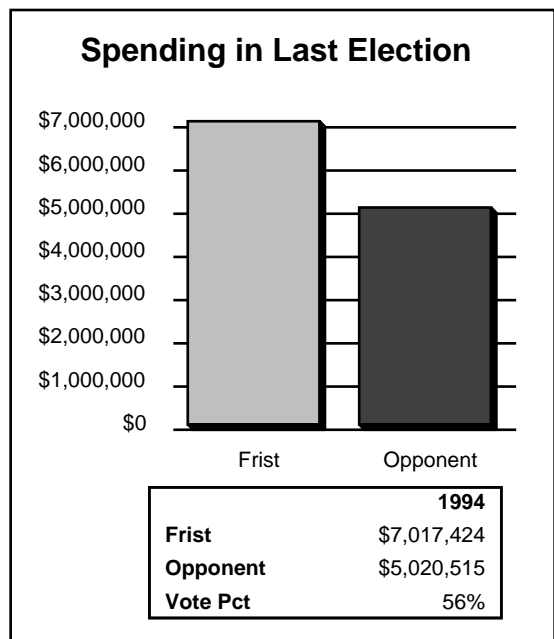
