PURPOSE:

The Hall of Fame of Delaware Women was established to recognize the lasting contributions and achievements of Delaware women. Nominees may have worked on a neighborhood, community, city, state, national or international level and their contributions may stem from work in any field as a professional or volunteer.

ELIGIBILITY:

- ◆ Nominees must have made a significant impact upon the lives of others.
- ◆ Their contributions to society or to women's history should have lasting significance.
- ◆ Distinguished selfless achievements also may be the basis for recognition.
- ◆ Nominees must be native-born Delawareans or have resided in the state for at least ten years. If the nominee is deceased, the same requirements apply; add date of death after date of birth on the form below.

THE PROCESS:

Inductees are selected by a committee of non-commissioners appointed by the Chair of the Delaware Commission for Women. Selected nominees and all nominators will be notified of the outcome. **Nominators are responsible for verifying the accuracy of the information submitted about the nominee.**
