# Blueprint Receives More National and Local Awards

Adding to mounting accolades, SACOG received two awards in November for the Blueprint Project. SACOG was recognized as one of five winners of the 2004 National Award for Smart Growth Achievement by the Environmental Protection Agency at an awards ceremony at the National Building Museum in Washington, D.C. on November 17. The Blueprint Project was honored as an innovative approach to development that strengthens community identity and protects the environment.

"EPA is proud to recognize these exceptional communities that are creating healthy, attractive, and enduring places to live, work, and play," said EPA Administrator Mike Leavitt. "We salute these winners for their outstanding achievements and challenge others to follow their example in protecting the environment and improving the quality of life of our great nation."

"We are proud and honored to receive this award," said SACOG Executive Director Martin Tuttle. "The Blueprint Project

"Sandy Hilliard, Paul McNamara, Roger Niello, and Gary Ulman have all played a key role in SACOG's evolution," said SACOG Board Chair Christopher Cabaldon. "They will be missed."

Sandy Hilliard, outgoing Mayor of Yuba City, is the senior member of the SACOG Board having served since 1995. She was Vice Chair of the Board in 1999, and Chair in 2000. Most recently she was a member of the Administration Committee and represented SACOG as Chair of the California Association of Councils of Governments (CALCOG). Ms. Hilliard's seat on the Board expired when her term as Mayor of Yuba City ended.

Paul McNamara, outgoing Mayor of Marysville, has been a SACOG Board member since March 1996, and has served

### Blueprint "Next Steps" Set for December Board Action

THE SACOG BOARD UNANIMOUSLY APPROVED refinements to the draft Blueprint map, growth principles and next steps at its November 15 meeting. The changes were designed to increase transit ridership through more

transit-oriented development, to respond to requests from local governments, and to clearly define how the organization will move forward in 2005 and beyond, in order to use the Blueprint Project in a manner that is consistent with local land use decision-making responsibilities.

A public hearing on the draft Blueprint documents will occur at the December 16 Board



meeting, when the Board is expected to act on the recommendations.

Changes to the land use map and transit system yielded an increase of 30,000 transit riders a day, compared to the Discussion Draft Preferred Blueprint

Scenario presented at the October 14 Regional Elected Officials Summit. Additional refinements to the map are expected shortly, particularly in Colfax, where the City Council and Planning Commission will provide final direction to SACOG staff in late November.

continues to be recognized as a new and innovative way to collect better data for local governments to make informed decisions that benefit not only individual communities, but the Sacramento region as a whole."

Former EPA Administrator Christine Todd Whitman created the National Awards for Smart Growth Achievement in January 2002. Through this program, EPA recognizes

exceptional approaches to development that benefit the economy, public health, and the environment.

The Mountain-Valley Chapter of the American Leadership Forum presented the SACOG Board of Directors with its annual "Thanks to You Award for Collaborative Leadership" or "ALFie" award at SACOG's November Board Meeting.

"We present this award annually to entities that make a coalition effort that significantly impacts our region," said Doni Blumenstock, ALF Executive Director.

ALF Board President and Regional Vice President of USAA Rick Fowler presented the award, which SACOG will share with Valley Vision. "SACOG through the Blueprint Project has dramatically increased the level of civic involvement in the

Sacramento region," said Fowler. "We are honored to present this award to SACOG for your efforts."

Previous winners of the ALFie award include the Counties of Sacramento and Yolo and the City of West Sacramento for regional collaboration on Raley Field; Sacramento Board of Supervisors and McClellan Park for

staving off potential negative economic impacts by turning the McClellan Field into a regional business center; and Valley Vision for encouraging regional collaboration in the Sacramento area.

To date SACOG has received numerous awards for the Blueprint Project, including: the Metropolitan Planning Organization of the Year Award from the Association of Metropolitan Planning Organizations, the Planning Excellence Award from the Federal Highway Administration and the Federal Transit Administration, a Presidential Citation from the American Institute of Architects, the Environmentalist of the Year award from the Environmental Council of Sacramento, and the 2003 Governor's Environment and Economic Leadership Award.

# Regional Bicycle, Pedestrian, and Trails Master Plan Adopted

THE REGIONAL BICYCLE. Pedestrian, and Trails Master Plan was adopted by the Board of Directors at its November meeting, providing a boost for alternative commuters and bicycle enthusiasts in the Sacramento region. The plan contains more than 300 projects throughout the region, including bike trails, pedestrian upgrades, river crossings, and inter-modal access, and will establish eligibility to receive first round federal funding of \$2.5 million for SACOG's Bicycle and Pedestrian Funding Program.

The program was included in the Metropolitan Transportation Plan for 2025 and the Board approved funding program guidelines for projects in September 2003 based on recommendations from an advisory committee and SACOG staff. The goal for the 23-year, \$320 million program is to provide bicycle and pedestrian access within or through the central business districts of the region. Additionally, funds will be used to provide connections between and within the cities and towns of the six-county region, to public transit systems, park-and-ride lots, and regional and local activity centers including schools, libraries, community centers, hospitals, and employment centers. The next round of funding is expected to be in 2005.

### A New Focus on Smart Growth?

SENATOR DON PERATA (D-OAKLAND), who was recently selected by his fellow democrats as the new Senate President pro tem, has launched a bold structural change in the Senate which may signal a new emphasis on smart growth.

Senator Perata recently announced that the Senate Transportation Committee and the Senate Housing and Community Development Committee would be collapsed into a single committee. "It makes sense to look at housing policy in terms of its impact on transportation and at transportation issues in terms of how they affect communities and neighborhoods," Perata said.

Senator Tom Torlakson (D-Antioch), a longtime advocate of smart growth and the author of the state's Traffic Congestion Relief Plan, has been selected by Perata to chair the new Senate Transportation and Housing Committee.

"I have always advocated

better coordination of transportation investments, land use policies, and housing opportunities for all Californians." Senator Torlakson said. He added, "The people of California can see the big picture. The homes they can afford are too far away from the jobs they need. Family life suffers, the economy slows down, and the quality of life we all cherish declines. We need to turn this situation around."

By combining transportation

and housing issues into a single committee, and appointing the Senate's most vocal supporter of smart growth principles to take the helm, Senator Perata is sending a very clear single that he intends to force greater coordination between the roads we build and the homes we live in.
