The Disability Living Allowance is a benefit paid to people under 65, who are disabled, and need help with personal care, and/or getting around. In August 2000, 11,520 people in Carmarthenshire received this benefit.

Within Kidwelly, 15 per cent of those unemployed were aged 50 and over, 6 per cent had never worked and 34 per cent were long term unemployed.

In August 2000, there were 2,455 Jobseeker Allowance claimants in Carmarthenshire of which 29 per cent had child dependants. The Job Seeker Allowance (JSA) is payable to people under pensionable age who are available for, and actively seeking, work of at least 40 hours a week. Figures produced here are those only for people claiming income-based JSA.

Income support was introduced on April 11th 1988 and can be paid to a person who is aged 16 and over, is not working 16 hours or more a week, and has less money coming in than the law says they need to live on.
