Miriam Hoover Pledges \$1 Million to Name Hoover-Leppen Theatre at Center

The first week of October marked a major milestone for Center on Halsted. Local philanthropist Miriam Hoover became the newest donor to Center on Halsted's Capital Campaign with a pledge of \$1 million - the largest individual contribution to the campaign. Hoover's gift was made in honor of her nephew and campaign donor, Michael Leppen. In recognition of her gift, the performance space at Center on Halsted will be named the Hoover-Leppen Theatre.

Mrs. Hoover's most direct connection to Center on Halsted is her nephew, Michael Leppen. Michael has been a long time supporter of Center on Halsted through both the Annual Fund and Capital Campaign. For the past twenty-five years he has worked very closely with Miriam as the Vice President of the Hoover Management Corporation. The \$1 million pledge to the campaign is also a tribute to his years of dedication. "He is the most giving person I've known in my life - with time and with any means that he's had. I don't know anyone, except for maybe my husband, who has so passionately wanted to help make the world a better place," said Hoover.

A resident of Illinois for nearly seventy years, Mrs. Hoover has a long history of generosity. She has been involved with many organizations ranging from social services to the arts.

Her husband, the late H. Earl Hoover, was very influential in her becoming a donor. "He was my best friend and my counselor. I was very happy learning about philanthropy as my husband felt very strongly the joy of giving - giving back something you've earned to help others."

The pledge brings Center on Halsted one major step closer to successfully completing the \$20 million campaign. Mrs. Hoover is thrilled that she can help us expand our programs for those in need. "[The new building] will be a better place to go seek help and not be afraid to go in. Everyone needs the liberty and safety to go into a place for help and I think Center on Halsted will be a sanctuary for those people."

New AVP Team

It is with much pride and enthusiasm that Center on Halsted introduces Laura Velazquez and Lisa Gilmore as the new Anti-Violence Project (AVP) team.

Laura Velazquez has been promoted to Manager of the AVP. Laura has worked as the Victim Advocacy Coordinator for the past year. Her professional background spans ten years of work in anti-violence advocacy and domestic violence issues. She draws upon a diversity of experience, including domestic violence trainings and her time as a police officer in the Western Suburbs of Chicago. During this time she engaged, firsthand, issues faced by victims of violence.

In addition to responding to calls on the Crisis Line, assisting clients through the court system, and attending area coalition meetings, Laura has provided numerous trainings for area agencies on domestic violence and hate crimes.

Lisa Gilmore was welcomed to the AVP team on October 3rd as the Anti-Violence Therapist. Lisa recently completed a year long mental health internship at the Center and is extremely excited about her move into this new position. During her internship, Lisa gained valuable experience working with persons who have experienced trauma, as well as additional insight concerning clinical work with persons who identify as LGBTQ. She will bring this experience and knowledge into her new position as she provides counseling to individuals seeking services.

AVP Initiatives

Laura and Lisa recently produced the annual Center on Halsted Anti-Violence Vigil, held on October 19th, 2005. The vigil was an opportunity for community members, social service providers, and survivors to commemorate and celebrate the lives of both victims and survivors of violence. Through the AVP team's dedication and collaborative work the vigil was very well attended and brought the issue of violence within the LGBTQ community out of the shadows, bringing a great sense of awareness to this complex and multi-faceted issue.

In addition to providing direct services to clients, Lisa will be working on the continuing development of a service provider network to more adequately serve the multitude of cultural identities individuals possess. Collaborations with other LGBTQ providers will be developed and fostered to enhance overall service delivery. As awareness and exposure are at the center of addressing the impact of violence, Lisa will be leading educational seminars to both LGBTQ identified

groups and non-LGBTQ groups on violence within the LGBTQ community.

Center on Halsted's Anti-Violence Project (AVP) has served thousands of survivors of anti-LGBT hate crimes, domestic violence, sexual assault, discrimination, and police misconduct since the program's inception in 1988. Crisis Hotline services, advocacy, community education, and incident documentation comprise key components of the Anti-Violence Project and are central to the program's goal to holistically serve survivors of violence and increase community awareness.

Following welcoming remarks, attendees enjoyed an opportunity to relax and mingle at a reception held on SideTrack's beautiful rooftop patio. In all, over \$24,000 was raised to support the programming and pursuits of Center on Halsted and Equality Illinois.

A battle cry echoed throughout the streets of Lakeview Sunday, June 26th, as Center on Halsted marked its second year of participation in Chicago's Pride Parade.

Forty-two representatives boarded Center on Halsted's red double decker bus for an enchanted magical ride armed with bubble-blowing guns, bubble wands, flavored-ice pops, iridescent flower-pinwheels, balloons reflecting every color in the rainbow, ice-cold bottles of water, and just enough sun block.

Out Latino actor and gay youth advocate, Wilson Cruz, was the Grand Marshall of the 36th Annual Chicago Pride Parade. From the corner of Belmont and Halsted the procession traveled north on Halsted, south on Broadway, then east on Diversey to Cannon Drive.
