Protection & Education Panel

Dr. Elizabeth D. Benchley, Pensacola

Elizabeth D. Benchley is Director of the Archaeology Institute at the University of West Florida in Pensacola. She earned a Master's and Ph.D. in Anthropology at the University of Wisconsin-Milwaukee (UWM) where she studied Native American archaeology of the Midwest. After graduating, she taught archaeology and was in charge of the Cultural Resource Management program at UWM for over 20 years. She moved to Florida in 1997 and has researched the Spanish and British colonial archaeology of the region, along with teaching historic preservation courses and working with the public. She also serves as archaeology grants manager and is familiar with the Bureau of Historic Preservation grants program.

Rosalie (Roz) Foster, Titusville

Rosalie Foster has extensive experience with historic preservation projects and service organizations. She has served as a member of the Brevard County Historical Commission, the Advisory Board of the East Central FPAN Regional Center and was a Research Fellow of the Field Library of Florida History. Ms. Foster has participated in projects involving the restoration and documentation of historic cemeteries, the Titusville Historic Plaque Program, tours of the historic downtown district and has researched and written text for the Florida State Historical Marker Program. She founded and was president of North Brevard Heritage Foundation, Inc. and has served as a consultant to other non-profit organizations, statewide, seeking information about resources for preservation/restoration projects, and/or documentation of such projects. She received the Titusville Community Service Award in 2004, the Caroline P. Rossetter Outstanding Woman in Florida History in 2007, and the NASA Group Achievement Award in 2007.

Gail K. Hamilton, Kissimmee

Gail K. Hamilton has been the Director of the Community Redevelopment Agency for the City of Kissimmee since June 2001. Prior to her service in Kissimmee, Gail worked for the Historic District of Ybor City and Dade City and has 20 years experience in Special District/CRA management. Ms. Hamilton serves as president of the Friends of Florida Main Street, an organization dedicated to enhancing and perpetuating the programs offered by Florida Main Street, and she is past president of the Florida Redevelopment Association.

Dr. Beverly A. Nash, Quincy

Beverly A. Nash holds a Bachelor of Science in Public Administration from the University of Arizona; a Master's degree in Student Services in Higher Education/Counseling from Clemson University; and a Ph.D. in Educational Leadership from Florida Agricultural and Mechanical University. She worked for the Florida Department of Education as a senior regulatory administrator for over 15 years. Dr. Nash has worked as an adjunct professor and administrator at several community colleges and universities; and served two Florida Governors while working as coordinator of Technology Training and User Support Services for the Executive Office of the Governor (State of Florida). Currently, she serves as president of the Board of Directors for the Tallahassee Girls Choir of CHOICE. She owns her own education and development consulting company, specializing in program and project development and management, and educational research.

Jorge Zamanillo, Miami

Jorge Zamanillo is the curator of Object Collections at the Historical Museum of Southern Florida. Prior to joining the museum in 2000, Jorge worked for over 10 years as an archaeologist and project manager for Archaeological and Historical Conservancy, Inc. He holds a Bachelor of Arts in Anthropology from Florida State University and is currently working on his Master of Arts in Museum Studies. Jorge serves on the board of the Florida Association of Museums as the History Section Chair and sits on local historic preservation boards, including the Historic and Environmental Preservation Board for the City of Miami. While working with the Archaeological and Historical Conservancy, Jorge worked on the Miami Circle archaeological excavations. He currently is the project manager for the collaborative project between the State of Florida's Division of Historical Resources and the Historical Museum to open an interpretive park at the Miami Circle site.

Acquisition & Development Panel

D. Shawn Beckwith, Cocoa Beach

Shawn Beckwith grew up under the family influence of craftsmanship, heritage, civic and philanthropic activities in and around the East Hampton and Sag Harbor communities of Long Island New York. Those familial influences and activities included participation in John Jermaine Library and Sag Harbor Whaling Museum as well as genealogical associations, which led him to a passion for historic preservation. The passion has helped him to expand the Durable Restoration Company for which he serves as Historical Restoration Specialist. He was project manager of the complete restoration of the Burton J. Westcott House, built by Frank Lloyd Wright as well as many projects in the State of Florida, including the restorations of the Pritchard House, the Amelia Island Lighthouse, the Porcher House and the Meyer Davis Hasty Cottage among many others. Mr. Beckwith also volunteers with many historic and heritage preservation societies through community and educational consulting to further the promotion of historic preservation in the state. He holds a Bachelor of Science in Agriculture, with a minor in Horticulture from The Ohio State University.

Dr. Anthony E. Dixon, Tallahassee

Dr. Anthony Dixon is an adjunct instructor in the Division of History and Social Sciences at Tallahassee Community College. He has taught at Florida A&M University, Florida International University and Florida State University. He is co-founder of Archival and Historical Research Associates, LLC of Miami and Tallahassee. Dr. Dixon is assistant director of the John G. Riley Museum in Tallahassee, and he has served as curator at the Virginia Key Beach Park in Miami. Dr. Dixon holds a Bachelor of Science in History and a Master of Applied Social Science with a concentration in African American History from Florida A&M University. In 2007, he received his doctorate in History from Indiana University.

Virginia Littrell, St. Petersburg

Virginia Littrell is a former member of the St. Petersburg City Council. During her five year tenure, two new National Register Districts were established in the council district she represented. Prior to her election, she was appointed to St. Petersburg's Historic Preservation Commission where she served for five years and was elected chair in her last year of service on the commission. Virginia is a past member of the Florida Historical Commission, and she has served on the Board of Trustees and executive committee of the Florida Trust for Historic Preservation and is a past president of St. Petersburg Preservation, Inc.

Carter Quina, Pensacola

Carter Quina, AIA, LEED AP, has practiced architecture as a principal in the firm Quina Grundhoefer Architects in Pensacola, Florida, since 1984. Mr. Quina served as a member of the Florida Historical Commission from 2000 to 2008 and is presently a member of the West Florida Historical Preservation Board. The recipient of 12 Florida Trust Historic Preservation Awards, Mr. Quina is recognized as one of the state's leaders in historic preservation. Since graduation from Auburn University in 1978, Mr. Quina has broadened his education through world travel, volunteer participation, raising three children and active church membership.

Ivan A. Rodriguez, Coral Gables

Ivan A. Rodriguez is principal architect and director of historic preservation services with R.J. Heisenbottle Architects. Mr. Rodriguez founded and directed Miami-Dade County's Historic Preservation Division under which he conducted countywide surveys of historic and archeological sites; authored *From Wilderness to Metropolis*, a book describing the historical and architectural development of Miami-Dade County; and oversaw the implementation of the county's historic preservation ordinance. After serving for a time as director of the Deering Estate (an environmental, historical and archaeological park), he returned to Miami-Dade County to serve as staff director to the Miami-Dade County Historic Preservation Board. Mr. Rodriguez has also served as executive director of Miami-Dade County's Art in Public Places. He holds a Bachelor of Design and a Master of Architecture in Architectural History and Historic Preservation from the University of Florida.

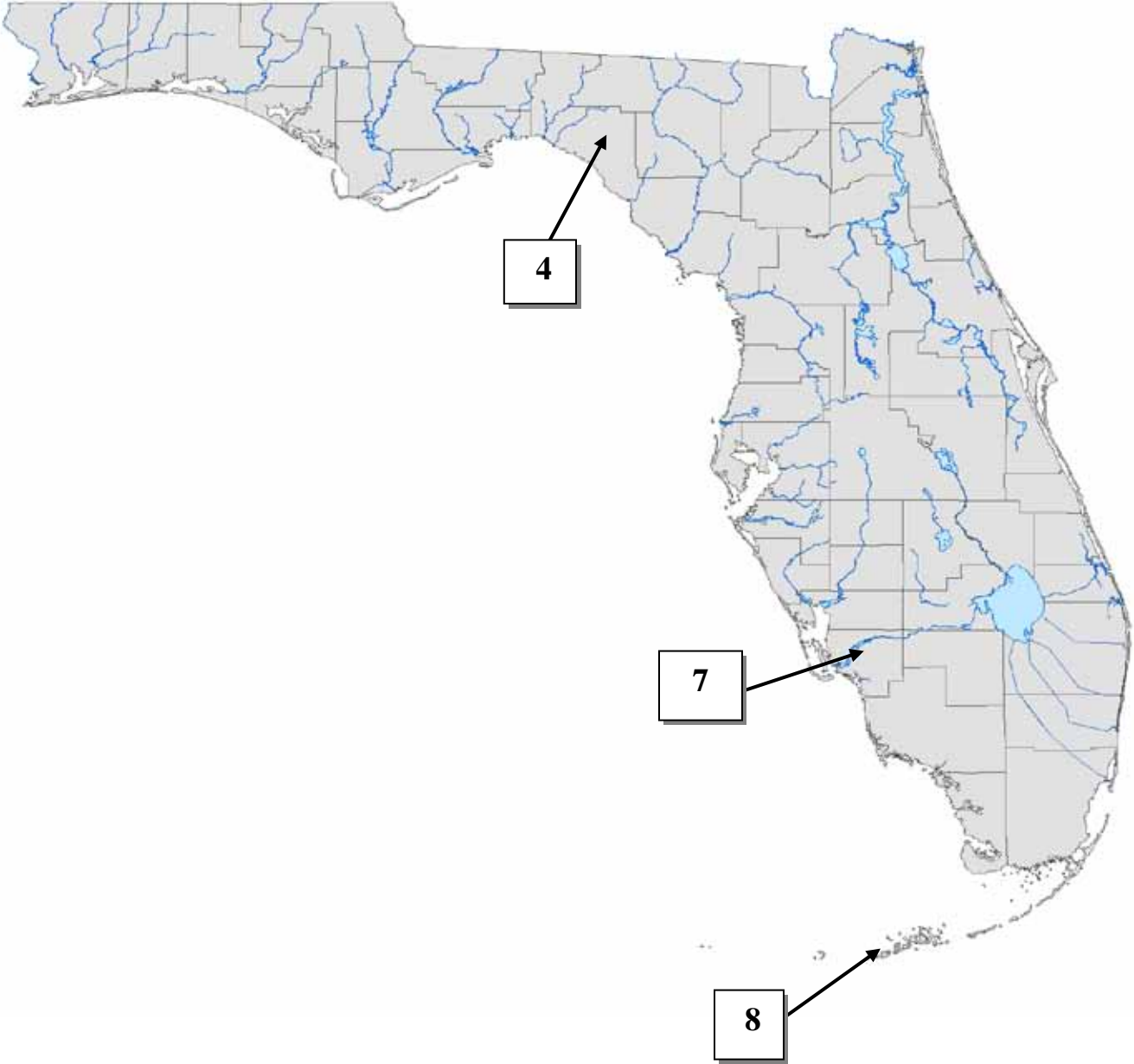

GRANT APPLICATION LOCATIONS**



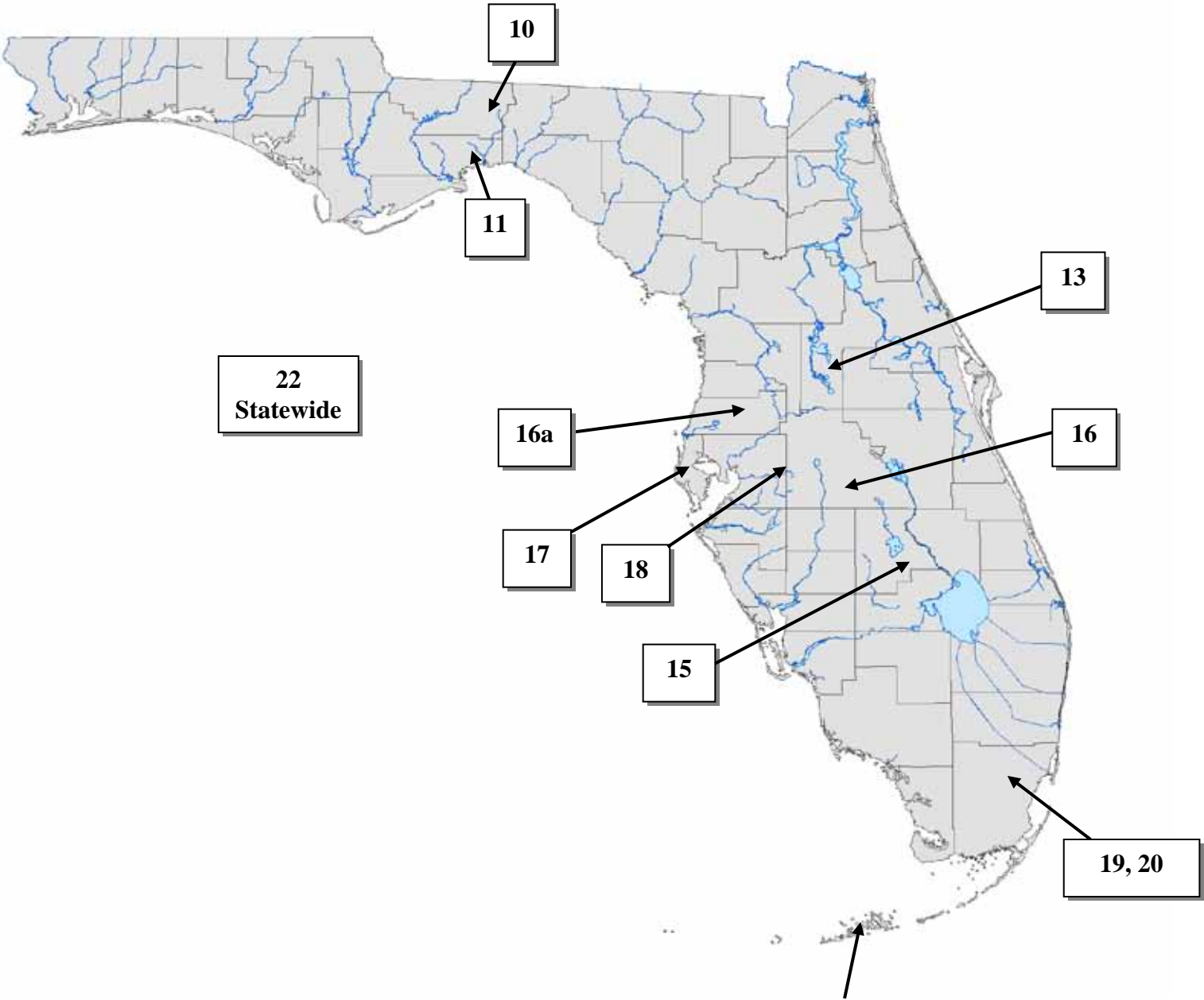

GRANT APPLICATION LOCATIONS**



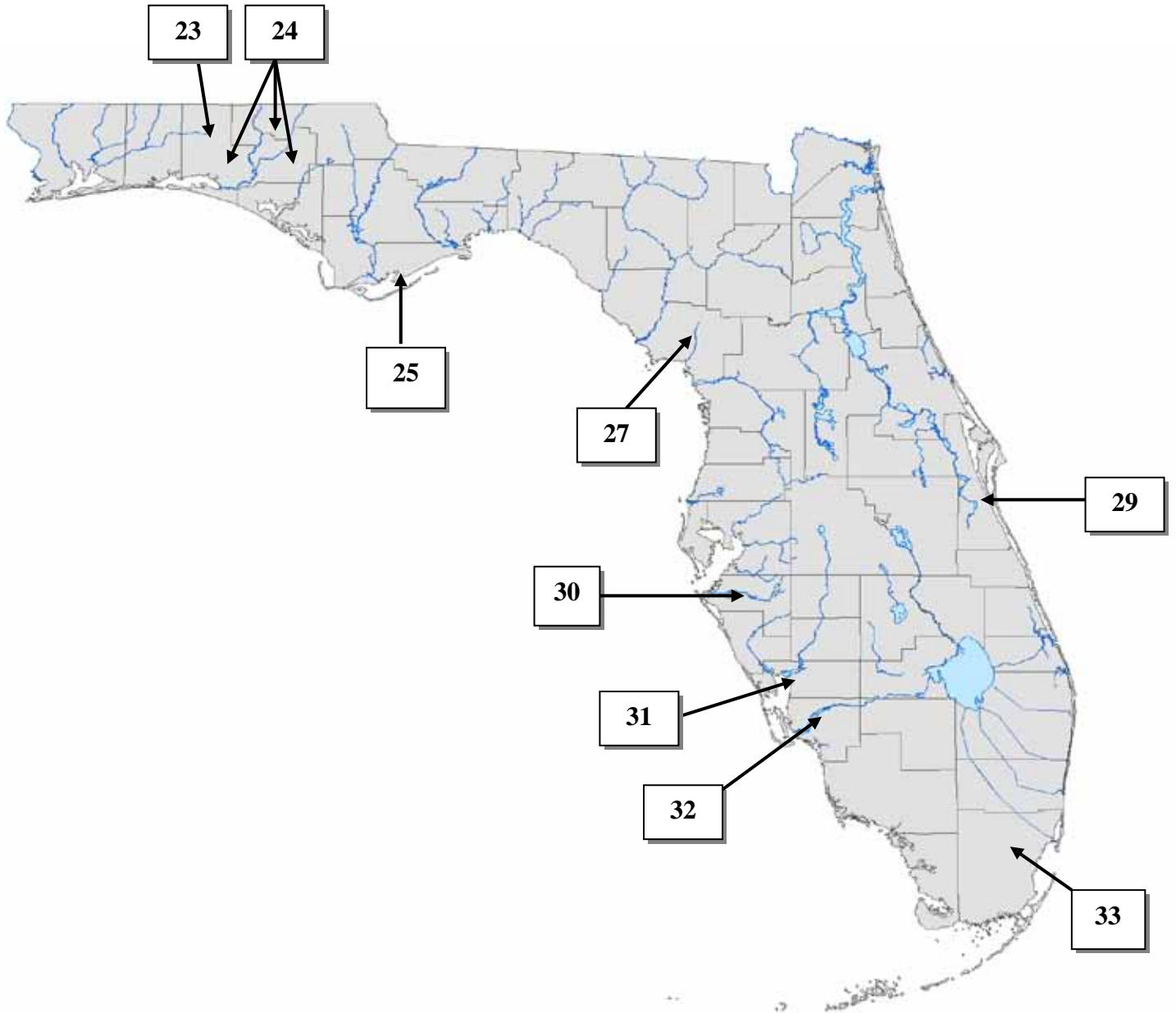

GRANT APPLICATION LOCATIONS**



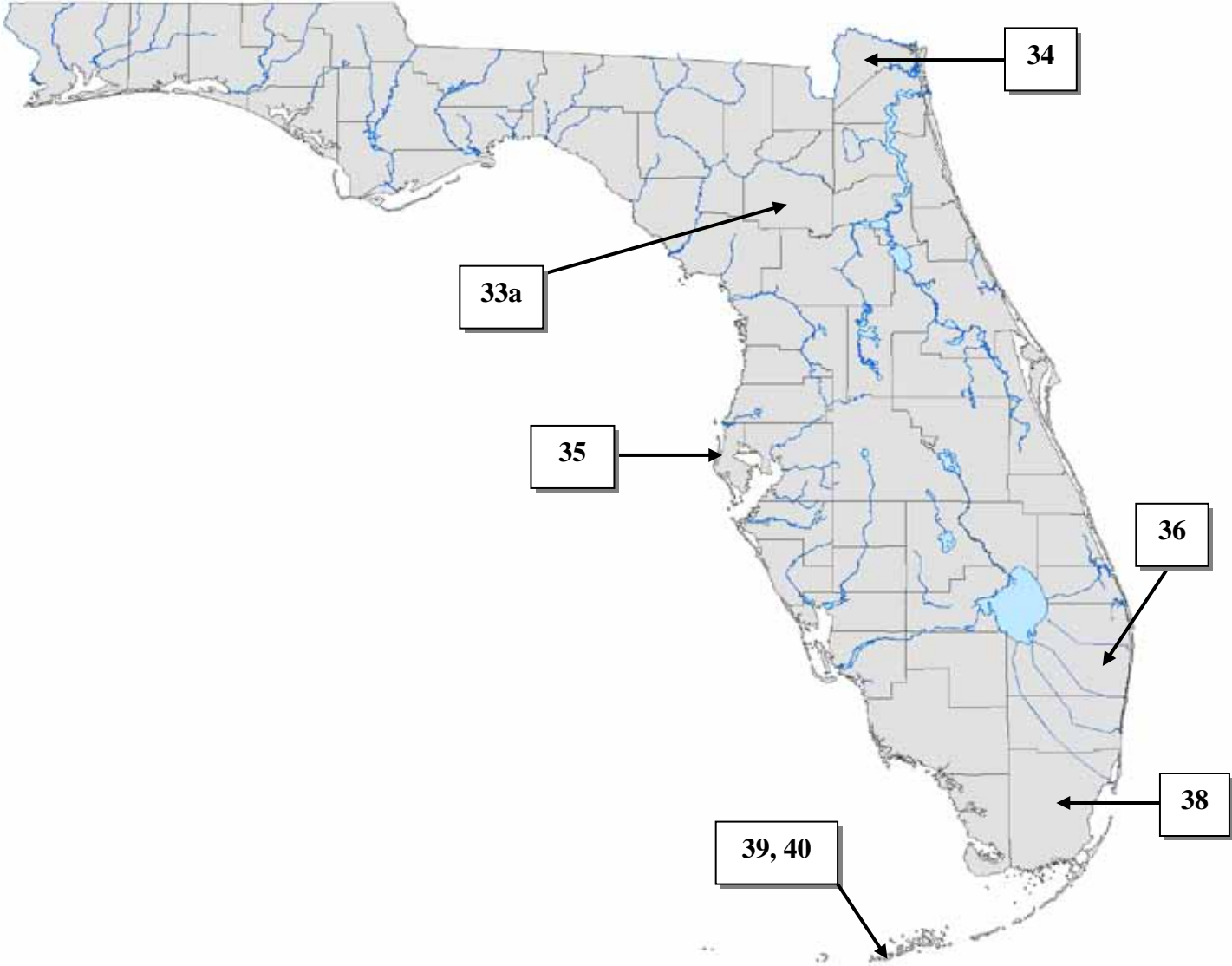
