Mark H. Beaubien, Jr., a seven-term Republican state Representative from Barrington Hills, died June 5, 2011, at age 68.

Beaubien was appointed to the House in 1995, and went on to win seven two-year term elections. A fiscal conservative, he was a point person on budget matters for years, but weighed in more moderately on social policies. In November 2010, he was one of only a few Republican legislators to vote in favor of a law allowing same-sex couples to enter civil unions in Illinois. He most recently sat on the House Committees on Consumer Protection; Income Tax; Insurance; International Trade and Commerce; Labor; Mass Transit; and Revenue and Finance. Beaubien also served as Assistant Republican Leader for nearly 10 years.

Representative Beaubien was born in Waukegan and earned his bachelor's and law degrees from Northwestern University. He was a former Lake County Board member and a top official at Suburban Bank of Barrington. He is survived by his wife of 47 years, Dee, two sons and five grandchildren.
