#### The Challenge

Argenta Private Capital Limited (Argenta) carried out a review of their current approach to corporate governance, with a particular focus on how decision making was evidenced, and how Board and Committee packs were presented and circulated.

Having completed the review, they concluded that their current paper-based process could be significantly improved, both within Argenta and harmonised across the Argenta Group, if it were digitised as this would give them an enhanced audit trail and would lead to smoother, more secure, communications. During the process, they also discovered that a significant amount of resource was expended in producing and circulating Board and Committee packs (for around 70 participants on four main Boards and their 14 Committees within the Argenta Group) which they felt could be better utilized on other activities.

#### **Delivering the Solution**

The BoardLink team at Thomson Reuters partnered with the Director and Company Secretary at Argenta, Chris Fairs, to develop a robust business case to present to their senior management. The business case included a critical assessment of their current methods of producing meeting papers. "After reviewing our pre BoardLink arrangements, it became evident in the long run that there would be a significant saving in terms of production costs and man hours spent putting together Board and Committee packs," said Chris.

It was proposed that their current outdated approach be replaced by a system that enables Board or Committee members and Company Secretariat to upload documentation onto a secure web enabled system, where users can review and comment on documents online and offline via their desktop, laptop or iPads.

"The issue of data security and the protection of sensitive information internally was a key factor in the provider we chose to partner with. A detailed report went to our IT Manager with a very robust set of assurances, where the results concluded very quickly that the data security BoardLink had to offer was exceptional, not to mention the ability to introduce our own layer of security with the iPad device."
