Minimum qualifications for Board Certified Environmental Engineer (BCEE) or Board Certified Environmental Scientist (BCES) applicants include an environmental or other approved engineering or science degree, and 8 years experience in environmental engineering or science, 4 of which include responsible charge. BCEE certification requires a PE license.

Applicants with fewer than 16 years experience and 12 years responsible charge sit for a 100-question, multiple-choice exam and a peer review in the applicant's selected specialty area (Engineers-Air Pollution Control, Environmental Sustainability, General Environmental Engineering, Hazardous Waste Management, Industrial Hygiene, Radiation Protection, Solid Waste Management, Water Supply/Wastewater Management; Scientists-Air Resources, Environmental Biology, Environmental Chemistry, Environmental Microbiology, Environmental Toxicology, Groundwater and the Subsurface Environment, Surface Water Resources, Sustainability Science).

Applicants with more than 16 years of experience may request a waiver of the written examination. If approved, peer review is still required.
