#### **BIG 8 CONFERENCE**

#### CONSTITUTION

(REVISED - JUNE 2010)

#### <u>Article I</u>

#### Name

The name of the organization will be the Big Eight Conference.

#### <u>Article II</u>

#### Purpose

The objective of this conference shall be to foster and promote interscholastic athletics among all high schools who are members of this conference and a state approved Athletic Association.

#### Article III

#### Membership

Section 1. This conference shall be composed of member schools who are duly admitted and in good standing.

#### Charter Schools are as follows:

1. Boonville2. Princeton Community3. Gibson Southern (withdrew 6/30/1992)4. Tell City (withdrew 6/30/2001)3. Jasper6. Vincennes Lincoln7. Mt. Vernon8. Washington9. Mt. Carmel (entered 6/2002 - effective 2003 - 2004)

Section 2. Additional schools who are members of a state approved athletic association may be admitted by a unanimous vote of the Board of Directors.



#### Article IV

#### Administration

Section 1. Management of the conference will be vested with the Board of Directors.

- Section 2. The Board of Directors shall consist of the principals of each member school or their appointed representative.
- Section 3. The officers of this organization shall consist of a president, vice president, and secretary treasurer. They shall be chosen annually by a majority of the Board of Directors at the regular June meeting.
- Section 4. The Board of Directors shall meet at least four times annually with meetings being held during the months of August, November, March, and June. Athletic Directors are expected to attend these meetings as resource persons.
- Section 5. In addition to the Board of Directors, an advisory committee consisting of head coaches (or designees) shall meet to prepare conference recommendations as per the following schedule.

#### Board of Directors Meeting Schedule

- August Board of Directors' Dinner Meeting
  - Agenda Items:
    - 1. The Board of Directors considers Spring Sports Proposals.
    - 2. The Financial Report of the Conference shall be audited by no less than two members of the Board.
    - 3. The Coaches of Spring Sports may meet to review their areas and prepare proposals. (advisory).
    - 4. Public Relations: The meeting of the Board of Directors may be followed by a Public Relations dinner at which the presentation of the All Sports plaques or trophies will be made.

#### November - Board of Directors' Meeting

- 1. General discussion items no proposals are to be presented.
- 2. The Coaches of Fall Sports may meet to review their areas and prepare proposals (advisory).
- March Board of Directors' Meeting
  - 1. The Board of Directors considers Fall Sports proposals.
  - 2. The Coaches of Winter Sports may meet to review their areas and prepare proposals (advisory).

June - Board of Directors' Meeting

- 1. The Board will set meeting, conference tournament, and all-conference meeting dates and sites for the year at this meeting.
- 2. Board of Directors considers Winter Sports proposals.
- 3. Elect Officers for the following year.



Statement of Clarification:

1. Presentations of Proposals:

a. All proposals must be presented to the secretary no later than one month

following their respective Advisory Committee meeting.

b. Where a proposal is coming before the Board of Directors, the chairperson or his designee of that sport may be in attendance at the meeting.

2. Conference sports by season "As mandated by the IHSAA." (11/9/94):

#### Article V

#### **Funds and Finances**

- Section 1. Dues: Each school shall pay to the treasurer of this organization an annual fee of \$300.00 on or before October 1.
- Section 2. Expenditure by the secretary treasurer in excess of \$100 shall be approved in advance by the President. The books of the secretary-treasurer will audited annually by a committee appointed by the president.
- Section 3. All expenses are to be reviewed by the Board of Directors at the November and June meetings with the audit being conducted at the August meeting each year.
- Section 4. The Board of Directors may levy special assessments upon member approval.

#### Article VI

#### Contest

- Section 1. This conference shall conduct such contests as are provided for in the by-laws. Conflicts in scheduling, due to unforeseen circumstances, will be referred to and rescheduled by the Board of Directors.
- Section 2. The school hosting a conference meet will send a financial report to the conference secretary/treasurer. The conference will absorb any losses from conference meets. The conference will receive any profits from conference meets.
- Section 3. Suspended Contests (adopted Fall 1999). In the case of a suspended contest the following will be in effect:
  - Baseball and Softball– The game will be called complete after 4 ½ innings of play. Prior to 4 ½ innings the game will be replayed in its entirety.

Cross Country - The meet will be rescheduled in its entirety.

Volleyball - Play will resume from the point of suspension.

Tennis and Golf - Play will resume from the point of suspension.

Football - Play will resume from the point of suspension.

Section 4. The Big 8 Conference will follow the rules and procedures of the NFHS and IHSAA for

conducting Big 8 Tournaments unless other wise specified in the by-laws. (3/04/2004)

# **BIG** HCHIP CONFERENCE

#### Article VII

#### **Publicity Director**

A Publicity Director appointed by the Board of Directors may handle conference publicity. The Publicity Director will be employed by the conference. The publicity budget will be reviewed annually.

#### Article VIII

#### Amendments

The constitution of the organization or its by-laws may be amended by a two-thirds vote of the Board of Directors at any regular meeting or special meeting provided that the proposed amendment had been submitted by a director to the secretary not less than two weeks before the regular meeting or special meeting. The secretary shall submit any and all proposed amendments to the member schools at least one week before the regular or special meeting.





#### BY-LAWS

#### (REVISED - JUNE 2008)

The by-laws of this constitution may be amended at any official meeting by a two-thirds vote of the Board of Directors.

#### Football:

- Section 1. Each school must participate in a contest with each member school in good standing to be eligible for the conference championship.
- Section 2. The football championship and order of place finishes will be decided on a percentage basis of games won and lost, with each team playing the other team in an official game. In the event of a tie, the schools involved will share the championship.
- Section 3. In the event the same two schools engage in more than one contest, only the first contest counts in the conference percentage.
- Section 4. The conference shall play eleven man football according to the rules and by-laws of the National Federation of State High School Athletic Associations and the Indiana High School Athletic Association.

Section 5. An all conference team will be selected each year in football.

#### Section 6. (11/05) See form: Page 41

- A. All Big Eight schools will play a game on the Monday following the Varsity game on Friday. This game will be a Frosh-Soph contract. By mutual agreement the game may be contracted as a reserve game (unlimited juniors). Site will be opposite the Varsity game e.g. Boonville at Princeton varsity game on Friday and Princeton at Boonville Frosh-Soph on the following Monday. You cannot cancel the Frosh-Soph game on Monday in order to play a Freshman game on Thursday. IHSAA quarter rules must be followed. The IHSAA week runs from Friday to Thursday.
- B. Protocol for the Frosh-Soph games include:
  - 1. A list of Juniors. who will be in uniform, will need to be faxed to the opposing school by 10:00 am of the Thursday prior to the Monday of play. Head coach and AD must sign this list.
  - 2. The List of Juniors can be no more than 6.
  - 3. Big 8 approval form must be used and filled out completely. (See attached form: Page 41)
  - 4. Opposing school must fax the approved Jr. list back to the sending school by 10:00 AM on Friday. The head football coach and AD must sign the approved list.



**BY-LAWS** 

#### Football:

Section 6. B. continued

- 5. All coaches must use good judgment in the use or non-use of juniors. The reason to dress juniors is not a win at all cost decision. It is a decision to let some below average juniors participate in a football game. The reason to scratch a Junior is not a decision based solely upon the winning or losing of the football game. It is a decision based upon preventing a potential physical mismatch from occurring on the football field.
- 6. Items to consider Number of Juniors on the field at one time, score of the game, a Junior who letters as a Sophomore.
- Section 7. Football coaches are to exchange the film from a previous week's game with their respective opponents for the forthcoming week. The exchange of video is to be accomplished each week by Saturday P.M. (3/1992)

#### Basketball - Boys and Girls:

- Section 1. Each school must participate in a contest with each member school in good standing to be eligible for the conference championship.
- Section 2. The basketball championship and order of place finishes will be decided on a percentage basis of games won and lost, with each team playing the other team in an official game. In the event of a tie, the schools involved will share the championship.

Section 3. An all - conference team will be selected each year in basketball.

#### Track & Field - Boys and Girls:

- Section 1. The conference track championships and the order of place finishes will be determined by official conference track meets.
- Section 2. The time and place of the conference track meets will be determined at the June Board of Directors meeting.
- Section 3. Participation in the conference track meets is limited to four events. (11/1995). Scoring shall be in a like manner to the IHSAA sectional track meet.

Section 4. Starting heights for the following events will be used in the conference track meets: (6/2010)

<u>Girls</u>: Pole Vault - 6'0" High Jump - 4'6" <u>Boys</u>: Pole Vault - 10'0" High Jump - 5'8"

Section 5. An all-conference team will be selected each year in track.



#### Track & Field - Boys and Girls: continued

- Section 5. The top six finishers in the running events should be timed; and the use of VCR or other sophisticated electronic device at the finish would supersede other place-pickings (11/12/86).
- Section 6. The announcer should be an experienced person so as to keep the meet running smoothly; and all stop watches to be used will be determined by the starter and head finish judge (11/12/86).
- Section 7. Schools will be allowed to enter three participants in an event provided the third athlete equals or betters the state standard or conference record for that event (whichever one is easier to attain). The current year IHSAA Spring Bulletin, available on-line at <u>www.ihsaa.org</u>, will be compared to Big 8 records. (08/25/10)

#### Baseball:

- Section 1. Each school must participate in a contest with each member school in good standing to be eligible for the conference championship.
- Section 2. The championship and places of finish shall be determined on a percentage basis of games won and lost. In the event of a tie, the schools involved will share the championship.
- Section 3. In the event that the two schools engage in more than one contest, only the first regular season contest counts when two separate games are scheduled and the first game has to be made up.
- Section 4. An all-conference team will be selected each year in baseball.

#### Cross Country - Boys and Girls:

- Section 1. The conference will annually have a varsity boys' and a varsity girls' meet and the winner of the cross country championships and the order of finish will be determined by this meet.
- Section 2. The time and place of the meet will be determined at the June Board of Directors meeting.
- Section 3. Each school may enter a team of 7 members and score 5. The meet shall be governed in accordance to IHSAA rules.
- Section 4. An all conference team will be selected each year in cross country. An all conference team for girls was approved (11/1984).
- Section 5. The Boys and Girls race will be 5000 meters; and a reserve meet will be held with both boys and girls running. (8/2007)





#### Golf - Boys and Girls:

Section 1. The conference golf championship shall be determined by an annual conference meet, the time and place of which shall be established annually by the Board of Directors. The meet will be conducted as medal play, 18 holes.

Section 2. Current USGA rules as modified by the IHSAA will be in effect.

Section 3. Each threesome or foursome will be made up of players from different school. The players will count and keep score for each other.

Section 4. Five players may participate but only four low scores will count.

Section 5. Refer to IHSAA bulletin for ties.

Section 6. An all-conference team will be selected each year in golf.

Section 7. Ribbons will be awarded to the top 10 places plus 5 team ribbons.

#### Tennis - Boys and Girls: (March 16, 1994: effective 1994-5 school year):

- Section 1. Each school must participate in a contest with each member school to be eligible for the conference championship.
- Section 2. To honor individuals in singles and doubles play, ribbons will be awarded to those with the best records, including ties, in each of the five divisions. Team Championship ribbons will be awarded to the seven team members.

Section 3. An all-conference team will be selected each year in tennis at a meeting of the coaches.

#### Wrestling:

- Section 1. A conference wrestling tournament will be held to determine the conference championship and standings.
- Section 2. The Board of Directors will determine the time and place of the conference wrestling tournament. (3/10/04) Weigh-in time is established as 8:30AM CST. Start time will be 9:15am CST.

#### Section 3. Seeding:

- A. Items needed: Chalkboard, numbers, and shaker bottle, sufficient blank bracket sheets for each weight class and coach.
- B. Follow the conduct of tournament recommendations in the official IHSAA wrestling rules rule 10.
- C. Each coach is to prepare a complete individual record of his wrestlers to be seeded including opponents' names, schools, and match scores.
- D. Criteria for determining seeded wrestlers are as follows:
  - 1. 20 minutes (maximum) per weight class for discussion. If no agreement has been reached, the seeding chairperson directs that seeding be accomplished by lot in that particular weight class.
  - 2. Head to head competition. If the individuals have wrestled each other more than once, the overall record prevails. When the overall record is even, the result of the latest match takes preference.
  - 3. Record against common opponents.
  - 4. A returning champion or runner-up in the same weight class.
  - 5. A contestant with the best overall record within the conference in that weight class. Determination of best record to be by a .500 record or better with a minimum of three (3) decisions required. In the event of a percentage tie, the contestant with the largest number of victories prevails.
  - 6. A contestant with the best overall record.
  - 7. A seeded contestant shall have the same opportunity to draw for a bye as other contestants in his bracket.

<u>Note:</u> Each seeded position is to be done separately; i.e., after the No. 1 seed is determined, the procedure for determining the No. 2 seed starts with the criteria No. 2 (above) and down the list until that seed is completed. This format is to be followed for each seeded position. The margin of victory is not a determining factor. A win is a win and a loss is a loss.

8. In the event that a seeded wrestler is replaced the IHSAA sectional guidelines for replacing a seeded wrestler will be followed. The term "last seeded wrestler" will be the unseeded wrestler on the highest numbered line (7-6-3-2).



#### Volleyball:

- Section 1. Each school must participate in a contest with each member school in good standing to be eligible for the conference championship.
- Section 2. The conference championship shall be determined on a percentage basis. In the event of a percentage tie, the schools involved will share the championship.
- Section 3. The first regularly scheduled match between two conference schools is to count toward the conference championship. If there were no regularly scheduled match during the season, the first round-robin match for a respective school would count toward the conference championship. No tournament matches are to count toward the conference championship (3/1981).

(Note: Match will be as per IHSAA mandate)

Section 4. An all - conference team will be selected each year in volleyball.

#### Swimming - Boys and Girls: (11/1984)

Section 1. A conference meet will be held for boys and a similar meet for girls.

Section 2. A championship plaque will be awarded in each meet, and individual ribbons in all events, as in conference track meets, will be awarded.

Section 3. All - conference teams will be named each year for both boys and girls.

Section 4 Prelims on a Thursday (no diving); eight dives on a Saturday morning; on Saturday afternoon, three dives plus swim event finals. (6/1993) See also: Page 38-39 (3/2008)

#### Soccer - Boys and Girls: (11/1994)

- Section 1. Each school having soccer (boys and/or girls) will play each other school having soccer. If two schools engage in more than one game, only the first regular season match counts.
- Section 2. The championship and places of finish shall be determined on a percentage basis of games won and lost. In the event of a tie, the schools involved will share the championship and other place-finishes.

#### Soccer - Boys and Girls: continued

Section 3. A championship plaque will be awarded to the team champion (girls and boys).

Section 4. An all - conference team will be selected each year (boys and girls).

Section 5. Conference matches should not end in a tie. The IHSAA allows for conferences to utilize state tournament rules for overtime play. The overtime period will consist of two (2) seven (7) minute periods and move to penalty kick shootout should a tie still exist. (3/2008)

#### Softball: (11/1993: effective 1994-5 school year)

Section 1. Each school having softball will play each other school having softball. If two schools engage in more than one regular season contest, only the first one counts.

Section 2. A championship plaque will be awarded to the champion, determined on a win-loss percentage.

Section 3. An all - conference team will be selected each year in softball.

#### Awards and Plaques:

- Section 1. Upon notification by the secretary of the conference, the awards committee will purchase plaques and certificates not to exceed the conference limitation on price or number for the conference.
- Section 2. The conference will purchase all plaques for conference champions and a member of the Board of Directors of the conference may make proper presentations of all varsity plaques.
- Section 3. Plaques shall be approved for each varsity conference champion. In case of ties duplicate awards shall be provided.



#### All-Sports Plaque: (3/1994 effective 1994-5 school year)

Section 1. Three all-sports plaques will be awarded: Overall, Boys, and Girls

Section 2. Conference sports will be pointed according to the following:

Place	First	Second	Third	Fourth	Fifth	Sixth	Seventh
Points	100	80	65	50	40	30	20

- Section 3. At the conclusion of the season in each sport the conference standing will be used to determine points for the all-sports plaque.
- Section 4. In football, basketball, baseball, volleyball, tennis, softball, and soccer, the win lose percentage will be used. If the percentage is the same the points will be split. All other conference sports will use championship tournament results.
- Section 5. Each school must declare two exemptions in boys' sports and two exemptions in girls' sports. Said exemptions may be used for a sport(s) not being offered by a school. A school participating in all of the boys' sports and/ or all of the girls' sports may exempt its two "lowest finishes". Each school will designate its respective exemption(s) to the conference secretary at the respective June meeting of the conference. (11/1994)
- Section 6. The 1<sup>st</sup> regular season contest will count toward the conference championship. Invitationals and tourneys will not count. Exception: The only exception is where conference tournaments are held to determine conference champions. (11/12/2003)

#### Academic All-Conference:

Certificates will be issued at the end of the first Semester and at the completion of the school year. They will be awarded to the senior student athletes with a 3.5 GPA or higher for the respective grading period.

#### **CONFERENCE ADMISSION PRICES**

(Effective 2009-2010 school year)

All Varsity sports will not exceed a maximum price of \$5.00 per person. All non-varsity sports will be \$3.00 for adults and students. Conference Cross Country meet will be \$3.00.

Conference Wrestling meet \$6.00 per person for all sessions.

Conference Swimming meet \$5.00 per session.

Conference Track meet will be \$5.00.

# GIRLS' CROSS COUNTRY - VOLLEYBALL - GIRLS' BASKETBALL - GIRLS' TRACK - GIRLS' TENNIS GIRLS' SWIMMING - SOFTBALL - GIRLS' SOCCER(1995) - GIRLS' GOLF(1995)

All Big 8 Conference head coaches are required to attend a mandatory all-conference selection meeting for their sport with the exception of Boys' and Girls' Golf, Cross Country, Swimming, Track and Wrestling which determine all - conference team members based upon conference tournament results. All - conference selection meetings will be held in a central location. Sports that select all - conference team members during their district meetings are exempt from the central meeting location requirement. (2/2007)

#### Cross Country - Boys and Girls: 10 members (6/1993) (6/1998)

The first ten finishers in the conference meet are to comprise the All-Conference team, but in the case of injury/ hardship to a worthy athlete, preventing his/her participating in the conference meet, the head varsity CC coaches may add such athlete(s).

#### Football: Offense - 13 members - Defense - 11 members

The offense will consist of one center, two guards, two tackles, one tight end, one quarterback, three backs and one receiver or two backs and two receivers, one kicker, and one punter (Total 13).

The defense will consist of four down linemen, four linebackers, and three defensive backs (Total 11).

The first place team in the conference receives eight nominations. Second place - 7; 3rd place - 6; 4th place - 5; 5th place - 4; 6th place - 3; 7th place - 2. An eighth place team would receive one nomination.

In addition to the allotted nominations, each team earns an additional nomination per conference win.

In case of a tie, teams get the number of nominations of the place they tie for. (Example: Tie for 2nd - teams get seven nominations)

Each head coach must cast his vote for a player at each position. He may not vote for his own players. The player receiving the greater number of votes is the all-conference selection.

In case of tie votes, the following tiebreakers will be used:

- A. A ballot is taken among the head coaches, and the coaches of the players involved in the tie do not vote.
- B. If the ballot still remains a tie, the second method for breaking the tie is the records of the players' teams in the conference. The player whose team has the better conference record would be selected all- conference.
- C. If there still is a tie, the third tie breaker is head to head competition whose team won when they played each other. The player on the winning team is selected all-conference.

#### Volleyball: 12 members (6/1993)

Each coach may nominate from his/her own team, maximums as follow (11/8/95): 1<sup>st</sup> place - 6; 2<sup>nd</sup> place - 6; 3<sup>rd</sup> place - 4; 4<sup>th</sup> place - 4; 5<sup>th</sup> place - 3; 6<sup>th</sup> place - 3; 7<sup>th</sup> place - 2; 8<sup>th</sup> place (if applicable) - 2.

Nominating ballots must be returned to the volleyball chairperson within three days of the last conference match. Nominating ballots may include such individual statistical information on nominees as compiled by the respective coaches and submitted to the chairperson (3/1991).

From the nominations received from the coaches, the chairperson will make up the final ballot. Each coach then will vote for 12 players not on his/her team numbering them in order of preference. Twelve points will be awarded the No. 1 choice; 11 points the No. 2 choice, etc. The final ballots will be tabulated, and the top 12 point winners will comprise the all-conference team.

#### Wrestling: 16 members (14+2) (3/1996)

The all-conference team will include all individual weight class champions (14) plus a possible two extra individuals. One extra wrestler will be nominated and voted upon at the conclusion of the Big Eight Conference Wrestling Tournament. The second wrestler may be nominated in case of injury or illness to a worthy athlete that prevented him from competing in the conference meet. All coaches will have one nomination plus one vote. A coach may not vote for his own wrestler. The wrestler with the greatest number of votes will be named all conference. In case of a tie vote the following tiebreaker will be used:

- a. A ballot is taken among the head coaches, and the coaches of the wrestlers involved do not vote.
- b. If the ballot still remains in a tie, the second method of breaking the tie is the individual wrestler's record in conference matches.
- c. If there still is a tie, the third tie breaker is head to head competition. Whose team won when the two teams wrestled each other? The wrestler on the winning team is selected All- Conference.

#### Tennis - Boys and Girls : 10 members (6/99)

In a post-season meeting, coaches from each school will determine the All - Conference team.

- a. A total of ten players will be selected All-Conference.
- b. Each head coach (or his designee) present may nominate up to five (5) players.
- c. Season data on each nominated player must be available for all coaches in attendance.
- d. The top 10 players (at least two must be doubles players\*) will be selected one at a time, in open vote of coaches present. \*Must participate in MORE doubles than singles during conference play.
- e. Nominations will be open to all players through the first 8 rounds. If no doubles players have yet been selected, the nominations will be open for doubles players. Only rounds 9 and 10 can be used exclusively for doubles players.
- f. Each school with coach or designee present will receive 1 vote per round.
- g. A coach can not vote for their own player

h. A coach may not abstain from voting to alter voting results.



## **ALL - CONFERENCE CRITERIA**

#### Track - Boys and Girls: All blue ribbon winners + 2 (6/1984)

The all - conference team will include all individuals winning blue ribbons (individual events and relays\*), The extra "2" will be utilized if there is a tie, if two individuals break a conference record, and/or in case of injury to a worthy athlete, preventing his/her completing action in the conference meet.

\*Varsity relay runners only are eligible for all conference recognition.

#### Golf - Boys and Girls: 7 members (4+3) (11/1994) (6/1998)

Four (4) members of the all - conference team are to be determined as a result of being the top four (4) and ties in the conference meet. The remaining three (3) are to be selected from the list of nominees as submitted by conference coaches. However, golfers may be selected by conference coaches in case of injury/hardship to a worthy athlete, preventing him/her from competing in the conference meet. A coach may nominate a player from his own team. (Note: A coach may nominate a golfer from another school for all-conference honors in lieu of a golfer from his own school. (11/1992). From the list of nominees, the three (3) receiving the most votes (and ties) complete the seven (7) players on the all - conference team. Only seven total members of the all-conference team will be allowed. (5/2007)

#### Baseball and Softball: 13 members (10+3) (3/1994)

Each coach may nominate only five (5) players from his own team. A player may be nominated as a pitcher or as a candidate for one of the other ten- (10) positions (not both). In order to help the other coaches make a decision on your players, please rank your nominee's one (1) through five (5) with one (1) being your best, and so forth. This ranking will appear on the final ballot with all the stats.

Nominating ballots must be returned to the baseball chairman by the Friday prior to the sectional. They should include all game stats, and every effort should be made to include the defensive stats of A, PO, E, and Pct.

From nominations received from the coaches, the chairman will make up and send to the coaches a final ballot with all the stats.

Each coach must vote for ten (10) players (regardless of position), plus three (3) pitchers who are not members of his team. A ballot that is not completely filled out will be invalid and tossed out.

The Coaches will rank their selections from one (1) to ten (10). The all conference players will be selected by the total number of ballot votes of the coaches. The point <u>values</u> will be used only in case of a tie for the tenth  $(10^{th})$  place or third  $(3^{rd})$  pitcher. Then, the coaches will go by total points received to break the tie in ballots. A first-place vote will be ten (10) points; second-place nine (9) points etc. For the pitchers, the points will be three-two-one (3-2-1). Hence, the order of coaches' choices may be very important.

The Chairman will tabulate the ballots.



**ALL - CONFERENCE CRITERIA** 

#### Girls' Basketball: 10 members (6/1993)

- 1. Ten (10) members to be selected.
- 2. Each Coach will nominate up to three players from his/her team.
- 3. Each coach will vote 10 points for the best player; 9 points for the second best player through the 10<sup>th</sup> best player, who will receive "1" point.
- 4. Coaches do not vote for their own players.
- 5. All ballots will be tabulated and top 10 scores in the voting will be the all conference team.

<u>Note:</u> In case of a tie for 10<sup>th</sup> place, the more "10-point" votes; then, "9- point"; then "8-point" votes, etc., would break the tie. If a tie still exists all coaches would vote on the tie players with coaches of all players involved in the voting.

#### Boys' Basketball: 10 members (6/1993)

- 1. Ten (10) members to be selected.
- 2. Each Coach will nominate up to five players from his/her squad.
- 3. A ballot will be prepared by the Advisory Committee Chairperson and mailed to all coaches.
  - a. In voting, no coach may vote for his own player(s).
  - b. Each coach votes his top 10 players "10" for the best "9" second best, etc., through "1".
  - c. These will be tabulated, and the 10 players with the highest point totals would comprise the allconference team.
- 4. If a tie for the 10<sup>th</sup> position results, the player with more first place; then second-place; etc., would be named.

<u>Note:</u> In case of a tie for 10<sup>th</sup> place, the more "10-point" votes; then, "9- point"; then "8-point" votes, etc., would break the tie. If a tie still exists all coaches would vote on the tie players with coaches of all players involved in the voting.

#### Swimming - Boys and Girls: All blue ribbons + 2

All individuals winning blue ribbons (individual events and relays); and the extra "2" will be utilized if there is a tie, if two individuals break a conference record, and/or in case of injury to a worthy athlete, preventing his/her completing action in the conference meet.

#### Soccer - Boys and Girls: 17 members (15+2) (3/2008)

- 1. Coaches shall meet at the All-District meeting to select all-conference members.
- 2. Fifteen (15) field players and two (2) goalkeepers will make up the all conference team.
- 3. Each School will be allowed to nominate five (5) field players and one (1) goaltender.
- 4. Each coach will submit a list of nominees two weeks before the all conference meeting. Ballots must be returned prior to the all conference meeting. The rankings will be totaled at the all conference meeting.
- 5. The Soccer Chairman will compile a list of nominees prior to the meeting.

#### Soccer - Boys and Girls: 17 members (15+2) (3/2008) continued

- 6. Coaches will vote and the totals will be compiled prior to leaving that meeting.
- 7. Coaches shall not vote for their own athletes.
- 8. When voting for all conference members, each coach shall vote for fifteen (15) field players only, and then, vote for two (2) goalies only.
- 9. From the nominations received from the coaches, the chairperson will make up the final ballot. Each coach then will vote for 15 players not on his/her team numbering them in order of preference. Fifteen points will be awarded the No. 1 choice; 14 points the No. 2 choice, etc. The final ballots will be tabulated, and the top 15 point winners will comprise the all-conference team. Goal keepers No. 1 choice, 2 points; No. 2 choice, 1 point. Ties will count for the top fifteen positions. All Coaches will cast a secret ballot to break any tie for the fifteenth position. The goalkeepers will be ranked in the same manner. The two goalkeepers with the highest point totals will be selected all conference.

\*\*\*\*\*\*

No athlete is to be considered for all - conference honors if he or she does not participate in the conference meet unless otherwise specified in conference rule regarding specific sports. (11/1986 to an earlier motion passed 6/1984)

Coaches in each sport shall review and/or select each respective all - conference team in a meeting or at the conference meet or match: Cross Country - Boys' and Girls', Wrestling, Track - Boys' and Girls', Swimming - Boys' and Girls', Golf - Boys' and Girls' (11/1987 and 6/ 1988)

At a time other than the conference meet or event, a meeting shall be held to select all - conference teams for Football, Volleyball, Basketball - Boys' and Girls', Baseball, Softball, and Tennis - Boys' and Girls'. Said meeting should be at a reasonable time and not scheduled on a Sunday without Board approval. At the all - conference team selection meetings, there should be discussion and open voting with no secret balloting.

A school not having a representative at the all conference meeting will not be allowed to nominate players from their school to be on the all - conference ballot. Before the all - conference voting begins, a coach in attendance can nominate a player from the school not having representation to be on the all - conference team. That player can be put on the all - conference team only by unanimous vote of the coaches present. Player(s) would count toward the total number allowed on the all - conference team. (6/2006)

#### Frosh - Soph Guidelines:

For this to work all coaches must use good judgment in the use or non-use of juniors. The reason to dress juniors is not a win at all cost decision. It is a decision to let some below average juniors participate in a football game. The reason to scratch a junior is not a decision based solely upon the winning or losing of the football game. It is a decision based upon preventing a potential physical miss match from occurring on the football field.
