This collection consists of more than 3000 documents, dating from the 1420s to 1980s, mainly relating to the family of Skene of Rubislaw (near Aberdeen). At its centre are the papers of James Skene (1775-1864), artist and friend of Sir Walter Scott. Skene corresponded with notable individuals in the cultural circles of his day and was connected with such organizations as the Royal Institution, the Society of Antiquaries of Scotland, the Royal Society of Edinburgh, the Institute for the Encouragement of the Fine Arts in Scotland, the Board of Trustees for Manufacturers, and the Bannatyne Club, among others.

The archive was formerly in the possession of Major P.I.C. Payne, of Minehead, in Somerset, who acquired the material by purchase from various sources. Some of Major Payne's own papers relating to the collection from the 1960s, 70s and 80s are included (folders 102-107).

Major Payne provided individual descriptions of a portion of the earlier Skene family papers (folders 1-10). These descriptions are listed in the Appendix to this inventory. Folder 10 includes some letters of James Skene himself. Other related families (folders 22-36) include Moir of Stoneywood (the family of James Skene's mother, Jane), the Forbes family (that of Skene's wife, Jane, daughter of Sir William Forbes of Pitsligo), Russell of Aden, Keith of Ludquhairn, Gordon of Balgown, Ramsay of Invernellie and Peterhead, and Skene of Halyards and Curriehill.

Later family papers (folders 37-39) include correspondence and other material of James Skene's three sons: 1) George Skene (1807-1875), advocate and professor of law in Glasgow University; 2) William Forbes Skene, historian (1809-1892), author of (among other titles) *Celtic Scotland: a History of Ancient Alban,* and the *Memorials of the Family of Skene* and historiographer royal for Scotland; and 3) James Hay Skene (1812-1886), author and Consul General at Aleppo.

Major Payne acquired – and in some cases extracted from the Skene papers – material relating to Sir Walter Scott and his family (folders 87-99). Of particular note are letters from Scott, his daughter and son-in-law, John Gibson Lockhart (folder 89), and correspondence (more than 100 items) by or relating to Scott's father, Walter Scott, W.S, written from 1774 to 1806. Dr J. C. Corson arranged this material and produced an index (located in folder 91). A further acquisition by Major Payne comprised two commonplace books of James Ellis (1763-1830) of Otterburn, poetical editor and associate of Sir Walter Scott. These volumes include an 'Ode to the Genius of Scott', accounts of visits to Scott, poetry, transcriptions of letters, and a collection of verse by Thomas Bedingfeld, whom Ellis edited.

A part of Major Payne's collection was inventoried by the NRA(S) in October 1969 [survey 0464]. As this ordering had not been fully retained at the time of accession, a more logical regrouping was implemented, bringing together papers of families and individuals and establishing a more consistent chronology.

This accession complements existing holdings of Skene family papers (including James Skene), references to which are widely scattered in the Library's published manuscript catalogues (especially volumes I and 2) and in online lists. Among these are: MSS.965, 3854, 20465-80; Acc.8518, 9718, 10050, 10608, 11068, and 11537. Other James Skene and Skene family papers are located in the Edinburgh Public Library, Edinburgh University Library, the National Gallery of Scotland, the National Archives of Scotland (GD244), Aberdeen University Library and University College, London.

Accounts and receipts 1785-1836, primarily of James Skene but also of family members, of business dealings in Edinburgh, London, Glasgow and other places, including goods purchased, estate accounts (such as tenants' wages); material relating to foreign travel 1802-03; receipts for painting supplies, 1805, an account with Chalmers & Son, engrarvers, gilders & picture cleaners, listing a portrait of Sir Walter Scott, etc. Skene's accounts with the bankers Forbes & Hunter are separated in folder 86. A number of the documents are on engraved stationery and in letterpress. (Documents are filed chronologically, and where spanning more than one year, by the latest date recorded.)

DESCRIPTION OF THE ITEMS IN FOLDERS 1-10 (NUMBERED 1-318)

Brackets [] typically indicate undeciphered text or missing information.

Items 1-12 are contained in folder 1

- 1. OBLIGATION by Thos. Forsyth, Isbel Knox and William Fulles to pay Colonel Archibald Spens of Lathallan Lodge £8:1:- for corn. Kelso, 21 August 1813.
- 2. LETTERS OF EXCOMMUNICATION by the official Principal of St Andrews at the instance of Margaret Dunbar, relict of the deceased William Forbes against William Ruthwane of Bandane for nonfulfilment of an order under the sign of Patrick Ross priest of St Andrews diocese, notary, dated 10 July 1537 to him through his attorney Mr James Spens to fulfill a contract with the said Margaret Dunbar, St Andrews, 28 June 1539.
- 3. Royal GRANT in favour of Robert Wood of the non-entries of the lands of Lamhalland and Kittite formerly pertaining to the deceased John Spens of Lamhalland and also of the marriage of John Spens son and heir to the said John. Edinburgh, 27 December 1521.
- Copy of a royal GRANT in favour of the town of St Andrews to provide for the ministers of the gospel and the poor of the property and rents of the Greyfriars, the Blackfriars, the chapels of St Nicholas, Kinglassie, Kynninmount and the collegiate church of Kirkhill, Edinburgh, 17 April 1567.
- 5. INSTRUMENT OF SASINE dated 29 May 1574 recording that James Spens of Lathalland Eister with consent of Elizabeth Seytoun his spouse has given possession of an annual rent of 18 merks out of Lathalland Eister to Florentinus Auchtmowty of Halhill and Margaret Bury his spouse. Witnesses: Arthur Spens, apparent of Lathalland, David Roucht and David Wilson. Notary: David Auchtmowty clerk of St Andrews diocese.
- 6. Royal WARRANT for a feu charter under the great seal in favour of Captain Patrick Setone and his heirs of the Kirklands of the vicarage Strameglor with the glebe, manse etc. for a feu of the 20 merks formerly payed to the vicar with an augmentation of 13/4, 158 [Date not filled up].
- 7. Royal INHIBITION at the instance of George, Lord Seytoun complaining that the place of the Blackfriars in St Andrews pertaining to him has had some parts cast down and the stones taken away and that the same people intend to demolish the place and take away the stones; whereby all and sundry are forbidden to demolish any part. St Andrews, 22 August 1583. Endorsed with execution at the market cross on 22 August 1583 by Robert Mwdy messenger against the

- provost baillies and all others. Witnesses: Mr James Seton, James Young, John Seton and William Ramsay, trumpetor.
- 8. DISCHARGE by Alexander Spens son to James Spens of Lathalland to James Irnis of Kinclune on behalf of James, Lord Ogilvy of Airlie and Mr David Auchmwtie, citizen of St Andrews his cautioner for £260 owed to Captain Patrick Setoun Usan of the King of France's guard with consent of Mr Julian Quentene, merchant in Pareis. Dundee, 22 November 1589. Witnesses: George Ogilvy, burgess of Dundee, Gilbert Ogilvy of Brekis, William Thomsoun, procurator in Dundee and David Skinner, writer.
- 9. OBLIGATION by James Spens of Lathalland to Alexander Spens his second son, having spent a good part of his young years waiting in Edinburgh at all times of session pursuing David Kynneir of that ilk for his father, to get himself infeft in the halflands of Kittitye and Craigsanquhor once occupied by the deceased James and Robert Moreis and now by the said David Kynneir and thereafter to transfer title to the said Alexander. Edinburgh, 17 December 1599. Witnesses: George Spens, servitor to Mr Richard Spens, advocate, James Borthuik, writer and Andrew Lyndsay and Robert Balfour his servants.
- 10. CONTRACT at Newhous of Lochlevin 16 February 1595 between Alexander Spens son to James Spens of Lathallane on the one part and Andrew Howburne son to Patrick Howburne of Tilliboll on behalf of Janet Dowglass relict of Alexander Robertsone in Cragow and Robert Robertsone her son on the other part whereby Alexander agrees to get a precept of clare constat from his father to enter the said Janet to Drumghar Zairds in the town of Perth and to transfer his right in a contract made between the deceased Alexander Robertson and him to the said Andrew in return for an unspecified sum. Witnesses: David Barclay of Stuey, William Duncan (Chirurgeon) burgess of Dundy and Hewie Dowglas.
- 11. DISCHARGE by John, Earl of Rothes to Alexander Spens of Lathalland for writs concerning the lands and barony of Condland [25 documents, 1603-1614 listed]. Leslie, 21 June 1622. Witnesses: James Ayttoun servitor to the granter, Mr David Ayttoun, younger in Edinburgh, Robert Balfour servitor to Michael Arnot of that ilk, Andrew Beathe in Leslie, David Andersone, Gawine Wemys writer hereof and Robert Bonstoun servitor to the said David Anderson.
- 12. NOMINATION by Janet Forratt residenter at Lathalleand of Thomas and Helen Spens lawful children to Nathaniel Spens of Lathalleand as her executors [name of David Spens apparently cut out] especially for a sum owed by Margaret Moncreife, lady of Lathalleand elder and she leaves in legacy to Nathaniel Spens her master for his kindness her bygone fees, £20 in the hands of John Rumgay elder in Cordies Meallemy, £8:11:- in the hands of Christian Rodger in the Coattoune of Cassingray and £3 in the hands of James Bred tailor in Kilconquhar. At Lathalleand, 9 February 1669. Witnesses: John
