### *Sproul, Wm. Cameron*

WM. CAMERON SPROUL, Manufacturer and Capitalist, resides at "Lapidea Manor," in Nether Providence Township. Prior to his election to the Governorship in 1919 he served as Senator from Delaware County from 1896, and in 1903-1905 he presided as President of the Senate. He served as Delegate to the Republican National Conventions in 1916, 1920 and 1924. His clubs are the Union League, of Philadelphia, of which he is President, and where he served as President during the years 1917 and 1918; Philadelphia Club, Art Club, Chester Club, Springhaven, Corinthian Yacht, Bankers', India House, Manhattan, N. Y., and Congressional Country Club, Washington. He is a 33rd Degree Mason. His societies are the Phi Beta Kappa, Kappa Psi, Sigma Xi, Pennsylvania and Delaware County Historical Societies and Swedish Colonial. Governor Sproul was born at Colerain Township, Lancaster County, September 16, 1870, the son of William Hall Sproul and Deborah Dickinson Slokom Sproul. On January 20, 1892, he married Emeline W. Roach, daughter of John B. Roach. Their two children are Dorothy (Mrs. L. B. Sharples), and Captain John R. Sproul. He is President of the General Refractories Company and Director of the Lackawanna and Wyoming R. R., Scranton and Wilkes-Barre Corp., Penn Mutual Life Insurance Company, P. B. & W. R. R., Bank of North America and Trust Company, Delaware County National Bank, and the First National Bank of Chester, etc. He has had degrees conferred upon him by Swarthmore, Lafayette, University of Pittsburgh, University of Pennsylvania, Pennsylvania Military College, etc. He is a member of the Society of Friends. His hobby is history and patriotic subjects, having restored the old Chester Court House and returned it to the city. His sports are hunting and fishing.

*Fronefield, Judge W. Roger*

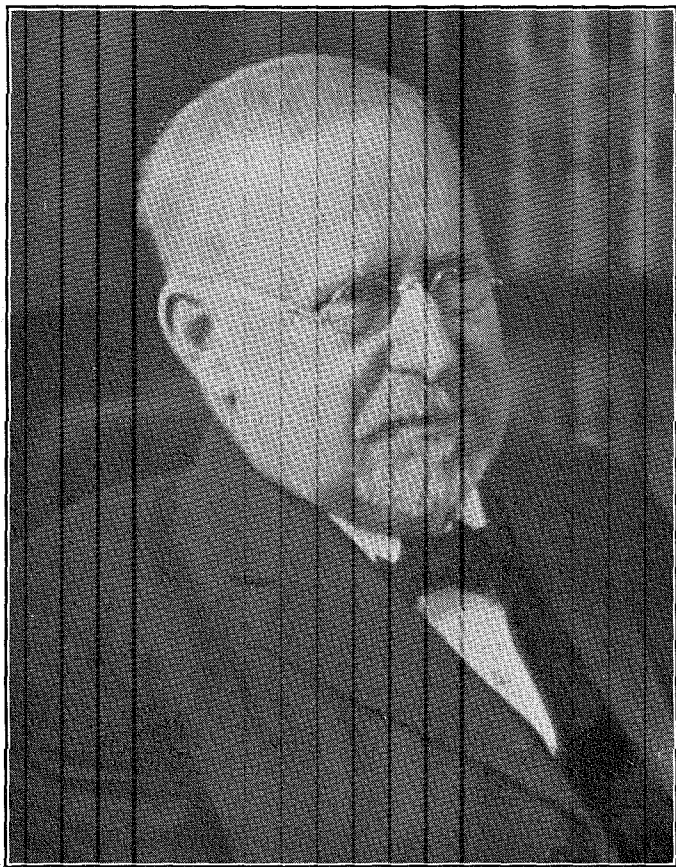

He resides in Moylan. One of the foremost members of the Bar in this county. At the time of his going on the bench was President of the Charter National Bank of Media. He was born in 1864, on November 22nd. Mr. Fronefield has the degrees, M. E. L. L. B. On June 29th, 1892, Mr. Fronefield married Phelina Marshall Lewis, who died June 18th, 1922. His two daughters are Elizabeth Lewis Fronefield, who married Alfred H. Porter, and Louise Fronefield, who attends Goucher College, Baltimore. Mr. Fronefield in politics is a Democrat. JUDGE JOHN MARTIN BROOMALL, 3d, was elevated to the bench of the Courts of Common Pleas and Quarter Sessions of Delaware County by Governor Pinchot on June 25, 1926. He resides in Media. When 21 years old he was admitted to the Bar, since which time he has held high rank among those of the legal profession hereabout. Judge Broomall was born in 1878, on June 26, the son of John M. Broomall, Jr., and Elizabeth Cook Broomall. His wife is Margaret Hamilton Broomall, and their children are Margaret Armstrong Broomall, John Martin Broomall, 4th, Katherine Vaughan Broomall and Thomas Hamilton Broomall. He is a member of the American, Pennsylvania and Delaware County Bar Associations, and of the Delaware County Historical Society. Judge Broomall is a veteran of the Spanish-American War. 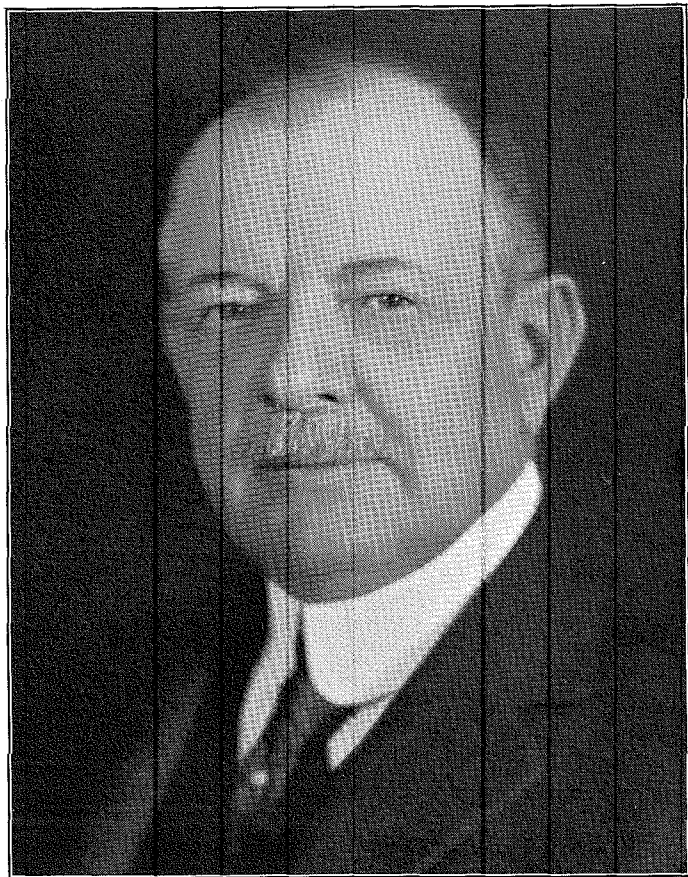
*Johnson, Judge Isaac*

JUDGE ISAAC JOHNSON (deceased), at the time of his death was the President Judge of the Courts of Common Pleas and Quarter Sessions of Delaware County. He resided in Media. He was a member of the Masonic fraternity, Grand Army of the Republic, and of the Pennsylvania and Delaware County Historical Societies. He was born in 1841, on August 11th, and until immediately before his death, June 10th, 1926, was one of the most active members on the bench throughout Pennsylvania. He served for many years as chairman of the State Board of Charities. He served as a Captain through the Civil War. Few men during their lifetime enjoyed the many splendid tributes paid him by those from every station in life. He was beloved by those who make up the rank and file here in Delaware County. His one hobby was fishing.



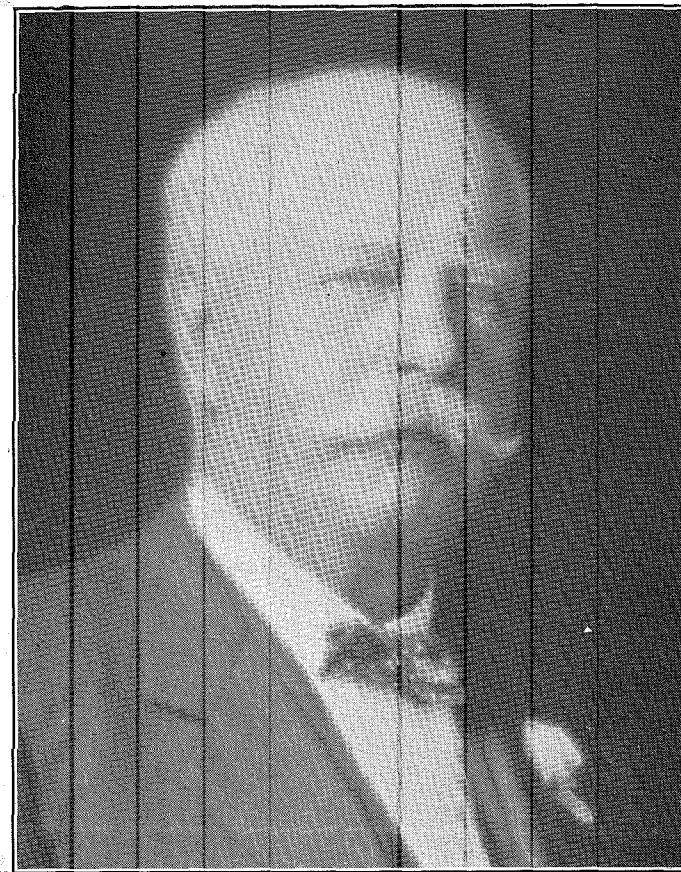
*Fussell, Robert*

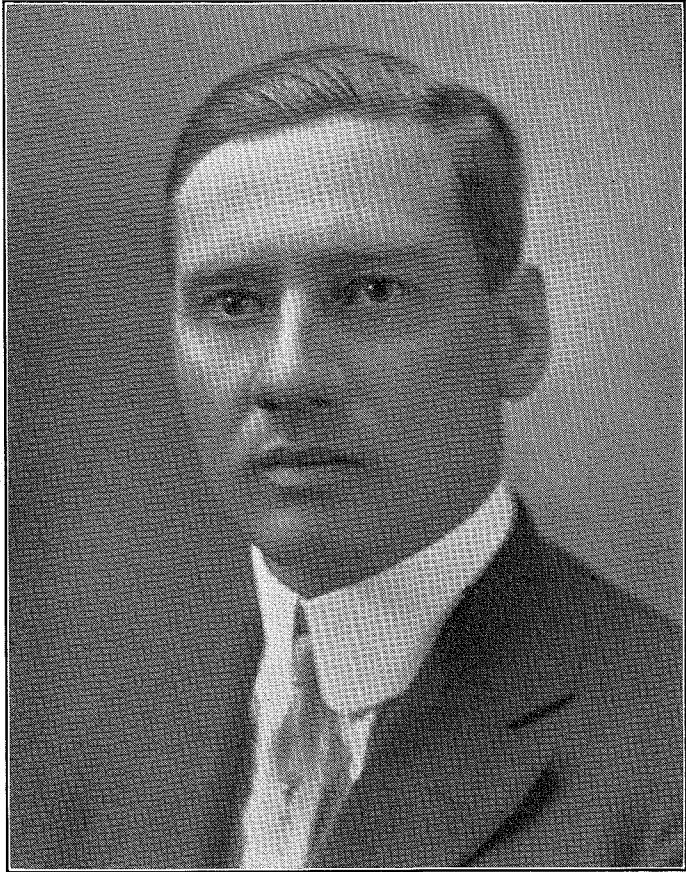
*Roth, Henry W.*

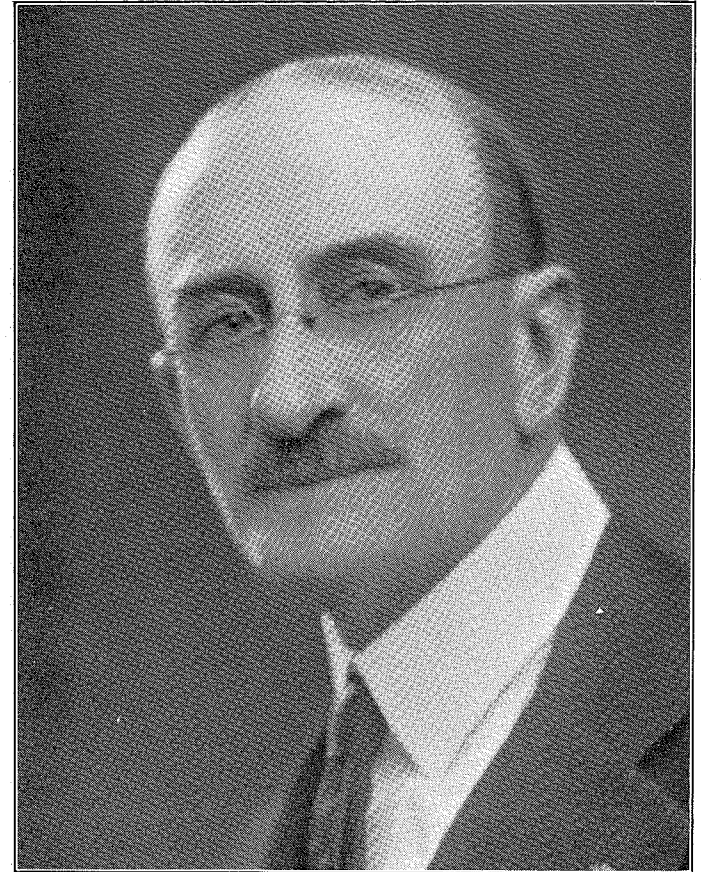
*Crozer, John Price*

*Parker, Bert R.*

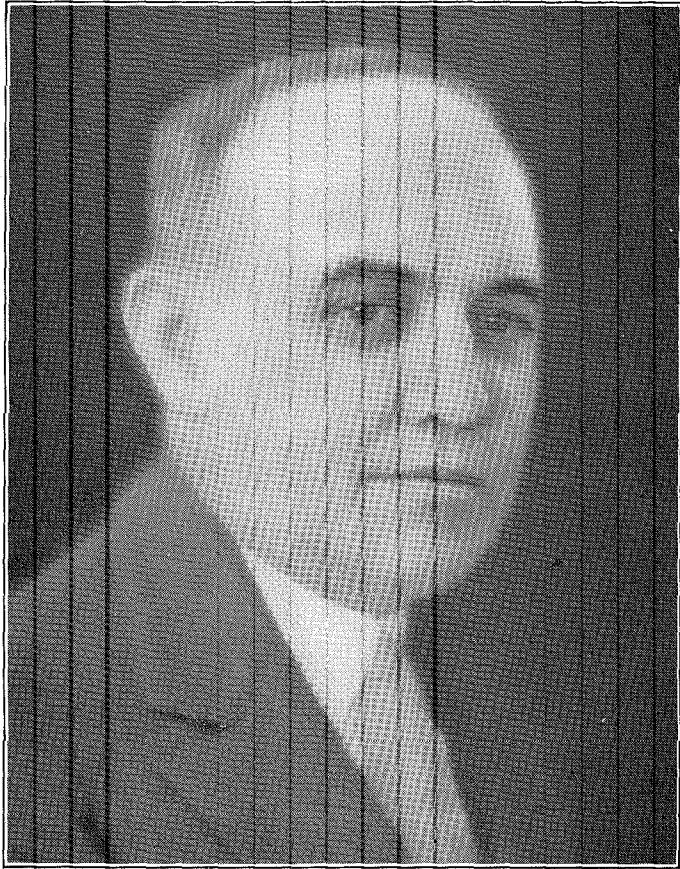

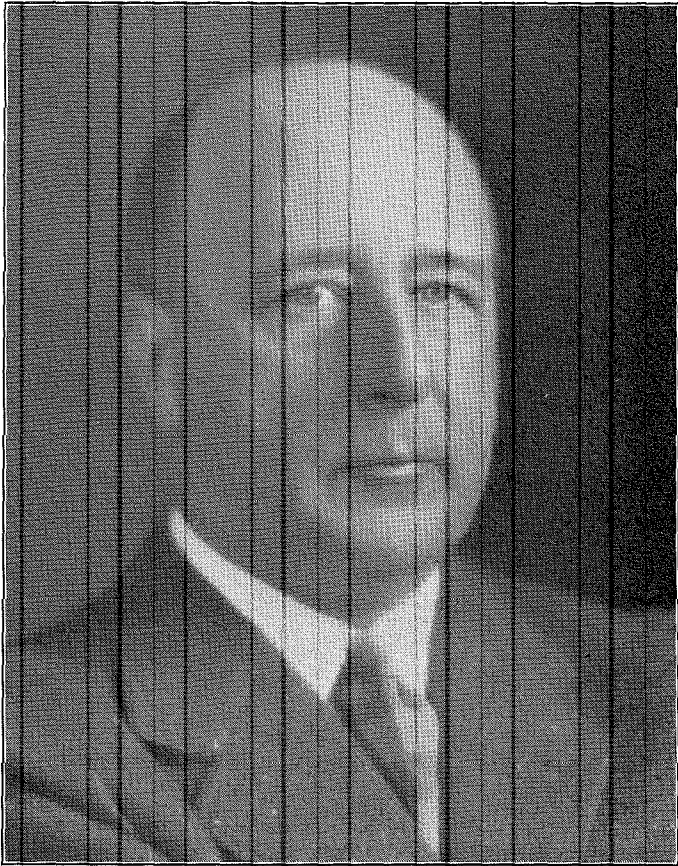
*Sheridan, Thomas A.*

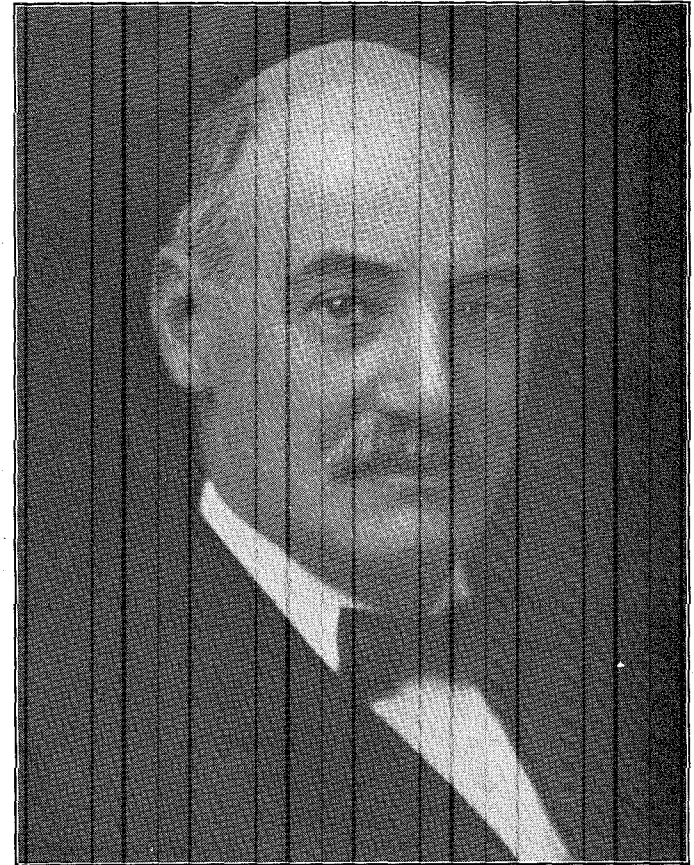
*Kent, Everett Leonard,*

*Damon, Albert F., Jr.*

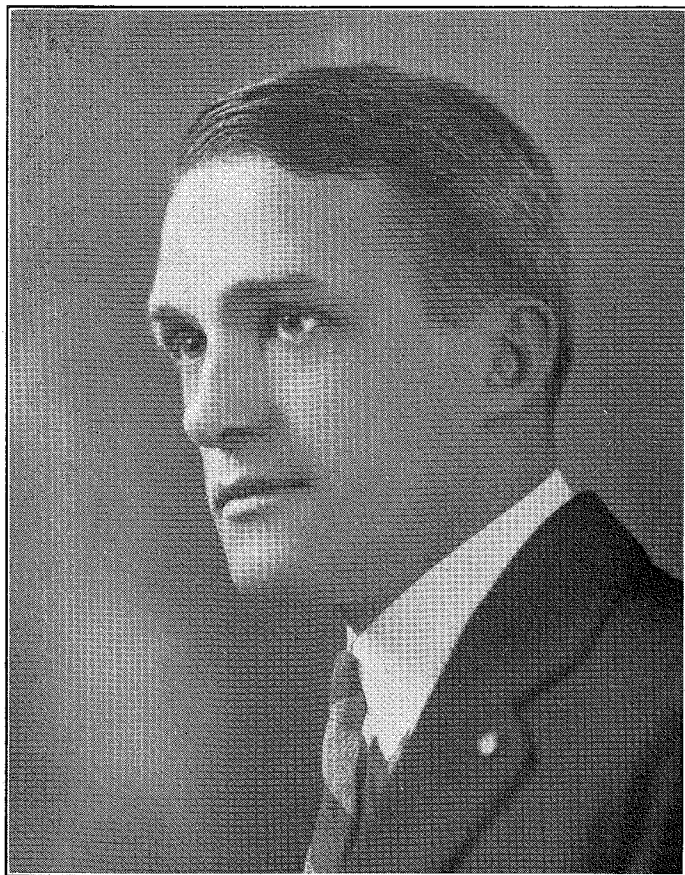

*Kane, John Kent*

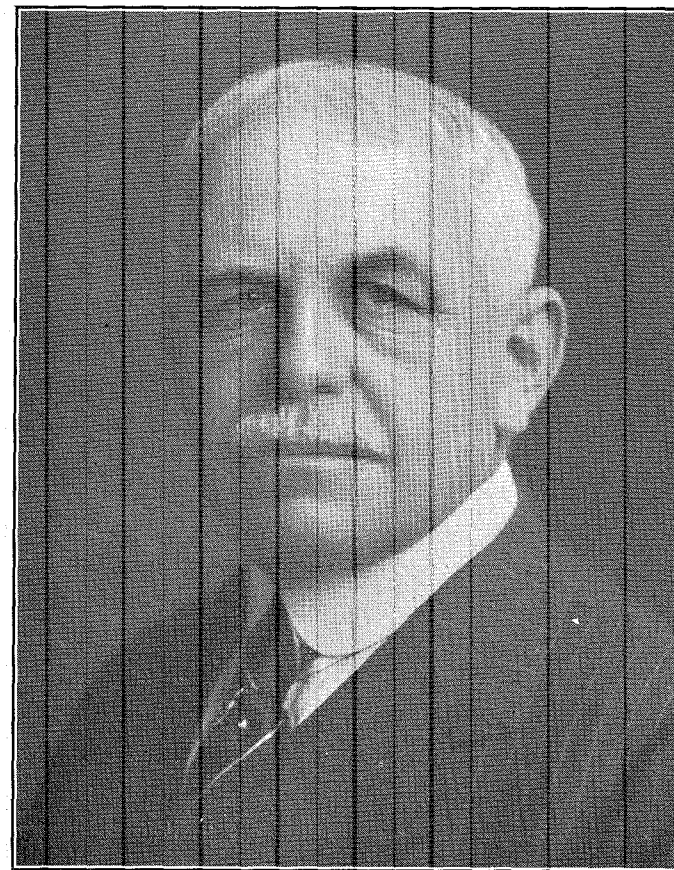

He was a Presbyterian, being President of the Board of Trustees of the First Presbyterian Church, Chester. In politics Mr. Glauser was rock-ribbed Republican, serving at one time in Chester Councils, and as chairman of the Coolidge Campaign in Delaware County. He is survived by his wife, Emma P. B. Glauser, and daughter, Katheryn (Mrs. Herbert P. Spackman). His hobby was community betterment; his sport was golf.



*Hinkson, Joseph H.*

**JOSEPH H. HINKSON** (deceased), Attorney-at-Law, was one of the most prominent members of the Bar and President of the Cambridge Trust Company, Chester. He resided at Ridley Park. Mr. Hinkson was born in the City of Chester on May 22nd, 1865, and died on February 14th, 1926. He was the eldest son of former Mayor John B. Hinkson and Kate Warrington Caldwell Hinkson. He was a member of the Union League, Philadelphia; Chester Club, Penn Club, Springhaven Country Club and the Rolling Green Golf Club, as well as the Masonic fraternity, Chester Lodge, of which he was former Past Master, Past High Priest Chester Chapter, R. A. M., and Past Commander of Chester Commandery, No. 66, K. T. Mr. Hinkson was a member of the University of Pennsylvania Law School, class of 1886. He was a director of the First National Bank of Chester, Ridley Park National Bank, Consumers' Ice Company, Allison Steel Products Company and many other corporations. WESLEY S. McDOWELL (deceased), headed the firm bearing his name in the City of Chester and was one of the most beloved Chesterites ever to hold public office, died April 6, 1920. As Mayor of the City of Chester during the hectic days of war he served his beloved city with distinction and great honor, from 1916 to 1920. As the chairman of Draft Board No. 2, he rendered his country distinguished service. He was born in 1860, on May 12th, the son of Agnes McQuillen and John McDowell. A member of the Chester Lodge, F. & A. M., Lu Lu Temple, Chester Commandery, Knights Templar and of the P. O. S. of A. Among his clubs were the Chester; an original member of Kiwanis, and the Keystone Masonic. For seventeen years he served as President of the Felton Fire Company. He served in Councils; was County Treasurer; President of the School Board, and a Delegate to Republican National Convention, held in St. Louis. He was also President of the Pennsylvania National Bank. In religion a Methodist. He is survived by his widow, Elizabeth K. Law McDowell, and two sons, Wesley and Harold.



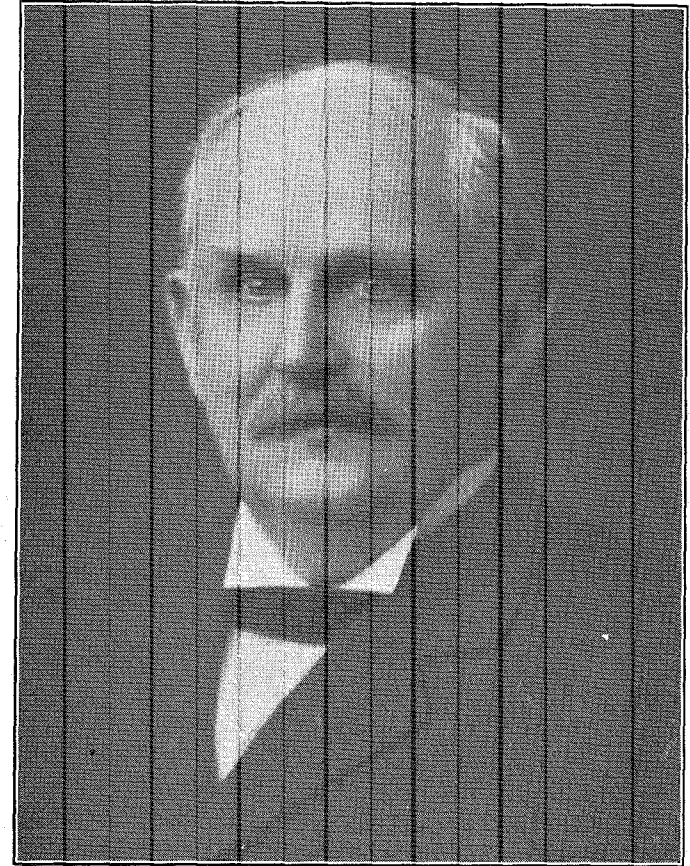
*McDowell, Harold Donald*

*Perry, Fred R.*

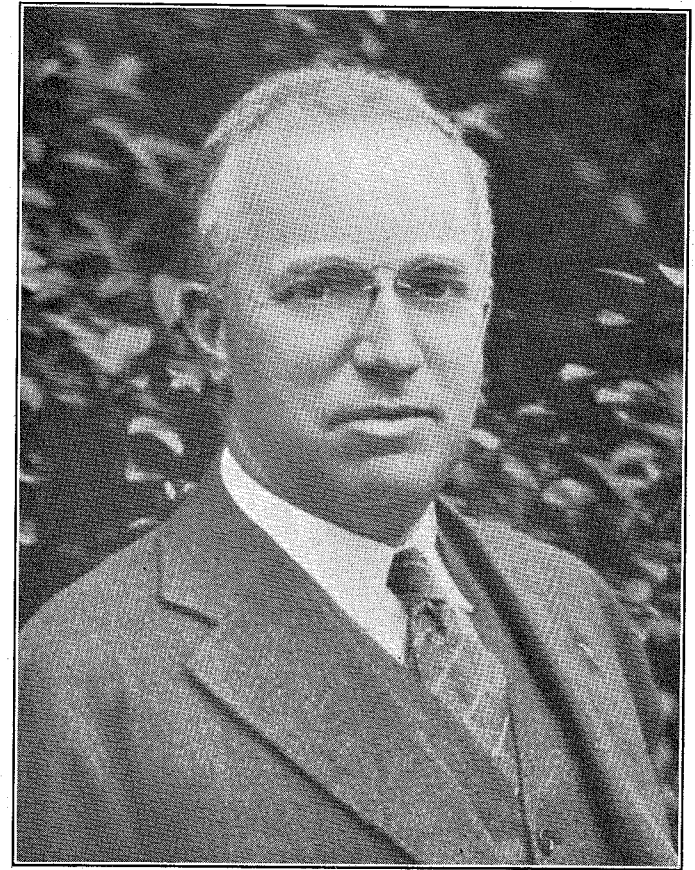

*Johnson, Isaac W.*

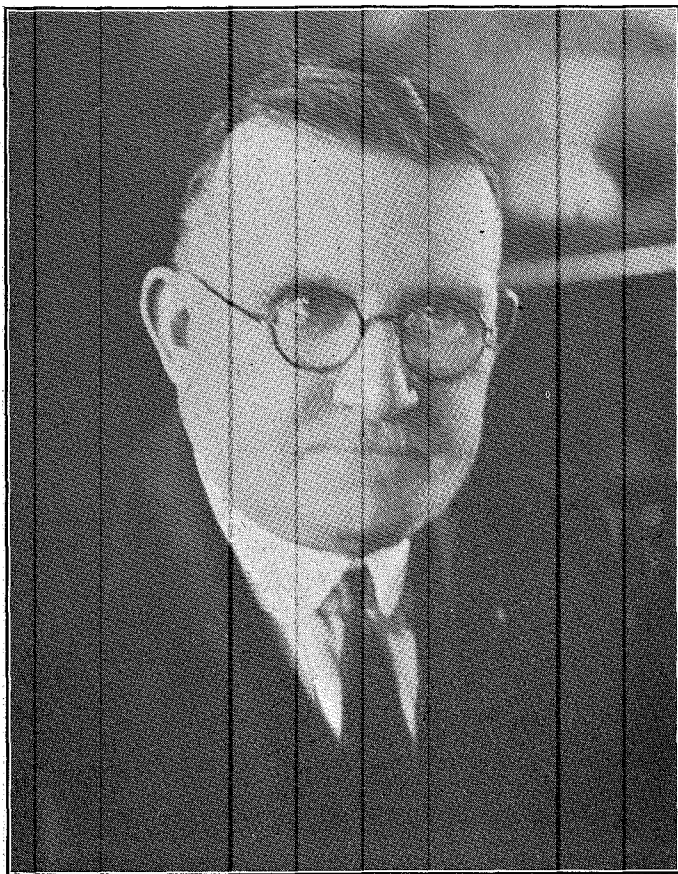

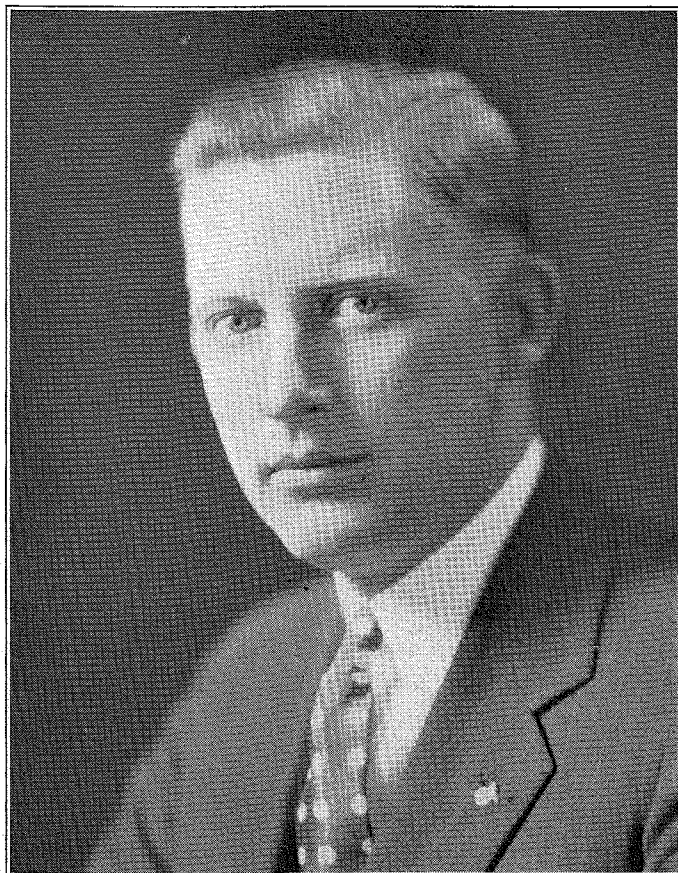
### *Allen, George Washington*

### *McEvoy, John C.*

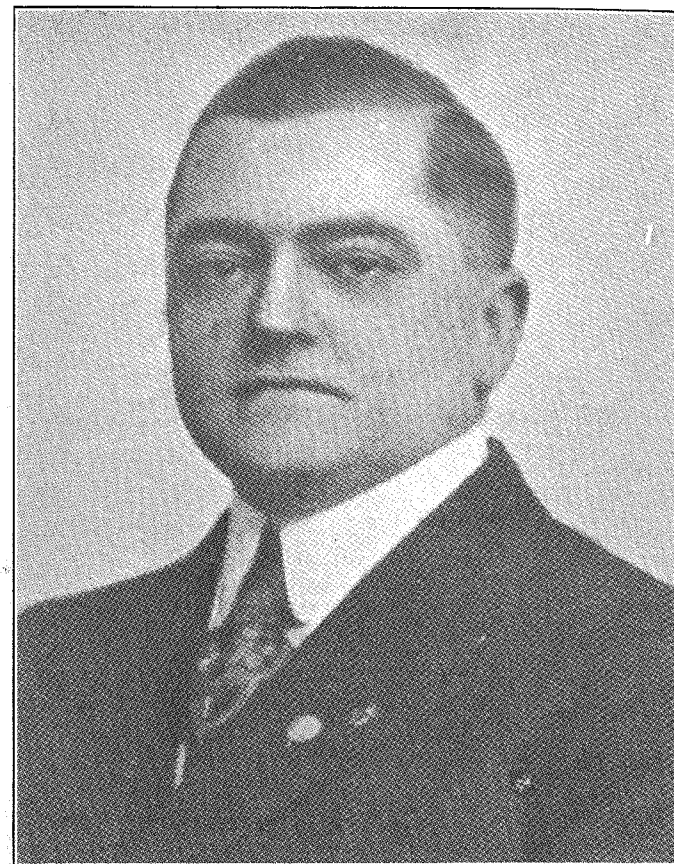
