- HEADLINE: Mutant Polio Virus Spreads in Nigeria
124 Children Afflicted This Year By Paralyzing Disease, Believed To Be Caused By Same Vaccine Used To Fight It (2009)
- World Health Organization issued a warning that the vaccine-spread mutant polio virus might extend beyond Africa.
- “Experts have long believed epidemics unleashed by a vaccine's mutated virus wouldn't last since the vaccine only contains a weakened virus strain - but that assumption is coming under pressure. Some experts now say that once viruses from vaccines start circulating they can become just as dangerous as wild viruses.”

The Virus

What is its origin?

- "The only difference is that this virus was originally in a vaccine vial," said Olen Kew, a virologist at the U.S. Centers for Disease Control and Prevention."
- The first vaccine that will be given to U.S. citizens for H1N1 in 2009 is MedImmune's LIVE VIRUS VACCINE.
- Both the MedImmune vaccine and the polio vaccine causing polio in Nigeria are nasal spray vaccines.

The Virus

What is the severity? Of the 2009 H1N1 flu? (1 of 4)

■ Very mild

- James Chin, professor at the University of California, Berkeley, and former WHO epidemiologist:

“My bet is that the coming [U.S.] season will not be too severe – at or below that of a usual flu season.”

- “What if we have a vaccine and then the genetics of the virus changes?”

[US National Institute of Allergy and Infectious Diseases (NIAID) director Anthony Fauci] “You never can predict that, but things look encouraging to me from a molecular-virological standpoint. If you look at the molecular and genetic make-up of the virus from the very first isolates in early April compared to what we are seeing now in late July, it's virtually an identical virus everywhere. **So it doesn't look like it is under pressure to mutate to a significant degree.** We hope it stays that way for the autumn and winter season.”

What is the severity? Of the 2009 H1N1 flu? (1 of 4)

■ Bowdoin College (Brunswick, Maine)

“[Bowdoin spokesman Doug] Boxer-Cook says that, so far, none of the confirmed cases has been particularly severe. "In our experience, the symptoms have been milder than those of the regular seasonal flu, and the students are cycling through it generally in three days or so, so we feel really fortunate that it's been this mild.”

The Pandemic

- **June 11, 2009 World Health Organization (WHO) declared H1N1 level 6 pandemic.**
 - **Highest level pandemic**
 - **Authorizes countries to force quarantine, force vaccinate, and use drugs “off license”**
 - Off license means that drugs that are not licensed for a particular disease can be used. Some drugs have been allowed to be used for the H1N1 virus that are not approved for this use.
 - **WHO is a UN organization with no current board members from the U.S.**
 - **The United Nations (UN) is effectively a world government, whose governing body is not elected by citizens of any nation, including the U.S.**

The Pandemic

Statistics - Southern Hemisphere

Australia (estimated population 21,885,016)

- According to <http://flutracker.rhizalabs.com/> 36,229 *reported cases* of H1N1, 172 fatalities (9/11/09)
- 1 in every 210 *reported cases* with H1N1 a fatality (0.5%)
- 1 in every 127,238 Australians died from H1N1 according to *reported cases* (.008%)
- Aug 28, 2009 Australia *reported* 147 deaths from H1N1 BUT: “While all of the 147 victims had swine flu, it is not clear how many were killed by the virus or died from other medical conditions.” (http://www.straitstimes.com/Breaking%2BNews/World/Story/STIStory_422437.htm)
- So...some deaths reportedly from H1N1 may be due to other causes AND most cases are mild and thus not likely reported, therefore the ratio of deaths to *actual* number of cases of H1N1 could be MUCH lower than what has been reported.

WHO Preparedness Checklist

WHO checklist for influenza pandemic preparedness planning

- 1.5.1 Legal issues
- Rationale
- During a pandemic, it may be necessary to overrule existing legislation or (individual) human rights. Examples are the enforcement of quarantine (overruling individual freedom of movement), use of privately owned buildings for hospitals, off-license use of drugs, compulsory vaccination or implementation of emergency shifts in essential services.

The Pandemic Statistics

- **How accurate are the statistics?**

Testing for H1N1 not done on everyone with a flu-like illness according to Anne Schuchat, MD at CDC briefing, 9/11/09.

- Therefore stats are not exact. Those with seasonal flu virus may be lumped in with those with H1N1.

The Pandemic

Statistics - Southern Hemisphere

- Southern Hemisphere – flu season ended Aug. 31, 2009.

“CANBERRA - AUSTRALIA'S H1N1 flu epidemic appears to be peaking after 147 people died with the virus, far fewer than initially expected, a top health official said on Friday.” (8/28/09)

The Pandemic

Statistics – U.S.

Sept. 19, 2009

- Confirmed cases: 125, 178
- Fatal cases: 632
- Fatality rate is 0.2% based on these numbers

CDC not testing every case so the number of cases could be much higher, making the fatality ratio much lower.

Statistics – Maine (USA)

- “Maine has identified 370 cases of H1N1, which include 19 individuals requiring hospitalization and one individual who has died. Since the last update, there has been one residential school outbreak in a college.” (9/10/2009) (<http://www.maine.gov/tools/whatsnew/attach.php?id=79040&>)

The Vaccines

What's in them?

■ Novartis:

- Influenza A (H1N1) (killed) virus antigens
- Mercury
(single dose syringe – less than 1 mcg, multi-dose vial – 25 mcg per dose)
- Egg protein
- Beta-propiolactone (considered to be a carcinogen)
- Nonylphenol ethoxylate (surfactant closely related to nonoxynol-9 spermicide)

The Vaccines

What's in them?

■ Sanofi-Pasteur:

- Influenza A (H1N1) (killed) virus antigens
- Thimerosal (approx. 49% mercury by weight)
(in the multi-dose vial only – 25 mcg per dose, none in the single syringe)
- Formaldehyde
- Gelatin
- Egg protein
- Polyethylene glycol p-isooctylphenyl ether (detergent)
- Sucrose (table sugar)

Would you take a vaccine or let your child take a vaccine that contains **lead**?

The Vaccines

What's in them?

"The maximum amount of mercury that the Environment Protection Agency allows people to be exposed to is 5,000 times smaller than the permissible amount of lead exposure; in other words **the EPA apparently considers mercury to be 5,000 times more toxic than lead.**" (Marcia Basciano DDS at annual meeting of IAOMT, San Diego 1994.)

(IAOMT = International Academy of Oral Medicine and Toxicology)

Therefore, most of the H1N1 vaccines contain a substance that the EPA considers to be 5,000x more toxic than lead.

The Vaccines

What might be added to them before they are given?

■ Squalene-based adjuvants

- Adjuvants help stimulate immune response to vaccine antigen
- US purchased **\$698 million** worth of these adjuvants for emergency stockpiles
- 9/3/09 - CDC Director Friedan said not planning to use it now but that could change
- 9/18/09 – WHO says “global production of vaccines for pandemic flu will be “substantially less” than the previous maximum forecast of 94 million doses a week.” Is this a scenario under which the adjuvants might be used?
- These adjuvants **not approved for use in U.S.**
- BUT, due to PREP Act of 2006, can be used during pandemic.

The Vaccines

What's wrong with these adjuvants?

- ANTI-SQUALENE ANTIBODIES LINK GULF WAR SYNDROME TO ANTHRAX VACCINE

“Data published in the February 2000 and August 2002 issues of Experimental and Molecular Pathology strongly suggests that Gulf War Syndrome is caused by a vaccine contaminated with squalene.”

The Vaccines

Safety Testing - *What safety testing?*

- Vaccine manufacturer GlaxoSmithKline states on its website:

“The total population studied in clinical trials will be limited due to the need to provide the vaccine to governments as quickly as possible.

Additional studies will therefore be required and conducted **after** the vaccine is made available.”

The Vaccines

Safety Testing - *What* safety testing?

- And WHO likewise says:

“Time constraints mean that clinical data at the time when pandemic vaccines are first administered will inevitably be limited. Further testing of safety and effectiveness will need to take place **after** administration of the vaccine has begun.”

Safety Testing - *What safety testing?*

Novartis vaccine insert states:

USE IN SPECIFIC POPULATIONS

Safety and effectiveness of Influenza A (H1N1) 2009 Monovalent Vaccine have not been established in pregnant women, nursing mothers or children less than 4 years of age. (8.1, 8.3, 8.4)

8.1 Pregnancy

Pregnancy Category C: *Animal reproduction studies have not been conducted* with Influenza A (H1N1) 2009 Monovalent Vaccine or FLUVIRIN. It is also *not known* whether Influenza A (H1N1) 2009 Monovalent Vaccine or FLUVIRIN *can cause fetal harm* when administered to a pregnant woman or *can affect reproduction capacity*. Influenza A (H1N1) 2009 Monovalent Vaccine should be given to a pregnant woman only if clearly needed.

The Vaccines

Safety Testing - *What safety testing?*

Novartis vaccine insert states:

13.1 Carcinogenesis, Mutagenesis, Impairment of Fertility

Neither FLUVIRIN nor the Influenza A (H1N1) 2009 Monovalent Vaccine **have been evaluated for carcinogenic or mutagenic potential, or for impairment of fertility.**

The Vaccines

Safety Testing - *What safety testing?*

ALL four H1N1 vaccines that were approved by the FDA earlier this week contain inserts that state the exact same thing as Novartis in terms of testing for carcinogenicity, mutagenicity or fertility impairment.

Meaning...**NONE** of them have been tested for these things.

(And neither have the seasonal flu vaccines that these vaccines are based on.)

The Vaccines

Safety Testing - *What safety testing?*

MedImmune – nasal spray vaccine – first one to be available in U.S.

- Not known whether it causes harm to fetus when given to pregnant women.
- Not known whether it's excreted in mother's milk plus it can shed, so caution should be used if administered to nursing mothers.
- MedImmune states that safety and effectiveness of FluMist has been demonstrated for children over 2 years— this is the seasonal vaccine that the H1N1 vaccine is based on.

The Vaccines

Safety Testing - *What safety testing?*

The 21 day trials.

- H1N1 vaccine trials using several HEALTHY population groups have been or are currently being conducted.
- At this time the Sanofi vaccine is being tested on pregnant women in the 2nd and 3rd trimesters.
- Not been able to find any studies testing it on UNhealthy people – the group most likely to be injured by vaccines.

The Vaccines

Do you want a fast-tracked vaccine injected into your body that:

- has not been tested for carcinogenicity, mutagenic potential or for fertility impairment
- has only been tested for 3 weeks
- that will be tested more fully *AFTER* you've taken it
- contains known carcinogens
- and contains a substance 5,000x more toxic than lead?

Novartis Bad Samaritan History

Novartis says 'no' to free flu vaccines

“Novartis, the Swiss pharmaceuticals group, defied the World Health Organisation and some of its corporate peers by ruling out a donation to the poor of vaccines to counter the latest flu pandemic, and saying developing nations or donor nations should cover the costs.

Daniel Vasella, Novartis chief executive, told the Financial Times that he would consider offering discounted pricing to low-income nations, but unlike other drug companies, including GlaxoSmithKline, would not offer vaccines for free. He said: "If you want to make production sustainable, you have to create financial incentives.”

Novartis Nazi History

“Several leading Swiss firms collaborated with the Nazi regime to boost profits and expand their interests in Germany, according to the findings of an Independent Commission of Experts (ICE) set up to probe Switzerland’s wartime past.

The ICE singled out the Basel chemical companies **Ciba and Sandoz (now merged into Novartis)**, which implemented the Nazis’ Aryanisation policies in a bid to win lucrative supply contracts from the Third Reich.”

Sanofi Pasteur Profile

- Sanofi Pasteur - vaccine division of Sanofi-Aventis Group.
- Sanofi-Aventis - multinational pharmaceutical company headquartered in Paris, France
- World's fourth-largest by prescription sales
- Spent \$4 million for lobbying in US (2009)

Sanofi Pasteur Safety History

Toxic antibiotic trial

“In 2006, an antibiotic from Sanofi-Aventis continued to be used in drug trials with more than 900 children worldwide, even after it was found to cause four times the average rate of acute liver failure in adults. The continued trials of the drug Ketek (Telithromycin) were criticized by a U.S. Food and Drug Administration official and a study consultant.

Initially, Sanofi-Aventis defended the antibiotic as safe when used as directed. [1] However, after a flurry of negative reports, the company announced on June 8, 2006, that it was voluntarily ceasing the Ketek trials involving children. The FDA also ceased recruitment for the study.”

Sanofi Pasteur Safety History

Toxic antibiotic trial...continued

“The criticism before Sanofi-Aventis' reversal was scathing. "How does one justify balancing the risk of fatal liver failure against one day less of ear pain?" asks Dr. Rosemary Johann-Liang, of the FDA's Office of Drug Safety, in a memo uncovered by the New York Times. [2] Duke University infectious disease specialist Dr. Danny Benjamin called the pediatric trial "hard to support." Benjamin also noted that antibiotics are less frequently recommended for pediatric treatment of routine ear infections. [3]”

Sanofi Bad Samaritan History

Scamming the poor

“In May 2009, the Sanofi-Aventis-owned subsidiary Aventis Pharmaceutical was fined more than \$95 million, "after overcharging US and local health agencies for medications destined for indigent patients" according to U.S. federal prosecutors. Aventis "acknowledged that it violated the False Claims Act by misreporting drug prices for patients in the Medicaid Drug Rebate program for poor patients," reported Agence France-Presse. Aventis "deliberately misquoted the prices, underpaying rebates to Medicaid and overcharging some public health agencies for the medications. The fraud occurred between 1995 and 2000, and concerned the steroid-based anti-inflammatory nasal sprays Azmacort, Nasacort and Nasacort AQ. 'We will continue to be vigilant in investigating and prosecuting those who scam the Medicaid system -- a system that is meant to benefit the poor' said Michael Loucks, acting US Attorney for the District of Massachusetts, in the Justice Department statement. 'When a drug company agrees to be a provider to the Medicaid programs, it agrees to sell its drugs to them at the same price it gives its best customers. We will, as here, pursue those who break their promises.'" [5]”

Sanofi Aventis Nazi History

- Formed in 1999 as merger between Rhône-Poulenc S.A. and **Hoechst** Marion Roussel
- Hoechst Marion Roussel was formed from the merger of **Hoechst AG** with Roussel Uclaf and Marion Merrell Dow
- Hoechst AG was integral component of **IG Farben** conglomerate

The Pharmaceutical Companies Making the Vaccines

Sanofi Aventis Nazi History

“In the immediate aftermath of the collapse of Hitler’s Third Reich, the victorious Allies dissolved the notorious German chemical monopoly, IG Farbenindustrie AG, and tried many of its surviving executives at Nuremberg. despite complicity in crimes, including plunder and the enslavement and murder of camp prisoners, the executives were either acquitted or received relatively light sentences (up to eight years, all eventually commuted). Many later returned to serve with Farben’s successor corporations (chief among them were the “big three,” BASF, Bayer, and Hoechst AG), which remained intact through the 1990s.”

The Pharmaceutical Companies Making the Vaccines

Sanofi Aventis Nazi History

- Karl Winnacker, head of corporate management of Hoechst in 1951, when it emerged from an older incarnation of Hoechst, reinstated several colleagues who were tried at Nuremberg
- Winnacker regarded these former colleagues as “victims” of Allied punishment
- Worth noting that IG Farben worked closely with the Rockefeller Standard Oil company, which gave IG Farben \$50 million in loans

The Pharmaceutical Companies Making the Vaccines

Sanofi Aventis Nazi History

- Senior plant managers collaborated with the Nazis
- Several managers at Hoechst were enthusiastic Nazis
- The company routinely exploited imported foreign workers
- Some corporate officials collaborated with SS doctors testing drugs on concentration camp prisoners, which often led to their deaths

The Pharmaceutical Companies Making the Vaccines

Baxter Pharmaceuticals Safety History – Dishonorable Mention

“The company [Baxter] that released contaminated flu virus material from a plant in Austria confirmed Friday that the experimental product contained live H5N1 avian flu viruses. (2/27/ 2009)”

This incident is dwarfed by Baxter’s involvement in producing Factor VIII (a blood product for hemophiliacs) in the 1970s-80s that was contaminated with HIV. Thousands of people worldwide became infected with HIV as a result.

- “Of 13 countries in a recent comparison, the United States ranks an average of 12th (second from the bottom) for 16 available health indicators.”

The Pharmaceutical Companies Making the Vaccines

It can be said that **Conventional Medicine** is the third leading cause of death in America as it is the doctors and their pharmaceutical drugs together that caused 225,000 deaths in the U.S. in 2000.

Again worth noting that the **Rockefeller Foundation** played a major role in shaping and funding the conventional medical paradigm practiced in the U.S. today.

Rockefellers funded eugenics movements in U.S. and Germany

“The Rockefeller Foundation helped found the German eugenics program and even funded the program that Josef Mengele worked in before he went to Auschwitz.”

“More than just providing the scientific roadmap, America funded Germany's eugenic institutions. By 1926, Rockefeller had donated some \$410,000 -- almost \$4 million in 21st-Century money -- to hundreds of German researchers. In May 1926, Rockefeller awarded \$250,000 to the German Psychiatric Institute of the Kaiser Wilhelm Institute, later to become the Kaiser Wilhelm Institute for Psychiatry. Among the leading psychiatrists at the German Psychiatric Institute was Ernst Rüdin, who became director and eventually an architect of Hitler's systematic medical repression.”

Drug company physician interaction presents information favoring the sponsor's product and increases the likelihood of prescribing that product.”

What happened during the last swine flu pandemic in 1976?

- The U.S. vaccinated over 40 million Americans
- Stopped the vaccination campaign after 10 weeks because too many people were being injured or killed by the vaccine
- When dust settled, 1 person died of the swine flu virus, 25 or more **died from the vaccine** and thousands more were **injured by the vaccine.**

What happened during the last swine flu pandemic in 1976?

- The 1976 Swine Flu Vaccine caused Guillain-Barré Syndrome – a crippling paralysis that can be fatal if not treated quickly
- Media now reporting that there was an unproven **link** to GBS, BUT the acting head of the CDC's Immunization Safety Office, Dr. John Iskander said in Feb. 2008 "A proven association between the 1976-1977 swine influenza vaccine and Guillain-Barré syndrome halted that particular national vaccination campaign."

Guillain-Barré Syndrome

- 8/15/09 - Leaked letter from the UK government warned neurologists to be on the watch for increased incidences of GBS due to the new swine flu vaccine.

Mayo Clinic Study - Children Who Get Flu Vaccine Have Three Times Risk Of Hospitalization For Flu, Study Suggests

ScienceDaily (May 20, 2009) — The inactivated flu vaccine does not appear to be effective in preventing influenza-related hospitalizations in children, especially the ones with asthma. In fact, children who get the flu vaccine are more at risk for hospitalization than their peers who do not get the vaccine, according to new research that will be presented on May 19, at the 105th International Conference of the American Thoracic Society in San Diego.

WHEREAS: The process of approving and "recommending" vaccines is tainted with conflicts of interest;

BE IT THEREFORE RESOLVED: That AAPS calls for a moratorium on vaccine mandates and for physicians to insist upon truly informed consent for the use of vaccines.

PPT by Glen Nowak, current CDC director of media relations:

“Recipe” that Fosters Influenza

Vaccine Interest and Demand (2)

3. Medical experts and public health authorities publicly (e.g., via media) **state concern and alarm (and predict dire outcomes)–and urge influenza vaccination.**

4. The combination of ‘2’ and ‘3’ result in:

A. Significant media interest and attention

B. Framing of the flu season in terms that motivate behavior (e.g., as “very severe,” “more severe than last or past years,” “deadly”)

The Hype

Government creates campaign of fear

“Recipe” that Fosters Influenza Vaccine Interest and Demand (3)

5. Continued reports (e.g., from health officials and media) that influenza is causing severe illness and/or affecting lots of people— helping foster the perception that many people are susceptible to a bad case of influenza.
6. Visible/tangible examples of the seriousness of the illness (e.g., pictures of children, families of those affected coming forward) and people getting vaccinated (the first to motivate, the latter to reinforce)
7. References to, and discussions, of pandemic influenza— along with continued reference to the importance of vaccination.



Legal Issues - Federal

PREP Act 2006:

“On June 15, 2009, Secretary Sebelius signed a declaration under the Public Readiness and Emergency Preparedness (PREP) Act to extend liability immunity against tort claims (except for willful misconduct) to individuals and entities involved in all stages of 2009 H1N1 influenza vaccine development, testing, manufacture, distribution, prescribing, administration, and use.

Liability immunity means that there is no legal tort claim that can be pursued in state or federal court. Individuals and entities that receive liability immunity under the declaration include manufacturers, distributors, States, locals, Tribes, and other entities that supervise or administer a vaccination program, and healthcare professionals or others authorized under State law to prescribe, administer, and dispense vaccines, when they are carrying out activities in accordance with the conditions stated in the declaration.”

Legal Issues - Federal

Secretary Sibelius of the DHHS has designated the Health Resources and Services Administration (HRSA) to address adverse vaccine reactions.

The HRSA created a Countermeasures Injury Compensation Program, with the potential to compensate citizens injured by the swine flu vaccine. The current appropriated budget for swine flu vaccine injuries is 14 million dollars, according to Meryl Nass, MD. A government doctor employed by HRSA will "judge" the claims and determine who does or does not get compensated.

Legal Issues - Federal

“The precise method for proving a claim is not known yet, but will be entirely non-judicial. A physician employee of HRSA will review claims and make a determination as to whether the injured party proved that the vaccine caused their injury. An appeals process will exist within DHHS, but will also be entirely non-judicial. No lawyers' fees will be paid by the program, nor will there be payments for "pain and suffering.”

Legal Issues - Maine

Maine Governor Signs Civil Emergency Order to Fight Flu, Facilitate School-Based Vaccinations

September 1, 2009

“Many school districts reported that a concern about potential liability was putting at risk their ability to participate in vaccination clinics. The proclamation protects school districts and other vaccination clinic participants from liability.”

Legal Issues - Maine

- Declaring a “Civil Emergency” does not allow the State of Maine to force vaccinate anyone.
- However, the state of Maine **CAN force drug, force vaccinate, force detain or force quarantine Maine citizens** IF the Governor declares a “civil disaster”.
- In essence, on the whim of the sitting Governor at any given time, Maine citizens can be force drugged, detained or quarantined against our will.

Legal Issues – other states

- U.S. military – vaccines are **mandatory**
- Employers in several states have made the 2009 H1N1 vaccine **mandatory** for their employees.
- Several colleges have made it **mandatory** for their students.
- Massachusetts just passed legislation that would allow the state government to **force vaccinate, force quarantine, enter private homes by force, and fine citizens \$1,000 day or jail them if non-compliant**

Summary

- Mild virus
- Provenance may be natural, or man-made
- Southern Hemisphere flu season is over – much milder than expected
- Vaccines “Fast-tracked” a.k.a. **experimental**
- Adjuvants linked to GWS

Summary

- The pharmaceutical companies given the most U.S. taxpayer money for the vaccines both have problematic safety histories and both gained much of their wealth and prominence from aiding Hitler

Summary
