3. <u>Historical Narrative</u>. In 1985 United States Ship MCINERNEY (FFG-8) was deployed to the Middle East Force from 01 January to 16 March. As part of Middle East Force 1-85 MCINERNEY set an Aviation Safety and Readiness Record with a 98 percent availability rate over 4.5 months and 153 consecutive days fully mission capable (FMC). MCINERNEY conducted extensive surveillance operations of Persian Gulf shipping and monitored the progress of United States Flag Tankers in the Persian Gulf. MCINERNEY conducted post attack damage assessment of foreign flag tankers attacked by Iran and Iraq in conjunction with the economic war in the Persian Gulf commonly referred to as the "Tanker War".

After out-chopping from Middle East Force on 16 March 1985, MCINERNEY visited Palma and Rota, Spain, and Ponta Delgada, Azores enroute to her arrival in Mayport, Florida on 06 April 1985. Since return from deployment, MCINERNEY conducted an Interim Refresher Training, Carrier Escort, Engineering and ASW Schoolship Exercises, and Law Enforcement Operations with the United States Coast Guard. MCINERNEY received the highest grade possible - an above average - in the rigorous Atlantic Fleet Propulsion Examining Board's OPPE in October 1985 and was awarded the Commander In Chief United States Atlantic Fleet, Golden Anchor Award for retention excellence in December 1985. MCINERNEY was the Host Ship for the Navy Birthday/Columbus Day Celebration in New York City and Host Ship for Homecoming Weekend at the United States Naval Academy in October 1985.

4. Chronological Order of Events:

01 January	Underway with LAMPS MK I Helicopter Detachment (HSL-34 Det 4), conducted surveillance operations in the Persian Gulf as a member of the Middle East Force.
05 January	Inport Mina Sulman, Bahrain for a brief upkeep period to change out the engine block of Number Three Diesel.
14 January	Underway for surveillance in the Persian Gulf.
28 January	Overnight stop in Mina Sulman, Bahrain for fuel, cargo, and mail.
29 January	Remained at sea, transited to Al Jubail, Saudi Arabia

- 10 February In Al Jubail, Saudi Arabia hosted local dignitaries, Saudi Military Officials, American School children, and American Nationals living in the area.
- 12 February Departed Al Jubail and continued operations in the Persian Gulf until 22 February.
- 22 February Arrived in Mina Sulman, Bahrain for an upkeep period prior to departure from the Persian Gulf.
- 28 February Underway to conduct surveillance operations.
- 07 March Conducted a midnight transit of the Strait of Hormuz passing the USS ARTHUR W. RADFORD as she entered the Persian Gulf.
- 08 March Conducted an at sea rendezvous with the USS ANTRIM for turnover brief with the embarked LAMPS Detachment and met the USS CHARLES F. ADAMS for Middle East Force turnover. Upon completion, transited the Gulf of Oman enroute the Republic of Djibouti.
- 12 March Arrived in Djibouti for a brief stop for fuel. After departing, transited the Bab El Mandeb Straits in company with the USS HAYLER.
- 14 March Joined up with USS ESTOCIN, and USS JOHN HANCOCK and proceeded to Port Suez, Egypt to await passage through the Suez Canal.
- 16 March All four ships commenced a northbound transit of the Suez Canal, exiting thirteen hours later. At midnight, inchopped to Commander Sixth Fleet and CINCUSNAVEUR and began transit across the Meditteranean Sea in company with USS HAYLER, USS JOHN HANCOCK, and the USS ESTOCIN.
- 21 March Commenced a port visit in Palma De Majorca, Spain.
- 24 March Departed Palma enroute Rota, Spain for fuel.
- 25 March Transited the Straits of Gilbralter.
- 26 March Stopped at Rota, Spain for fuel, then began Atlantic transit.
- 29 March Arrived in Ponta Delgada, Azores for fuel. Remained overnight due to poor weather.
- 30 March Began final transit of deployment to Mayport, Florida.
- 06 April Arrived Mayport, Florida.
- 15 April Participated in Battle Force Inport Training until 19 April.

## Began an Intermediate Maintenance Availability until 07 June. Departed Mayport, Florida enroute Newport, RI. Arrived in Newport, RI for services in support of Surface Warfare Officers School Command Engineering Schoolship. Departed Mayport, Florida enroute Newport, RI.
