## AB 580, FUNDING FOR THE ARTS IN THE 21<sup>ST</sup> CENTURY ASSEMBLYMEMBER ADRIN NAZARIAN

### This bill:

AB 580 will create jobs and boost California's economy by restoring funding to the arts. Specifically, AB 580 will allocate \$75 million to the California Arts Council, from the General Fund, to fund art programs that will be enjoyed and taken advantage of by local communities throughout the state.

### **Background:**

Governor Edmund G. Brown created the California Arts Council almost 40 years ago to encourage public participation in the arts; help build strong arts organizations to assist with the professional development of arts leaders; promote awareness of the value of the arts and directly fund art programs in California's communities.

Unfortunately, in the last decade, the California Arts Council's budget has suffered devastating cuts. In the 2000-2001 fiscal year, the state allocated approximately \$30 million dollars to the California Arts Council, the highest allocation in the council's history. Consequently, over the years the state has slashed down allocations to roughly \$17 million in the 2002-2003 fiscal year and roughly \$1.1-1.6 million for all subsequent years. The cuts to the California Arts Council have been steep and have drastically impacted local arts programs in communities statewide.

Today, the state of California spends about 3 cents per resident from the general fund to support of the California Arts Council. This amount is much less than what other states invest in the arts. According to the National Assembly of State Arts Agencies, California ranks 47<sup>th</sup> in the nation of per capita spending on state art agencies.

#### **Purpose:**

At the proposed estimate of \$2.00 per person (which equals approximately 75 million), California would still not rank in the top ten in state funding. However, AB 580 will provide a significant amount of support to the arts and to the residents of California to remediate the lost funding the California Arts Council has faced in the last decade.

The arts contribute significantly to California's economy through tourism, jobs, social services and educational outreach. The arts provide an intellectual infrastructure for our entire creative economy, from technology to the entertainment industry. Just as importantly, the arts are vital to our state's international reputation and to the quality of life that we are very proud of as Californians. Specifically, AB 580 will empower the Arts Council to expand its grant program to continue supporting the arts. The arts have proven vital to California economy, specifically;

Non-Profit Arts-related sector statewide supports:

- 91,000 arts-related businesses
- 500,891 jobs for people in California

Non-profit arts specifically generate:

- \$9.4 billion in total economic impact
- 7.6 % of total employment in California
- \$700 million in state and local taxes

Additionally, the arts:

- Spur cultural tourism with over 6,000,000 arts tourists per year to California
- Revitalize depressed neighborhoods
- Attract creative workers and industries
- Provide a creative infrastructure for innovation and imagination
- Serve as a crucial corollary to California's entertainment industry
- Unite our communities, celebrating diversity and building bridges of tolerance and understanding
