The Institute of Chartered Financial Analysts of India University, Mizoram has been established vide Govt. of Mizoram Notification No.B.12012/2/2006 - EDC, dated 19.10.2006 under The Institute of Chartered Financial Analysts of India University, Mizoram Act 2006, passed by Legislative Assembly of the State of Mizoram.

Th University started it operation with effect from academic year 2005-06 with BBA programme with a strength of 26 students out of which 11 students completed the course. MBA was introduced in 2006-07, BCA in 2007-08 and BHTM in the year 2008-09.

Presently the University is functioning from leased accommodation at Aizawl. The proposed campus of the University is under construction at Durtlang North, at the outskirt of Aizawl city.
